Srinagar, Dec 07 Union Minister of State for Home Nityanand Rai on Wednesday said 180 militants have been killed in Jammu and Kashmir during encounters with security forces this year so far.

Nityanand Rai, while informing the Rajya Sabha as per the news agency-Kashmir News Observer (KNO), said that that 62 security forces personnel including 31 civilian were also killed during the current year. He said added 123 militancy-related incidents took place in J&K during the current year with 31 security forces personnel and 31 civilian being killed.He also said 8 journalists working with Srinagar based local newspapers received threat through "Kashmir Fight" blog and 4 journalists belonging to the media house Rising Kashmir also resigned.

"2,639 Kashmiri mi grants appointed in last 5 years including 841 in 2020-21, 1,296 in 2021-22 and 502 in 2022-23. As for the remaining 361, selection for 198 posts at different stages of completion," Rai, as per

Srinagar, Dec 7, : Local power consumers in Kashmir Valley are taking advantage of the 'Amnesty Scheme' declared by Jammu Kashmir Power Development Corporation. JKPDCL has been organizing various programs to make consumers aware of the benefits of the 'Power Amnestv Scheme. An official from JKPDCL. Farhan Manzoor who looked after the event at Ilahi Bagh Srinagar told news agency Kashmir News Trust that more and more consumers are taking benefits under the scheme and are paying the principal amount.

He said under the 'Power Amnesty Scheme' 100% interest/surcharge on outstanding electricity bills in favor of domestic consumers accumulated up to March 31, 2022, is being waived off and the outstanding principal amount arrears will have to be paid by the consumers in a maximum of 12 instalments.

"The Power Department could have taken a legal course to recover bills from the defaulters but it came up with this scheme in the interest of the domestic consumers. It is a good scheme and is helping the defaulters to clear their pending bills," he added. The official informed that power bills worth over Rs 1800 crore are pending with the defaulters.



#### 500,000 Australians infected with Covid, predicts expert

leading infectious diseases expert on Wednesday predicted that up to 500,000 Australians are currently infected with Covid-19.

Peter Collignon, an infectious diseases physician and microbiologist from Australian National University (ANU) and Canberra Hospital, warned that up to 2 per cent of the country's population were likely to have the virus, reports Xinhua news agency

The latest data from the Department of Health revealed that there were more than 14,000 infections reported per day in the week to November 29. but Collignon said the actual number of cases was likely much higher.

"I would think one or two percent of people have probably got Covid at this point in time, which is a lot, but the vast majority are reinfections now. Intensive Care Unit (ICU) admissions and ICU ventilations are nowhere near what it was earlier this vear." he told the media.

In mid-October, there was a weekly average of 170.3 new cases in Australia per 1 million people. By late November the figure had increased to

Spinal cord injury management requires to be tackled at multiple levels and by multiple people so as to give a respectful and meaningful life to individuals affected by this ailment, he said.

"Understanding the advancements and use of technology will go a long way to help these patients. We need to learn from others and we should also impart our knowledge and expertise to others and this is what is being reflected by so many experts joining hands from within our country and from outside India. This assumes all the more importance since India has just started with Presidency of G20 nations and conferences like these are very much required to focus on the theme Vasudhaiva Kutumbakam," Kumar said.

Talking about the spine injury, Rajesh Aggarwal said that various psychosocial issues compound such injuries and need to be taken care of for an optimal outcome. "We also appreciate the hard work done by all doctors and disciplines who have gathered together for the conference."



blood level (bound and free level) of the hormone T4. A Free T4 test measures how much hormone is not bound and is free to enter and affect the body tissues.

It is good practice for doctors to measure T4 in children, as T4 is essential to brain development. Tests measuring free T4 hormone more accurately reflect how the antibodies induce the thyroid to thyroid gland functions when

checked with a TSH.

Results showing an elevated TSH but low free T4 (FT4) indicate primary hypothyroidism caused by any disease in the thyroid gland. On the other hand, low TSH and FT4 values indicate hypothyroidism due to a pituitary gland problem. A low TSH with an elevated FT4 signifies the presence of hyperthyroidism.

#### T3 Test

T3 test measures the other major thyroid hormone, T3 (triiodothyronine), in the blood. It is helpful to diagnose hyperthyroidism and determine the severity of your hyperthyroidism. It is because people who are hyperthyroid shows an elevated T3 level. However, T3 testing is rarely helpful in hypothyroid patients because they can have a normal T3 with a high TSH and low FT4

#### **Thyroid Antibodies Test**

Thyroid antibodies are produced by the immune system, causing an autoimmune thyroid condition that results when these cells target and kill healthy thyroid cells.

While specific antibodies damage thyroid tissue and cause low thyroid hormone levels, other release excessive thyroid hor-

Therefore, thyroid tests are essential to understand how your body is doing regarding its thyroid hormone levels and antibodies. While thyroid hormone levels can be determined by blood tests known as thyroid function tests, thyroid antibody tests detect different types of thyroid antibodies that cause autoimmune diseases

#### When Do You Need to Get Tested?

Testing is when you experience thyroid-related symptoms, or your doctor has suspicions about an autoimmune thyroid disorder. Losing weight, anxiety, anger, sadness, hair loss, and missed or light periods are all indications of hyperthyroidism, which cause high T3 and T4 levels.

Lethargy, difficulty concentrating, weight gain, melancholy, excessive menstrual bleeding,

and joint and muscular pain are all common signs of hypothyroidism (low T3 and T4 levels).

#### **Normal Reference Range**

For any abnormal value, you should consult a doctor. According to the results of your thyroid test, your hormone levels should typically fall between the following range:

T3: 100-200 nanograms per deciliter of blood (ng/dL)

T4: 4.5 - 11.2 micrograms per deciliter of blood (mcg/dL)

TSH: 0.4-5.0 milli-international units per litre (mIU/dL)

TSH (If you already have thyroid): 0.5-0.3 milli-international units per litre (mIU/dL)

#### **Preparation Tips and Precautions**

Typically, no additional precautions, such as fasting, are required before a thyroid test.

Take your blood test before taking your daily dose if you are already on medication for thyroid illness.

You can take a thyroid test when pregnant if necessary because thyroid alterations are frequent during this time.

As consuming biotin (Vitamin B7) two days before a thyroid function test is known to cause some aberrancy in your test results, it is best to avoid taking it.

he Union Territory (UT) of

Jammu & Kashmir (J&K) was formerly one of the largest princely states of India and is bounded by the Indian Union Territory of Ladakh, to the south by Himachal Pradesh and Punjab, to the southwest by Pakistan and to the northwest by the Pakistan administration portion of Kashmir. The UT of J&K is bestowed by blissful climate and the flora and fauna of the region remains a symbol of pride for the nation. When the erstwhile state formed a part of India in 1947, it was widely felt that substantial ground would require to be covered before the state was truly integrated with the country being to the unusual conditions prevailing at that time. To neutralize the political scenar io of the state and to give certain prudential rights to the citizens or the residents of the state provision of art 370 was introduced in the state of J&K. Art 370 granted special status to the erstwhile state of J&K. Aim of the statute that time was firstly, to preserve the distinct identity of the people of J&K and secondly, to moderate the feeling of uncertainty prevalent among the people of Kashmir. Except Foreign Affairs, Defense Finance and Communication, the Indian parliament needed the concurrence of the state government for applying all other laws. In addition, the state was allowed to have its own flag and constitution. Also, no one from outside the state could purchase property in the state. Although the jurisdiction of supreme court was extended over J&K as a functional requirement. In 1952 Delhi Agreement came, according to which

state Constituent Assembly was required to be set up so that constitutional relationship was required to be build up between state & India. And that was the purpose of making the provision (Art 370) temporary

The demand engine is driven by urban consumers, encouraged by a return to precovid levels of economic activity. Rural consumers were more cautious as their inflation outpaced that of their urban counterparts.

According to World Gold Council estimates, world jewellery consumption continued to rebound in the third quarter of this year and is now back to pre-pandemic levels, reaching 523 tonnes, which is 10 percent higher compared to the same period in 2021. Much of this growth was spearheaded by India's urban consumers who drove up prices demand 17 percent year on year to 146 tonnes

Similarly impressive growth was also seen in much of the Middle East, with Saudi Arabian jewellery consumption up 20 percent since the third quarter of 2021, and United Arab Emirates up 30 percent for the same period. Chi-

nese jewellery demand also saw a modest 5 percent increase, driven by improved consumer confidence and a dip in the local gold price, prompting the release of some pentup demand.

China, which is the biggest consumer of gold in the world, is expected to see a further pick-up in jewellery demand, boosting the overall numbers further, although a spike in infection more recently in that country has marred the outlook

Retail investors bought gold as a store of value amid surging global inflation, while ETF investors reduced their holdings in the face of rising global interest rates. Gold's safe-haven appeal has also been boosted by a depreciating rupee and falling local equity

Just as consumer gold demand firmed, central bank buying picked up significantly with estimated record purchases of nearly 400 tonnes in the third quarter. A council survey of central banks indicated the intention by a quarter of central banks to increase their to increase their gold reserves in the



next 12 months.

Even as the country led the global gold jewellery recovery, the Reserve Bank of India added 17.46 tonnes of gold reserves in the third quarter. With the latest purchases, India's total gold reserves have gone up to 785.35 tonnes, comprising 7.8 percent of the total reserves. Gold imports by the trade

recorded a decline after the Centre

hiked the tariff on gold from 7.5 percent to 12.5 percent in July this year. But this has led to a significant increase in the smuggling of gold into the country. Smugglers are using innovative methods to dodge customs authorities to bring in their illegal gold, such as conversion of the metal into paste, powder forms, which are more difficult to detect

The World Gold Council had, in fact, forecast that the increase in tariff could increase gold smuggling by a third to touch 160 tonnes in calendar year 2022 as compared to the pre-covid period when the duty was 5 percent lower.

The trade is now seeking a reduction in the taxes and duties on gold to encourage more imports through official channels. The All India Gem and Jewellery Domestic Council is urging the government to reverse the tariff increase as well as a reduction in the GST tax to 1.25 per cent from the current 3 per cent.

The trade points out that the higher import duty is creating problems for the domestic industry as it encourages smuggling.

According to the industry, a reduction of duty to 4-6 percent would act as a disincentive for illegal trade. This will not only lead to less smuggling, but also add to government's tax revenue from the legitimate channels, they argue.

According to gold smuggling and seizure data provided by Directorate of Revenue Intelligence, as much as 73 per cent of the gold caught had been brought through Myanmar and Bangladesh. The smuggled gold is apparently brought into Myanmar from China through the border towns on the Chinese and Myanmarese borders. Smuggling using airline passengers as carriers is also rampant on the Gulf-Kerala sector, where seizures happen as a matter of routine, but much larger quantities escape scrutiny.

A proposal to this effect is reportedly under the consideration of the commerce ministry, which has apparently approached the finance ministry on the possibility. There is widespread expectation that some such decision would be announced in the next budget. IPA SERVICE

# RBI policy announcement in line with expectations: Abheek Barua

Srinagar, Dec 7, KNT: Chief Economist HDFC Bank Abheek Barua while commenting on monetary policy said RBI policy announcement today was in line with expectations in terms of raising the policy rate by 35bps and keeping the policy stance unchanged. However, the policy tone was distinctly more hawkish than expected. When a central bank combines its sanguine view on growth with continued concerns on inflation – particularly the persistence in core inflation – it suggests that it is prepared to continue its fight against inflation and has the space and willingness to raise rates further. The central bank emphasized that it is not ready to let up its inflation battle and aims to bring down inflation below 6% in the near term and then closer to 4% over the medium term.

He said there were other signs in the governor's statement that suggested that tightness in financial conditions could intensify going forward.

"Today's policy announcement does provide a soft support for the rupee ahead of the Fed meeting next week and can be viewed perhaps as an attempt by the RBI to continue aligning itself with the still hawkish G7 central banks. Furthermore, the RBI's continued emphasis on the factors that lend support to the rupee, signals its preference for a stable rupee going forward implying intervention on both sides of the market to keep it range bound into 2023." In terms of forecasts, GDP growth was revised down marginally by 20bps to 6.8% for FY23, although the central bank showed comfort around the current growth momentum. On inflation, the full year figures were kept unchanged at 6.7%.

Bottom line is the poicy announcement today signalled that more rate hikes are in the offing. We expect the terminal rate to be close 6.5-6.75%. [KNT]

## **Chinese flags flutter in Saudi** capital ahead of Xi visit



The Saudi capital was bedecked with Chinese flags ahead of President Xi Jinping's visit on Wednesday that is likely to focus on energy ties but also follows months of tensions with the United States.

The red-and-gold Chinese emblem alternated with the green flag of Saudi Arabia along major roads in Riyadh, while Xi was pictured on the front pages of newspapers that highlighted the trip's potential economic benefits. China, the world's second-biggest economy, is the top customer for oil from Saudi Arabia, the leading exporter of crude, and both sides appear keen to expand their relationship at a time of economic turmoil and geopolitical realignment.

The three-day trip — only Xi's third overseas journey since the coronavirus pandemic began, and his first to Saudi Arabia since 2016 — comes after US President Joe Biden's visit in July, when he pleaded in vain for higher oil production.

It will feature bilateral meetings with Saudi King Salman and Crown Prince Mohammed bin Salman, the de facto ruler, as well as a summit with the six-member Gulf Cooperation Council and a wider China-Arab summit.

The programme represents the "largest-scale diplomatic activity between China and the Arab world since the founding of the PRC", or People's Republic of China, foreign ministry spokeswoman Mao Ning said on Wednesday.

# Japan announces grant of \$38.9m for Pakistan flood victims

Japan has announced its plan to provide a "grant assistance" of \$38.9 million to Pakistan as part of the country's supplementary budget to deliver life-saving aid to the flood victims, its embassy in Islamabad said on Wednesday.

In August of this year, the world watched in horror as Pakistan was struck by unprecedented floods that rendered over one million people displaced and around 1,700 dead.

According to the Japanese Embassy statement, the projects will commence in January 2023 and Tokyo "will support the affected population in various social and economic dimensions in partnership with WHO, UNF-PA, FAO, UNDP, UNICEF, WFP, UNWOMEN, UNHCR, and IPPF in Sindh, Khyber Pakhtunkhwa, Balochistan, and Punjab provinces, as well as the Islamabad Capital Territory.

The statement added that the proposed areas for support included "emergency medical assistance, food distribution, agriculture and livestock restoration, livelihood recreation, and gender-based violence risk mitigation and response.

It pointed out that "the unprecedented levels of flooding have triggered a multi-dimensional humanitarian crisis, leaving the affected population with increased health risks and food insecurity, insecure livelihoods, and heightened vulnerabilities to gender-based violence.

# **AAP's Big Win, Defeats BJP In Key Delhi Polls:**

New Delhi: In an election that turned out to be closer than expected, the AAP managed a prestige win; and the BJP did not lose as badly as was predicted. The Congress barely managed to hold on to some relevance. Arvind

Kejriwal-led AAP has won the pres-tige battle for the Municipal Corporation of Delhi (MCD), unseating an entrenched BJP. It has won 134 seats, eight above the majority in a House of 250. The BJP, which ran the campaign with PM Narendra Modi's face, has won 104 — a not-sobad performance after 15 years of continuous rule. The Congress was reduced to nine, which means its base in Delhi continues to erode. In the 2017 MCD polls - when the BJP won 181 of the total 272 wards, while AAP could mange only 48 — the Congress had man-

aged 30 seats. The AAP office saw celebrations massive with supporters dancing to dhol beats, and kids dressed as Delhi Chief Minister Arvind Kejriwal. The office had kept balloons and celebratory posters ready since morning. AAP leaders had gone into a huddle as the counting threw up a con-



test much tighter than the AAP sweep predicted by exit polls.

This AAP win is the first time it has unseated the BJP in any election. Its wins in Delhi have either been against the Congress or a vote of confidence while in power already. In Punjab early this year, it again won against the Congress. Party leader Sanjay Singh pointed to this:, "The BJP would always say AAP has only defeated Congress. Today, Arvind Kejriwal has given them an answer." Though the BJP has not formed the Delhi state government in the past 24 years, its control over MCD remained strong through Congress and AAP governments. Even when the AAP won a record 67 of 70 seats in the

2015 assembly polls, the BJP, two years later, re-tained the MCD. The AAP and BJP, both currently controlling parts of Delhi's adminis-

tration through state and central governments, saw this as a prestige battle. These were the first civic elections after the MCD

The BJP made promises of housing, and pressed on corruption charges on several AAP ministers. The Congress used these to take digs at the AAP. But Mr Kejriwal said his "shaandaar" (glorious) work as chief minister won't be defeated by "bo-gus charges" and "misuse of central agencies".

The Congress was hoping to get some pockets of influence at least, but has lost further ground. It's still rebuilding in Delhi after a decline began in 2014, and then came the death of Sheila Dikshit in 2019. The party's focus on macro-politics of ideology – evident in Rahul Gandhi's 'Bharat Jodo Yatra' that's in Rajasthan now meant the civic body elections weren't high on its priority list.

## HT NATIONAL /WORLD HEADLINES TODAY Unicef seeks \$10bn to help 110m children in 155 states

ISLAMABAD: The United Nations Children's Fund (Unicef) has launched a \$10.3 billion emergency funding appeal to reach more than 173 million people, including 110 million children, affected by Covid-19 pandemic worldwide and the growing threat of climate-impacted severe weather events.

Funds will support essential programmes for over 110 million children across 155 countries and territories through 2023, according to a Unicef press statement released on Tuesday.

Around the world, a resurgence of disease outbreaks, including cholera and measles, bring an additional danger to children in emergencies, said the statement. With humanitarian needs at an unprecedented high, Unicef is calling on partners to increase support to life-saving humanitarian response for children, maximising the flexibility of this funding, prioritise climate-adaptive anticipatory action and preparedness efforts, urgently adopt no-regrets approaches to preparedness and response, and ensure equitable and principled humanitarian assistance.

This year began with an estimated 274 million people in need of humanitarian assistance and protection. Throughout the year, these needs grew considerably, largely due to conflict, including the war in Ukraine; to rising food insecurity; to threats of famine brought about by climate-related and other factors; and to the devastating floods in Pakistan.

"Today, there are more children in need of humanitarian assistance than at any other time in recent history," said Unicef Executive Director Catherine Russell. "Across the globe, they are facing a deadly mix of crises, from conflict and displacement to disease outbreaks and soaring rates of malnutrition.

Meanwhile, climate change is making these crises worse and unleashing new ones. It is critical that we have the right support in place to reach children with decisive and timely humanitarian action.

## Turkish MP in intensive care after fight in parliament

ANKARA: A lawmaker from a Turkish nationalist opposition party was rushed to intensive care on Tuesday after getting punched in the head in parliament during a heated budget debate.

Images released by the DHA news agency showed Iyi (Good) Party lawmaker Huseyin Ors, 58, being struck by ruling AKP parliamentarian Zafer Isik. Several other lawmakers fell to the ground during the brawl. Fellow Iyi Party lawmaker Aylin Cesur, a doctor by training who administered first aid on the chamber's floor, said Ors's condition remained critical. "He is still being treated in intensive care," DHA quoted Cesur as saying.

"I am very sad," she said. "His general condition was not good after the blow to the head.

Turkiye's lively parliament has witnessed numerous fights during particularly sensitive debates. In 2020, a fistfight erupted during tense discussions over Turkiye's military involvement in Syria.

This year's budget debates come with lawmakers of all stripes trying to defend their interests six months before the next scheduled parliamentary and presidential polls.

### Google launches anti-misinformation campaign in India

STOCKHOLM: Google's Jigsaw subsidiary is launching a new anti-misinformation project in India, aimed at preventing misleading information that has been blamed for inciting violence, a top executive said.

The initiative will use "prebunking" videos designed to counter false claims before they become widespread circulated on the company's YouTube platform and other social media sites.

Google's efforts to challenge the spread of misinformation mark a contrast with rival Twitter which is cutting its trust and safety teams, despite new owner Elon Musk saying it will not become a "free-for-all hellscape".Google recently conducted an experiment in Europe where it sought to counter anti-refugee narratives online in the wake of the Russian invasion of Ukraine. The experiment in India will be bigger in scope as it will deal with multiple local languages -Bengali, Hindi and Marathi - and cover diverse sections of a country populated by over a billion people. "This presented an opportunity to research prebunking in a non-western, global south market," said Beth Goldberg, Jigsaw's head of research and development. Like other countries, misinformation spreads rapidly across India, mostly through social media, creating political and religious tensions.

China announced on Wednesday a nationwide loosening of Covid-19 restrictions following protests against the hardline strategy that grew into calls for greater political freedoms.

Under the new guidelines, some asymptomatic and mild cases of Covid-19 can now quarantine at home, ending a requirement that all positive cases be isolated in centralised government facilities.

Under the new guidelines announced by the National Health Commission, the frequency and scope of PCR testing - long a tedious mainstay of life in zero-Covid China — will be reduced.

Lockdowns will also be scaled down and people with non-severe Covid cases can isolate at home instead of centralised government facilities.

And people will no longer be required to show a green health code on their phone to enter public buildings and spaces, except for "nursing homes, medical institutions, kindergartens, middle and high schools"

The new rules scrap the forced quarantines for people with no symptoms or with mild cases.

"Asymptomatic infected persons and mild cases who are eligible for home isolation are generally isolated at home, or they can voluntarily choose centralised isolation for treatment," the new rules read.

"Mass PCR testing only carried out in schools, hospitals, nursing homes and high-risk work units; scope and frequency of PCR testing to be further reduced," they added. "People travelling across provinces do not need to provide a 48-hour test result and do not need to test upon arrival.

China will also accelerate the vaccination of the elderly, the NHC said, long seen as a major obstacle to the relaxation of Beijing's no-tolerance approach to Covid.

Rare demonstrations against the ruling Communist Party's zero-Covid strategy broke out across China late last month. They expanded into calls for more political freedoms, with some even calling for President Xi Jinping to resign.

Authorities cracked down on subsequent efforts to protest while easing a number of restrictions, with some Chinese cities tentatively rolling back mass testing and curbs on movement.

The capital Beijing, where many businesses have fully reopened, said this week that commuters were no longer required to show a negative virus test taken within 48 hours to use public transport.

New Delhi: The Multi-State Co-operative Societies (Amendment) Bill, 2022, which seeks to bring transparency and accountability in the sector, was introduced in the Lok Sabha on Wednesday amidst demands from Opposition MPs that it be referred to a standing committee for review. The Bill, introduced by Minister of State (MoS) for

Cooperation BL Verma, also seeks to strengthen governance, reform the electoral process, improve the monitoring mechanism, and ensure ease of doing business in multi-state co-operative societies Opposition MPs alleged the Bill's pro-

visions encroach on the rights of state governments. 'Cooperative society is a state sub-

ject. There is a clear indication that the central government has been encroaching upon the territory of state governments (and) that is why protests are cropping up across the nation," said Leader of Congress in the Lok Sabha Adhir Ranjan Chowdhury.

This government has always called for cooperative federalism and it should have been followed before the preparation of this Bill, he said.

"This (Bill) may lead to the concentration of power of the central government, which may impact the autonomy and functioning of the multi-state cooperative society and create potential for misuse.

"Given the intricacies, given the ramifications and encroachment of the state territory, this Bill should be referred to a standing committee," he said.Revolutionary Socialist Par-ty (RSP) leader NK Premachandran said there are technical issues in the Bill and it is against the spirit of the definition of cooperative societies as enshrined in the Constitution.

The Bill seeks to "take away" the rights of state governments and is against the federal structure of the country, he charged.

Congress leader Manish Tewari called for the withdrawal of the Bill and said

certain provisions of the proposed legislation "strike at the heart of the autonomy of cooperative societies"

He also pointed out five clauses of the Bill which he claimed are beyond the legislative competence of the House clause 6 in sub-section 10 into sub-section 17, clause 13, clause 17, clause 24 and clause 45.

Certain provisions in the Bill put an "additional burden on the cooperatives and infringe on the cardinal principle of autonomous functioning as provided in Article 43B of the Constitution", he added.

Article 43B says the State shall endeavour to promote voluntary formation, autonomous functioning, democratic control and professional management of cooperative societies.

"This Bill should be withdrawn. It should be reconsidered (as) it violates and attacks the federal spirit of the Constitution with a sledgehammer," Mr Tewari said.

Indian government officials have called on tech companies such as Google, Meta, and Twitter to take stronger action against the spread of fake news.

# **Rohit Sharma's Effort In Vain As Bangladesh Clinch 2nd Successive ODI Series vs India At Home**

Dhaka, India's shoddy batting dis-play and the inability to land the killer blow contributed to their second successive series loss in Bangladesh after the diminutive Mehidy Hasan Miraz led the hosts to a five-run win in the second ODI with a memorable hundred here on Wednesday. Miraz tormented the Indian bowlers on way to his maiden century as Bangladesh staged a remarkable recovery to reach 271 for seven. India's challenge looked all over at 207 for seven but skipper Rohit Sharma's (51 not out off 28 balls) valiant effort went in-vain as he nearly took his team home while batting with a split left webbing.

India needed a six off the final ball of the game but Mustafizur did well to perfect the yorker under pressure after bowling a slew of slow legbreaks in the 48th over forcing Mohammed Siraj to play out a maiden. Bangladesh had also won their last ODI series against at home back in 2015 when Mashrafe Mortaza's men got the better of M S Dhoni and Co. The series loss also forces India to go back to the drawing board with the World Cup less than 12 months away.At 65 for four, India were in dire straits in the run chase before



a spirted 101-ball 107-run between Shreyas Iyer (82 off 102) and Axar Patel (56 off 56) brought them back into the contest.

Captain Rohit did not come out to open after hurting his elbow while fielding in Bangladesh's innings. It was only after the fall of seventh wicket, he decided to walk into the middle but clearly looked in dis-

comfort.It was a courageous call to come out with a heavily taped left thumb and Rohit did provide a ray of hope by collecting couple of sixes and four from Ebadot Hussain in the 46th over. Then two sixes off Mahmudullah in the 49th over brought the equation down to 20 from the final six balls. The wily Mustafizur was able to defend that after con-

ceding two fours and a six. India's top-order struggled again with Shikhar Dhawan and Virat Kohli, who came out to open in Rohit's absence. falling cheaply. While Kohli played an attempted pull on to his stumps with the ball not bouncing as per his expectations, Dhawan fell to a snorter from Mustafzur Rahman. Both Washington Sundar (11 off 19) and K L Rahul (14 of 28) fell to poor shot selection.

Earlier, India had Bangladesh on the mat at 69 for six before last match's hero Miraz (100 off 83 balls) stitched an epic 148-run partnership off 165 balls with Mahmudullah (77 off 96) to help the home team put up a fighting total.

It was the highest ever seventh-wicket stand against India.

Miraz saved his best for the 50th over when he smashed Shardul Thakur for couple of sixes, including a sweetly timed pick up shot, before reaching three figure-mark in the final ball of the innings.

The visitors had struggled to take the decisive last wicket in the series-opener and ran out of ideas on Wednesday as well after more than half of the Bangladesh line-up was sent back to the dressing room.

## Cummins to miss second Test as Australia name replacement

Adelaide, Dec 7 (UNI) Australia have decided to not risk Pat Cummins during this week's secondTest against the West Indies and have left their captain out of their final XI for the Adelaide day-night contest. Cummins failed to bowl during the final two days of Australia's emphatic 164-run triumph over the West Indies in the first Test in Perth due to a quad injury and his spot in the XI for Adelaide will instead be taken by fellow quick Scott Boland, an ICC report said. Boland hasn't played a Test since he collected 18 wickets from three Ashes Tests against England last summer, but earns a recall after missing out on selection in Perth. The absence of Cummins also means veteran batter Steve Smith will captain Australia once again, after he stood in for the Australia skipper in the Adelaide Test against England last year when Cummins was deemed a close COVID-19 contact.It is expected that Cummins will be fit in time to lead Australia in the first Test against South Africa in Brisbane next week."Team medical staff commenced Cummins' recovery in Adelaide but selectors deemed there was not sufficient time for the fast bowler to be fully fit for the match, which starts tomorrow," a statement from Cricket Australia read."Cummins is expected to return for the opening Test match against South Africa in Brisbane."Smith said he was looking forward to filling in for Cummins and promised he would bring his own attributes to the role."I have to do it my own way, I can't be someone else," Smith said on Wednesday. "I am pretty chilled – I took over for the game here last year and thought it went pretty smoothly. So same again."

# Croatia gear up for 'scary' Brazil test



The morning after his side ended Japan's dream of reaching the quarter-finals, Croatia head coach Zlatko Dalic held a news conference at the Al Ersal Complex training ground in the heart of Doha. His players had a day off after their excruciating penalty shootout win over a spirited Japanese side less than 12 hours ago.In Qatar, Dalic is looking to go one better than in Russia four years ago when the Croats reached the final. But just to get into the semi-finals here, Dalic will be going up against a side which in his own words he would've liked to meet in the title clash."It doesn't get better than playing Brazil but it would've been good if we were playing the final instead of the quarter-final, Dalic told reporters on Tuesday.When Croatia overcame Japan thanks to the goalkeeping, penalty-stopping brilliance of Dominik Livakovic, they hadn't known who their lasteight opponents would be. It was back at their hotel on the West Bay, on the edge of the Arabian Gulf did they discover it will be Brazil, who made a statement of

their intent later on Monday night when they thrashed South Korea 4-1 with all their goals coming in the first half.

"They have so many great players," said Dalic. "It's scary so it will be a big test for us. But we will not surrender before the game. We want to counter Brazil's quality with our own."

A lot of members of the Croatian squad from four years ago have now long gone. But the talismanic Luka Modric still remains the beating heart of this side at the ripe age of 37. Modric was unable to last the full duration of the game against Japan. Croatia did however continue their remarkable run of winning all their knockout matches since the World up in Russia when they went beyond 90 minutes."It seems that we can't do it without the drama," said Modric, for whom every next game is a bonus. ## **Angry David Warner abandons bid** to overturn Australia leadership ban

But he has seemingly now shut the door with a scathing, and lengthy, statement on social media claiming the panel had made "offensive and comments unhelpful"
