# J&K Govt announces Rs 129.05 cr initiative to reduce fodder deficit, boost livestock sector under HADP

Union Territory of Jammu and Kashmir, recognizing the potential of livestock husbandry to improve the socio-economic conditions of farming communities and boost the overall economic growth of the region, has launched several measures under the Holistic Agriculture Development Program (HADP). Jammu and Kashmir, acknowledged for its tremendous agricultural potential and production, comprises of mostly small and fragmented landholdings owned by the farmers. Over 70 per cent of the population in the region depends on agriculture and related vocations for their livelihood, either directly or indirectly.

Over the years, livestock husbandry has emerged as a crucial growth engine for sustainable and equitable development, which is vital for uplifting the socio-economic status of farming communities in J&K.

Furthermore. various technological options such as cultivable fodder. chaffing of fodder/straws, urea treatment, roughage block, and silage making can be promoted to enhance fodder production.

#### Court quashes dismissal of BSF constable posted in J&K

Jammu, Mar 17, KNT: A Division Bench of High Court of Jammu & Kashmir and Ladakh at Jammu comprising Justice Sanjeev Kumar and Justice Puneet Gupta, has allowed an appeal filed by Sunil Kumar-a BSF Constable, who had been dismissed from service in 2001 for remaining absent and whose writ petition was also dismissed by a Single Judge of the High Court of J&K in 2019.

While allowing the appeal, the Division Bench quashed the order of dismissal and held that the appellant shall be deemed to have been reinstated in service with effect from the date he was dismissed from service with all consequential benefits.

Åfter hearing Advocate Muzzaffar Ali Shah appearing for BSF Constable, whereas Central Government Standing Counsel Sandeep Gupta appearing for BSF, the Division Bench headed by Justice Sanjeev Kumar further held, 'it shall, however, remain open to the BSF Authorities to proceed with and conclude the trial by the Summary Security Force Court de novo within two months. The disbursement of consequential benefits shall be dependent upon the outcome of de novo trial by SSFC.'

During the course of arguments, Advocate Muzzaffar Ali Shah submitted that plea of "guilty" has been recorded on a cyclostyle/type sheet with blanks which have been filled up later during recording of the plea. The questions asked to the writ petitioner-Constable are in English language without making it clear whether the questions were also translated in the manner the charge sheet is said to have been translated and read over to the writ petitioner. The Division Bench after perusal of the record of the proceedings further observed, "it is crystal clear that is a pre-typed page where the particulars of the writ petitioner have been filled in with questions as to whether you plead "guilty" or "not guilty" to the charges. Below the questions, there are answer using singular word "guilty" and in the last paragraph, compliance to Rule 142 of the Rules is indicated by borrowing the language used in Rule 142 itself. As already noted, the plea of "guilty" is neither signed by the writ petitioner nor by Dy. Commandant D.S.Samyal, who acted as a friend of the writ petitioner in the trial."

The Division Bench headed by Justice Sanjeev Kumar further observed, "In the instant case, the respondents have put the cart before the horse. The plea of "guilty" is recorded first and then the writ petitioner has been stated to have been informed about what is laid down in Rule 142 of the Rules. Even in the absence of their being specific provision in Rule 142 in the year 2001, it was prudent for the SSFC to obtain signatures of the writ petitioners or his friend appointed to defend him in acknowledgment of such plea of "guilty" made by the writ petitioner to the charges for which he was put on trial by the SSFC." After considering the rival contentions and going through the record of proceedings, the Division Bench came to a conclusion that the appellant had either not pleaded guilty to any of the Charge as is recorded by the Court or same was not voluntarily in nature. The Division Bench of the High Court further observed that the right of the appellant to have a fair trial before the SSFC

has been violated and he has been condemned unheard. With these observations, the Division Bench while setting aside the Judgment of the Single Judge allowed the appeal and quashed the dismissal of the appellant and held him entitled to reinstatement with effect from the date of dismissal. [KNT]

### 3 Days workshop on 'Household Income Expenditure survey' & 'Employment/ Labour Force Survey' held

SRINAGAR, MARCH 17: The Directorate of Economics & Statistics, J&K organised a three days workshop on surveys, viz. 'Household Income Expenditure Survey' and 'Employment Labour Force Survey' under 'Support for Statistical Strengthening' from 16th to 18th of March, 2023 at Directorate of Economics Statistics, Bemina Srinagar.

The workshop was inaugurated by Director General, Regional Director (E&S) Kashmir, Athar Hussain Qadri.

Regional Director, E&S Kashmir in his address highlighted the importance of the surveys vis-à-vis the role of Directorate for collecting the data on the designed surveys. He im-



pressed upon all the field functionaries for collecting reliable and coherent data that will pave the way for making Government poli-

He also briefed them about the survey and encouraged them to take full benefit of training so that quality data could be obtained.

The instant surveys will focus on obtaining the data on unemployment, income expenditure scenarios as the basis for effective socio-economic policy formulation so as to position the developmental efforts in more pragmatic and people oriented directions.

#### No vaccine available for rate bite victims in Srinagar hospitals

The victim identified as Muhammad Magbool Ganai, a resident of Noorbagh Guzarbal was taken to SKIMS Soura by his family for treatment shortly after his right finger was bitten by a rodent at his home.

Jan Muhammad, the son of the victim told the news agency Kashmir News Trust that doctors at SKIMS asked him to take his father to SMHS Hospital as no vaccine for a rat bite is available in the hospital.

"Though rats don't cause rabies, and my father didn't need it but to my surprise, even anti-rabies vaccines are not available at SKIMS," he said adding that the same scenario prevails at SMHS hospital where no vaccine is available for rate bite victims. He said his father was given anti-biotic tablets and was asked to get a vaccine each day from the open market for a whole month. "Both the hospitals wasted our time and we were forced to look for private treatment," he said. When contacted a medico said that a rat bite victim needs a 'tetanus toxoid' vaccine on an urgent basis but unfortunately that is not available in the

## **Domestic Violence** in Kashmir

## DRUG ADDICTION IN KASHMIR: FACTORS AND SOLUTIONS

nited Nations Drug Control Program has presented that nearly 70000 people in Kashmir are addicted to drugs of which 4000 are females. In the last three years, there has been an upsurge of 1500% in the usage of drugs. Drug addiction is a significant problem in many parts of the world, and the Indian state of Jammu and Kashmir is no exception. It has emerged as a major problem in Kashmir, with thousands of people falling victim to this scourge. Kashmir, which has seen years of political unrest and conflict, has a high prevalence of substance abuse. While the reasons for the rise in drug abuse in the region are complex and multifaceted, the consequences of this trend are devastating, and urgent action is needed to address the problem. ## Infantino re-elected, Women's World Cup prize money increased

KIGALI: Gianni Infantino has been re-elected as president of FIFA until 2027 after standing unopposed at the congress of world football's governing body on Thursday. The 52-year-old Swiss lawyer, who succeeded the disgraced Sepp Blatter in 2016, was waved in for a third term by acclamation, just as he was four years ago, by delegates from the 211 member federations.

"To all those who love me, and I know there are so many, and also those who hate me, I know there are a few: I love you all," Infantino told delegates in the Rwandan capital, where the voting system did not register the number of dissident voices. While FIFA statutes currently limit a president to a maximum three four-year terms, Infantino has already prepared the ground to stay until 2031, de-



claring in December that his first three years at the helm did not count as a full term.Infantino, who staunchly defended Qatar's hosting of last year's World Cup

as the Gulf state's treatment of migrant workers, women and the LGBTQ community came under the spotlight, has overseen the expansion of the men's and

women's World Cups and huge increases in FIFA revenues.Norwegian Football Federation president Lise Klaveness had said she would not support Infantino and tabled a proposal to discuss at the congress "FIFA's responsibilities to remedy human rights abuses' in relation to the Qatar World Cup and future tournaments.

The Norwegian and Swedish rep-

resentatives in Kigali displayed

their opposition by not joining the delegates who rose to applaud. On Wednesday, German FA president Bernd Neuendorf said he would not back Infantino, citing a lack of transparency from FIFA and insufficient explanations of "why certain decisions are made and who was involved in them". ## Record-holding Aleem Dar steps down

LAHORE: Pakistan's veteran Aleem Dar stepped down on Thursday from the ICC Elite Panel of Umpires after officiating in a record number of international cricket matches during his distinguished career. The 58-year-old stood in 144 Tests and 222 ODIs — both world records — in addition to 69 T20 Internationals.

"The veteran umpire [Aleem] Dar has stepped down after 19 years on the Elite Panel, standing in a record 435 men's international matches," the International Cricket Council (ICC) said in a press release. Aleem's first international match as an Elite Panel umpire was in 2002 and a year later he stood in the 2003 World Cup in South Africa. Aleem, who took up umpiring after playing first-class cricket in Pakistan, said he was honoured to have officiated international matches.

"It has been a long journey, but I have enjoyed every bit of it," Aleem was quoted in the ICC release."I have had the pleasure and honour of umpiring the world over and what I have achieved is something I did not even dream of when I started in the profession."ICC chief executive Geoff Allardice praised Aleem's contribution to the sport."Aleem's contribution to international cricket and to



the ICC has been truly remarkable. Consistently elite performances over such a long period saw him enjoy enormous respect across all involved in international cricket," said Allardice. The ICC said South Africa's Adrian Holdstock and Pakistan's Ahsan Raza have been added to the Elite Panel. Ahsan has replaced Aleem. Meanwhile, Pakistan Cricket Board (PCB) Management Committee Najam Sethi congratulated Ahsan on his promotion to the ICC Elite Panel of Umpires and has also thanked Aleem for his services. Ahsan, 48, has been a member of the ICC International Panel of Umpires since 2010 and is the first to reach the 50 T20 Internationals mark as an umpire.

#### Real full of confidence in Champions League after reaching quarters

MADRID: Real Madrid coach Carlo Ancelotti said his team were full of confidence after reaching the Champions League quarter-finals on Wednesday.

The record 14-time champions of Europe beat Liverpool 1-0 at the Santiago Bernabeu, 6-2 on aggregate, to progress to the last eight.Real are aiming to win the Champions League for the sixth time in 10 seasons and Ancelotti believes his team's remarkable run to glory last season has given them a lot of confidence. Los Blancos pulled off stunning comebacks against Paris St-Germain, Chelsea and Manchester City, before beating Liverpool in the final.

Even in the last 16 first-leg clash with Jurgen Klopp's Reds, Real fell two goals behind before roaring to a 5-2 win.

"We have a lot more confidence, because of what happened last year, it gave us a lot of confidence," Ancelotti told reporters."We saw that in this tie, against a strong team, we did well in the two games."But later, with confidence alone, we don't reach the semi-finals. We have to play surprising football ... as always, the Champions League is very complicated and we have to compete until the end."
