



J&K Reports 50 Fresh Covid-19 **Cases, No Death**

SRINAGAR, APR 10: Jammu and Kashmir reported 50 fresh covid-19 cases while there was no death due to the virus during the last 24 hours, officials said on Monday.

They said that 32 cases were reported from Jammu division and 18 from Kashmir Valley,



taking the overall tally to 480223. Among the cases, 174303 are from Jammu division and 305919 from Kashmir Valley.

Providing district wise details of the cases, they told GNS, 20 cases were reported Jammu, nine from Pulwama, seven each from Samba, six from Srinagar, two each from Doda, Reasi, Kupwara and one each from Poonch and Baramulla.

Sharp decline in RTI applications in J&K

Findings of CHRI reveal 31 % RTI receipts less in 2021-22

SRINAGAR, APR 10: Jammu & Kashmir Union Territory recorded a sharp decline in the number of applications filed with different departments under the Right to Information Act-2005 in 2021-22, a report by a transparency panel said on Tuesday.

According to an analysis of the Central Information Commission (CIC) annual report for 2021-22 by the Commonwealth Human Rights Initiative (CHRI), Jammu and Kashmir administration reported a 31.44% decline in RTI applications received in 2021-22 as compared to 2020-21. "Among the

that the Z-Morh tunnel, which connects Gagangir with Sonamarg and provides all-weather connectivity to the resort in the Ganderbal district of central Kashmir, will be inaugurated in October this year.

"This is a historic and important tunnel in the history of India. The tunnel length is supposed to be the highest in Asia," Gadkari told reporters after inspecting the work on the site at an altitude of over 11,500 feet.

The Union minister led a 13-member delegation of the Parliamentary consultative committee on the ministry.

The tunnel project – through the mighty Zojila Pass at an altitude of 11,578 feet on the Srinagar-Kargil-Leh National highway – is of strategic importance as the highway remains closed during winters due to heavy snowfall, cutting off the Ladakh region from Kashmir.

The single-tube Zojila tunnel – from Baltal, in the Ganderbal district of central Kashmir, to Minimarg, in Drass town of Kargil district of Ladakh, is 13 km long with an approach road of 18 km.

Gadkari said the estimated cost of the project was Rs 12,000 crore, but, after discussions with experts and international consultants for a year, its cost was brought down by Rs 5,000 crore.

"This is the first time in the history of our country that we have a saving of Rs 5,000 crore as far as the estimated cost is concerned. This is a very difficult task, the people are working here in minus 26 degrees," he said.

This is to be a state-of-art-project and with the cooperation of J-KLG Manoj Sinha and his administration, it will be very helpful for us, he said.

Laying out a roadmap for connecting several cities across the country, Gadkari said the Zojila tunnel is one of the important things of "our dream to connect Kashmir to Kanyakumari". This will be connectivity between north to south, he added.

He also applauded engineers and contractors, saying it is very difficult to work here.

The union minister said about 38 per cent of the work has been completed, and a part of the project will be inaugurated this year for providing relief to the people.

"With the permission of the prime minister, the LG, we want to try to inaugurate a part of the project because that will give relief to the people," he said.

According to Harpal Singh, Project Head of Megha Engineering and Infrastructure Ltd, which is constructing the project, the total length of the project from Sonamarg to Minimarg is 31 km. From Sonamarg to Baltal, it is 18 km, and then the main tunnel from Baltal to Minimarg is 13 km long. The work is going on at a rapid pace on both projects.

Gadkari said the project once completed would develop tourism in the area.

"The tourism in Kashmir will be increased 3-4 times and tourism is a sector which creates maximum employment avenues," he said.

"I have requested LG and JK government to plan resorts, and adventure sports, and just like Switzerland, we can develop a lot of things here, he said. the union minister that local youth be given more employment opportunities in the project. The minister assured Sinha that the contractor has been directed to provide maximum employment opportunities to the local youth.

Meanwhile, Following the inspection of the ongoing work on the Zojila Tunnel, Union Minister Nitin Gadkari on Monday said that tourism will increase by 2-3 times with the construction of the tunnel.

"With the construction of this tunnel, tourism will increase by 2-3 times and employment opportunities will also grow in Jammu and Kashmir," said Gadkari.

"We will achieve connectivity between Kashmir to Kanniyakumari in the true sense," he added.

Gadkari in a tweet said that as many as 19 tunnels are being constructed in Jammu and Kashmir at a cost of Rs 25 thousand crore.

"19 tunnels are being constructed in Jammu and Kashmir at a cost of Rs 25 thousand crore. Under this, construction work of 13.14 km long tunnel and approach road is in progress at Zojila at a cost of Rs 6800 crore. It is a 7.57 meter high horseshoe-shaped single tube, 2-lane tunnel, which will pass under the Zojila Pass in the Himalayas between Ganderbal in Kashmir and Drass town in Kargil district of Ladakh. The project includes a Smart Tunnel (SCADA) system, constructed using the New Austrian Tunneling Method. It is equipped with facilities like CCTV, radio control, uninterrupted power supply, ventilation. The Government of India has also saved Rs 5000 crore by the use of modern technology in this project," tweeted Gadkari in Hindi.

The transport minister further said that with the construction of this tunnel, there will be allweather connectivity for Ladakh.

"With the construction of this tunnel, there will be all-weather connectivity for Ladakh. Now the average travel time to cross the Zojila Pass sometimes takes three hours, after the completion of this tunnel the travel time will come down to 20.0 minutes. The reduction in travel time will ultimately result in fuel savings, he tweeted.

He said that under the leadership of Prime Minister Narendra Modi, the aim is for the allround development of J-K through better road connectivity.

"The terrain near Zojila Passis extremely inhospitable, with many fatal accidents taking place here every year. After the completion of the Zojila Tunnel, the chances of accidents will be zero. This tunnel will provide year-round connectivity between the Kashmir Valley and Ladakh, which will be extremely important for the development of Ladakh, the promotion of tourism, free movement of local goods and the movement of Indian armed forces in case of emergency. We are committed to the all-round development of Jammu and Kashmir through better road connectivity under the leadership of respected Prime Minister Narendra Modi," he tweeted.

Earlier on April 9, Hyderabad-based Megha Engineering and Infrastructure Limited (MEIL), which is executing Zoji La Tunnel, is going on at a rapid pace and is likely to be completed by December 2026. He said that a four-lane Greenfield Expressway, connecting Delhi-Katra, will also be made, which will reduce the distance between the two cities by 58 Km.

"Atotal of 32 Green Express Highways are being built, the most important of which is Delhi-Amritsar-Katra Greenfield. This 670 km four-lane Green Field Expressway from Delhi to Vaishno Devi Dham, Katra will be completed by December 2023 at a cost of 37,524 crores," Nitin Gadkari said.

"Presently the distance from Delhi to Katra is 727 km, this expressway will reduce the distance by 58 km. With this, there is a possibility that the distance between Delhi-Amritsar, Delhi-Katra, and Delhi-Srinagar will be covered in 4 hours, 6 hours, and 8 hours respectively," he added.

Gadkari said that we have also taken up a work of a 78 Km four-lane Srinagar ring road, a Rs 4,660 crore worth project, which will be completed in 2023-24.

"With the construction of this ring road, the people, coming to Baramulla, Kupwara, Bandipora, Gurez, Kargil, and Leh, will not have to come inside Srinagar city. This will reduce the traffic congestion and pollution in the city," Gadkari said further.

Earlier in the day, the Union Minister accompanied by Jammu and Kashmir LG Manoj Sinha visited 'Asia's largest tunnel', Zojila Tunnel, to inspect the ongoing work.

"With the construction of this tunnel, tourism will increase by 2-3 times and employment opportunities will also grow in Jammu and Kashmir," said Gadkari.

compared with the 2020-21 figure (1,603)," the CHRI said in its findings.

The CHRI findings accessed by news agency—Kashmir News Observer (KNO) further reveal that although Jammu & Kashmir reported only 94 RTI applications carried over from 2020-21, it was nevertheless a 683.33% increase over the 2019-20 figure (12 RTI applications).

The CHRI further said that J&K reported a sharp decline in the proportion of RTIs transferred by PIOs in 2021-22 as compared to 2020-21.

In 2021-22, 4.73% RTI applications were transferred in J&K while it was 38.74% in 2020-21, the CHRI said.

It is pertinent to mention that Central Right to Information Act-2005 became applicable in Jammu & Kashmir UT after the Centre effected constitutional changes in 2019.

Before these changes, Jammu & Kashmir had its own RTI law.

"Somewhere, we need permission from the airforce, it is in the process. At the time of emergency, we can use those," he said.

Asked once the breakthrough of the tunnel is achieved, would the army be allowed to travel on the rough tunnel if need be, Gadkari said whatever has to be done at the time of emergency, it will be done at that time.

"In times of emergency and in the interest of the country, a result is achieved with positivity. There has not been a such need, and there is no possibility of such need, but, if there arises a need, then we will surely do what our defence forces say," the union minister said.

Later, the minister inspected the work progress on the Z-Morh tunnel, and announced it will be inaugurated in October this year. "We will inaugurate Z-Morh tunnel in October. This will help the people a great deal and also help increase tourism, and employment opportunities," Gadkari said.

Chief Secretary also disclosed that ranking of panchayats will be done based on set parameters and panchayats should move ahead while the government will act as a facilitator. He also enquired about the usage of digital services in villages and whether people are being benefited. The villagers expressed satisfaction over the use of online services and said that the online mode has saved them a lot of time and money.

He told them to ensure convergence of sectoral plans in the District and UT plans as per the nature and scope of the work and impressed upon completion of all works before December end.

Dr Mehta asked from the representatives and village level workers about the functioning of Schools, Health Centres, AnganwadiCentres and

referred to the status report filed by the Ministry of Minority Affairs which said that 24 states and six UTs have so far furnished their comments on the issue.

The status report, filed in the apex court in January, had said that comments from six states and UTs — Arunachal Pradesh, Jammu and Kashmir, Jharkhand, Lakshadweep, Rajasthan and Telangana — were still awaited.

On November 22 last year, the Centre had told the top court that it has held consultative meetings with all state governments, UTs and other stake holders on the issue of identification of minorities at the state level and 14 states had furnished their views so far. During the earlier hearing, Upadhyay had

told the bench that he has challenged the validity of section 2(f) of the National Commission for Minority Education Institution Act, 2004.

Terming section 2(f) of the Act, which empowers the Centre to identify and notify minority communities in India, as "manifestly arbitrary, irrational, and offending", his plea has alleged that it gives unbridled power to the Centre.

"Can minority status be decided districtwise? How can that be done," the bench had earlier observed during the hearing.

On May 10 last year, the apex court had expressed displeasure over the Centre's shifting stand on the issue of identification of minorities, including Hindus, at the state level and directed it to hold consultations with the states within three months.

In supersession of its earlier stand, the Centre had told the apex court that power to notify minorities is vested with the Union government and any decision with regard to the issue will be taken after discussion with states and other stake holders. (Agencies)

Prices of essentials skyrocket in Bandipora

Consumers seek authorities' attention

SRINAGAR, APR 10: Since the beginning of the holy month of Ramadan in Bandipora, the prices of all essential commodities, including fruits and vegetables, have skyrocketed. Consumers are expressing concern over the administration's failure to check prices.

As per the news agency-Kashmir News Observer (KNO), the agitated consumers have accused the authorities of leaving them at the mercy of profiteers and hoarders. They have pointed out that shopkeepers and street vendors are busy fleecing poor customers, as there is no mechanism in place to curb overpricing.

Meat sellers have closed their shops for the past month and are selling meat at exorbitant rates of up to Rs 700 per kg, with impunity, as the administration has failed to act against these erring traders.

One consumer, Showket Ahmad Wani, has pointed out that no shopkeeper or street vendor is bothering to comply with the rate list issued by the Food, Civil Supplies and Consumer Affairs (FCS&CA) department. "Bananas are being sold at Rs 130-180 a dozen, and Saag at Rs 80," he said. He added that the wholesalers are equally responsible for the sky-high rates.

The other consumers said that local bread makers and retailers have increased prices at their own whims and fancies, with market checking squads not visible in the markets. They have further alleged that no essential commodity is being sold at the rates fixed by the government.

"The prices of essential commodities, including fruits and vegetables, have witnessed a hike, and common people are being pushed to the wall," said Jahangeer Ahmad.

According to the FCS&CA rate list, the price of potatoes has been fixed at Rs 18 (white potato) and Rs 22 per kilogram (red potato), onions at Rs 22 per kg, and tomatoes at Rs 26 per kg.

The price of Saag has been fixed at Rs 50 per kg. The price of bananas, depending on their quality, has been fixed at Rs 80 and Rs 120 per dozen. However, consumers argue that these prices are rarely adhered to. In different markets in Bandipora, tomatoes are being sold at Rs 60 a kg, beans at Rs 80, potatoes at Rs 50, and chicken at 150-160 per kg.

Mohammad Arif, another consumer, said that he had bought a tray of eggs containing two and a half dozen eggs for Rs 150, while yesterday the same tray cost him Rs 190. Vegetable sellers have no rate lists, and they have hiked the prices of locally grown vegetables such as nadru, turnip, and radish. Meanwhile, the administration is passing the buck.

Local residents have said that the government has failed to put market checking squads in place, resulting in a hike in the prices of essential commodifies.

J&K demotes officer after inquiry establishes violations during his stint with LCMA

SRINAGAR, APR 10: The Jammu & Kashmirgovernment has demoted a retired officer from the date he was placed as in-charge deputy superintendent of police (DySP) after an inquiry established that there were building plan and master plan violations during his stint with the Lakes & Waterways Development Authority which has been renamed as the Lake Conservation and Management Authority (LCMA).

In an order, a copy of which is in possession of news agency-Kashmir News Observer (KNO), J&K's Home department has imposed a penalty of "reduction to a lower post" on Shah Sikander, in-charge DySP(now retired).

The Home department's order states that Shah Sikander, in-charge DySP, is demoted to the post of inspector with effect from 20.07.2012, the date he was placed as in-charge DySP.

Sikander, the then enforcement officer of Lake and Waterways Development Authority (LAWDA),



was arrested by then State Vigilance Organisation on March 14, 2017 in a case registered against him in 2015 for violations in peripheral areas of Dal Lake.

According to the order, Sikander was served charge-sheet on June 21, 2017 for submitting a written statement of defence within period of 21 days.

He submitted his statement on September 25, 2017 and refuted all the charges. As per the order, the response submitted by the officer was found unsatisfactory and accordingly, it was decided that the charges were required to be inquired thoroughly.

On January 01, 2018, the government appointed an inquiry officer to probe the charges against him. In the report, the inquiry officer established that there was violation of building permission norms and instances of illegal construction around the Dal lake during his posting with LAWDA (now LCMA).

"The competent authority decided to impose the penalty of "reduction in rank" for violating J&K Government Employees (Conduct) Rules, 1971," reads the order.

A third generation shikara maker, Ghulam Nabi of Baba Mohalla Dal Lake told news agency-Kashmir News Observer (KNO), that since last 35 years, he has been making Shikara but demand has

picked up since last year. "As last year there was a good tourism season, the demand for Shikara has increased as more and more unemployed youth are starting Shikara so as to at least earn some money for themselves,' he said as per news agency-Kashmir News Observer (KNO).

According to him, they too have to face many challenges as timber is not easily available and rates are high.

"It usually takes a person around 15-20 days to make one

Shikara and mostly deodar strongest timber is used in making it," he said.

A Shikara costs around 2.5-3 lakhs and around 35 ft of timber is required to make a boat.

His Shikaras are in use in Mansar and Tawi in Jammu, Hyderabad, Bengal, Rajasthan and other places as well.

But he complained that the government has never supported them while requesting the authorities to give them timber for continuing their craft.

Waste Management in Srinagar City: A **Tough Challenge**

Srinagar is currently grappling with a major issue of solid waste management. The city has been facing a garbage crisis for years, and the situation has only worsened with time. The city's landfill sites are overflowing, and the municipality dumps are not only an eyesore but also a health hazard for the residents.

Understand the Needs of Your Special Child



Which parent might not wish their child for standing out in the extracurricular and academics activities? However, in a few cases, even children having average intelligence levels face troubles in picking the fundamental skills like reading, speaking, and writing. It should be considered that those children might be suffering from learning disorder so might find all the conventional learning methods difficult. Children having diverse physical abilities or physically disabled children also toil hard in school. However, it is significant to recognize that you just cannot disregard the future of your child only because he or she is suffering from a learning disability. Parents may do many things for the special children through sheer determination, positive attitude, and proper approach.

Building a Support System

It is about creating the conducive environment. Here are some measures that you may take to handle your special child's requirements:

Love and Care: Special requirements are managed with true love and care. Love, care, and family help must outline the foundation of the method you take for dealing with the special child requirements. **Collect Information:** Collect information about your child's position. Supervise your child's condition. Collect information about a particular condition which he or she suffers and adopt a holistic and tangible approach. Contact the families and parents who face similar situations. It will aid you in boosting your confidence. **Positive Determination:** Positive approach with great determination is needed. It is examined that learning about disorders like Autism (neurobiological disorder), Dysgraphia (impaired writing), Dyslexia (impaired language ability), and Dyscalculia (difficulty in understanding fundamental mathematical operations) may easily be overcome with a firm combination of special training, grit, and care. Physically challenged children can easily be admitted to normal schools with the help of bionic or artificial limbs, special desks, and wheelchairs. **Environment:** The atmosphere at home must be relaxed for the special child. You have to offer a comfortable and healthy environment for your children so that their everyday routine, studies, as well as other activities, continue unhindered. Make your house children-friendly so that your children's friends can meet them easily. Parents feel low if they realize that their child has a disability. Parents do not make out what to do. Rather than concentrating on the external factors, first they must shed their negative feelings. When they recover from mental obstruct, the road in front gets brighter and easier. Therefore, do not feel the burden that your child is not like others. Think that you have a special child with special interests and talents. Put in your best efforts in making your child feels comfortable and make sure he or she doesn't feel embarrassed.

Commend good behaviours and ignore bad ones if possible. Source and effects are among the earliest models any child learns. If he or she learns that you notice (even though it is to warn him or stop him physically) while he reacts improperly, he will carry on his poor behaviour by looking for your negative attention.

Special children might not recognize you as they have the problem with concentrating. They could not realize what you say or they (may) not remember what you have said. You could also need to repeat obvious instructions many times. Several children are very sensitive to cold or hot. They could get some textures very frightening, or they don't make out how to take part in the games. They could also be tired or hungry.

from them. Though these requests help the child as well as create a bond between the family and the staff. Being a teacher, ask the children's parents with special requirements for suggestions and ideas in the classroom. For instance, a child who is very sensitive against touching should bring a particular pillow and blanket from home. A child having taste problems wants to know a menu one week earlier and is permitted to bring a packed lunch on particular days. Besides, it may be really helpful to chat with the occupational therapist honestly about activities which can be incorporated into a standard curriculum which all the children will like. Make sure to get written consent from parents as well as share results of the conversation with parents.

Discipline Techniques for Special Child

Disciplining any special child is tougher than disciplining any normally developing child. This is not any kind of punishment. This is an instrument to be used for promoting positive behaviours as well as decreasing negative behaviours. This need to be used as a means of encouraging child's progress across all the development aspects. Every child is different show different behaviours when they grow. Some discipline techniques are there for the special child. Let's go through them:

Commend good behaviours and ignore bad ones if possible. Source and effects are among the earliest models any child learns. If he or she learns that you notice (even though it is to warn him or stop him physically) while he reacts improperly, he will

Special Child with Special Requirements

All the children want ample love and kindness without boundaries and limits to steer their behaviour. Think if the behaviour of your child is a part of natural development. Majority of children endure stages since they throw foodstuff. Some children could need more help with knowledge and might develop behaviour which is rather unusual. It doesn't show they want specialist involvement. It might show they have difficulty in understanding what is being requested to do.

Some Ideas to dead with a Special Child

Be constant. This is very important in case your child is having difficulty in understanding instructions.

Praise them when they do some good work.

Don't physically assault your child, although you're actually frustrated. They could copy your actions or become afraid of you.

If you become very angry, walk off and take a few deep breaths.

Just see their behaviour and try to analyze it. Are they frustrated, scared, tired, and sensitive to the situation or your touch?

You need to have a well-structured routine so that every day your child sleeps and eats at a particular time.

Life with the special child can be extremely demanding. Contact your friends, take help of the support groups as well as keep your relatives engaged. You need people who can talk to you and support you and the people with whom you can enjoy the life.

Special Requirements from Parent's Viewpoint

Parents need early childhood instructors to apply them as partners for supporting their family with the majority of all care and love for their children, despite the disabilities associated. A few parents may feel tentative to share the diagnosis of their child with his or her teacher. It may look odd, however, parents who struggle to understand how they may help their children and at times themselves can be scared of teacher's conclusion or the cure their child get when the special child is identified. Often parents are scared of being liable, and generally, have an unwholesome dose of guiltiness themselves; after being encouraged that disability is not a fault. A few parents can feel relieved to finally recognize what's happening with the child. At times these emotions may look wrong to the stranger observer, however, no parents with a special need for their child. The reprieve comes to know what is mistaken for the child and has a suitable plan of action.

Teacher's Role

At times, busy teachers can feel extinguish at special accommodations which a parent needs carry on his poor behaviour by looking for your negative attention. So, the better option is to educate him that good behaviour will result in the praise and attention he seeks.

If possible, find out the fundamental source of behaviours and deal with it. It may be very frustrating not to successfully communicate for meeting the requirements. Before you reply, check the position and offer as much help as you can for help him communicate with you. After that, authorize his feelings and give your order.

Avoid punishments if possible. Research tells that behaviour management and positive discipline are more successful than physical punishment.

Decide suitable behaviours for them yourself. Special children will not recognize all the things. Children will copy what they watch in their environments. Consider how and when you lift your vote or while you show listening abilities for your special child.

In case you have any trouble, give options. If you say to your child about doing something, he or she must complete that requested action, though you may give him options for how he or she completes that activity.

Consequences need to be associated with the activities. Timeout is great to calm down but can't be effective for decreasing the behaviour in case the child does not realize that the result is associated with the behaviour. In case your child chucks a toy, he has to stop his action and go get back that toy (using your help if needed). If he declines to finish an activity, he should not complete other activity until the first request is done (using your help if needed).

Conclusion

Some defiant behaviours are a normal part of the development of all children. This is the way to learn more about their roles as well as the way of applying for independence. It may be uncomfortable and difficult to cope with the public meltdowns as well as shattering unhappy children. Special children are intelligent and talented human beings. As a parent, you need to work out the finest way of bringing out the hidden skills and beauty of your child.

Uttar Pradesh, a northern Indian state, is home to the capital city of Lucknow. It was established by Nawab Asaf-ud-doula in 1777 and named after his son, Nawab Muhammed Ali Khan Bahadur (1699–1793).

Lucknow was founded as a city by Nawab Asaf-ud-Daula. The foundation stone was laid at Kalanagar, but due to some disputes between him and his brother Mirza Najaf Khan over succession rights, he shifted its site to Allahabad, where he built a fort that later came into being known as 'Lucknow.'

city of Lucknow from rebel sepoys (Indian soldiers in the British East India Company's Army) during the Indian Rebellion of 1857.

After two successive relief attempts had reached the city, the defenders and civilians were evacuated from the Residency, which was then abandoned.

The state of Oudh/Awadh had been annexed by the British East India Company and the Nawab Wajid Ali Shah was exiled to Calcutta the year before the rebellion broke out.

This high-handed action by the East India Company was greatly resented within the state and elsewhere in India. The first British Commissioner (in effect the governor) appointed to the newly acquired territory was Coverley Jackson.

He behaved tactlessly, and Sir Henry Lawrence, a very experienced administrator, took up the appointment only six weeks before the rebellion broke out.

The sepoys of the East India Company's Bengal Presidency Army had become increasingly troubled over the preceding years, feeling that their religion and customs were under threat from the evangelizing activities of the Company.

Lawrence was well aware of the rebellious mood of the Indian troops under his command (which included several units of Oudh Irregulars, recruited from the former army of the state of Oudh).

On 18 April, he warned the Governor General, Lord Canning, of some of the manifestations of discontent, and asked permission to transfer certain rebellious corps to another province.

The boiling point of the rebellion was the introduction of the Enfield rifle; the cartridges for this weapon were believed to be greased with a mixture of beef and pork fat, which was felt would defile both Hindu and Muslim Indian soldiers.

On 1 May, the 7th Oudh Irregular Infantry refused to bite the cartridge, and on 3 May they were disarmed by other regiments.

On 10 May, the Indian soldiers at Meerut broke into open rebellion, and marched on Delhi. When news of this reached Lucknow, Lawrence recognized the gravity of the crisis and summoned from their homes two sets of pensioners, one of sepoys and one of artillerymen, to whose loyalty, and to that of the Sikh and some Hindu sepoys, the successful defense of the Residency was largely due.

On 23 May, Lawrence began fortifying the Residency and laying in supplies for a siege; large numbers of British civilians made their way there from outlying districts. On 30 May (the Muslim festival of Eid ul-Fitr), most of the Oudh and Bengal troops at Lucknow broke into open rebellion. In addition to his locally recruited pensioners, Lawrence also had the bulk of the British 32nd Regiment of Foot available, and they were able to drive the rebels away from the city.

On 4 June, there was a rebellion at Sitapur, a large and important station 51 miles (82 km) from Lucknow. This was followed by another at Faizabad, one of the most important cities in the province, and outbreaks at Daryabad, Sultanpur and Salon.

Thus, in the course of ten days, British authority in Oudh practically evaporated

On 30 June, Lawrence learned that the rebels were gathering north of Lucknow and ordered a reconnaissance in force, despite the available intelligence being of poor quality. Although he had comparatively little military experience, Lawrence led the expedition himself.

The expedition was not very well organized. The troops were forced to march without food or adequate water during the hottest part of the day at the height of summer, and at the Battle of Chinhat they met a well-organized rebel force, led by Barkat Ahmad with cavalry and dug-in artillery.

Whilst they were under attack, some of Lawrence's sepoys and Indian artillerymen defected to the rebels, overturning their guns and cutting the traces.] His exhausted British soldiers retreated in disorder. Some died of heatstroke within sight of the Residency.

Lieutenant William George Cubitt, 13th

Native Infantry, was awarded the Victoria Cross several years later, for his act of saving the lives of three men of the 32nd Regiment of Foot during the retreat.

His was not a unique action; sepoys loyal to the British, especially those of the 13th Native Infantry, saved many British soldiers, even at the cost of abandoning their own wounded men, who were hacked to pieces by rebel sepoys.

As a result of the defeat, the detached turreted building, Machchhi Bhawan (Muchee Bowan), which contained 200 barrels(27 tons) of gunpowder and a large supply of ball cartridge, was blown up and the detachment withdrew to the Residency.

This changed the Military history of Lucknow! Time fled by and World Ears happened, India became independent and it was time for the Britishers to hand over the baton to Independent India. With that came the setting up of commands. Central Command happened to be one of them! HOW IT came into existence we will tell you later in the script! So please keep reading!

Some facts::

Central Command, also known as Surya Command, was raised on 01 May 1963 at Lucknow, in the aftermath of the Chinese aggression of 1962, with an aim to guard the Central Sector on the Line of Actual Control. Lt Gen Kanwar Bahadur Singh was the

first GOC-in-C of Central Command.

The insignia in the formation sign of Central Command is 'Surya', the Sun. The ethos of Surya, the 'Eye of the Universe' and the most profound source of energy that sustains all life in Earth, lies in its centrality to everything.

From the borders with Tibet and Nepal

to the shores of Bay of Bengal, the Central Army is spread centrally across eight states of Himachal Pradesh, Uttarakhand, Uttar Pradesh, Madhya Pradesh, Bihar, Jharkhand, Chhattisgarh and Odisha. It shares its boundary with all other Commands of the Indian Army and is Central to Victory.

Over time, Surva Command has grown in size and stature. Today, the Command is operationally responsible for the defense of the Central Sector along the LAC and International Border with Nepal stretching across the four states of Himachal Pradesh, Uttarakhand, Uttar Pradesh and Bihar.

Pradhan Mantri Mudra Yojana: Credit saturation for livelihoods

The scheme has supported small enterprises and revitalized the Indian micro-credit ecosystem in its eight years of existence


As India's Pradhan Mantri Mudra Yojana(PMMY) completed eight years on 8 April, we can glance back at the changes wrought by this mass credit saturation programme that was envisaged during the bleak days of 2014-15 when our formal financial sector was reeling under bad loans, especially its impact on the sociocultural fabric of the country. The PMMY is one of the flagship schemes of Union government to encourage self- employment. The scheme targets micro and own-account enterprises that constitute a vibrant business ecosystem in India. Micro enterprises are mostly engaged in manufacturing, processing, trading and services, and many of these units are single-ownership businesses.

The country's formal or institutional architecture was unable to reach out to them and meet their financial requirements. These units were largely self-financed or reliant on either personal networks or moneylenders. With this gap kept in mind, the PMMY was floated with the objective to create an easily accessible bridge between a large unbanked sector and formal lenders. Launched in 2015, PMMY provides collateral-free institutional credit up to ₹10 lakh, as provided by Member LendingInstitutions(MLIs): i.e., Scheduled Commercial Banks (SCBs), Regional Rural Banks (RRBs), Non-Banking Financial Companies (NBFCs) and Micro Finance Institutions (MFIs).

Under the aegis of the PMMY, the Micro Units Development and RefinanceAgency(MUDRA)created three sub-schemes that differ by the loan amount: Shishu (for loans up to ₹50,000), Kishore (₹50,001–₹5 lakh) and Tarun (₹500,001–₹10 lakh). The

names Shishu, Kishore and Tarun also signify the stage of the beneficiary micro unit's growth or development and its funding needs. Any individual who is otherwise eligible to take a loan and has a business plan for a small business enterprise can avail of credit under the scheme.

Since its launch, the scheme has undergone numerous changes. Its target area, for example, has been widened to maximize its positive economic impact. Initially, the PMMY covered income-generating activity only in the sectors of manufacturing, trading and services. However, since 2016-17, activities allied with agriculture and their support services promoting livelihoods have been brought under its ambit; since 2017-18, loans have been sanctioned for the purchase of tractors and power tillers; and from 2018-19, loans to buy two wheelers for commercial purposes have also been included.

Total disbursement under the scheme showed an average 33% growth in its first three years, indicating that its unique selling proposition was well received. The outbreak of the covid pandemic and subsequent slowdown in economic activity impacted the demand for these loans. During this phase, a special relief provision of the Reserve Bank of India (RBI) permitted all lending institutions to grant a moratorium of six months on the payment of all instalments under the scheme.

After the economy's re-opening, loan demand under the PMMY has gathered pace.In most categories, disbursements have surpassed pre-covid levels. Data as on 24 March 2023 puts the scheme's cumulative disburse amount at ₹22.65 trillion. The share of Shishu loans is the highest, at 40%, suggesting that the PMMY has largely supported first-time entrepreneurs.

The PMMY's economic impact is now well established. As per survey

results of the ministry of labour and employment, the scheme had helped in generating 11.2 million net additional jobs during the period 2015 to 2018.

The social impact of the PMMY is a much deeper story and can be understood at three levels. These three levels include the scheme's impact on (1) broad social groups; 2) women; and 3) members of minority communities.

In terms of the first, the PMMY has benefitted all segments of Indian society: General, Schedule Caste/Tribe(SC/ ST) groups and Other Backward Classes(OBCs). The increasing participation of OBCs and SCs in availing these loans in recent times is an indication of the scheme's outreach.

One of the scheme's most commendable achievements is its impetus to women's entrepreneurship. In its cumulative data since inception, the share of accounts held by women is as high as 69%, while the share of women in the

sanction list is 45%. Disbursements to women entrepreneurs registered an average growth of 23% in the scheme's first four years. In 2022, it surpassed its pre-covid level, registering a robust growth of 28%

The PMMY also fares well on other measures of inclusivity. The scheme has been able to cater to the requirements of minorities. Loans to members of minority groups touched an all-time high in 2022, with their overall share at 10%, with Shishu and Kishore loans accounting for 85% of total cumulative disbursement.

Since the PMMY is a national scheme, its spatial dispersion is an important consideration from the point of view of balanced economic growth. One of the objectives of India's growth policy has been to bridge the divide between the thriving western and lagging eastern parts of the country. A Herfindahl Concentration Index estimate of the number of accounts and disbursed

amounts shows significant dispersion across states and products. This indicates an impressive geographical coverage.

States such as Uttar Pradesh, Odisha and Bihar have recorded all-round gains from the PMMY. West Bengal and Tripura have also seen a rise in their total share(and also in the Kishore and Tarun categories), indicating an eastward flow of beneficiaries. Developed regions such as the national capital region, Maharashtra, Karnataka and Goa have seen their shares decline, even though they dominate the scheme in absolute terms.

Overall, the PMMY has achieved its objectives of equitable and fair spatial distribution of benefits during its ninth year of operation by fostering self employment across social groups, doubling the participation rate of women over that observed in commercial-bank lending and boosting the participation of minority groups.

In the coming years, it is imperative that the PMMY reaps the benefits of 5G technology and e-commerce, even as Mudra cards are popularized further. Encouraging the registration and formalization of own-account enterprises could be another way of taking this scheme to new highs.

The celebrated anthropologist Oscar Lewis had once argued in his seminal work, The Children of Sanchez, that a "culture of poverty" tends to perpetuate itself over time, often transcending boundaries. The PMMY, in a short span, has not only attacked and altered the course of this culture of poverty, but infused a sense of vibrancy and can-do spirit in the Indian micro-credit ecosystem. The PMMY has clearly been an uncommon solution to 'common problems'.

AAP Now National Party; Trinamool, Sharad Pawar's NCP, CPI Lose Status

New Delhi: Arvind Kejriwal-led Aam Aadmi Party, or AAP, which emerged out of Anna Hazare-led anticorruption movement in 2012, got elevated to a national party status on Monday. The party is currently in power in two states - Delhi and Punjab.

The Election Commission said the AAP has been named as a national party based on its electoral performance in four states - Delhi, Goa, Punjab and Gujarat.

Party boss Arvind Kejriwal termed the development a "huge responsibility" and "nothing less than a miracle" as the AAP achieved the national party status in record time.

"National party in such a short time? This is nothing less than a miracle. Many congratulations to all. Crores of people of the country have taken us here. People expect a lot from us. Today people have given us this huge responsibility. Lord, bless us to fulfill this responsibility well," Mr Kejriwal tweeted in Hindi. Sharad Pawar's Nationalist Congress Party (NCP) and Mamata Banerjee's Trinamool, in a big setback, have been downgraded to the status of regional parties. The CPI too was assigned the regional party status.

For a political party to be recognised as a national party, it has to be a recognised state party in four or more states (or) 2% seats in Lok Sabha, say rules.

Once a party loses a national party



status, the party will not get common symbol for its candidates in states where it's not recognised.

For example, Trinamool candidates will not get its symbol for elections in Karnataka if it chooses to contest. In the multi-party system that India enjoys, there are six national parties after today's restructuring - Congress, BJP, CPM, Bahujan Samaj Party, National People's Party (NPP) and the latest entrant, the Aam Aadmi Party.

India had also demanded an explanation for the complete absence of British security that allowed the Khalistani elements to enter the Indian High Commission premises.

In a statement, India had said it finds "unacceptable the indifference of the UK Government to the security of Indian diplomatic premises and personnel in the UK".India also demanded that the perpetrators be immediately arrested and prosecuted and stringent measures be put in place to prevent recurrence of such treaty text discussions in these policy areas.

The February session was conducted in hybrid fashion, with a number of Indian officials travelling to London for negotiations and others attending virtually.

The India-UK FTA negotiations cover 26 policy areas. The negotiators had closed discussions on 13 of them, and the trade ministers of both sides had met in December 2022, and January this year to take stock of the progress.

India accounts for 1.7 percent of total UK exports and India was the 12th largest export market for the UK in the four quarters to the end of Q3 2022.

The UK Business and Trade Secretary Kemi Badenoch also expressed optimism about business and export trade prospects with India, saying: "India's growing economy and middle class represent an enormous opportunity for enterprising UK companies looking for new markets."

Key issues for India-UK FTA negotiators include liquor, automobiles, intellectual property, and mobility of students and professionals.

Anti-Terror Agency Raids 14 Location In Jharkhand In Maoist Conspiracy Case

New Delhi: The National Investigation Agency (NIA) has conducted searches at 14 locations in Lohardaga and Latehar districts in Jharkhand and arrested one suspect namely Sajan Kumar in its ongoing probe in the case of a conspiracy by active cadres of CPI (Maoist) to attack security forces in June 2022, the agency said on Monday. The anti-terror agency conducted these searches on Sunday at the premises of accused and suspected persons at nine locations in Lohardaga and five locations in Latehar. During the searches, the agency said, "One country-made pistol along with six live rounds, one magazine, electronic gadgets and incriminating documents pertaining to financial transactions and property were seized."One suspect namely Sajan Kumar, a resident of Chakla in Jharkhand, was arrested from one of the search locations at Lohardaga.Sajan used to work as Munshi at a brick kiln namely Raju Bricks owned by suspect Raju Kumar alias Raju Sao. Raju is allegedly involved in the collection and investment of levy money on behalf of Maoist Ravindra Ganjhu, who is still evading arrest and Sajan was fully aware of the transactions. Covid-19: India logs 5,880 fresh cases, hospitals to conduct mock drill

New Delhi, Apr 10 (UNI) India recorded a single-day jump of 5,880 fresh Covid-19 cases during the last 24 hours, taking the active caseload to 35,199 according to the Union Health Ministry on Monday. The toll has risen to 5,30,979 with 12 more deaths-four each reported from Delhi and Himachal Pradesh, and one each from Gujarat, Jammu and Kashmir, Maharashtra, and Rajasthan. As many as 205 patients recovered from the disease during the past 24 hours. The total number of people who have recuperated from the disease is 4.41 crore (4,41,96,318). The recovery rate currently stands at 98.73 percent.The daily positivity rate was recorded at 6.91 percent while the weekly positivity was pegged at 3.67 percent.Meanwhile, 92.28 cr Total Tests have been conducted so far; 85,076 tests were conducted in the last 24 hours as per Ministry data. Meanwhile, Delhi on Sunday logged 699 fresh Covid-19 cases with a positivity rate of 21.15 percent, according to data shared by the city government's health department.

BJP may release 180 plus candidates' list by evening: Yediyurappa

China rehearses 'sealing off' Taiwan, **US deploys naval destroyer**

China simulated "sealing off" Taiwan during a third day of wargames around the self-ruled island on Monday, as the United States deployed a naval destroyer into Beijing-claimed waters in a show of force.

China launched the exercises in response to Taiwan President Tsai Ing-wen last week meeting US House speaker Kevin McCarthy, an encounter it had warned would provoke a furious response.

After two days of exercises that included simulating targeted strikes on Taiwan and encirclement of the island, the Chinese military said the wargames also included "sealing" it off.

One of China's two aircraft carriers also "participated in today's exercise," the military said.

The United States, which had repeatedly called for China to show restraint, on Monday sent the guided-missile destroyer the USS Milius through contested parts of the South China Sea.

"This freedom of navigation operation upheld the rights, freedoms, and lawful uses of the sea," the US Navy said in a statement. It added the vessel had passed near the Spratly Islands – an archi-



pelago claimed by China, Taiwan, the Philippines, Vietnam, Malaysia and Brunei. It is about 1,300 kilometres (800 miles) from Taiwan.The deployment of the Milius immediately triggered more anger from China, which said the vessel had "illegally intruded" into its territorial waters.

'No war'On Beigan island, part of Taiwan's Matsu archipelago that is within eyesight of China's mainland, 60-year-old chef Lin Keqiang told AFP he simply did not deliberately ambiguous on whethwant war."We, common people,

This was viewed as a compromise that would underscore support for Taiwan but avoid inflaming tensions with Beijing.

But China had repeatedly warned against any meeting, and began the latest wargames soon after Tsai returned to Taiwan.

'These operations serve as a stern warning against the collusion between separatist forces seeking 'Taiwan independence' and external forces and against their provocative activities," said Shi Yin, a PLA spokesman, said about "Joint Sword". Tsai responded to the drills by pledging to work with "the US and other like-minded countries" in the face of "continued authoritarian expansionism".Live-fire exercises

Exercises on Monday were set to include live-fire drills off the rocky coast of China's Fujian province, about 80 kilometres (50 miles) south of the Matsu islands and 190 kilometres from Taipei.

The local maritime authority said the exercises would be held between 7:00 am and 8pm around Pingtan, a southeastern island that is China's nearest point to Taiwan.AFP journalists on Pingtan did not see any immediate military activity in an offshore area on Monday.

Iranian delegation set to visit Saudi Arabia this week

TEHRAN: Iran's foreign ministry said on Sunday a delegation will visit Saudi Arabia by Friday to pave the way for reopening its diplomatic missions there following a similar move by Riyadh.

The announcement comes a day after a Saudi delegation arrived in Tehran on a similar diplomatic trip, and follows a historic meeting between the two Gulf countries' foreign ministers in China.

"We are expecting a foreign ministry delegation to visit Saudi Arabia" by Friday, Deputy Foreign Minister Alireza Enayati said in an interview with state television.

"Two separate delegations will go to Riyadh and Jeddah", ahead of reopening Iran's embassy and consulate respectively.

The two countries have pledged to bring back security and stability to the turbulent Gulf

Saudi Arabia severed relations with Iran in January 2016, after its embassy in Tehran and consulate in the north-western city of Mashhad were attacked by protesters demonstrating over Riyadh's execution of cleric Nimr al-Nimr.

Iranian Foreign Minister Hossein Amir-Abdollahian and his Saudi counterpart Prince Faisal bin Farhan met in the Chinese capital on Thursday after Tehran and Riyadh agreed last month to restore diplomatic ties

In a joint statement, the ministers pledged to bring back security and stability to the turbulent Gulf.

Iran and Saudi Arabia have backed rival sides in conflict zones across the region, including in Yemen.

Iranian President Ebrahim Raisi has been invited by Saudi King Salman to Riyadh, a trip planned to take place after Ramazan.

Riyadh leads a military coalition that supports the internationally recognised government in the Arabian Peninsula country, while Tehran backs the Houthi rebels who control the capital Sanaa and large areas of the north.

The two Middle East powerhouses had held several rounds of dialogue in Iraq and Oman before reaching the agreement in Beijing, negotiated over five days between Iran's secretary of the Supreme National Security Council Ali Shamkhani and his Saudi counterpart Musaad bin Mohammad Al-Aiban.

Pope expresses 'deep concern' over unrest in Israeli-held areas

VATICAN CITY: Pope Francis noted his "deep concern" on Sunday over a flare-up in tensions between Israel and Palestinians, delivering an Easter Mass in which he denounced the barriers to peace in the world.

He said the renewed violence "threatens the desired climate of trust and mutual respect needed to resume dialogue", addressing a crowd of some 100,000 gathered in Saint Peter's Square.

The Argentinian pontiff, a week after leaving hospital, also cited a string of "stumbling blocks" to peace in the world during his traditional Easter message, making special mention of the war in Ukraine. "Help the beloved Ukrainian people on their journey towards peace, and shed the light of Easter upon the people of Russia," he said. "Comfort the wounded and all those who have lost loved ones because of the war, and grant that prisoners may return safe and sound to their families." He drew attention to conflicts around the world, from Syria to the Democratic Republic of Congo, and offered prayers for victims of the earthquake in Turkiye and Syria. This week has seen a surge in violence and unrest between Israel and Palestinians at the same time as the Ramazan. Passover and Easter have coincided. The pope called for a resumption in dialogue to ensure peace "in the Holy City (of Jerusalem) and in the entire region". The 86-year-old pope has returned to his duties after a recent stay in hospital following a bout of bronchitis.

New Delhi: A wealthy bidder has splashed out a world-record 55 million dirhams (\$15 million or 123 crore) for a rare car license plate in Dubai, smashing a bar set in the United Arab Emirates more than a decade ago.Emirates Auction LLC sold plate number P 7 - which, at first glance, looks like the number 7 alone, with the P off to the side - on Saturday during a charity auction, according to the company. Proceeds will go to Dubai ruler Sheikh Mohammed bin Rashid's global food aid initiative, the 1 Billion Meals Endowment.The UAE has made a habit of auctioning off vanity plates, used by the ultra-rich to show off their status and wealth, for charity. The latest auction broke a record set in 2008 by local businessman Saeed Abdul Ghaffar Khouri, who paid 52.2 million dirhams for a plate bearing the number 1 in Abu Dhabi. Vanity plates have also fetched eye-watering prices outside the Middle East: Someone bought the single-letter "R" plate at auction in Hong Kong earlier this year for HK\$25.5 million (\$3.2 million).For years, Dubai has been a safe space for the mega-wealthy to flash their wealth and live a tax-free lifestyle. India has "disengaged" from trade talks with Britain after accusing it of failing to condemn the Sikh separatist group that attacked the Indian High Commission in London last month, The Times reported on Monday, citing British government sources.

"Indians don't want to talk about trade until they get a very public demonstration of condemnation of Khalistan extremism in the UK," a Whitehall source told The Times.

The incident occurred on March 19, when protesters with 'Khalistan' banners staged a demonstration at the High Commission and took down an Indian flag from the building's first floor balcony to denounce recent police action in Punjab.

Khalistan refers to an independent Sikh state sought by some groups but which does not exist.

Subsequently, India had summoned the most senior British diplomat in New Delhi to protest at the actions taken by "separatist and extremist elements" against the country's mission in London. Moreover, British foreign minister James Cleverly has said the country will review security at the Indian High Commission in London following "unacceptable acts of violence" towards the mission's staff.

Emmer wheat or Khapli: Everything we should know about this healthy grain

What is Emmer wheat?

Also known as Farro, it is an ancient grain that has been cultivated for centuries. A native of the Middle East, historical evidence traces it to the Middle Pre-Pottery Neolithic Age (10,200 to 9,500 BC) when it was collected and consumed by hunter gatherers. It has been discovered in several Neolithic archaeological sites. Emmer is grown in parts of Africa, Spain, US, Albania, Turkey, Switzerland, Germany, Greece and Italy. Cultivation in India

Emmer wheat known as Khapli in India is not commonly cultivated. It is traditionally cultivated on a limited scale in Karnataka, parts of Maharashtra, Gujarat, Andhra and Tamil Nadu. Due to an increased awareness towards its health benefits, Emmer wheat is available in specialty stores and online markets in India, where it is often sold as a health food due to its high nutritional value and low gluten content.

As per a report published by AB Damania, Department of Plant Sciences, University of California, "Archaeological findings from Kunal in Haryana, Kanishkapura in Kashmir, Harappan settlement of Rohira in Punjab also show evidence of Khapli cultivation. It is speculated that Khapli wheat came to Kashmir from the Middle East through Persia and Afghanistan and to southern India by sea from north eastern Africa. Today Khapli wheat forms only 1% of all wheat grown in India."

Conclusion

According to celebrity nutritionist Sandhya Gugnani, "Emmer wheat is high in protein and low in calories as compared to refined flour. It is a rich source of vitamin B3, magnesium, selenium and iron. Since it's high in fibre, protein and other vitamins and minerals, this makes it a complete plant based high-protein food source for a vegetarian diet. One can add legumes and other vegetables too. It's widely used in soups and is a healthy substitute for rice. It's easy to digest but people with gluten intolerance should avoid it completely." This ancient wheat variety can be used both in grain and flour form. It is hard to distinguish it from the regular atta consumed in Indian households and hence it can be a good substitute for the regular flour due to its numerous health benefits. From chapatis and parathas to dalia, pulao and salads, the grain can be conveniently incorporated in Indian recipes.
