NEW DELHI, APR 19: Defence Minister Rajnath Singh on Wednesday asked the Army to maintain strong vigil along the Line of Actual Control (LAC) with China as the situation in the northern sector remained "tense" in view of deployment of PLA troops.

In his address at the Army Commanders' Conference, Singh, without making specific references, called upon the armed forces to take note of geo-political changes around the world, and accordingly mould their

planning and strategies, sources said. "The situation is tense due to deployment of PLA troops in the northern sector. Our armed forces,

especially the Indian Army, will have to continuously keep their vigilance in order to maintain the security of the LAC," he said, according to the

Singh's comments came in the backdrop of the three-year border row in eastern Ladakh.

The defence minister said the security of the country is the "topmost priority" for the government.

"I assure all of you that it is the whole endeavour of the government to provide the best weapons and facilities to each and every soldier posted on the border," he said at the conference in Delhi.

Sameer Ahmad, a customer from Anantnag said that they purchase Sheermal and gift some to their relatives as well.

He added that Sheermals are being made in other parts as well but they are not as crunchy and tasty as Rajpora Sheermal.

Nazir Ahmad, Banker by profession said he prefers in-store shopping over online shopping. "Call me an old type of person but I am more inclined to traditional shopping, I would like to see and feel the material of any product that I want to purchase, especially clothes and shoes."

He added, "When we shop online, there is a certain level of unpredictability and anticipation – from not being sure when one will receive the package to tracking the order, and waiting for it to arrive. This is just simple event of anticipation and delayed gratification."

Suhail, who has been hopping online for four years, said, "It saves time and you can do it anywhere. You don't need to wait and pay. With a click I can check out easily and avoid the crowds of in-store shopping."

The survey also showed that 90 percent participants used their mobile phone for online shopping while 10 percent said they used a computer.

The day temperature in most places of Jammu and Kashmir remained below 4 -10 degree Celsius forcing people and tourists to wear warm clothes. Night temperature was recorded 2-3 degree Celsius below normal in Kashmir valley.

Regarding the rainfall, the MeT office said Srinagar received 15.9 mm, Qazigund had 30.0 mm of rainfall, Pahalgam 41.0 mm, Kupwara 26.9 mm, Kokernag 25 mm and Gulmarg 49.6 mm, Udhampur 15.8 mm, Jammu 17.1 mm, Katra 22.2 mm and Kathua 3.4 mm of rainfall during the past 24 hours till 0830 hours this morning.

Srinagar recorded a low of 10.3 degree celsius against the 11 degree Celsius the previous night and it was 2.4 degree Celsius above normal for the summer capital of Jammu and Kashmir during this period of the season.

The maximum temperature was recorded 5.8 degree Celsius below normal in Srinagar on Wednesday against 21.1 degree Celsius on Tuesday.

Qazigund recorded a minimum temperature of 9.2 degree Celsius against 9.8 degree Celsius the previous day which was 2.7 degree Celsius above normal at the gateway of Kashmir.

Tourist hot spot of Pahalgam recorded a low of 5.4 degree Celsius against 5.6 degree Celsius the previous night and it was 2.0 degree Celsius above normal.

Kokernag had a low of 6.5 degree Celsius and Kupwara recorded a low of 6.8 degree

Gulmarg in North Kashmir recorded a low of 2.0 degree Celsius which was 0.3 degree Celsius below normal for the ski resort on Wednesday, the MeT office said.

No Alarming.....

there is no alarming flood-like situation in the Valley and people need not to panic. Quoting chief engineer Irrigation and

Flood Control Department, Er Naresh Kumar, that there is not alarming situation in the Valley as of now.

"The alert level at Sangam is well below the danger mark and same is in Ram Munshi Bagh. There is no alarming flood like situation as of now and people also need not to panic," he said.

He also said it expected that the weather is likely to improve in the afternoon, so for now there is no need to panic.

Kashmir Valley witnessed incessant rainfall since yesterday, while the weatherman has predicted more rain showers as the day progresses.

An independent weatherman predicted that the higher reaches of Jammu and Kashmir will receive good amount of snow, while plains may get moderate to heavy rain.

He further said that more showers are expected till Friday, while maximum temperature will stay below normal by 4 to 13 Degree Celsius at most places.

24 persons.....

Speaking to the news agency-Kashmir News Observer (KNO), Tehsildar Wagoora, Mubashir Amin (JKAS) said the move was taken to send a stern message to the encroachers over grabbing the government land.

"During the anti-encroachment drives carried out time and again, at least 170 kanals of state/kahcharai land was retrieved from the encroachers at Kachwa Magam area of the tehsil and was later handed over to the Rural Development Department for undertaking various kinds of development including developing playgrounds for the youth. However, the miscreants later again encroached upon the evicted land, forcing us to take this harsh step," he said.

So far, 24 people have been identified, who have grabbed the state land again and are creating hurdles in the developmental activities undertaken by the government, Amin said, adding that the identified encroachers were also called in his chamber and cautioned against encroaching the land again, but despite warnings, they didn't desist.

Meanwhile, warning the encroachers to desist from violating the government directives in the future and asking them to remove the encroachments immediately, the Tehsildar said they have decided to impose a fine of Rs 25,000

each on the 24 identified persons.

Conference began on Monday. It is deliberating on India's national security challenges along the borders with China and Pakistan and wavs to boost combat capability of the force.

Referring to Jammu and Kashmir, the defence minister said it is witnessing peace and stability and there has been a significant decline in the number of terrorist activities in the Union Territory.

"In the North-Eastern states too, there has been a lot of improvement in the internal security scenario following operations carried out by the Indian Army," Singh said.

"Nevertheless, we have to be vigilant against anti-national organisations that challenge the government's efforts for peace," he

In his remarks, Singh also said that future warfare will be highly unpredictable due to "many uncertainties".

"In today's changing times, the scope of threats and weapons has become very wide-ranging. There is a need to assess your defense preparedness accordingly," he told the commanders.

The defence minister said there is a need to ensure use of real-time intelligence more effectively so that "we can be fully prepared to face any such future challenges.

He said the welfare and well-being of each and every soldier and ex-serviceman is also an important goal of the government.

The government is working for the armed forces as diligently as the armed forces are working for the security of the nation, he said.

"The government is fully committed to the welfare of not only the armed forces, but also veterans, and their families," Singh said. The Army Commanders' Confer-

ence is an apex-level biannual event that is held in April and October every year. The conference is an institutional

platform for conceptual-level deliberations, culminating in making important policy decisions for the Indian Army.

"In Kulgam, a police party led by SHO Police Station Kulgam during naka checking at Dalwach intercepted a suspicious person, who has been identified as Ghulam Rasool Bhat son of Ghulam Mohammad Bhat resident of Nussu Badragund. During search, 2.5Kg of Poppy Straw like substance concealed in a bag was recovered from his possession. He has been arrested and a case vide FIR No 64/2023 under relevant sections of law was registered in PS Qazigund and investigation was initiated," police said.

During the course of investigation and based on the disclosure of arrested person, two more drug peddlers identified as Bilal Ahmad Ganaie son of Mohd Jabbar Ganaie resident of Nussu Badragund and Mohd Ayub Malik Ghulam Mohd Malik resident of Brinal Lammar were arrested with 4Kgs of Poppy Straw like contraband substance, the statement said.

Similarly, in another checkpoint established at Dalwach crossing on NHW-44 one more drug peddler identified as Mudasir Ahmad Ganaie son of Bashir Ahmad Ganaie resident of Hassanpora, Bijebhara was arrested alongwith 34 Codeine Phosphate bottles, police said.

In Handwara, a police party of Police Station Vilgam during naka checking at Sumo Stand Vilgam intercepted a person who had attempted to avoid the police party in a suspicious manner. 
Junk food behind fatty liver epidemic in Kashmir: DAK

SRINAGAR, APR 19: On World Liver Day, Doctors Association Kashmir (DAK) on Wednesday expressed concern over the surge in fatty liver disease which has reached epidemic proportions in Kashmir valley. "Junk food is causing a spike in fatty liver cases in the valley," said DAK President Dr Nisar ul Hassan.

Dr Hassan said junk food has become a routine part of people's lives and has largely replaced homemade meals. Fast food is the quickest meal not just for busy professionals, but there is a rising trend of fast food among children and teenagers. They are often seen eating fast foods like pizzas and burgers. Children are addicted to chips, sugary drinks and frozen ready meals.

"This change in dietary habits from homemade to pro-



cessed and convenient foods is the primary factor contributing to enormous burden of fatty liver in Kashmir," he said.

The DAK President said according to a new study from

the University of Southern California's Keck school of Medicine published in clinical gastroenterology and hepatology, junk food has been found

to cause fatty liver disease.

"If you are obese or diabetic, fast food has even more negative impact on the liver and can lead to even higher amounts of fat in the liver," he said.

Dr Nisar said one in three

persons in Kashmir have fatty liver and young people are mostly hit.

The prevalence of disease is 60-70% among diabetics and obese individuals.

He said non-alcoholic fatty liver disease is a life threatening disease in which fat builds up in the liver. It is the commonest cause of cirrhosis or scarring of liverwhich can cause liver failure and even cancer.

People with fatty liver have a greater chance of developing cardiovascular disease. "In order to prevent this disease, we need to go back to our culture of taking homemade meals and avoid junk food. We need to be on roads and gyms rather than in luxury cars," he said.

"Every year on April 19 World Liver Day is observed to spread awareness about the importance of liver health and educate people on how to maintain a healthy liver," he added.

Several villages await completion of bridge over Shaliganga river in Budgam

BUDGAM, APR 19: The residents of the Shalnar, Frestiwar, Arigam and Draggar areas in this central Kashmir's Budgam district are facing severe difficulties due to the non-completion of a bridge over the Shaliganga river in the Arigam area.

The residents told the news agency—Kashmir News Observer (KNO) that the bridge, which connects these villages, has been under construction for the last five years by the PMGSY department but remains incomplete.

The incomplete bridge has led to numerous problems, including difficulty in accessing medical facilities, schools, and markets. "As a result of the delay, villagers have been mostly cut off from Khansahib tehsil headquarters, causing significant inconvenience and suffering," they said.

The villagers said despite repeated assurances from the authorities, the bridge remains unfinished, and they are left to bear the consequences.

"The PMGSY Department's failure to complete the construction of the bridge despite the passage of five years has caused considerable inconvenience and suffering to us," said a group of locals of Arigam. They urged the authorities to expedite the construction process.

When contacted, the concerned Executive Engineer of PMGSY said there were some technical issues with the concerned contractor who moved to the high court due to which the process was delayed. He assured that the department will look into the matter.

Guidelines for deputation of employees to Ladakh: LG issues fresh directions

Directs to repatriate officers from Ladakh who completed 2 years tenure within a month

SRINAGAR, APR 19: The Jammu and Kashmir government on Wednesday directed that all the officers, who are on deputation and have completed two years tenure in the Union Territory of Ladakh be repatriated within next one month.

According to the guidelines, a copy of which lies with the news agency— Kashmir News Observer (KNO), the Lieutenant Governor, J&K has directed all the officers whose tenure has got completed as per the policy issued by General Administration Department dated 01-12-2022 must be repatriated preferably within next one month as per the policy guidelines.

It added that all the pending representations regarding repatriation on health grounds be got duly examined as provided in the policy preferably within next one month and a clear view taken in this regard under an intimation to such representing Officers/Employees.

The LG as per the document has

further instructed that the timely decisions on representations under other categories concerning repatriation must also be taken without allowing them to languish for long period of time. "In future all efforts be made to ensure adherence to the timelines and provisions of the policy under reference," it added.

Moreover, all the Administrative Secretaries have been directed to take immediate necessary action on the following points.

"All the Administrative Departments shall submit proposals for repatriation of its employees who have completed two years tenure in the Union Territory of Ladakh and propose suitable replacements as per the Deputation Guidelines within a week positively, enabling this department to place the same for consideration of Competent Authority, keeping in view that all such cases have to be decided in the month of April only, in terms of Transfer Policy and Deputation

Guidelines," it said.

It added that all the Administrative Departments must get the representations examined, received from the employees for repatriation from UT of Ladakh on health grounds as per the provisions of the policy within 15 days in consultation with Health & Medical Education Department and take a clear view/ stand under an intimation to such representing officers/ employees.

"The representations preferred by the employees for repatriation from UT of Ladakh on other grounds shall also be decided expeditiously and the decision must be conveyed to the concerned employees," it further

Further, the Administrative Secretary, Health and Medical Education Department, is requested to facilitate conduct of Special Standing Medical Board for all such cases referred in the third week of April, under an intimation to this department for ensuring that the cases are decided by end of the month of April, 2023, it said.

Shooting Stones Snatching Human lives....Who Cares?

The Jammu-Srinagar highway, the lifeline of the people of Jammu and Kashmir, has been witnessing recurring incidents of shooting stones and landslides, causing massive disruptions in traffic movement and leading to several unfortunate deaths. The recent incidents have once again brought to the fore the negligence of the authorities and the lack of attention towards the safety of the people.

The shooting stones and landslides on the Jammu-Srinagar highway have been a perennial problem, particularly during the monsoon season when the region receives heavy rainfall. Ali' and 'Ek pita ki dui santaan, ek of a father, one Hindu, the other Muslim), the Mohammadi and Mahaveer (Hanuman) flags were first raised in Awadh at the Battle of Chinhat in which Hindus, Muslims, Sikhs, Taluqdaars and farmers came together to fight the British. At a time the country's environment is rife with communal flare-ups, June 30 marks the anniversary of the Battle of Chinhat which is said to be the first organised battle the British lost to a united Indian population after their fall in Kremlin, Russia.

Several other slogans of unity filled the air 160 years ago in Lucknow. 'Mohammadi and Mahaveer flags symbolising Hanuman are well documented to have been part of the battle and so was the slogan of deen,' said SZH Jafri, a history professor of Delhi University, who specialises on topics related to the uprising of 1857!

Taluqdaars and clerics. 'Nawab Ali, the Mahmudabad Taluqdaar was first to commit his forces to the uprising and with the sepoy revolt and civil Hindu ek Musalman' (Two children unrest, the movement turned into an organised battle,'!

What happened next baffled the British who had underestimated the Indian strength. When Henry Lawrence, then chief commissioner of Awadh, crossed over the Kukrail bridge towards Chinhat, he was met by some fighters at Ismailganj who lured the British army towards Chinhat, only to reveal a large number of natives hiding in mango groves. An organised battle was then fought and the British suffered heavy casualty, while those who survived retreated to the Residency!

India's Historic Battles: Lucknow, 1857: By Rosie Llewellyn Jones is a wonderful book and I have that on by library shelf (at the moment right in front of me)!

The brief as far as the book goes: The city of Lucknow was the epicentre of the uprising of 1857. In Lucknow, 1857 – part of a new series of books on India's historic battles – historian Rosie Llewellyn-Jones examines the conflict in detail, from the British annexation of Awadh to the Indian response nad the subsequent revolt by sepoys. The defeat of a unit of the East India Company's army at Chinhat led immediately to the siege of the extensive British Residency in the heart of the city. Here, nearly 3,000 people - British, Indian and Anglo-Indian – held out for four and a half months. The winter saw huge defensive barricades being built around Lucknow, but with their superior firepower, the British recapture was the inevitable outcome.

Another incident about which many would not be knowing is the storming of the Sikander Bagh took place on 17 November 1857 by British troops under the command of Sir Colin Campbell. The villa was built by Wajid Ali Shah. During the Siege of Lucknow, the villa became a stronghold and was occupied by over 2000 Sepoy Rebels, many of whom were slain by the 93rd Highlanders and 4th

1857 was yet another episode and was part of Indian Mutiny! The location was Alambagh, Lucknow, Uttar Pradesh, Presidency: Bengal



India Overtakes China, Is **Most Populous Nation With** 142.86 Crore People

New Delhi: India has become the world's most populous country, overtaking China, shows data released by the United Nations today. According to UN estimates, India's population is 142.86 crore against China's 142.57

This is the first time that India has topped the UN list of most populous countries since it started collecting population data in 1950.

China is facing a looming demographic decline as birth rates plunge and its workforce ages. Several regions have also announced plans to boost birth rates -- but official efforts have so far failed to reverse the decline.

India has no recent official data on how many people it has because it has not conducted a census since 2011.

India's once in a decade census was due to be held in 2021 but was delayed due to the coronavirus pandemic.

Nearly 1/4th of India's population is under the age of 14, according to the UN data. 68 per cent of the popula India is on its way to becoming the world's most populous country, overtaking China with almost 3 million more people in the middle of this year, data released on Wednesday by the United Nations showed. The demographic data from the United Nations



Population Fund's (UNFPA) State of World Population Report, 2023 estimates India's population at 1,428.6m or 1.4286 billion against 1.4257bn for China. The United States is a distant third, with an estimated population of 340m, the data showed. The data reflects information available as of February 2023, the report said.

Population experts using previous data from the UN have projected India would go past China this month. But the latest report from the global body did not specify a date for when the change would take place.UN population officials have said it was not possible to specify a date due to "uncer-

tainty" about the data coming out of India and China, especially since India's last census was conducted in 2011 and the next one due in 2021 has been delayed due to the pandemic. Although India and China will account for more than one-third of the estimated global population of 8.045bn, the population growth in both Asian giants has been slowing, at a much faster pace in China than in India. Last year, China's population fell for the first time in six decades, a historic turn that is expected to mark the start of a long period of decline in its citizen numbers with profound implications for its economy and the world

India coordinating very closely with Saudi, UAE, US, UK on safety of Indians in Sudan

New Delhi, Apr 19 (UNI) The situation in Sudan is very tense and India is coordinating closely with various countries to ensure the safety and security of Indian nationals there. External Affairs Minister S Jaishankar has spoken with his counterparts in Saudi Arabia and UAE in the context, and both have assured their practical support on the ground, sources said.

The Quartet countries of US, UK, Saudi Arabia and UAE have a key role and we are engaging them accordingly, said sources.

"Our Ambassador in Washington DC and High Commissioner in London are in touch with their respective host Governments. We are also working with UN, which has a substantial presence in Sudan," the sources added.

In New Delhi, the Ministry of External Affairs has set up a dedicated Control Room. The MEA is in continuous touch with the Embassy in Khartoum and is getting regular reports of the status of the Indian

community. The Embassy in turn is in

touch with the Indian community and individuals through multiple methods including WhatsApp groups, the sources added.

The situation on the street in Sudan is very tense and movement is very risky at this stage.

"Our priority is safety of movement and the wellbeing of individuals where ever they are located," the sources added.

"While both the Ministry and the Embassy are continuously monitoring the situation, concerns of safety and security constrain us from putting out specific details," the sources said.On Tuesday late night, EAM Jaishankar in tweets spoke about his telephonic conversation with his counterparts from Saudi Arabia and the UAE. "Thank HH @ABZayed,

Foreign Minister of UAE, for the exchange of views on the situation in Sudan.

"Our continuing contacts are helpful."

"Spoke to Foreign Minister of Saudi Arabia, HH @ FaisalbinFarhan just now.

"Appreciated his assessment of the Sudan situation. Will remain in close touch," he said in tweets.

On Tuesday, amid the escalating fighting in Sudan, the Indian Embassy said that it has come across many instances of looting and urged Indian nationals not to venture out and ration their supplies.

In a tweet, the Indian Embassy also asked the Indians in Sudan to remain indoors."We have come

across many instances of looting. All Indian nationals are advised please not to venture out. Please ration your supplies. The situation may continue for a few more days. Please try to take help from your neighbours. Please stay at home and remain safe," it said.

On Sunday, an Indian national was killed when he was hit by a stray bullet in Khartoum amid the clashes between the Sudanese Army and the paramilitary.

On Tuesday, EAM Jaishankar said the Indian Embassy in Khartoum is in constant touch with the Ministry of External Affairs regarding the 31 members of the Hakki Pikki tribe who are stranded in Sudan.

"Plans regarding them have to take into account a very complicated security scenario. The Embassy is in constant touch with the Ministry in that regard," he

New Delhi: BJP sources on Wednesday cited the critical stance of previous Congress governments on the issue of caste census to accuse Rahul Gandhi of "hypocrisy" after the Congress leader came out strongly in support of the census demand in a bid to corner the ruling party.

Congress leader and then Union minister Ajay Maken had written in 2010 to then Rajya Sabha MP Ali Anwar that a decision to "discourage community distinction" based on caste was taken keeping in view the spirit of the secular state enshrined in the Preamble of the Constitution of India, BJP sources noted.

In 2018, the then Karnataka chief minister Siddaramaiah did not publish the findings of a caste-based census before the state assembly elections, they said.

They added that Rajiv Gandhi had hit out at the VPSingh government during a debate in Parliament in 1990 for implementing the Mandal Commission report, which had recommended reservation for Other Backward Classes. He had termed it as an attempt to divide the country on caste lines and alleged that it was not very different from



what the Britishers had done, the sources

In 2010, a Group of Ministers headed by Pranab Mukheriee had never reached a conclusion on the issue of caste census as many senior Congress leaders were against such a census, BJP sources said.

They also cited the country's first prime minister Jawaharlal Nehru's stand against caste census and noted that Indira Gandhi followed by Rajiv Gandhi had put the Mandal Commission on the back burner when they were in power.

The BJP has so far not taken an official stand on the issue of caste census, a demand first raised by regional parties like the RJD and the JD(U) and then supported by most other opposition parties.

"Will Resign If Proved": **Mamata Banerjee On Alleged Call To Amit Shah**

Kolkata: West Bengal Chief Minister Mamata Banerjee on Wednesday said she would step down if it was proved that she had called Union Home Minister Amit Shah after her party, the Trinamool Congress, lost its national party

"I was surprised and shocked... I will resign if it is proven that I called up Amit Shah over Trinamool's national party status," Ms Banerjee told reporters at a news briefing at the state secretariat.

The Trinamool was stripped of its national party status by the Election Commission earlier this month after a review of its eligibility.

The leader of te opposition in West Bengal, Suvendu Adhikari, had claimed on Tuesday that Ms Banerjee had dialled Mr Shah to request him to intervene and restore the Trinamool's national status.

Mr Adhikari, a former close aide of Ms Banerjee who defected to the BJP before the 2021 assembly elections, was lying, the Chief Minister said.

Ms Banerjee also commented on the intensifying efforts by opposition parties to team up against the BJP ahead of next year's national elections.

"Sometimes silence is golden. Don't think the opposition is not sitting together. We all exist, and everybody is maintaining relations with each other. When it comes, it will happen like a tornado," she said.

The Trinamool chief, however, was more circumspect on a question on the Supreme Court case over legalising same-sex marriage, saying, "I will not say anything because the matter is sub-judice. The ministry reported "six minor injuries from live fire" reached a governmental hospital in Jenin, while another person shot had been admitted to a nearby hospital following the raid in the northern West Bank city.

A statement from the Israeli military said "security forces are currently operating in the Jenin (refugee) camp", without giving further details.

There was no immediate confirmation of the identity of those wounded in Jenin, a hotbed for Palestinian armed groups.

Heavy gunfire rocks Khartoum right after Sudan truce due to take effect

Heavy gunfire shattered a 24-hour truce deal in Sudan on Tuesday, shortly after it was due to take effect under US pressure on warring military factions to pause fighting that has touched off a humanitarian crisis.Loud shooting reverberated in the background of live feeds by Arab television news channels in the Khartoum capital region minutes after the agreed 6pm (1600 GMT) onset of the ceasefire deal, and warplanes could be seen in the skies above.

The conflict between Sudan's military leader and his deputy broke out four days ago, derailing an internationally backed plan for a transition to civilian democratic rule four years after the fall of autocrat Omar al-Bashir to a popular uprising and

two years after a military coup. The fighting has triggered what the United Nations has described as a humanitarian catastrophe, including the near collapse of the health system.

At least 185 people have been killed across the sprawling country.

US Secretary of State Antony Blinken, speaking in Japan, said on Tuesday he had telephoned both army chief General Abdel Fattah al-Burhan and paramilitary leader General Mohamed Hamdan Dagalo of the Rapid Support Forces (RSF), appealing for their rival forces to cease fire "to allow the Sudanese to be safely reunited with families" and to provide them with relief.

The ceasefire deal will not extend beyond the agreed 24 hours, Army General Shams



El Din Kabbashi, a member of Sudan's ruling military council, said earlier on al Ara-

A Reuters reporter in Khartoum said he heard tanks firing shortly after the truce was due to take hold.

It was unclear in the chaotic din who was behind the various bouts of gunfire, though the RSF issued a Facebook statement shortly after the truce was to take effect blaming the army for violations.

One resident told Reuters they had heard an air strike being carried out in Omdurman, Khartoum's sister city on the opposite bank of the Nile River.

Fighting had appeared to tail off close to the deadline for the ceasefire, which coincided with iftar.

Warplanes and explosions

Earlier in the day, the sounds of warplanes and explosions echoed across Khartoum. Residents in the neighbouring cities of Omdurman and Bahri reported air strikes that shook buildings and anti-aircraft fire. Fighting also raged in the west of the country, the UN said.

Saudi foreign minister meets Syria's Assad on first trip to Damascus since war

Syrian President Bashar al-Assad met with Saudi Arabia's top diplomat in Damascus on Tuesday, state media reported, ending more than a decade of diplomatic deepfreeze between the two countries.

"President Bashar al-Assad meets Saudi Foreign Minister Faisal bin Farhan," Syria's official news agency SANA reported.

The Saudi prince arrived in Damascus on Tuesday afternoon on the first visit to Syria's capital by a Saudi official since the start of the country's civil war in 2011.

Assad has been politically isolated in the region since the conflict began, but a flurry of diplomatic activity has been underway in the past week as regional relations shift following a decision by Saudi Arabia and Damascus's ally Iran to resume ties.

The trip comes less than a week after Syrian Foreign Minister Faisal Mekdad visited Saudi Arabia, also on the first such visit since the conflict began.

Last week, diplomats from nine Arab countries met in the Saudi city of Jeddah to discuss ending Syria's long spell in the diplomatic wilderness and its possible return to the 22-member Arab League after Damascus was suspended in 2011.

The diplomats stressed the "importance of having an Arab leadership role in efforts to end the crisis" in Syria, according to a statement by the Saudi foreign ministry.

Saudi Arabia severed ties with Assad's government in 2012 and Riyadh had long openly championed Assad's ouster, backing Syrian rebels in earlier stages of the war. Several other Arab countries also cut ties



with Syria as some powers bet on Assad's

But regional capitals have gradually been warming to Assad as he has clawed back most of the territory lost to rivals, with crucial backing from Russia and Iran.

The United Arab Emirates (UAE), which re-established ties in late 2018, has been leading the charge to reintegrate Damascus into the Arab fold.

Arab outreach

A February 6 earthquake that wreaked devastation in Turkey and Syria sparked Araboutreach to Assad's government, and the surprise rapprochement between Riyadh and Tehran was announced the following month.

Assad himself has visited both Oman and the UAE since the quake.

Russia summons Western

MOSCOW: Russia's for eign ministry summoned theUS, British and Canadian ambassadors for a dressing down on Tuesday after they condemned the conviction of an opposition politician on treason charges.

A Moscow court jailed Kremlin critic Vladimir Kara-Murza, who holds Russian and British passports, for 25 years on Monday after a trial he and the West said was politically motivated.

Kara-Murza, 41, had lobbied Western governments for sanctions that were later imposed on Russia and individual Russians for purported human rights violations, and condemned what Moscow calls its "special military operation" in Ukraine.

The Russian foreign ministry accused the three ambassadors of "crude interference in Russia's internal affairs and activity incompatible with their diplomatic status", Interfax news agency reported.

There was no immediate comment from the three embassies.The US, British and Canadian ambassadors had made a joint appearance in front of TV cameras on the steps of the Moscow court on Monday to condemn the verdict against Kara-Murza and demand his release

British Ambassador Deborah Bronnert delivered her remarks in Russian so that Russian-language TV channels could potentially broadcast them.

Focus On Reproductive Rights Rather Than Soaring Population: UN

Geneva, Switzerland: Rather than fixating on the impact of the world's soaring population, the world should look at women's reproductive rights to shore up "demographic resilience," the UN said Wednesday.

The United Nations Population Fund (UNFPA) -- the UN's sexual and reproductive health agency -- acknowledged there was widespread anxiety over the size of the world's population, which is expected to peak at around 10.4 billion during the 2080s.

But the UNFPA said the focus should be on giving women more power to control when and how they have children.

"The question is: 'Can everyone exercise their fundamental human right to choose the number and spacing of their children?'. Sadly, the answer is a resounding no," said UNFPA chief Natalia Kanem.

She said that "44 percent, almost half of women, are unable to exercise bodily autonomy. Unable to make choices about contraception, healthcare and whether or with whom to have sex. And globally, nearly half of all pregnancies are unintended.'

She said countries with the highest fertility rates contribute the least to global warming and suffer the most from its impact.

In its flagship annual "State of World Population" report, the UNFPA found the most commonly-held view is that the world's population is too big.

But it said that passing the eight billion mark "should be a reason to celebrate. It is a milestone representing historic advances for humanity in medicine, science, health, agriculture and education".

"It is time to put aside fear, to turn away from population targets and towards demographic resilience -- an ability to adapt to fluctuations in population growth and fertility rate," it said.

"The world population is rapidly reordering itself," Kanem told a press conference.

Russian, Ukrainian leaders visit frontline towns, meet troops

KYIV: Ukrainian President Volodymyr Zelensky met troops in a frontline town Tuesday, a day after Russian leader Vladimir Putin visited occupied zones as Kyiv builds up to an expected counteroffensive.While 45-year-old Zelensky spoke with soldiers in the heavily bombarded town of Avdiivka in eastern Ukraine, the Kremlin's footage showed Putin, 70, visiting the occupied territory in the south and east, under a veil of secrecy.

Taliban ban on working women continues A UN statement explained, "UN national personnel in Afghanistan – both women and men – have been instructed not to report to UN offices" during the review period. But it did make "limited and calibrated exceptions" for those involved in "critical tasks." Since their return to power in August 2021, Afghan Taliban have implemented a series of discriminatory measures that restricted Afghan women and girls from participating in most areas of public and daily life.

Weight Loss Tied to Premature Death for Older Adults

much of our lives thinking that a little bit of weight loss might be good for our health. But according to new research, by the time we reach old age, weight loss may be associated with an increased risk of premature death.

A study published April 10 in JAMA Network Open examined the connection between changes in body weight and longevity among healthy older adults, including 16,703 people 70 and older in Australia and 2,411 individuals 65 and older in the United States. None of the participants had any conditions known to cause premature death among older adults, such as cardiovascular disease, dementia, physical disabilities, or life-limiting chronic illnesses.

Over an average follow-up period of 4.4 years, a total of 1,256 people died. Weight loss of at least 5 percent was associated with a 33 percent higher mortality risk for men and a 26 percent higher mortality risk for women. And weight loss of at least 10 percent



was associated with an almost tripled mortality risk for men and a more than doubled mortality risk for women.

"It is important for older adults to be aware that even a small weight loss of 5 percent, especially in the absence of any evident disease, can significantly increase the risk of mortality," says the lead study author, Sultana Monira Hussain, MBBS, PhD, MPH, a senior research fellow at the School of Public Health and Preventive Medicine at Monash University in Melbourne, Australia.

If this happens, people need to

see their primary care provider, because it could be an early warning sign of previously undiagnosed health problems that could hasten death. Dr. Hussain savs.

Can Unintentional Weight Loss Cause Premature Death?

When researchers looked at some common causes of death among older adults, they found that weight loss was associated with increased mortality from both cardiovascular disease and

For example, weight loss of at least 10 percent was associated with a more than tripled risk of

death from cancer among men and an almost tripled risk for women. And weight loss of at least 10 percent was also linked to a more than tripled risk of death from cardiovascular disease among men and an almost double risk for women.The study wasn't a controlled experiment designed increased risk of premature death.

One limitation of the study is that researchers lacked data on why people lost weight, although the study team did note that weight loss surgery — the main cause of this magnitude of weight loss for younger individuals — is rarely done for older adults.

Another drawback of the study is that researchers lacked data on any changes in physical activity levels that might impact both body weight and overall health during the study period, the researchers noted.Unintentional Weight Loss May Be a Sign of Underlying ProblemsThere are many possible reasons why weight loss might indicate medical issues that older adults need to address, says Bellal

Joseph, MD, a professor of surgery at the University of Arizona College of Medicine in Tucson who wasn't involved in the new study.

Unexplained weight loss could be a sign of malnutrition, which can lead to physical weakness, difficulty with mobility, fatigue, and increased risk of infection and to prove whether or how weight chronic illness, Dr. Joseph says. It loss might directly cause an can also be a sign of frailty, a syndrome caused by age-associated depletion of physiological reserves, leading to an increased risk of falls, disability, and death due to increased susceptibility to stressors, Joseph adds.

Weight loss can also lead to loss of muscle mass, which reduces body strength and increases frailty among older adults, Joseph says. And weight loss can also be a sign of depression, anxiety, or

other mental health issues. "If left untreated, any of these can lead to further physical decline and even premature death," Joseph says. "Therefore, it is essential to consult with a doctor to determine the cause of the weight loss and take steps to address any underlying issues.

NEWS Junk food behind fatty liver epidemic in Kashmir: DAK



Srinagar, Apr 19: On World Liver Day, Doctors Association Kashmir (DAK) on Wednesday expressed pressing concern over surge in fatty liver disease which has reached to epidemic proportions in Kashmir valley."Junk food is causing spike in fatty liver cases in the valley," said DAK President Dr Nisar ul Hassan. Dr Hassan said junk food has become routine part of people's lives and has largely replaced homemade meals. Fast food is the quickest meal not just for busy professionals, but there is a rising trend of fast food among children and teenagers. They are often seen eating fast foods like pizzas and burgers. Children are addicted to chips, sugary drinks and frozen ready meals."This change in dietary habits from homemade to processed and convenient foods is the primary factor contributing to enormous burden of fatty liver in Kashmir," he said. The DAK President said according to a new study from the University of Southern California's Keck school of Medicine published in clinical gastroenterology and hepatology, junk food has been found to cause fatty liver disease."If you are obese or diabetic, fast food has even more negative impact on the liver and can lead to even higher amounts of fat in the liver," he said.Dr Nisar said one in three persons in Kashmir have fatty liver and young people are mostly hit. The prevalence of disease is 60-70% among diabet-

ics and obese individuals.

Eating fruits and vegetables may put a person at lower risk of developing heart disease and cancer. Fruit is also an important source of vitamins, minerals, and fiber.

However, fruit can also be high in sugar. People with diabetes must keep a watchful eye on their sugar intake to avoid blood sugar spikes.

That said, there is a difference between the type of sugar in fruit and the type of sugar in other foods, such as chocolate and baked goods.

This article will explore which fruits a person with diabetes should eat and avoid and how they relate to diabetes.

Fruits to avoid

In general, a person should not have to exclude fruit from their diet. In fact, one 2017 studyTrusted Source suggests that eating fruit can actually help prevent diabetes. However, it may be worth people

Fruits high in sugar

The glycemic index (GI) shows how much a certain food can raise a person's blood sugar after they have eaten it.

If a food has a GI score of between 70 and 100, it is high in sugar. Some fruits with a score in this range include:

WATERMELONS

overly ripe bananas

These fruits are still safe for a person with diabetes to eat. However, they should do so in moderation. Consuming larger portions of fruits that have lower GI scores may be more suitable for a person with diabetes.

Most other fruits have a low-tomedium GI score. Learn more about low and medium GI foods here. THE SUGAR MYTH

Many people believe that since fruit

is often high in sugar, people with diabetes should avoid it.

However, the sugars in fresh fruit are not "free" sugars. Free sugars are added sugars and those present in honey, syrups, nectars, and unsweetened fruit and vegetable juices. The sugar in fresh fruit is fructose, which does not have much of an effect on a person's blood sugar or insulin levels, according to one 2017 articleTrusted Source.

Foods such as chocolate, baked goods, and some sodas have high levels of free sugars, which do cause spikes in blood sugar.

Fruits high in carbohydrates

According to Diabetes UK, the amount of carbs a person eats has the most impact on their blood sugar levels. If a person is following a low



carb diet, they should identify which carbs they are eating that are low in nutrients or unhealthy in other ways and cut those out first. Fresh fruit carries many health benefits, so it may not be first on the list.

FRUIT JUICE



The Centers for Disease Control and Prevention(CDC)Trusted Source state that drinking fruit juice during a meal or on its own quickly raises a person's blood sugar levels.

However, the combination of fiber and simple sugars in fruit slows the absorption of sugar into the blood

when a person eats whole fruits. A 2013 research paperTrusted

Source looked at how fruit consumption affects the likelihood that a person will develop type 2 diabetes.

The results showed that people who consumed more whole fruit were less likely to develop the condition. People who drank larger amounts of fruit juice were more likely to develop the condition.

DRIED FRUIT

A person can also include dried fruit in their diet, as long as it was not dried with added sugar.

In a 2017 studyTrusted Source, researchers found a positive correlation between eating nuts and dried fruit and the prevention of type 2 diabetes.

The American Diabetes Association (ADA) confirm that dried fruit can be a good option for people with diabetes, but they should be mindful of the fact that portion sizes can be small.


