SRINAGAR, MAR 14: Women this time will have a decisive role to play during the forthcoming elections in Jammu and Kashmir with their electorate comprising 49 percent of total vote count.

Details available with the news agency-Kashmir News Observer (KNO), out of the total 86.93 lakh voters in Jammu and Kashmir, women make up 42.58 lakh voters. Anantnag leads in women's participation among the five parliamentary constituencies, with 9.02 lakh

Women Will.....

Sabha elections draws near, women have begun actively ensuring their participation. The extent of their involvement as candidates will be revealed once all parties announce their nominees, with several parties, including the BJP, Congress, NC, PDP, Apni Party, and others, nominating women candidates, activating their respective wings.

Pulwama emerges as the sole district in Jammu and Kashmir where women voters outnumber men, with 2726 more women voters than men, out of a total of 403,795 voters. In other districts, male voters surpass female voters.

In a bid to foster a conducive environment for women voters, pink booths will be established in all districts during the Lok Sabha elections, staffed entirely by female employees, an initiative by the Office of the Chief Electoral Officer.

Pertinent to mention that the increased participation of women was evident in the District Development Council (DDC) elections held in 2020, with over 98 percent voter turnout and the occupation of more than five DDCs by women.

Modi Govt.....

Dr Singh informed, adding that the district now has its own radio station for which a demand was raised in 1965, but this genuine demand was never fulfilled by the earlier government. Not only this, Udhampur has a passport office now, he said.

"For the first time, a 9.5 kilometre national tunnel named after Shyama Prasad Mukherjee has been constructed in this district, and North India's first river rejuvenation project undertaken at River Devika undertaken here", the minister said.

Dr Jitendra Singh said this constituency is in near future all set to become a tourist-cum-religious pilgrim destination as well as a centre for learning.

Dr Jitendra Singh underlined that rising above narrow considerations of caste, creed and region, Narendra Modi government's first term was focused on overcoming the shortcomings of the previous governments. In the second term, the government dedicated itself to laying the foundation of a developed India. Now, in its third, the government will solidify its gains and march ahead in the journey of realising Narendra Modi's vision of Viksit Bharat by 2047.

Talking about the success of Lavender revolution in Bhaderwah area of district Doda, Dr Singh said its cultivation is now being taken up in Basantgarh-Dudu area of Udhampur given its success.

He said this region was unknown to the concept of start-ups, but in the last few years it has emerged as a hub of agri start-ups. More and more youth are giving up their secured government jobs and are now joining the Aroma Mission which offers lucrative opportunities to increase their income through the sale of perfumes which sell at high costs not only in the country but also abroad.

The Minister exuded confidence that while in the upcoming general elections, Narendra Modi will return to power, with 400 seats, the voters of Udhampur-Kathua-DodaLokSabhaseataregoing to script a new record by bestowing a 5 lakh plus record margin on Dr Jitendra Singh, and tumble the previous record voter turnout here.

In the last election, this constituency had a

railway project.

"We are not opposed to the railway line, but it should not be laid through our orchards as our economy is fully dependent on this," a fruit grower from Zainapora Shopian said. "I appeal to the PM to consider our demand and divert the railway track."

In Baramulla, civil society members have also demanded a diversion of the railway track, which they said passes through one of the oldest college grounds in north Kashmir.

"It came to the notice that the Department of Railways authorities have earmarked the degree college ground in Baramulla for fleeting the railway track towards Urithat bisects the playground, which is the only available ground in Baramulla," a representation by the Civil Society Baramulla to Deputy Commissioner Baramulla read

The Baramulla administration has written to the Deputy Chief Engineer, Northern Railway Srinagar, and asked him to look into the matter and redress the grievance on merit.

The mainstream politicians, too, have demanded the shifting of these railway tracks.

"The survey conducted by the railways in the apple belt of Zainapora for railroad development has created panic among residents, who fear for their livelihoods. The survey should not be carried out recklessly, as it could impact the livelihood of locals. The concerns of apple cultivators in applerich villages in south Kashmir should be taken into consideration, and efforts should be made to minimize any potential losses," CPIM leader M.Y. Tarigami said.

"These are very genuine demands and merit the government's attention. People are not opposed to the project but are urging the authorities to safeguard their orchard land. We are requesting the J&K government to consider relocating the project by utilizing state-owned land instead," State Spokesperson of the National Conference Imran Dar said.

On Wednesday, Peoples Democratic Party (PDP) president Mehbooba Mufti urged the government to avoid the chopping of fruit orchards and the "haphazard" laying of railway lines in Kashmir.

"Our economy depends on agriculture and fruit industry, and without giving a thought, you lay a railway line through villages and chop down thousands of trees, which are our economy's backbone. This should not be done like this, and experts should be involved. Laying a railway line is right, but cutting trees through every village and damaging the environment should be avoided," she said. (UNI)

petitioners submitted that the administration is shielding the IAS Officers allegedly involved in the arms licenses scam and is sitting over the Prosecution Sanction files deliberately for the last two years and has also posted the tainted bureaucrats on prime positions whereas the Prosecution Sanction was granted against JKAS Officers way back in the year 2021 and several challans have been filed in the CBI Special Courts in UT of I&K.

Advocate Rahul Raina further submitted that there cannot be two laws one for common men and the other for the IAS officers. The Division Bench observed that it is

unable to pass any order in the absence of any Counsel from the government. The Division Bench directed the Registry that a copy of this order be sent to the concerned Ministries of the Union of India and also to the UT Administration for necessary action.

Looking into the importance of the matter the Division Bench directed the registry to re-notify the matter for 23 April 2024.

Pertinently, under this scam, it is alleged that more than 2.78 lakh arms licenses were issued to non-entitled persons in J&K between 2012 and 2016 and all this took place under some top-notch IAS officers. [KNT]

He called on providing them the desirable counselling through social mobilization besides enhancing their capacity to enlarge their enterprises on commercial lines.

The Chief Secretary also took stock of the performance made by the Department in PMAY(G), IWMP and Himayat schemes. He enjoined upon the concerned to meet the targets set under each scheme. He asked them to cover all the beneficiaries eligible under such housing and livelihood generation schemes.

In his presentation the Secretary, RDD, Shahid Iqbal Choudhary gave out the gist of the performance made by the Department under different schemes during the ensuing financial year. He also threw light on the action plans proposed by the Department for the year 2024-25.

The Secretary apprised the meeting that till now around 3.31 crore person days of work had been generated under MGNREGA which is 114% of the target set for the year. It was added that the fund utilization stands at an impressive rate of 97% this year. He further gave out that this year around 1,16,295 works had been completed and 2,95,834 works still going on at different stages of completion.

Regarding the annual action plan 2024-25for MGNREGA it was revealed that the Department is going to augment the critical infrastructure in rural areas in convergence with this scheme. It was given out that the Department is going to accomplish around 195000 works with around 12000 works under convergence mode.

Moreover the plan will lay focus on District

"How did this particular case reach the point of contempt petition which led to VC's personal appearance is a big question which needs thorough investigation," said a senior KU academician, who wished anonymity. He said it is neither good for the institution's image northe dignity of VC's chair that court cases are allowed to reach the stage of contempt petitions.

Meanwhile, after today's appearance of KU authorities before the division bench, the HC listed the matter for further hearing on April 1, after submissions and assurances made by the KU VC on implementation of court directions.

Doctors' warning about artificial ripened fruits leads to 50 pc drop in watermelon sales

SRINAGAR, MAR 15: The

Kashmir Valley has witnessed a 50% decrease in watermelon sales following concerns raised on social media regarding the safety of consuming artificially ripened watermelons.

Dr Wajahat, a clinical oncologist at a premier hospital, recently cautioned against consuming artificially ripened watermelons during the offseason, citing potential cancer risks.

"This Ramzan, say NO to artificially ripened watermelons. Protect yourself from harmful chemicals and potential chemotherapy," Dr Wajahat posted on a social media site X on March 08, which garnered support from several other doctors.

Ghulam Nabi Bhat, a vendor, expressed concern over economic losses incurred since the beginning of Ramadan. He said that despite bringing watermel-

ons to the market, nobody is buying them due to claims made by doctors. Bhat urged the government to investigate the matter to help vendors like him avoid further economic losses. Bashir Ahmad Bashir, chairman of the Kashmir Valley Fruit

Growers Cum Dealers Union, speaking with the news agency-Kashmir News Observer (KNO) said there has been a 50% drop in water melon sales in the valley due to the current situa-



tion. "Previously, the valley used to receive twelve trucks of watermelons daily, but now there has been a 50% decrease in sales," he said.

Bashir said the food department has taken samples of watermelons, and he hopes for clarity soon. "Health is a priority, but economic losses are also concerning. The government should share the test samples as soon as possible," he added. Deputy Commissioner of Food Safety in Kashmir, Shagufta Jalal, said the department has collected hundreds of samples from various districts of the valley for testing.

'The test reports will be available tomorrow," she said. Once the report is available, it will be shared with the public to address any concerns, Shagufta said, adding that there have been no adverse findings so far in the surveillance sampling



EDITORIAL **Ramadan and Kashmir's Power Crisis**



Schools in the Kashmir valley reopened after a hiatus of more than two months of winter vacations. With the introduction of March session last year to make it uniform all over the country, students of all classes had already geared up to face the yearly annual exams. District Institute of Education and Trainings(DIETs) of all the districts of valley had finalized the datesheet of primary and upper primary classes well before the school Reopening. State Council for Education Research and Training (SCERT) Srinagar, also made the datesheet of class 8th public couple of weeks ago.

Accordingly the examination of class 8th of Kashmir division com-

Question no 3 was again asked to check the learning ability of the students in the form of a brief paragraph but this one chosen from the textbook. It was a nicely written paragraph about safron and safron fields of Pampore Kashmir. It also had five part questions which were comfortably answered by students. Part second of the question paper was from the grammar portion. Five different sentances were written on the paper and students had to choose a noun, adjective, verb, subject and predicate from these sentences just to check their linguistic skills.

After many years I have gone through a question paper that was not just designed to check the learning comprehension and a vast amount of knowledge students had acquired during the academic session but they were this time relieved off the stress which they would usually accompany to their exam halls.

Alongside writing the answers to the questions in the exam hall, examinees acquired extra amount of information which they previously lacked while going through the pages of the paper. The question paper seemed an outcome of extensive consultations with stakeholders, experts and research work of months together.

Persons from SCERT, associated with the formulation of such question papers need to be appreciated and they deserve special recognition for discovering the latest scale of measuring students abilities without drowning them in the well of exam-phobia. If the trend goes on, not only the enrollment in public schools will see a surge but the entire educational scenario will be transformed.

Teaching Weak Students

Parents should pay close attention to their children's learning difficulties so that they can acquire reading skills with full understanding and not be disadvantaged in the future based on lack of familiarity with reading skills.

Due to the lack of familiarity with the correct teaching method, children may have difficulty learning and especially reading. Like weakness and hesitation in reading, weakness in spelling and poor retention.

According to Renowned Educationists the biggest difficulty a student faces in reading is matching the letter and its sound. Then it becomes difficult to make a word out of the words. Similarly, there is difficulty in remembering and understand-

ing words that have a slight difference in form. How to overcome reading difficulties?

This can be controlled by following the points given below.

1. The sooner a child's condition is diagnosed, the more likely it is to overcome reading difficulties. When you find out where the child is having difficulty, You will avoid many problems later on.

2. Parents should understand the nature of their children's problems and cooperate with the school in solving them.

3. To provide an environment conducive to learning and understanding that is free from all distractions and stress. The school should collaborate in this matter on the basis of a special Remedial Teaching Programme in the School suitable for each



child according to the type of reading difficulty. 4. Similarly, training to distinguish between adjacent sounds of letters, such as distinguishing between long and

short vowels, and then training to combine letters to form sentences.

5. Training to connect letters to form words and then sentences, then reading the word and matching it to the meaning on the notebook or on the board, made clear and readable by the teacher.

5. Giving the child exercises at home or in the classroom that focus on engaging the mind during the reading proces, also activities that depend on visual perception, visual memory, auditory perception and auditory memory.

6. Trying to practice speed reading, where a text can be chosen to read in a certain amount of time.

Treatment of reading difficulties To provide an environment

suitable for learning and to keep children away from anything that may cause confusion and spoil their concentration. 
The Land-Locked Kashmir

Historically, Kashmir has always been known as a land-locked country in the high Himalayan Mountains. In the earliest Chinese records Kashmir is described as, "a country enveloped on all sides like a precious jewel by the snowy mountains, with a valley in the south which leads up to it and serves as a gate of the Kingdom". Famous Chinese traveller, Hiuen Tsang describes Kashmir which he calls Kia-shi-mi-lo as a country surrounded on all sides by very high mountains which have very narrow and contracted passes for entry. According to him these natural bulwarks have protected the country from its neighbours who have never succeeded in subduing it. The Greek chronicles also mention Kashmir as Kaspeira, a country surrounded by high mountains whose inhabitants are great footwalkers! In fact, this isolation of Kashmir in the high mountains allowed it to remain unmolested for a long time. In ancient Kashmir there used to be an official called the "Dawara Pati", the guardian of the passes whose job was to keep an eye on all passes which were guarded by garrisons of soldiers.

The conquest of Kashmir by Mughals, even though through treachery, ended Kashmir's isolation. However, even with the passing of the country from Mughals to Afghans, to Sikhs and finally to Dogras, the physical isolation continued. The only access was through the Jhelum Valley road along the River Jhelum. After, the events of 1947, even though Kashmir got disconnected from its Central Asian neighbours in the North, yet access became easier towards South. Finally, with the advent of civil aviation, Kashmir is no longer a land locked and isolated "country"! The valley of Kashmir has become a global tourist destination and millions of



almost for six months or so. These include Gurez and Tilel Valleys; Karnah; Wadwan Valley of Kishtwar. The other areas in the State which remain land-locked in winter are Ladakh where totally land-locked is the remote valley of Zanskar. In this modern age it is unthinkable of people getting totally isolated for months on end. They have no access either by road or by air. The people in these areas face not only a physical trauma but also a psychological one. Unfortunately, most of the rulers in recent times have totally neglected this aspect of winter inaccessibility of these remote areas.

After a wait of decades, the government has finally started work on the Zoji La tunnel to ensure year round access to Ladakh by road. This is a welcome step and one hopes the work would be completed on a fast track. It would have been ideal if notice of inaccessibility of other areas had also been taken. The long term accessibility of these areas would also require construction of tunnels below the passes which get closed in winter due to heavy snowfall. These include the Sadhna Pass, the Razdani Pass, the Simthan Pass, the Margan Pass and so on. These passes would need much shorter tunnels which may be cheaper and easier to construct. Let us hope the government keeps the requirements of these people living in remote areas in view and formulates a plan to

make these accessible in winter also.

Pending construction of tunnels, the government could explore connecting these remote areas by short haul turbo-prop aircraft. These aircraft do not need long and concrete runways and can land on small strips and in some cases even in plain fields. Air Asia and the Indigo Airlines do have these small turbo-prop aircraft and are operating services to some areas. The government needs to explore the possibility of inviting these airlines to survey the areas and start such short haul air services. Even these services could be subsidised to allow reasonable pricing of these flights. At the moment, some of these areas in the state are serviced by MI-17 helicopters of IAF for which the government makes payments to the Ministry of Defence. Similar, treatment needs to be given to the Zanskar area also which too remains totally cut off during winter. Here again sometime IAF courier services are operated. The worst part is the assistance to sick people during winter. Sometimes the concerned Deputy Commissioners do requisition heli-





Mamata Banerjee's Condition "Stable" **After Fall At Home, Say Doctors**

Kolkata: West Bengal Chief Minister Mamata Banerjee's health condition is "stable", a senior official of the state administration said on Friday.

The 69-year-old Banerjee, who suffered a major injury on her forehead and nose during a fall inside her Kalighat residence in South Kolkata on Thursday evening, also "slept well", he said."The CM's health condition is stable. She had a good sleep in the night as senior doctors kept a close watch on her throughout the period. This morning there will be another assessment of her condition," the official told PTI on Friday morning.

The Bengal CM underwent three stitches on her forehead and one on her nose and was discharged following necessary medical tests at the hospital.

"She had a cerebral concussion and had a sharp cut on her forehead and nose which was bleeding profusely. Initially, she was assessed by senior doctors of the neurosurgery, medicine, and cardiology departments of our institute and her vitals were stabilised. Three stitches were applied on her forehead, and one on her nose and the required dressing was done. Investigations like ECG, echocardiogram, CT-Scan, and Doppler were done," SSKM hospital director Manimoy Bandyopadhyay said. Meanwhile, police are yet to lodge a complaint in connection with the fall of the chief minister though they have upped the



security arrangements in and around Banerjee's residence in the Kalighat area, an officer said. Referring to SSKM Hospital's bulletin that the CM had a fall "due to some push", the police officer, however, declined to comment on whether they were planning to record the CM's statement or lodge any suo moto complaint in this regard. "As of now, there has been no complaint lodged in connection with the fall of the CM. We have increased the security around the CM's residence," he told PTI, adding that they were looking whether there was any security lapse or not.

Banerjee gets a "Z category" cover and has a special team of officers looking after her security and even at her residence.

Political Sparks Fly As Tripura Royals Enter Electoral Fray With BJP

Guwahati: In a move that has ignited a political firestorm in Tripura, Maharani Kriti Singh Debbarma, a scion of the erstwhile royal family and a member of the Bharatiya Janata Party (BJP), has been nominated as the party's candidate for the Tribal reserved East Tripura constituency. The decision has stoked a controversy with accusations of dynasty politics and opportunism flying thick and fast.

52-year-old Kriti Singh is the sister of Pradyot Debbarma, the founder of Tipra Motha and a prominent figure in Tripura politics. Her candidacy comes on the heels of a tripartite agreement signed between



the Narendra Modigovernment, the Tripura government, and the Tipra Motha, aimed at resolving issues concerning the indigenous population of the state.

Giving a poll ticket to the royal is being seen by many as a strategic maneuver by the BJP, particularly in light of Tipra Motha's recent alignment with the ruling party. Kriti Singh currently resides in Chhattisgarh, where she is married into another royal family. She was given the

ticket instead of the incumbent BJP MP Rebati Tripura. Critics have wasted no

time in lambasting the decision, labeling it as a betrayal of tribal interests and a blatant display of dynasty politics. Jitendra Chaudhury, General Secretary of the CPI(M) in Tripura, condemned the move as a "sell-out" of tribal

rights, pointing out that there were other potential candidates with deeper roots in the state.

BRS' K Kavitha Arrested After Raids Over Delhi Liquor Policy Case

Hyderabad/New Delhi: In a major development in the Delhi liquor policy case, BRS leader K Kavitha has been arrested by the Enforcement Directorate in Hyderabad and is being taken to Delhi, top officials have told NDTV.

Ms Kavitha is a Member of the Legislative Council (MLC) in Telangana and the daughter of Bharat Rashtra Samithi chief and former chief minister K Chandrashekar Rao. She was questioned in the case last year, but had skipped two summons this year.

The arrest, hours after her house was raided by the agency, comes weeks ahead of the Lok Sabha polls and on a day that the Congress government in Telangana completes 100 days. Prime Minister Narendra Modi also held a roadshow in the Hyderabad suburb of Malkajgiri on Friday. The Supreme Court, which had granted the BRS leader immunity from interrogation till Wednesday, also heard her petition against the agency's summons in the case on Friday. The next hearing in the case will be on Tuesday.

In a video, Ms Kavitha's brother and former Telangana minister KT Rama Rao can be seen confronting ED officials after he was asked how family members had entered the house.Speaking to the camera, he names an official of the agency, holds up a document, and says, "Search is over and an arrest warrant is produced, and now she says family cannot come in. She also says that she has no transit warrant, she cannot produce before a magistrate but she wants to make the case (sic)."

Mr Rao goes on to accuse the officials of violating an undertaking the agency had given to the Supreme Court and says, "You are in serious trouble". An ED official is heard telling him that legal remedies are available.

ED sources told NDTV that Mr Rao and other BRS members were obstructing the agency and videos also showed the agency's cars being surrounded when they were leaving with Ms Kavitha.

Mr Rao has, however, claimed the family is cooperating with the agency. Terming the protest illegal, he said he and other senior leaders have asked party workers to remain peaceful and not prevent the arrest.

REASI, MARCH 15: District Development Commissioner Reasi, Vishesh Mahajan, chaired a meeting of the multi-departmental District Level Task Force Committee focusing on the Geology and Mining activities in the district.

The District Mining Officer provided an update, stating that there are a total of 25 mining blocks in the district, out of which 8 are operational while the rest are either closed or seized.

Village Cheki -Sodal in Handwara Still **Awaits Mobile Connectivity**

Handwara, Mar, 15: HT-Despite two decades passing since the launch of mobile telephony. Checki-Sodal village in Jammu and Kashmir continues to be devoid of any network connectivity. Residents of this village in North Kashmir's Kupwara district are still grappling with the absence of mobile connectivity, which has hindered their daily lives and educational pursuits.Local residents expressed their frustration, highlighting the disparity between their village and the rest of the country in terms of phone connectivity. The residents of Checki-Sodal village and surrounding areas urge all concerned parties to prioritize the resolution of this long-standing issue and ensure equitable access to mobile connectivity for all. Excavator among 11 vehicles involved in illegal mining seized in Kathua

What India need from the Indian Premier League

There are around eight spots to fill in India's squad for the T20 World Cup, and the IPL is the best place to identify the right men

NEW DELHI: Whatever you say about prioritising domestic cricket (or not), the IPL will be far more important for international selection than the Syed Mushtaq Ali Trophy. And arguably even T20Is, given how little international T20 cricket India have played since this team management was hurriedly given an extension following the ODI World Cup. So this IPL is huge for contenders for places because there isn't even a week between the IPL and the T20 World Cup in the USA and the West Indies.

Let's firstly look at the players that can be considered reasonable certainties. Any such list should always start with Jasprit Bumrah. Then comes the captain, Rohit Sharma. His opening partner is more or less locked in: Yashasvi Jaiswal. And once you bring back Rohit, there is no way you don't bring back Virat Kohli. There is the added selectorial merit of experience and Kohli's efficiency against high pace. The only other batter who can confidently start putting together his

paperwork for visas is Suryakumar Yadav. Kuldeep Yadav has more or less booked his place as the wristspinner, and Ravindra Jadeja is more or less a given as the fingerspinning allrounder. That's seven spots out of 15.

Keeping that in mind, here is what the selectors will be looking at keenly during the IPL

If, for whatever reason, the selectors and the team management have decided to stick with the core of Rohit and Kohli, opposition spinners will fancy them. Even Suryakumar, a much more effective T20 batter, goes considerably slower against spin than against pace. Left-arm spin, especially, becomes an effective defensive tool against India.

To counter exactly this, India have been backing Shivam Dube, who played the exact same role for Chennai Super Kings in last year's IPL. However, there is one big difference: CSK could do it because of the Impact Player rule, which allowed them to use Dube in that super specialist

role.

Shubman Gill and Ruturaj Gaikwad have good numbers against spin, but that's because they start against the new ball and are in by the time they face spin in the middle overs.

If fully fit and in form, new Mumbai Indians captain Hardik Pandya is a definite starter. That seems a formality now, but the selectors will want to see what kind of role he plays for his IPL team. The other question for the selectors will be: is the selection of Dube, whom the team management has been trying to give some bowling, independent of Hardik's availability?

Not a specialist position anymore. He is a hitter who can keep wicket. Jitesh Sharma is the closest to sealing that spot, but the decision-makers would ideally have liked to see him a little more against international attacks. If there is a slight doubt around him, it is probably because the BCCI had no coach or captain for the T20 World Cup when the recent set of

T20Is began, and the interim team management kept playing Ishan Kishan, which not only deprived a more suitable candidate game time but also gave false hope to Kishan.

One of the great stories of this IPL is going to be the return of Rishabh Pant from the life-threatening accident a year and a quarter ago, but the national selectors might exercise some caution when it comes to rushing him back and that too at a World Cup.

If KL Rahul chooses to bat in the middle order in the IPL and can recreate the effectiveness he displayed for Royal Challengers Bangalore in the middle order in 2016, he can be an interesting option to look at. Especially because he is versatile and can be one back-up batter for more than one role.

Not exactly a separate head count but when they pick players for the aforementioned roles, they will have to consider at least two who can hit high pace in overs 17 to 20. Rinku Singh has been doing that role; there is no pressing reason to keep him out of the 15, but the final XI will be a challenge once everyone is back.

Bumrah is there for sure, but India need at least two more quicks for the starting XI. At the moment, no one is closer to sealing the place than the other. Ideally, they should be able to hit a six or two, but the selectors are not exactly spoilt for choices. The last squad had Arshdeep Singh, Avesh Khan and Mukesh Kumar. Mohammed Siraj, who was key in the Tests against England, will definitely be back in the mix. If Mohsin Khan, who has had his fitness issues, is bowling for Lucknow Super Giants, he is someone the selectors will want to look at.

You can have four of them. The selectors will have to choose among a fourth fast bowler, another wristspinner in Ravi Bishnoi, a spin-bowling allrounder in Axar Patel, an extra wicketkeeper-hitter who can possibly be batting back-up, a top-order back-up in the mode of Gill, and a pure middle-order hitter.

manent. During the trial period, no team was found to have exceeded the one-minute limit between overs three times in an innings, and so the five-run penalty has not yet been imposed for this offence.

In addition to the stop clock, there are two other penalties that can be imposed to police over-rates in limited-overs cricket - a fielding penalty and monetary fines.

The fielding penalty is laid out as follows: if the fielding side fails to begin the final over of the innings by the stipulated cut-off time, after accounting for delays, they will have to bring an extra fielder into the 30-yard circle for however many overs are remaining in the innings. So they will be allowed only four fielders outside the circle, instead of five, for



the duration of the penalty. This rule, introduced in early 2022, applies to both men's and women's limitedovers games.

The monetary fine includes a 5% cut in the team's match fee for every over they are short of the minimum required over rate, after the umpires have taken into account allowances for unavoidable delays. The fine for the captain is double that of his teammates, and the fines are capped at 50% of the match fee.

The 2024 T20 World Cup in the USA and West Indies in June will have reserve days in place for the semifinals and final, in case of delays and interruptions. And each of those knockout games will require a minimum of 10 overs per innings to constitute a completed game. For the group stages, the minimum requirement remains five-overs-per-side to constitute a match, as is the norm for T20 cricket.

The 2026 Men's T20 World Cup, like the upcoming edition, will comprise 20 teams, with 12 automatic qualifiers: the two hosts India and Sri Lanka as well as the other teams that make the Super Eights at the 2024 T20 World Cup. Then, two to four teams (it will be fewer than four if India or Sri Lanka finish outside the top eight in 2024) are decided by who are the next highest-ranked teams in the ICC's T20I rankings on June 30, 2024. The remaining eight spots for 2026 will be decided through the usual regional qualifiers pathway.
