SRINAGAR, MAR 16: Citing "additional security requirements" as a reason for not holding concurrent elections in Jammu and Kashmir, the Election Commission of India (ECI) Saturday announced a 7-phased Lok Sabha poll schedule with J&K's one seat going to polls on April 19.

"There will be seven phased Lok Sabha elections in the country including J&K that will commence from April 19," the CEC said in a press conference at New Delhi, as per news agency-Kashmir News Observer (KNO).

As per the schedule, Udhampur LS seat will go to polls on April 19, Jammu

To a query that ECI didn't announce simultaneous polls for J&K, the CEC said that J&K's Re-Organisation Act was passed in 2019 and Assembly seats were 107 including 24 reserved for PoK people. "After that, a delimitation exercise was done and a delimitation act passed. The number of seats reached 114 including 24 reserved for PoK. These two acts were not in sync till December 2023. So our meter for Assembly polls started in December itself," he said. "During our recent visit to Srinagar and Jammu, the J&K Administration clearly told us that there can't be two elections at a time due to more security requirements. The Administration told us that there will be roughly 8 to 9 candidates for each assembly segment which means approximately, there will be 1000 candidates in fray. This means, each candidate needs to be given proper security cover and for that there was more requirement of additional forces.

However, the CEC said that the Commission is committed to hold Assembly polls in J&K soon after Lok Sabha polls when security forces will be avail-

In reply to a query, the CEC said that Electronic Voting Machines (EVMs) are very safe and secure. "There is no question of any discrepancy as far as EVM is concerned," he said.

Earlier, the CEC appealed to the Political parties to refrain from hate speeches and abuses during the campaigning. On the total number of voters, he said that there are 97 Crore voters registered in the country. He said that the major challenges for the ECI in the upcoming elections are: 4M's--Muscle, Money, Misinformation and MCC violations. "Let me clarify that there will be no place for violence in elections." he said.

The CEC Rajiv Kumar welcomed two newly appointed commissioners—Gyanesh Kumar and Sukhvir Singh stating that the "our team is now complete." "We are committed to give nation a truly festive atmosphere for polls," he said, adding that the counting of votes will be done on June 4.

### As ECI announces.....

incumbent Member of Parliament from Srinagar constituency, Dr Farooq Abdullah has termed the decision has disheartening, saying that the time was apt to implement the Government of India's vision of One Nation and One Election.

"We are very disheartened that the assembly polls have not been announced. Four states are slated to go for the simultaneous assembly polls, but in J&K, we have been denied the elections since 2014," he said.

He added that there could be some suspicious reasons for being out behind the curtains by delaying the assembly polls in Jammu and Kashmir.

Congress leader, Ghulam Ahmad Mir, while talking to KNO said that the general elections were expected to be announced simultaneously with the rest of the country, but the people in Jammu & Kashmir were hoping for the concurrent parliamentary and assembly elections.

"If the situation is conducive for the LS polls in J&K then why not for the assembly elections," he said and termed the statement of ECI about the requirement of additional security for conducting assembly polls as a fake reason. "India is not a small state, when security can be arranged for the four states then why can't for J&K. This is nothing but a fake reason," he said.

Apni Party Senior Vice President, Ghulam Hassan Mir also expressed disappointment over the ECI's decision. He said that they were expecting the ECI to announce concurrent assembly and parliamentary polls in J&K.

"It is unfortunate the assembly polls have not been announced by the ECI when people were expecting it. We demand that there be early assembly polls in Jammu and Kashmir." Mir said.

Peoples Conference (PC) spokesman, Adnan Ashraf Mir said, "I don't think we were of the opinion that the simultaneous polls will be announced in J&K, but we hope the assembly polls are held before September this year. The Supreme Court has already passed a direction to ECI in this regard and we just hope that the directions are followed and assembly polls are held before September 2024."

According to CEC Rajiv Kumar, there are 96.8 crore people who are eligible to cast vote, of which, approximately 47.15 crore are women.

Expressing confidence that NDA will win 400 seats, Union Home Minister Amit Shah said, "This time under the leadership of Modi ji, NDA is going

## NIA Chargesheets.....

Superintendent of J&K Police were killed During the initial shootout, another soldier was also injured and his body was found on the third day of the operation.

The operation lasted for seven days in which top Lashkar-e-Toiba Commander Uzair Khan was killed.

NIA said the chargesheet was filed today before the NIA Special Court, Jammu, against Mohammad Akbar Dar and Ghulam Nabi Dar, both residents of Kokernag area of Anantnag. The duo have been charged under various

sections of IPC, Arms Act and UA(P) Act. NIA Investigations revealed that the two accused were working as overground work-

ers (OGWs) for Uzair Khan. "The duo was helping the terrorists active in the area to commit terror acts & activities in the UT of Jammu and Kashmir. They were providing information about the movement of the security forces, along with logistic support in the form of food, daily need items, etc. They were also harbouring terrorists by providing them shelter," the NIA investigation

The NIA said the terrorist killed in the encounter was an active member of The

Resistant Front (TRF), an off-shoot of LeT. They said Uzair had joined the LeTin August 2022 and was involved in promoting terror activities against security forces in Anantnag area through Pakistani handlers from across

"He had also been involved in earlier terror incidents in the Kokernag area, and on previous two occasions, he had managed to flee from the clutches of the security forces after taking advantage of the mountainous/forest terrain," NIA spokesman said.

"Both LeT and TRF are proscribed organisations and have been involved in continuous instigation/motivation of Kashmiri youth to oin the terror outfits in the name of Jihad," he added.

The NIA said LeT is the largest terrorist group formed in early 1990s, and actively engaged in reviving the network in the Anantnag area. It is working through various offshoots in Jammu & Kashmir region.

"The two outfits are operating on social media platforms like Twitter, Telegram and Youtube channels to promote their cause and lure unemployed youth to carry out terror activities," NIA said.

The case was initially registered on September 13, at Police Station Kokernag in Anantnag district, and re-registered by NIA on December 5. (UNI)

That's a better way of looking at things, that is how I look at things,' the CDS said.

"They retained their capabilities..., so, Pakistan remains a threat, you can't say that Pakistan armed forces will not remain a threat. Yes, there may be a challenge for them to fight a long war because of the current economic problems which they have. But they remain a threat for us," he added.

The remarks from the top general of the armed forces comes days after the Indian military conducted the mega exercise 'Bharat Shakti' at Pokhran near the international border, where it showcased the prowess of its indigenous defence equipment and platforms.

Gen Chauhan and other members of India's top military brass had also witnessed the exercise held in the field firing range located in the arid terrain of Pokhran in Jaisalmer district.

As far as the border is concerned, they are "reasonably well secured", the CDS said during the conclave.

"We have resources to take care of our borders, especially disputed borders in the north very well," he said. (Agencies)

# **Expert advises diabetics to monitor diet** during Ramadan Sehri for fluid balance

Advises limiting salt, sugar & spice intake; taking water to stay hydrated

**SRINAGAR, MAR 16:** People, especially those who are diabetic, need to limit the intake of salty, sugary and spicy food during Sehri (pre-dawn) meals in Ramdan to maintain fluid balance in the body, a noted endocrinologist said.

Speaking with the news agency-Kashmir News Observer (KNO), Dr Shariq Masoodi said that people, particularly those with diabetes, should control their consumption of sugar, salt and spices in their meals. "The sodium present in foods aids in maintaining fluid balance, but excessive intake of salty, sugary, and spicy foods can lead to increased thirst as water is with-

Dr Masoodi advised people to drink water regularly throughout Sehri but cautioned against consuming large quantities at once, as it may be quickly eliminated through urine. He suggested alternatives such as lemon water,

buttermilk(lassi), coconut water,

and unsweetened fruit juice while

recommending avoidance of caf-

feinated beverages due to their dehydrating effects. For Sehri, Dr Shariq recommended starting with water followed by a balanced diet consisting of green leafy vegetables for fibre, whole grain cereals with a low glycemic index to avoid sud-

During Iftari, he advised diabetic people to consume sugarfree fluids and limit themselves to one to three dates based on their disease control. Foods high in carbohydrates, salt, and fat should be avoided.

"The diabetic patients need to monitor blood sugar levels and check their levels several times a day, including before dawn, in the morning, midday, mid-afternoon, before sunset, two hours after Iftar, and anytime symptoms of hypoglycemia, hyperglycemia, or feeling unwell arise,"

The endocrinologist emphasised the necessity of proper sleep, recommending 7-8 hours of sleep even if it's divided into two por-

# Edu Deptt grants one time exemption in favor of teaching, other staff who acquire higher qualification in service

SRINAGAR. MAR 16: School Education Department has granted post facto approval to those teachers and other staff of the department who have acquired higher qualification through distance or online mode while being in service without any approval from the competent author-

The department in an order said that it was a one time exemption in favor of teaching and other staff of School Education Department who have acquired higher qualification during service through distance or online mode without obtaining prior permission from the administrative

According to the news agency— Kashmir News Observer (KNO), the Administrative Secretary School Education Department Piyush Singla said, "The issue is related to accord of permission in favor of teaching and other staff of School Education Department who have acquired higher qualification during service through distance or online mode without obtaining prior permission from the competent authority i.e. administrative department, which has now become impediment in finalization of seniorities in various disciplines and cadres.'

Singla in the order further said that it has observed that there are a number of incumbents who have acquired their higher qualification without obtaining prior permission from the competent authority "The cases were further examined in light



of government order issued in 2012 and 2017 regarding the validity of degrees obtained through distance mode," reads the order.

School Education Department further said that the matter was taken up with the finance department for opinion. The finance department in 2023 returned the case file with certain observations and relevant

"School Education Department may regularize the permission granted to the teachers for acquiring higher qualifications through distance mode or online mode in terms of circular instructions issued by the Finance Department in the year 2022,"

The order further reads that the finance department had said the permission should be granted only if the Universities or institutions are recognized by the UT Government.

"The courses are recognized. Proper entries of the leave availed for the duration of the examinations are recorded in the service book of the

"Sanction is accorded to grant one-time exemption in favor of teach $ing \, and \, other \, staff of School \, Education$ Department who have acquired higher qualification during service through distance or online mode, as on date without obtaining prior permission from the competent authority i.e.

Administrative Department subject to the fulfillment of conditions as conveyed by Finance Department," it reads.

The order further states that no case for post-facto permission for acquiring higher qualification shall be entertained by the Department henceforth, and only prior permission cases shall be decided as per set procedure or norms.

Modern slavery is defined by UNO (United Nations Organizations) as "The recruitment, harboring, transportation, provision, or obtaining of a person through the use of force, fraud, or coercion for the purpose of exploitation". The modern slavery effects society, which lasts for the rest of their lives and can have impacts on subsequent generations. Slavery skews demography, deteriorates agricultural production, increases gender discrimination and violence. The main victims of modern slavery are men, women and children of all ages.

# Sex trafficking is a form of modern day

In which a person gets exploited by trafficker which leads to the deterioration of individuals well being. International Labour Organization (ILO) reported 4.5 million victims of forced sexual exploitation and is increasing at an alarming rate Elements of modern slavery are child slavery, forced criminality, domestic servitude, sexual exploitation, forced labour, forced marriage and sex trafficking. It is being told that the most common form of modern slavery is forced labour and forced marriages. Roughly 49.6 million live in modern slavery out of which 22 million people are in forced marriage. There are myriad causes of Modern day slavery such as:

Lack of knowledge is a major cause of mental slavery. When people don't have access to knowledge, they are more likely to be vulnerable to the opinions and beliefs of others, which can limit their ability to think critically and make independent decisions.

In particular, individuals who lack education and access to information are more susceptible to falling into mental slavery without a solid foundation of

Mental slavery can also be the result of socialization oppression, in which we are bound to certain beliefs, values and even behaviors that are enforced on us through social norms.

Trauma and fear::Trauma cum fear can be also part of mental slavery, mostly when the situations, arise the individuals feel powerless. Trauma can lead to disempowerment and fear can lead a desire for safety and security which can be exploited by those who are in power or higher ups.

Psychological factor mental slavery can also be influenced by psychological factors, such as low self-esteem, lack of selfawareness, fear of uncertainty. These factors can lead to difficult for any individual to break the chains of slavery system and beliefs, even can lead to the sense of discomfort or resignation as per the circumstances.

The world which prides towards the progress, it is unsettling to confront the hidden reality of modern day slavery. We can't turn blind eye on the sufferings facing countless individuals. Need of hour, is the collective Conscious ness to break this chainof mess for the betterment of tomorrow.

# **Voting Period Of 2024 Lok Sabha Polls Longest Since First General Elections**

New Delhi: The voting period for the 2024 Lok Sabha polls, spread over 44 days, would be the second longest after the first parliamentary elections of 1951-52 that lasted for more than four months.

The shortest voting period for a general election in the country was in 1980 and it was just four days. The total days of the electoral process this time, from the announcement of the polls by the Election Commission on Saturday till counting of votes, is 82.

Lok Sabha polls will be held in seven phases beginning from April 19 and the counting of votes will take place on June 4 for the world's biggest election exercise in which Prime Minister Narendra Modi will bid for a third consecutive term.

Kumar, however, said more phases have to be held in larger states, which have higher number of constituencies and candidates. The country's first general election



was held between October 25, 1951, and February 21, 1952, the longest so far. During the 1951-52 election, 489 seats of the Lok Sabha were allotted across 401 constituencies in 25 states.

There were 314 constituencies electing one member using the first-past-the-post system, and 86 constituencies elected two members, one from the general category and one from scheduled castes or scheduled tribes. One constituency elected three representatives.

Due to the challenging logistics,

the election was held in 68 phases. Majority of voting took place in early 1952, but Himachal Pradesh voted in 1951 as its weather was commonly inclement in February and March. The remainder of states voted in February-March of 1952, except for Jammu and Kashmir, where no voting took place for Lok

Between 1962 to 1989, the duration of the Lok Sabha elections was between four to 10 days. The shortest election was held in 1980 - from January 3 to 6 - when Indira Gandhi

Sabha seats until 1967.

was voted back to power. Dates are decided based on the geography of regions and other factors such as public holidays, festivals and examinations, Chief Election Commissioner (CEC) Rajiv Kumar said at a press conference on Saturday when asked about the long-duration of polls.

He was also asked if this long schedule could work against opposition parties.

"It has been asked why elections are being held in seven phases and opposition parties have alleged that it may disturb the level-playing field...," Kumar said.

"Look at the geography of the country...there are rivers, mountains, snow, jungle, summers... think of the security forces' movements, they will move in the gaps between phases, through the length and breadth of the country... imagine the pressure on them. There are festivals and exams... when we sit with the calendar, we fix one date, then it has to be changed...," he said.

# In Chhattisgarh, BJP Eyeing To Knock Out Congress In All 11 Lok Sabha Seats

Raipur: An upbeat BJP is eyeing to knock out the Congress in all 11 Lok Sabha seats in Chhattisgarh after its landslide victory in the recent assembly polls in the state, where the grand old party is striving to overcome its shock defeat.

Lok Sabha polls in Chhattisgarh will be held in three phases on April 19, April 26 and May 7. Counting of votes will be held on June 4.

The ruling party hopes to continue the momentum, powered by the 'Modi factor', after it fulfilled various promises, particularly those made to farmers ahead of the state polls, while the Congress seeks to highlight issues related to agriculture, rising inflation, unemployment, and caste census to make a case for it.

The BJP, energised by Prime Minister Narendra Modi's call for 'Abki bar 400 par', has declared candidates for all 11 seats in the state, dropping four sitting MPs and introducing an incumbent state minister into the mix. Three women leaders, including a former MP and a former MLA, figure in its list.

The Congress has announced six names  $for Chhattisg arh so far, picking \, experienced$ leaders like former chief minister Bhupesh Baghel, two former state ministers and a sitting MP. Four of these are from the Other Backward Classes (OBC), and one belongs to the Scheduled Caste (SC) community.

Just a year ago, the then ruling Congress in the state appeared comfortably placed, riding high on populist schemes and regionalism rhetoric, but the scenario turned on its head in the assembly polls held in November 2023.

The BJP captured 54 seats in the 90-member assembly after running an aggressive campaign on corruption plank, Hindutva and populist promises and topped it with several rallies by PM Modi. Congress managed to win 35 seats, 33 less than it had won in 2018.

In the latest state assembly polls, BJP saw its vote share leap to 46.27 per cent from 32.97 per cent in 2018, while that of Congress dropped from 43.04 per cent to 42.23 per cent.

Since Chhattisgarh was carved out of Madhva Pradesh in 2000. Congress has not fared well in Chhattisgarh in the parliamentary elections of 2004, 2009, 2014

# In Bengal, BJP To Test Mamata Banerjee's Mettle Over Sandeshkhali, Corruption

Kolkata: The gloves are off and battle lines drawn for yet another high-voltage political face-off between Mamata Banerjee-led Trinamool Congress and its prime challenger, the BJP, in West Bengal where 42 Lok Sabha seats, the third highest in India after Uttar Pradesh and Maharashtra, are up for grabs.

Elections to the 42 Lok Sabha seats in West Bengal will be held in seven phases between April 19 and June 1.

While the opposition INDIA bloc fell through in Bengal with Ms Banerjee choosing to walk the 'Ekla Cholo Re' path, the state Pradesh Congress is still keen to forge ties with the Left parties whose hands it already held formally during the 2021 state polls. An official alliance between the two sides for the upcoming Lok Sabha elections is yet to be announced, though.

The BJP, on its part, is likely to rely on its consistent trump card, the popularity and persona of Prime Minister Narendra Modi, while reaching out to the state's electorate.Licking its wounds from the drubbing in the state polls where the TMC restricted the party to just 77 seats in the Assembly floor that hosts furniture for 294 members, the BJP has had a fresh lease of life over issues of widespread corruption under Ms Banerjee's rule and, more lately, allegations of land grab and sexual abuse of women against TMC leaders in the nondescript hamlet of Sandeshkhali in the Sunderbans delta.

For all practical purposes hence, the poll turf of Bengal looks set to witness yet another bare-knuckle PM Modi versus Mamata political fight where the saffron brigade would try and do its best to upset



the Trinamool apple cart by improving upon its previous tally of 18 seats, considered, much to the chagrin of the state's ruling dispensation, the party's best performance yet.

The issues around which the largely three-cornered contest in the state is likely to be centred are as follows:

1. Corruption: Perhaps the most potent of ammunition in BJP's weaponry, the issue of alleged widespread corruption in Trinamool ranks seems to have pushed the party on the political back foot. Although Ms Banerjee calls the phenomena nothing more than an "aberration in the party", top TMC leaders continue to languish in iail for alleged recruitment scams in schools and civic bodies, irregularities in food grain distribution and even crossborder cattle smuggling.2. Sandeshkhali and women voters: What broke out as an organised violence on a raiding ED team at TMC strongman Shajahan Sheikh's Sandeshkhali residence in early January, quickly metamorphosed into villagers' protests against forceful land grab and sustained sexual atrocities on women.

Previously, in 2019, following the Prime Minister's "Chowkidar" slogan, BJP leaders, as well as members of the general public, had appended "Main Bhi Chowkidar" to their names.

# BJP Aims For 10/10 In Haryana Again In Lok Sabha Polls, Faces INDIA Bloc Challenge

Chandigarh: Just days before the elections were announced, the ruling BJP made a bold move in Haryana. It replaced Manohar Lal Khattar with state unit president Nayab Singh Saini as chief minister, broke its coalition with the JIP and proved its majority through a trust vote in the assembly.

The chief minister switch comes a few months ahead of the assembly polls, and the BJP may have wanted to bring in a fresh face after the two Khattar terms.

But the move is also seen as an attempt to consolidate Haryana's non-Jat vote for the parliamentary polls which will be held in the state on May 25 in the sixth phase of voting.

Mr Saini is from the Other Backward Class community and will help in the consolidation of the non-Jat vote in the state. Simultaneously, the BJP has ditched the Jannayak Janta Party, which came to its rescue when it failed to win a majority in the Vidhan Sabha after the 2019 assembly polls.

Earlier that year, the BJP had won all 10 Lok Sabha seats in Haryana. Particularly after the recent moves, the party is aiming for a repeat performance.

Routed in the last general election, the Congress is the main opposition to the BJP in the state. In a seat-sharing arrangement with the Aam Aadmi Party, the Congress is fighting nine seats in the state, leaving Kurukshetra for the AAP.The JIP and its parent party, the Indian National Lok Dal (INLD), too are in the fray. Both woo the Jat vote.



The BJP will look to cash in on the "clean image" and "transparent administration" provided by previous chief minister Khattar, and highlight the work done by the BJP governments at the Centre and in the state over the past decade.

The Congress is counting on the antiincumbency factor, somewhat mitigated by the change of CM's.

It will also bank on the popularity of state leaders like former state chief minister Bhupinder Singh Hooda, Randeep Singh Surjewala and Kumari Selja.

In 2019, among the major upsets for the Congress was Mr Hooda's defeat to BJP's Ramesh Chander Kaushik from Sonipat. The party also lost Rohtak, the only seat it had won in the 2014 Lok Sabha polls.

Over the years, the BJP has been trying to make inroads in the Jat-dominated Deswali belt which also comprises the Sonipat and Rohtak regions.

In 2014, the BJP won seven of the eight seats it contested, while the INLD won two and the Congress one - a less onesided affair than the 2019 polls.

# **CBI Arrests Shajahan** Sheikh's Brother In **Attack-On-Officers Case**

 $New\,Delhi: The\,CBI\, on\, Saturday\, arrested\, three\, people,$ including the brother of suspended TMC leader Shajahan Sheikh, for being allegedly involved in the January 5 attack on an Enforcement Directorate team at Sandeshkhali in West Bengal, officials said.

Sheikh Alomgir, who is Shahjahan Sheikh's brother, Mafujar Molla, the president of the TMC's student wing in Sandeshkhali, and Sirajul Molla, a local, would be produced before a local court on Sunday.

The agency took into custody Sheikh's brother and two others during their questioning. The Central Bureau of Investigation (CBI) took over three FIRs registered by the West Bengal Police on the directions of the Calcutta High

After detailed examination, and according to technical evidence collected, they were arrested by the CBI today, the officials said.

With these arrests, the number of people nabbed by the CBI in the case has increased to 14.

The agency suspects that these people were allegedly part of the attack on Enforcement Directorate (ED) officials on January 5 and instigated a crowd to target the team when they went to raid the premises of Sheikh at Sandeshkhali in West Bengal, they said. Sheikh was arrested on February 29 after 55 days on the run following violent protests led by women, alleging sexual atrocities and land grab. He went missing after a mob attacked the ED team that went to search his house in an alleged ration distribution scam.

The state CID took over the investigation into the allegations against him. He was later handed over to the CBI on an order of the Calcutta High Court.

On March 10, the court sent him to CBI custody for four days which was later extended by another eight days -till March 22.

The CBI has taken over the investigation in three cases related to incidents on January 5, when the ED team was attacked by an around 1,000-strong mob. A former state minister has been arrested in the ration scam case.

# "This Is A Different India Today, Now Able To Seek Its Own Solutions": S Jaishankar

New Delhi: Weighing in on the changing global perceptions of India, External Affairs Minister S Jaishankar said the world now sees the country as one that is able to "seek its own solutions".

He said the country stood up for its consumer interests, energy choices and national security, stressing that "this is a different India today".

Speaking at the ET Awards 2023 where he was honoured as the 'Reformer of the Year', Mr Jaishankar said, "Today when the world thinks of India, the world actually sees a country which is able to seek its own solutions, speak its own mind, which will stand up, which stood up for our consumer interests when it came to its energy choices, which stood up for its national security when it came to deploying on our northern frontiers and in staying with the Quad. So this is a different India today, and I cannot tell you how



proud I am to represent it abroad." Mr Jaishankar noted that India, in the past few years, has left a deeper imprint on world consciousness. He said the world saw how India has tackled challenges such as the Covid-19 pandemic and shipped vaccines and other life-saving drugs to 100 nations around the world under 'Vaccine Maitri' even as it was dealing with a public health emergency in its

own backyard.

Highlighting India's global outreach, Mr Jaishankar said, "In the last few years, there's no question we have left a deeper imprint in the world consciousness. When they think of India today, if one is talking in terms of challenges, they see how we handled Covid, how we became through Vaccine Maitri a provider of vaccines to 100 countries across the world. They note

how we take care of our citizens abroad. It could be 'Operation Ganga' or 'Kaveri' or 'Ajay'. It could be the 'Vande Bharat' mission during Covid. They see today the achievements of our businesses in projects abroad, in terms of exports which have gone up. They note, of course, the enormous progress that India itself is making."

Speaking at the event, the External Affairs Minister touched on the burgeoning Indian economy, saying, "They (the world) see today that despite the tremendous global headwinds, this is an economy that is growing at 8 per cent. The fifth-largest economy was 11th (even) a decade ago. It will be (the) third hopefully very soon."

Mr Jaishankar said that the world, even after coming out of the pandemic, continues to face different challenges like the conflict in Ukraine, the conflict in Gaza and maritime concerns in the Red Sea. "There are other issues, some on our borders, some beyond. So the world is not without its challenges," he said.

# New York Judge Orders 30-Day Delay In Trump Hush Money Trial Case

New York: The New York judge presiding over Donald Trump's trial for allegedly covering up hush money payments linked to extramarital affairs ordered a delay Friday in proceedings that had been scheduled to get underway on March 25.

"Trial on this matter is adjourned for 30 days from the date of this letter on consent of the People," Judge Juan Merchan said in a court filing that will push the trial to at least mid-April.

The exact date will be determined at a hearing on March 25 which will also address complaints by the defense team about the disclosure of evidence ahead of trial, the letter said. Prosecutors preparing to try Trump, the first for-



mer US president to face criminal prosecution, said Thursday they would accept a delay of up to 30 days after both sides received a deluge of case documents.

Trump, seeking a comeback as the Republican candidate in this year's election, is accused of covering up hush money payments related to his successful 2016 bid for the White House.

"An immediate adjournment is appropriate," Trump's legal team wrote on Thursday in a letter to the judge.

But it argued "thirty days is not sufficient given the volume of recently produced materials and the nature of the ongoing disputes."

Prosecutors say Trump illegally covered up remittances to his long time aide Michael Cohen to reimburse him for payments made to bury stories revealing Trump's alleged extramarital sexual relations with porn star Stormy Daniels and a Playboy model. He denies the charg-

A New York grand jury indicted Trump in March 2023 over the payments made to Daniels, whose real name is Stephanie Clif-

Trump has previously described the proceedings as a "disgrace."

"It's a rigged state. It's a rigged city. It's a shame." he had said.

# Indian-Origin Couple, Daughter Burnt To **Death At Canada Home**

tain the cause."At this time. we are investigating this with our homicide bureau, and we are deeming this as suspicious as the Ontario Fire Marshal has deemed that this fire was not accidental," Mr Young told news channel CTV.A fire engulfed a home at the Big Sky Way and Van Kirk Drive area of Brampton on March 7, a press release by the Peel Police said.

Eyewitnesses reported hearing a loud explosion before the inferno engulfed the residence, adding to the puzzling circumstances surrounding the incident. Kenneth Yousaf. a neighbor of the deceased family, recounted the harrowing moment when he witnessed the house fully

engulfed in flames. Yousaf said he was alerted to the fire last week by a family member, who heard a big "bang." "When we came out, the house was on fire. So sad. Within a few hours, everything was down to the ground,'

OTTAWA: Canadian Prime Minister Justin Trudeau, whose Liberals are trailing badly in the polls, said on Friday he thought about quitting his "crazy job" every day, but

# Macron Warns Allies Against Imposing Limits On Support **For Ukraine**

Paris, France: French President Emmanuel Macron on Thursday warned allies against imposing limits on support for Ukraine, saying European security was at stake in Kyiv's battle against the Russian invasion.

With Ukraine suffering military setbacks since the failure of a counteroffensive last summer, Macron had last month shocked some allies by not ruling out sending Western troops to Ukraine. He said in an interview with French television aimed at clarifying his policy that the sending of ground forces was not on the agenda now but Europe had to keep "all options" open in case the war spread.

Macron's comments came as he prepares on Friday to travel to Berlin for a summit on Ukraine with allies German Chancellor Olaf Scholz and Polish Prime Minister Donald Tusk.

He rammed home his insistence that Europe should not show weakness and do everything it could to stop Russia winning a war that threatened the security of ordinary French and European citizens.

"If Russia wins this war, Europe's credibility will be reduced to zero," Macron said in the interview with French broadcasters TF1 and France 2 television.

# India Abstains From Voting On UN Resolution On Islamophobia

United Nations: India abstained in the UN General Assembly on a draft resolution introduced by Pakistan and co-sponsored by China on Islamophobia, asserting that the prevalence of "religiophobia" against Hinduism, Buddhism, Sikhism and other faiths facing violence and discrimination must also be acknowledged rather than singling out just one religion.

The 193-member General Assembly adopted the resolution 'Measures to combat Islamophobia', introduced by Pakistan on Friday, with 115 nations voting in favour, none against and 44 abstentions, including India, Brazil, France, Germany, Italy, Ukraine and the UK.

India's Permanent Representative to the UN Ambassador Ruchira Kamboj voiced condemnation of all acts motivated by anti-Semitism, Christianophobia and Islamophobia but asserted that it is crucial to acknowledge that such phobias extend beyond Abrahamic religions.



"Clear evidence shows that over decades, followers of non-Abrahamic religions have also been affected by religiophobia. This has led to the emergence of contemporary forms of religiophobia, particularly anti-Hindu, anti-Buddhist and anti-Sikh sentiments," she said, in an explanation of India's position on the resolution.

India stressed that the adoption of the resolution should not establish a precedent that could result in numerous resolutions centred on phobias tied to specific religions, "potentially dividing the United Nations into religious camps." "It is crucial for the UN to maintain its stance above such religious concerns, which have the potential to fragment us rather than unite us under the banner of peace and harmony, embracing the world as one global family," Kamboj said.

India called on all member states to consider the broader scope of religious discrimination that persists globally.

"While the issue of Islamophobia is undoubtedly significant, we must acknowledge that other religions are also facing discrimination and violence. Allocating resources solely to combat Islamophobia, while neglecting similar challenges faced by other faiths, might inadvertently perpetuate a sense of exclusion and inequality,"

Dr. Vijay said that it is a significant milestone for us, marking a culmination of hard work. dedication, and innovative thinking. Developing sustainable solutions has always been a core focus for us, and this patent approval reaffirms our commitment to environmental stewardship, he said.

"Mostly our biodegradable packaging film offers a sustainable alternative to traditional packaging materials, addressing the growing need for eco-friendly solutions in today's market," Dr Vijay said.

He said that the present invention relates



to a biodegradable packaging film comprising agarose, neem gum, hydroxyapatite and polysorbate 80. "The invention also relates to a process for the preparation of said biodegradable packaging film. The present biodegradable packaging film incorporates natural ingredients and is prepared by green synthesis," he added.

Another team member of the group, Dr. Vishal Sharma said in today's era, the most pervasive and enduring recent change to the environment is the accumulation and fragmentation of plastics.

"Plastic has lured humans due to its empowered quality of life whether it is through the ease of packaging or due to its flexibility, to humans," she said.

Dr Sharma said that however, on the contrary, the plastics have proved to be very harmful for humans, animals, and plants. Plastic causes harm to the habitat in the form of pollution, space-usage, contamination, and

its quality of persistence. They further cause serious health issues due to Bisphenol A (BPA) and phthalates which leech into the water and finally to the complete environment.

In view of the above, there exists a need in the state of the art to provide a packaging film, which is prepared by a completely green method as well as natural materials.

Kidney disease is a global public health problem, affecting over 750 million persons worldwide (70-80 crore, 10% of world population). The burden of kidney disease varies substantially across the world, as does its detection and treatment.

World Kidney Day is celebrated on 2nd Thursday of March every year. So, this year 14th march, 2024 is the world kidney day and campaign theme for this year is: kidney health for all-advancing equitable access to care and optimal medication

This day offers us an opportunity to raise awareness regarding kidney diseases, preventive measures and optimal treatment opportunities to those who are

World over, many countries still lack access to basic diagnostics, a trained nephrology workforce, universal access to primary health care, and renal replace-

Regular follow up with your doctor and monitoring is important to save your kidneys, heart and brain from harmful effects of high BP.

Life style changes like weight reduction

in those who are overweight, daily brisk walking for 30mins, eating green leafy vegetables rather than processed junk food helps kidneys and overall health of body in a big way.

Drink 10-12 glasses of water daily. It helps to keep body hydrated and lowers risk of kidney stone formation.

Even patients with near total loss of kidney function (<10% of remaining function) called CKD, can live a respectable and productive life with dialysis support. With the advent of automated and better biocompatible machines and accessories, dialysis in current era is much safer and effective for toxin removal from body.

Dialysis modalities are broadly of 2 types: I;e Haemodialysis (or blood dialysis) which is done in facility where patient needs to visit 2-3 times/week. The other one is called peritoneal dialysis done manually daily at home. An updated version of peritoneal dialysis is the automated peritoneal dialysis (APD) where the peritoneal dialysis is done by the bedside machine during night, while patient being asleep, thus giving the patient an opportunity to be dialysis free during the day.

Kidney transplantation is the best treatment available for such patients, where a relative of the patient donates his one kidney to the ailing patient. The new transplanted kidney perform all the functions of the body as done by his own kidneys and improves the quality of life, although some medications need to be taken by the patient lifelong. The transplant surgery is a safe and success rate of 95% is achieved after surgery.

Women may be more vulnerable to the physiological effects of depression. Also, women experience hormonal changes later in life, and the cardioprotective effects of estrogen begin to diminish, putting them at a heightened risk for cardiovascular disease.

A new study shows people with depression have a greater risk of developing cardiovascular disease, but more women experience heart disease due to depression compared to men.

sion seems essential for heart disease prevention. Results add to the evidence in favor of addressing depressionthrough screening, referral, and treatment—to reduce the risk for heart disease in men and women."

Gaffey was not involved in the study.

The connection between depression and heart health There are three main ways that depression and heart disease are connected, according to Dr. Roy C. Ziegelstein, MACP, Professor of Medicine and Vice Dean for Education at Johns Hopkins University School of Medicine. Ziegelstein was not involved in the study.

First, depression is a risk factor for the development of heart disease, and this study highlights that relationship. Some consider depression a "non-traditional" cardiovascular risk factor, Trusted Source with other, perhaps better known, risk factors being considered "traditional" (e.g., high blood pressure, diabetes, high cholesterol, and cigarette smoking).

Second, heart disease is associated with an increased likelihood of developing or being diagnosed with depression. These two aspects together lead to the description of the relationship between depression and heart disease as "bidirectional".

# 1 Billion People Have Obesity Worldwide, **What Researchers Say is the Cause**

new report has found that obesity trends have shifted significantly in the last 30 years.

Researchers find rates of obesity have risen drastically.

Experts say that the study further cements what those in the field have known for a long time.

A new analysis, recently published in the LancetTrusted Source, has found that the worldwide trends among people who are either obese or underweight have shifted over the last 30 years.

Now over 1 billion people are estimated to have obesity and the number of people who are underweight has decreased.

Obesity rates have risen significantly since 1990

The report looks at 3,663 studies, spanning from 1990 to 2022, and involves 222 million people overall. The indicator used was body mass index, which the authors acknowledged is an imperfect, though widely available, measure.

The researchers, who were part of the NCD Risk Factor Collaboration in conjunction with the World Health Organization, found that, in the vast majority of the world, the combined issues of being underweight/thin or obese have increased.

The number of people who are obese has increased significantly



since 1990.

For women, 2003 was the last year that the average person was more likely to be underweight than obese. For men, that year was 2009.

Today, more than a billion people in the world today can be characterized as having obesity.

Dr. Chris Damman, a clinical associate professor at the University of Washington who specializes in internal medicine and gastroenterology, says that this research confirms what those in the field have known for decades and highlights serious concerns about the trajectory of these

trends. "As we transition from countries which have had [a] higher prevalence of underweight we're moving directly into overweight, obesity, and metabolic disease," Damman said. "We're really trading one problem

for another. And the study confirms that understanding of what's happening with nutrition in the world."

The report also found that not only are more adults trending towards having obesity, so are children and adolescents.

The increasing number of obese adults worldwide was evident as early as the 1970's and 1980's, according to Dr. Eric Sternlicht, PhD, an associate professor at Chapman University who teaches a range of courses in their health sciences faculty. However, he says that this trend translating to younger populations is a growing problem.

For context, over the timespan studied, 1990 to 2022, the number of children with obesity rose drastically, Sternlicht said. The number of girls with obesity rose from 1.7% in 1990 to 6.9% in 2022. For boys with obesity, the number rose from 2.1% in 1990 to 9.3% in 2022, according to the report. "Our kids are no longer eating the traditional diets," Sternlicht said. "So, it's not surprising to me, as we become more mechanized, and especially with the advent of smartphones and computers, the amount of activity that individuals are doing is reduced."While there are still significant parts of the world where people are underweight, the steady rise of people with obesity has made headlines.

Children with kidney disease experience a range of disorders that affect the kidneys, including congenital conditions, inherited genetic diseases, acquired diseases due to infection, autoimmunity, or drug toxicity, and rarely, cancers of the kidney and



urinary tract. The incidence and prevalence of kidney ailments in children have increased significantly in recent years due to improved recognition and treatment," highlights Dr Darshan.

### **Symptoms of Kidney Disease** in Children

In children kidney disease range from congenital conditions of abnormalities in kidney development, inherited genetic diseases, acquired diseases due to infection, autoimmunity or drug toxicity and rarely cancers of the kidney and urinary tract. Symptoms can vary depending on the specific type of kidney disease, Dr Darshan shares common signs which include:

**Urination changes:** Increased or decreased frequency of urination, bedwetting(especially in a child who was previously dry at night), foamy or bloody urine.

Fatigue: Weakness, lethargy, or irritability.

Poor appetite: Nausea, vomiting, or weight loss.

*High blood pressure:* This is more common in older children and ado-

**Growth problems:** Delayed growth or short stature.

Pain: Abdominal pain, back pain, or

flank pain. When To Seek Professional Help?

Dr Darshan concludes, "It's important for parents to be aware of these symptoms and consult with a paediatrician and/or paediatric nephrologist if they suspect their child may have kidney disease. Early detection and treatment can help manage kidney disease and improve outcomes for children. The real impact of chronic kidney disease in children from developing countries is often under-recorded due to lack of paediatric renal services, accessibility to renal replacement therapy, and poor healthcare resource allocation." # Shane Watson drops out of race to be Pakistan head coach

**NEW DELHI:** Shane Watson has pulled out of the race to become Pakistan's head coach after being the PCB's preferred candidate.

Watson, the former Australian allrounder who coached Quetta Gladiators this season in the Pakistan Super League (PSL), was in advanced discussions over the last week regarding him taking over as Pakistan's limited-overs coach. It is understood he had seriously considered the offer after thoroughly enjoying his time in Pakistan during the PSL and was excited by the prospect of working with Pakistan's players.

But ESPNcricinfo understands that Watson has decided to honour his current coaching and commentary commitments for the time being. Watson currently has a commentary deal at the IPL and a head coaching role in Major League Cricket with San Francisco Unicorns, on top of his role with Quetta Gladiators. He also has a young family and is based in Sydney.

A full-time position with Pakistan would have seen him assume charge with immediate effect ahead of Pakistan's next limited-overs series against New Zealand at home in April and commit to Pakistan's limitedovers programme year-round.

Watson's decision to pull out of the race means Pakistan remain without a head coach ahead of the fivematch T20I series against New Zealand. Pakistan are also due to play T20Is against England in May ahead of the T20 World Cup in June.

While news reports in Pakistan suggested the PCB's offer to Watson ranged around US\$2 million a year, ESPNcricinfo understands the actual figure was closer to half that number. It is understood the PCB's financial offer played no part in Watson's deci-



sion to withdraw.

The speed at which developments occurred concerning the PCB's interest in Watson as head coach meant that accepting the offer would have necessitated pulling out of his other roles at short notice, which is understood to be the main reason for withdrawing. Watson was appointed head coach of Quetta Gladiators late last year. He won a title with Gladiators as a player in 2019.

He has rung the changes at the top

in his first season as coach, most notably playing a leading role in replacing Sarfaraz Ahmed - who had served as captain of the franchise for eight years - with South Africa's Rilee Rossouw.

Gladiators started extremely strongly and qualified for the playoffs for the first time in five seasons. However, they lost momentum towards the tail-end of the tournament and were eliminated by Islamabad UnitIncreasing business by reducing
