The accused, Sheraz Mir, who was then working as an accountant of Jamkash Vehicleades, was arrested after he committed criminal breach of trust and cheating by transferring a substantial amount of Rs 1.32 crore into his own bank accounts from the funds of the company, they said.

Currently, the weather is pleasant, with a bright sun shining over the Kashmir valley. The night temperature improved at most of the stations, while the day temperature recorded 5-7 °C above normal in Kashmir Valley on the previous day.

Srinagar recorded a low of 2.2 °C against 3.2 °C recorded during the intervening nights of Monday and Tuesday. It was -2.2 °C below normal for the summer capital of Jammu and Kashmir.

Qazigund on the Srinagar-Jammu national highway had a low of 2.2 °C, and the picnic spot of Kokernag in south Kashmir recorded a low of 3.5 °C on Tuesday.

Pahalgam had a low of -0.9 °C against the -1.3 °C recorded a day ago. It was -1.0 °C below normal for the famous tourist hot spot of south Kashmir.

Gulmarg settled at -1.0 °C against -2.3 °C the previous night, and it was 1.3 °C above normal for the famous ski resort of north Kashmir's Baramulla district on Tuesday.

Sharma was promoted to the position of in-charge lecturer in 2004, following which she was posted at Government Higher Secondary School in Mansar. However, her failure to provide original qualification documents led to the suspension of her allowances between 2004 and 2006.

Official reports divulged that the School Education Department issued an order on March 5, instructing the Chief Education Officers of Samba and Kathua districts to reassign Sharma and Chanyal to teaching roles. Both teachers have been directed to report to the office of the Chief Education Officer in their respective districts. (KNO)

Moreover for the proprietors, Ramadan brings a surge in sales and a sense of joy as customers clamor for their delectable offerings.


Similarly, Zahoor, a local told KNO that bakery items and pickles are not just food items for them but an essential part of Ramadan.



Similarly, Dr Shugufta said that deworming improves a child's immunity, protecting them from chronic illnesses caused by worms. "It enhances concentration and attendance in school, increases nutrient uptake, and controls infections like anaemia



and loose bowels. It also improves work potential and livelihood opportunities while reducing worm infection in the community," he said.

In mid-eighties, one had the opportunity of flying in a helicopter with a European ski expert over the snow areas of entire Kashmir valley. He had remarked that Kashmir has unlimited "White Gold". The oil reserves of the Arabs are termed as "Black Gold". Similarly, the huge easily accessible skiable snow areas of Kashmir can be termed as the "White Gold". We have the possibility to set up over a dozen world class ski resorts in our mountain areas. The terrain, snow conditions, and the climate are ideal and in some respects better than the Alps. Gulmarg is probably the nearest resort of its type and size to a jet airport which is now an International Airport in every respect except for the missing international flights. No other resort in this part of the world is so easily accessible to the International tourist traffic.

Even in the last century Gulmarg was considered by the British an important ski resort this side of Suez. In fact, the Ski Club of India was established by Major Metcarp and Major Headow, two British Army Officers, in 1927 at Gulmarg. Mr.B.N.Pestonji was its first Secretary. Skiing had been introduced as a sport in Gulmarg area almost at the same time as it had started in Alps. Those days all ski competitions were held at Khilanmarg and the pony track was kept open throughout the winter. There were two major events, the Christmas and Easter Competitions. The famous British Sports Equipment Firm, the "Lilywhites" had introduced some trophies for various ski competitions. In fact one of the ski slopes above Khilanmarg is still called the "Lilywhite Slope". The attendance in the open competition held at Christmas in 1938 was over 500. Gulmarg had two 100 room hotels and hundreds of chalets. There was a Cinema and a Golf Club House with two eighteen hole courses. One could get everything aristocratic and fashionable in the "Bazaar" of Gulmarg directly



imported from all parts of Europe. Families of some of the British Army Officers would come to Gulmarg simply to buy these goodies. Marion Doughty in her travelogue, "Afoot through Kashmir Valley" makes a special mention of the "Gulmarg Tea Dance" and the preparations she had to undergo at the British Residency in Srinagar for participating in the event. Gulmarg was discovered by Yusuf Shah Chak, the last Kashmiri ruler who used to camp here for days with his poetess Queen Habba Khatoon.

Europe has millions of skiers who are now looking for newer and less crowded places with equal facilities. In the recent years we have had regular Australian groups as it is summer in Australia when we have winter here. Also sizeable numbers of Russians have been coming to Gulmarg. Recently, the Chinese Ski Association had approached for training their teams in Gulmarg. Kashmir could be the ultimate winter destination for them if the potential is intelligently exploited. To tap this potential the first essential is international accessibility to this area. That can be achieved only after Srinagar's so called international airport gets international air connectivity enabling direct international flights to touch down here. In the alternative, like Goa it could get charter flights from a number of potential markets including Malaysia. At the moment it may seem a utopian dream but in the long run it may be one of the most important economic activities.

Interestingly, the Adventure Tourism of which the Winter Tourism like Alpine Skiing, Cross Country Skiing, and Ski Mountaineering are part has maximum potential in Kashmir. In fact, it is the unique type of Tourism suitable for present times. Most of the adventure activities are outside the populated areas. The state should have been encouraging this type of tourism which in overall context is high end tourism especially when it is organised in group form. In mid-nineties skiing at Gulmarg and Heli-Skiing in Sonamarg area continued without any problems. In fact, Gulmarg is presently underutilised when one considers the potential of

winter tourism. It has become a resort to see snow, have a gondola ride or so. The real adventure tourism involving various winter sports such as international level ski competitions, training of various ski teams and general skiing for pleasure seeking people has not grown much. The gondola which was installed to give access to skiers to higher slopes has remained an attraction for a joy ride for thousands of day tourists. The ski slopes which are some of the best in the world have not been got homologated by the International Ski Federation which is a must for holding international events.Apart from various ski events, Gulmarg can easily hold the fastest kilometre race like the French. There is an urgent need for reviewing not only winter sports in Gulmarg but the entire field of adventure tourism. Let us hope someone gets serious and the potential of all adventure tourism including the winter tourism in Gulmarg gets fully revived!

The motto, 'Where there's a will, there's a way' is the superstition of modern man. But for this girl it was not a superstition! She wanted to do it and she did it at the world stage!

A small incident I will start this story with a youth/man! Yes in order to sustain his creed, contemporary girl/man pays the price in a remarkable lack of introspection. He is blind to the fact that, with all his rationality and efficiency, he is possessed by 'powers' that are beyond his control. His god and demons have not disappeared at all; they have merely got new names. They keep him on the run with restlessness, vague apprehensions, psychological complications, an insatiable need for pills, alcohol, tobacco, food-and, above all, a large array of neuroses.'!

But this is a story of a woman's power and what she is capable of doing! Sheetal Devi knows this fallacy to the hilt!

She always wanted to be at the top of the world! I could have written this story a long back ut I waited and the wait was good enough!

Sheetal Devi (born 10 January 2007) is an Indian Para-archer.Devi was born with a rare medical condition called phocomelia,which makes her the first and the only international para-archery champion without upper limbsShe received the Arjuna Award 2023 from the President of India on 9

January 2024.

In the women's compound bow at the 2022 Asian Para Games, Devi received two gold medals in mixed doubles and women's individual after winning a silver medal in women's double compound!

She was born in Loidhar village, Kishtwar district in Jammu and Kashmir. In 2019, Sheetal attended ayouth event in Kishtwar where she was noticed by the Indian Army's Rashtriya Rifles unit resulting in the Army supporting her education and providing medical assistance.

In the youth event organized by the Indian army, the army coaches Abhilasha Chaudhary and Kuldeep Wadhwan noticed her confidence and decided to train her. As she was born with Phocomelia, she had no arms. So firstly the coaches decided to help her with prosthetics. But the medics said that prosthetics were not possible in her case. Here, she said that she was fond of and has expertise in climbing trees using her legs. This was a very pleasant surprise for the coaches.

Now coaches had one more challenge to face, they had never trained a person for archery who has no arms. But coaches did some research about whether it was possible to train her, and eventually they came to know about Matt Stutzman , who was armless and used his legs for archery. This made coaches very confident and within 11 months of training, Sheetal Devi participated in Asian Para Games and won two gold medals



for India.

The world of sports is no stranger to athletes overcoming odds to achieve big on the world stage. Yet, among all these odds-defying narratives, the story of the teenaged Indian para-archer Sheetal Devi stands out.

Fast forward to 2023 and Sheetal Devi's achievements in archery are already in the headlines after just one season. Sheetal Devi claimed a silver medal in the open women's compound archery event at the World Archery Para Championships 2023 in the Czech Republic in July. She was the first female armless archer to win a medal at the Para World Championships. The medal also helped Sheetal obtain a quota for India for the Paris 2024 Paralympic Games. Sheetal Devi's stellar debut sea-

son continued at the Asian Para Games 2023 in October. She bagged gold medals in the individual compound and mixed team events apart from winning the silver medal in the women's doubles competition.

What makes Sheetal Devi's achievements all the more aston-

ishing is that she is the only active female international archer to shoot without arms.

As a kid, Sheetal possessed a strong will and enjoyed climbing trees as a pastime. The activity helped her build a strong upper body which proved to be a turning point later in her life. The Indian Army played a pivotal role in propelling Sheetal Devi's career in para archery. It was at a youth event orchestrated by the Indian Army in Kishtwar, Jammu and Kashmir in 2021 that Sheetal's innate athleticism and confidence were discovered by army coaches. However, the initial attempts from the coaches to make Sheetal Devi a force in para archery hit a stumbling block. The coaches initially planned to help her with prosthetics but it did not work out.

Sheetal soon joined former archer and coach Kuldeep Vedwan's academy. Despite competing among the abled archers at the national competitions, Sheetal Devi's talent was for all to see. Using her legs and feet akin to para archery legend Stutzman, Sheetal Devi embraced the unconventional shooting technique and competed at the Para Archery National Championship in Haryana in March-April 2022. Vedwan said the tournament was crucial as it helped Sheetal Devi get formal recognition as an Indian para archer.

Now the latest is: ECI Name Para-archer and Arjuna Awardee Sheetal Devi as PwD National Icon. The Arjuna Awardee and paraarcher, Sheetal Devi has been named as the PwD national icon by the Election Commission of India.

The Election Commission of India (ECI) in association with the Board of Control for Cricket in India (BCCI) organised an Exhibition Cricket Match between the Indian Deaf Cricket Association (IDCA) Team and the Delhi & District Cricket Association (DDCA) team to foster voter education and inclusivity. The match was held on March 16, 2024, at Karnail Singh Stadium in New Delhi. On the occasion, Ms. Sheetal Devi, a distinguished Para-archer, and Arjuna Awardee, was announced as the National Icon in the PwD category.

The event was graced by Chief Election Commissioner Shri Rajiv Kumar and Election Commissioners Shri Gyanesh Kumar and Shri Sukhbir Singh Sandhu who felicitated the winning team. Renowned former Indian Cricketer, Nikhil Chopra, was also invited as the special guest alongside officials from DDCA and IDCA.

For the event, the Commission launched a dedicated Voter's Guide for PwDs and Senior Citizen Electors. The comprehensive booklet outlines essential provisions available to PwDs and senior citizens, including infrastructural, informative, and procedural details at polling stations, as well as the applicability and procedure for Postal Ballots, facilitating a smooth and pleasurable voting experience. Again it was the Indian Army who started it all!

Rekindling Ties With Nature

When I had started to live permanently in my village named Moutorh (District Purulia, West Bengal, India) I became interested in how nature can provide practical lessons and answers to challenges I was facing in my own life.

When I had started to live permanently in my village named Moutorh (District Purulia, West Bengal, India) I became interested in how nature can provide practical lessons and answers to challenges I was facing in my own life. During my tenure in the Central Pollution Control Board as scientist I visited many hill stations, forests, rivers, lakes, ground water sources, wetlands, cities, industries, and many more places to assess the level of pollution and its adverse impact on environment and human living as well as possible measures to minimize the level of pollution.

But what I observed was the suffering of poor people mainly due to contamination of water particularly ground water (arsenic, fluoride and many other pollutants) as well air pollution. In the backdrop of my sincere effort to prevent pollution, I can strongly advocate that I did nothing because at that time I did not consider myself as one of the 800 million citizens of the country and could not overcome a luxurious lifestyle. After reading many inspiring books, attending many seminars and discussing with Dr Samar Bagchi, who was a real fighter to protect the nature and put in sincere efforts to educate students with his "No cost, low cost" science experiments till his death, I could possibly find the way to spend my life (though it is late at age 67) teaching the students in my village to be in contact with nature and natural farming on a small scale.

After spending two years in my village, I discovered that nature had a huge impact not only on my own life but also on the lifestyles of my wife and students. Now I realize that nature is filled with amazing things to teach us how to think more clearly and scientifically, not only related to plants, birds and animals but also how to tune into our physical surroundings in all areas of life. Most people in the modern world have lost their innate naturalist intelligence, but human beings are animals at heart.

We must be surrounded by plants, birds and fresh air for amazing beneficial effects for the mind and body. But the way we are destroying our natural world has led to dreadful outcomes. One example can clearly focus on the loss of biodiversity and its adverse impacts on human beings. In the early 1990s, vultures across India started dying and declined to the brink of extinction. India's three most common vulture species declined by more than 97 per cent between 1992 and 2007. The vultures fed on the carcasses of cows contaminated with diclofenac, an anti-inflammatory drug routinely given to cattle in south Asia at the time and were thus poisoned.

That was the beginning of a far-reaching chain reaction. As vulture populations crashed, cow carcasses started to pile up, and the numbers of rats and wild dogs surged. Dogs became the main scavengers at dumps previously used by vultures. Data suggests that from 1992 to 2003, dogs increased by 7 million. The number of dog bites soared and rabies infections shot up, causing tens of thousands of people to die each year. In 2006, diclofenac was banned, and vulture populations have slowly started to recover. Many such examples exist. Sparrow slaughter in China sparked insect plagues and deadly frog fungus caused malaria spikes.

Many more examples can be cited to establish the dreadful outcomes of the destruction of the natural system. Wildlife populations



are in free-fall around the world, driven by human overconsumption, population growth and intensive agriculture. On average, global populations of mammals, birds, fish, amphibians and reptiles plunged by 68 per cent between 1970 and 2016. Despite knowing nature is declining at an unprecedented speed, we are spending decades talking about the declines but find ourselves unable to do anything to manage it. It really frustrates me.

Though personal responsibility is the crucial area, when I speak to my close friends, they say that their individual action does not make any difference. That is absolutely wrong. When I got worried about the disorder of the natural world that was affecting my life and making me unhappy, Istarted to involve myself in positive change such as a simple way of living and proper education to the students. Education of students through learning from nature is gradually motivating them to be informed and updated with what is happening in the world.

Now the students feel nature is their mother and they try to find ways to protect it. Fighting for a cleaner planet and a better world has never been as urgent as it is today. I believe that only students can make a difference. Now they have realised that the solution is not a difficult one. They have started to reduce what they are consuming, reuse what they are throwing away and recycle what they have to throw away.

Tomakethem aware, composting of house waste, minimum use of plastic, separation of plastics to use it for producing fuel (though not 100 per cent successful), production of indigenous paddy through natural farming without using any fertilizer and without cow manure to minimize greenhouse gases, reuse of domestic water for gardening, use of water hyacinth to produce handcrafts and other such activities are going on in my village on a small scale. In addition, I encourage them to walk or cycle or take public transport.

They carry their food in a reusable container and wash it later to save the planet from having to decompose plastic wrapping of food. They avoid buying a bottle of water at school and instead carry filtered water from home. They use pencils instead of pens as it is made out of wood that is recyclable and also use notebooks made out of recycled paper. They are not as shiny as the other ones but they keep them conscious. Though it is difficult to control the rest of the world, it is easier to control what I do in my own life.

Saving motherearth is important for students as it will make them aware of how to use natural resources and how a healthy balance can be maintained between nature and human life. Young people can fight strongly to save nature.

All you need to know about stomach cancer treatment

How common is gastric (stomach) cancer?

Worldwide about 1 million people are diagnosed with gastric cancer. It is ranked as the 5th most common cancer. In India it accounts for about 60,000 new cancer cases (6th most common) and about 53,000 deaths.

How is this diagnosed?

This is diagnosed after endoscopic biopsy.

What is the treatment for stomach cancer?

Stomach cancer treatment depends upon the stage of the disease. For early or locally advanced disease this is surgery, chemotherapy with or without radiotherapy. For stage 4 disease this is chemotherapy with or without targeted therapy. Sometimes immunotherapy is also used with or without chemotherapy. This is based on various factors.

How is the choice of treatment determined for stomach cancer patients?

Salem: Prime Minister Narendra Modi on Tuesday accused the INDIA bloc leaders of "deliberately insulting" Hindu dharma and said that their every statement against the religion is very "well thought out".

No Stay On CAA, Top Court Asks Centre **To Respond To Petitions In 3 Weeks**

New Delhi: The Supreme Court on Tuesday afternoon refused to stay implementation of the Citizenship Amendment Act, or CAA. The court also gave the government three weeks - till April 8 - to respond to 237 petitions challenging the law that was notified last week, days before the Lok Sabha election.

In addition, the petitioners were given leave to approach if citizenship is granted to any individual before that date; senior lawyers Kapil Sibal and Indira Jaising both made that request, as Solicitor-General Tushar Mehta (appearing for the government) said, "I am not making any statement".Mr Mehta had originally sought four weeks' time to respond to the petitions."We will have to file a detailed affidavit, on merits, to 237 petitions. 20 interim applications are already filed and many are in the pipeline. Realistically, we need four weeks," he told the court.

The matter was heard by Chief Justice DY Chandrachud, Justice JB Pardiwala, and Justice Manoj Misra. The petitioners included the Indian Union Muslim League (a Kerala-based political party) and also opposition leaders Jairam Ramesh of the Congress and Mahua Moitra of the Trinamool.The petitioners - who did not oppose the request for more time - have sought a pause on implementation of the "discriminatory" CAA, which they have said is against the Muslim community.



The petitioners told the court they would not oppose the government's request for more time to study the challenges, but urged the Chief Justice-led bench to order a stay on implementation.

In 2019, after the citizenship bill was cleared by Parliament, multiple challenges were filed.

The court did not, however, pause implementation as the rules had not been notified. Last week, arguing in this matter, Mr Sibal said that situation did not apply now, since the rules are notified.

"The problem is... notification was issued after four years. Under the law, rules have to be notified within six months. Now the problem is - if somebody gets citizenship, it will be impossible to reverse," he said when asked by the court to respond to the government's request for more time.

'They said (in 2019) they were not notifying rules, so no stay was granted. There is no question of 'rejection of stay' (in the earlier instance)... then there were no rules, so there was no stay.

"Planet On The Brink": UN As 2014-2023 **Recorded Hottest Decade Ever**

Geneva: Global heat records were "smashed" last year, the UN confirmed Tuesday, with 2023 rounding out the hottest decade on record, as heatwaves stalked oceans and glaciers suffered record ice loss.

The United Nations' World Meteorological Organization issued its annual State of the Climate report, confirming preliminary data indicating that 2023 was by far the hottest year ever recorded.

And it came at the end of "the warmest 10-year period on record", the WMO report said.

UN chief Antonio Guterres said the report showed "a planet on the brink".

"Earth's issuing a distress call," he said, pointing out that "fossil fuel pollution is sending climate chaos off the charts", and warning that "changes are speeding up"

The WMO said the average near-surface temperature was 1.45 degrees Celsius above pre-industrial levels last year -- dangerously close to the critical 1.5-degree threshold that countries agreed to avoid passing in the 2015 Paris climate accords.

The report, she said, should be seen as a "red alert to the world".

Going through the data, the organisation found that "records were once again broken, and in some cases smashed", warning that the numbers "gave ominous new significance to the phrase 'off the charts'."Saulo stressed that climate change was about much more than temperatures.

"What we witnessed in 2023, especially with the unprecedented ocean warmth, glacier retreat and Antarctic sea ice loss, is cause for particular concern."

One especially worrying finding was that marine heatwaves gripped nearly a third of the global ocean on an average day last year.

And by the end of 2023, more than 90 percent of the ocean had experienced heatwave conditions at some point during the year, the WMO said.

More frequent and intense marine heatwaves will have "profound negative repercussions for marine ecosystems and coral reefs", it warned.

At the same time, it warned that key glaciers worldwide suffered the largest loss of ice ever since records began in 1950, "driven by extreme melt in both western North America and Europe".

In Switzerland, where the WMO is headquartered, Alpine glaciers had for instance lost 10 percent of their remaining volume in the past two years alone, it said. The Antarctic sea ice extent was also "by far the low-

est on record", WMO said.

In fact, it pointed out, its maximum extent at the end of the southern winter was around one million square kilometres below the previous record year -- equivalent to the size of France and Germany combined.

Amini's death in custody 'unlawful': UN mission

GENEVA: A fact-finding mission mandated by the United Nations said on Monday the death of Mahsa Amini in the custody of Iran's morality police was unlawful and caused by violence and that Iranian women still suffer systematic discrimination.

The death of 22-year-old Amini, a Kurdish Iranian woman, in September 2022 while in custody for allegedly flouting Iran's Islamic dress code unleashed months of protests and the biggest challenge to the Islamic Republic's clerical leaders in decades.

"Our investigation established that her death was unlawful and caused by physical violence in the custody of state authorities," Sara Hossain, chairperson of the Independent International Fact-Finding Mission on Iran, told the UN Human Rights Council in Geneva. The fact-finding mission found the protests that followed were marked by extra-judicial executions, arbitrary arrests, torture and ill-treatment, as well as rape and sexual violence.

These acts were conducted in the context of a widespread and systematic attack against women and girls, and other persons expressing support for human rights," Hossain said.

"Some of these serious violations of human rights thus rose to the level of crimes against humanity."

In response, Kazem Gharib Abadi, secretary general of Iran's High Council for Human Rights, accused the fact-finding mission of a "glaring lack of independence and impartiality".

In separate comments to the Human Rights Council, Javaid Rehman, the UN Special Rapporteur on the human rights situation in Iran, said jailed human rights defender Narges Mohammadi "suffers from severe health issues, including serious heart and lung conditions, placing her health at great risk".

"She was denied medical access because she did not have the mandatory hijab," Hossain said about Mohammadi, who won the Nobel Peace Prize last year.

Hossain said that since the protests began in 2022, women and girls in Iran were confronted daily by discrimination "affecting virtually all aspects of their private and public lives".

She said it was "hard to fathom" that women's access to schools, universities, hospitals and courts as well as employment opportunities "should be subjected to a wholly arbitrary requirement of wearing the mandatory hijab".

In New Zealand, Chinese minister calls for working with 'friends'

WELLINGTON: Chinese Foreign Minister Wang Yi made a rare visit to New Zealand on Monday, stressing the need to work with "friends" in the face of the "tumultuous international situation".

The trip marks the start of a diplomatic blitz through New Zealand and Australia, Wang's first visit to either country since 2017.

The whistle-stop tour is expected to focus heavily on trade as Beijing looks to lessen the pain from slowing economic growth at home.

UN chief invokes film, warns of nuclear disaster

UNITED NATIONS: UN Secretary General Antonio Guterres invoked Oscarwinning film Oppenheimer on Monday as he warned that the world faced the highest risk of nuclear war in decades.

At a Security Council session called by Japan, Guterres said that the biopic about the morally conflicted father of the atomic bomb "brought the harsh reality of nuclear doomsday to vivid life for millions around the world.""Humanity cannot survive a sequel to Oppenheimer," Guterres said."We meet at a time when geopolitical tensions and mistrust have escalated the risk of nuclear warfare to its highest point in decades," he said.Russian President Vladimir Putin has made thinly veiled threats to use nuclear weapons as he warns the West against its support for Ukraine, which Moscow invaded more than two years ago. Without naming Putin, Guterres said, "Nuclear saber-rattling must stop." "Threats to use nuclear weapons in any capacity are unacceptable," he said. Guterres says threats to use nuclear weapons in any capacity are unacceptableElsewhere in the world, tensions surrounding



nuclear-armed North Korea have continued to rise and Iran has been enriching uranium closer to the level needed if it decides to build an atom bomb.Israel, the Middle East's only nuclear-armed power albeit an undeclared one, has been at war since Oct 7. Guterres called on the United States and Russia to resume negotiations, at a standstill since the Ukraine war, on a successor to the New START nuclear arms reduction treaty which expires in early 2026.He also called for progress on other initiatives including the Treaty on the Prohibition of Nuclear Weapons, which entered into force in 2021 but has little practical effect as no nuclear-weapons states are party to it.

West decries Putin's landslide election victory

LONDON: Western governments lined up on Monday to condemn Vladimir Putin's landslide election victory as unfair and undemocratic, but China, India and North Korea and some other countries congratulated the veteran Russian leader on extending his rule by a further six years.

The contrasting reactions underscored the geopolitical fault lines that have gaped wider since Russia launched a full-scale invasion of Ukraine two years ago, triggering the deepest crisis in relations with the West since the end of the Cold War.

Arriving in Brussels on Monday, EU foreign ministers roundly dismissed the election result as a sham ahead of agreeing sanctions on individuals linked to the mistreatment



Navalny."Russia's election was an election without choice," German Foreign Minister Annalena Baerbock said at the start of the meeting. China, North Korea, India vow

closer ties with Russia

Playing on Moscow's reference to its war in Ukraine as a "special military operation", French Foreign Minister Stephane Sejourne said and death of Kremlin critic Alexei Paris had taken note of the "special

election operation".

"The conditions for a free, pluralistic and democratic election were not met," his ministry said.

British Foreign Secretary David Cameron said the election outcome highlighted the "depth of repression" in Russia.

"Putin removes his political opponents, controls the media, and then crowns himself the winner. This is not democracy," Cameron said.

France, Britain and others condemned the fact that Russia had also held its election in occupied regions of Ukraine that it claims to have annexed during the war.

The Kremlin dismissed such criticism, saying the 87 per cent of the vote won by Putin during the threeday election showed that the Russian people were consolidating around him.Ukrainian President Volodymyr Zelensky said Russia's election had no legitimacy.

Bangladesh, Pakistan and India bottom in air quality rankings in 2023, data shows

Pakistan remained one of the world's three smoggiest countries in 2023, as Bangladesh and India replaced Chad and Iran, with particulate matter about 15 times the level recommended by the World Health Organisation, data published on Tuesday showed.

Average concentrations of PM2.5 - small airborne particles that damage the lungs - reached 79.9 micrograms per cubic metre in Bangladesh in 2023, and 73.7 micrograms in Pakistan. The WHO recommends no more than 5 micrograms."Because of the climate conditions and the geography (in South Asia), you get this streak of PM2.5 concentrations that just skyrocket because the pollution has nowhere to go," said Christi Chester Schroeder, air quality science manager at IQAir, a Swiss air monitoring organisation.

"On top of that are factors such as agricultural practices, industry and population density," she added. "Unfortunately, it really does look like it will get worse before it gets better."In 2022, Bangladesh was ranked as having the fifth-worst air quality, and India was eighth.

Speaking in the capital Wellington before a meeting with his New Zealand counterpart, Wang said the trip was also a chance to shore up diplomatic ties that have come under strain as Beijing adopts an increasingly aggressive stance on issues such as Taiwan and the South China Sea.

"In the face of the current tumultuous international situation, we are willing to strengthen strategic communication with our friends in New Zealand on international and regional issues of common concern," Wang said.

"And we will work together to maintain peace and stability in the region and the world," he added before his closed-door meeting with New Zealand Foreign Minister Winston Peters.

New Zealand is part of the Five Eyes intelligencesharing alliance alongside the United States, Canada, the United Kingdom and Australia.

But Wellington has been criticised for taking a softer line on China – putting its trading relationship ahead of its allies' security concerns.

In a statement on Monday, Peters said the talks touched on "trade, business, and people-to-people links", but also acknowledged "areas of difference such as human rights".

"We also highlighted New Zealand and China's shared interest in a secure and prosperous Indo-Pacific region and raised concerns over increased tensions in the South China Sea and Taiwan Strait," he added.

China is New Zealand's largest trading partner, and Chinese consumers have long had an appetite for the country's meat, wine, milk and wood.

Wang said he believed that "China-New Zealand relations will continue to be at the forefront of China's relations with developed countries".

"The relationship between us has developed smoothly and well," he said.

Later this week, Wang will meet Australian Foreign Minister Penny Wong in Canberra.

US urges Taliban to prevent attacks from Afghan soil

WASHINGTON: The US State Department called on Kabul's Taliban rulers on Monday to prevent terrorist activities originating from Afghan soil, while also urging both Afghanistan and Pakistan to prioritise the protection of civilian lives during security operations.

"We have seen reports that Pakistan carried out airstrikes in Afghanistan in response to the attack in Khyber Pakhtunkhwa, Pakistan, on Saturday at a military post," said the department's Principal Deputy Spokesperson Vedant Patel when asked at a news briefing to comment on these developments.

"We deeply regret the loss of life and injuries sustained during the attack in Pakistan and the loss of civilian lives during the strike in Afghanistan."

The US official, however, also sent a clear message to Afghanistan's Taliban rulers. "We urge the Taliban to and ensure civilians are not harmed in their counterter-



ensure that terrorist attacks are not launched from Afghan soil."And then he urged Pakistan "to exercise restraint rorism efforts". The State Department official also urged "both sides to address their differences" while underlining the need for Afghanistan to curb terrorism.

"We remain committed to ensuring that Afghanistan never again becomes a safe haven for terrorists who wish to harm the United States or our partners or allies," he said.When a journalist interpreted his statement as suggesting that the United States did not support Pakistan's stance on this issue, Patel said: "Any loss of civilian life is troubling and heartbreaking to us, so we want to make sure that when some of these operations are being conducted, every step possible is taken to ensure it is the perpetrators that are being held to account and not civilians who are being impacted."

Emphasising Pakistan's position as a close US ally, he said that Washington maintains "regular communication" with Pakistani leaders to "discuss Afghanistan in detail including through our counterterrorism dialogue and other bilateral consultations".

Astroke, also known as a cerebrovascular accident (CVA), occurs when the blood supply to part of the brain is interrupted or reduced, depriving brain tissue of oxygen and nutrients. Experimental Blood Test May Help Detect Colon Cancer Earlier

blood test known as a cfDNA test has proven to be accurate in detecting colorectal cancer in the majority of cases.

Colorectal cancer is often deadly, but screening for it can be inconvenient, so getting more adults to adhere to screening guidelines is a top priority.

Experts believe the novel test could help bridge the gap and get more people to regularly screen for colorectal cancer.

A novel blood test for colorectal cancer screening appears effective in clinical trial data, but questions remain about how it can be utilized.

Colorectal cancer screening has a reputation for being difficult, but a new type of screening could make the process as easy as giving some blood. It could even be done during a regular check-up with your doctor.

It's effective too, but with some caveats. In a study published this week in The New England Journal of Medicine, researchers found that a type of blood test known as a cellfree DNA blood-based test or cfDNA test was able to detect colorectal cancer in 83% of patients who had the disease. The study was funded by Guardant Health, the maker of the test.

The detection rate is similar to an



already widely used at-home screening test known as a fecal immunochemical (FIT) test, which is accurate in about eight out of 10 cases.

Colonoscopies remain the "gold standard" for colorectal cancer detection and prevention but require significantly more time, scheduling, and preparation. A colonoscopy is able to accurately identify colorectal cancer in about 95% of cases.

Experts told Healthline that the combination of accuracy and accessibility could be a game changer for screening.

"It's very, very exciting. I think this has real potential to reshape the entire landscape of colon cancer early detection," Dr. Christopher Chen, an Assistant Professor of Oncology and Director of Early Drug Development at the Stanford Cancer Institute, Stanford Medicine, told Healthline.

Dr. Ben Park, MD, PhD, Director of

the Vanderbilt-Ingram Cancer Center at Vanderbilt University, told Healthline, "It's studies like these that we really need to move the needle forward and demonstrate that there is validity, or what we call clinical validation, of a test like this. It's not perfect, as probably everyone can read from the numbers, but it's a big start."

Park was not affiliated with the research but disclosed that he is currently engaged in separate clinical trials involving Guardant Health. Accurate in 83% of cases

The results of the study come from a large, multi-center trial known as the ECLIPSE trial. Some 8,000 patients between the ages of 45 and 84. Participants were at average risk for colorectal cancer and were already undergoing routine screening for colorectal cancer.

The trial tested the effectiveness of Guardant Health's Shield blood test compared to colonoscopy. Sixtyfive participants in the trial had confirmed colorectal cancer from a colonoscopy. The cfDNA test positively identified cancer in 54 of 65 (83.1%) of those participants.

What the test does not do is test for precancerous lesions or polyps, which can develop into cancer. For precancerous lesions, the test only detected about 13% of cases.

Maternal Deaths May Be Overestimated, but There's Still a Maternal Health Crisis

New research challenges current CDC reporting about rising maternal death rates in the U.S., suggesting maternal mortality is stable and on par with other developed countries.

The study authors claim a "pregnancy checkbox" introduced by the CDC in 2003 may have contributed to inaccurate pregnancy-related death tolls.

Discrepancies around direct, indirect, incidental, and accidental deaths among pregnant people may have led to reporting errors, researchers say.

The CDC disagrees with the study findings and stands by the accuracy of its data collection methods.

The ongoing maternal health crisis in the United States affects millions of women who do not have access to quality prenatal and postnatal care, particularly those who live in areas with restricted abortion access. These disparities fuel rising maternal mortality rates that disproportionately affect women of color-Trusted Source.

But, new research suggests that the number of maternal deaths in the past two decades may have been overestimated.

The study, published March 12 in the American Journal of Obstetrics & Gynecology, shows maternal mortality in the U.S. held steady and was



on par with other developed countries.

The study data also indicate that maternal deaths from direct obstetric causes declined over the past 20 years.

Researchers say the 2003 inclusion of a pregnancy checkbox on death certificates, which showed whether a person was pregnant at or near their time of death, misrepresented the increase in the number of maternal deaths.

"Our study showed that maternal mortality rates were low and stable between 1999-2002 and 2018-2021, which is very different from the high rates and dramatic increases reported by the NVSS [National Vital Statistics System]Trusted Source in recent years," lead author Dr. K.S. Joseph, PhD, a Professor in the Departments of Obstetrics and Gynaecology and the School of Population and Public Health, University of British Columbia and the Children's and Women's Hospital & Health Centre of British Columbia said in a news release.

"We found that exclusive reliance on the pregnancy checkbox on death certificates, without corroboration from the cause-of-death information, led to an overestimation of maternal mortality rates by the NVSS in 2018-2021."

Maternal death rates lower than CDC estimates

The researchers found that maternal deaths in the U.S. were stable overall, averaging at just over 10 per 100,000 live births from 1999 to 2002, as well as from 2018 to 2021. This conflicts with maternal mortality rates reported by the Centers for Disease Control and Prevention, which increased from 9.65 per 100,000 live births to 23.6 per 100,000 live births for the same time period, respectively.

These findings challenge upward trends that were previously reported by the National Vital Statistics System (NVSS), a division of the CDC. The CDC's 2021 maternal mortality reportTrusted Source shows nearly a 40% increase in overall maternal deaths from 2020, with rates for non-Hispanic Black women 2.6 times higher than white women.

IPL INTRODUCES SMART REPLAY SYSTEM FOR QUICKER, MORE ACCURATE REVIEWS

NEW DELHI: To increase the accuracy and speed of decision-making, IPL 2024 will have the Smart Replay System.

ESPNcricinfo has learned that under the Smart Replay System, the TV umpire will receive inputs directly from two Hawk-Eye operators who will be sitting in the same room as the umpire and provide him with images captured by Hawk-Eye's eight hi-speed cameras across the ground. The TV broadcast director, who used to be a conduit between the third umpire and the Hawk-Eye operators until now, will no longer be involved under the new system.

It is understood that the Smart Replay

System will allow the TV umpire to refer when the fielder released the ball (think to more visuals than they previously had access to, including split-screen images. Take the example of a relay catch taken mid-air by the first fielder on the boundary rope. In the past, the broadcaster was unable to provide a split screen of the fielder's feet and hands at the precise moment when the ball was caught. Under the new system, a split screen can show the umpire when the ball was caught, or released, alongside synchronised footage of the feet.

2019 World Cup final for an example of a specific use case). Previously the TV umpire did not get such clear visuals, primarily because the broadcaster couldn't marry the two images.

There are eight Hawk-Eye cameras at any match: two on each side of the ground on the straight boundaries and two on each side square of the wicket. Until IPL 2023, Hawk-Eye cameras were mainly used for ball tracking and UltraEdge. So, outside of checks for lbws and edges, the broadcaster largely used footage from their own cameras for any on-field referral. That included referrals for stumpings,

run-outs, catches and overthrows.

In the case of a stumping referral, under the Smart Review System, the TV umpire can ask the Hawk-Eye operators to show him the split screen. In case there is a visible gap when the ball passed bat, he will not ask for the UltraEdge (to see if it was a caught behind) and instead directly proceed to check the side-on replay for the stumping. If the TV umpire doesn't see a clear gap between bat and ball, only then he will refer to UltraEdge.

For stumpings, the new system will show the TV umpire tri-vision - essentially footage from side-on cameras as well as from front-on in a single frame. es off the turf.

The front-on camera angle is important because it gives an accurate picture of bails being removed. Previously the broadcaster would show the side-on angle from each side along with footage from Stump Cam. But Stump Cam records the action at a low speed of approximately 50 frames per second, as opposed to the Hawk-Eye cameras which record at approximately 300 frames per second, meaning there will now be more accurate footage for the umpires to base their decision on. The Smart Review System is also likely to provide more clarity in the case of a catch taken inch-
