### **Over 175 Fire Incidents In Srinagar** In First Two Months Of 2024

Majority Of Fire Incidents Due To Electric Short Circuits, LPG Leaks: Officials

**SRINAGAR, MAR 26:** Srinagar is grappling with a concerning surge in fire incidents in recent months, with the majority of the incidents happening due to "electric short circuits and LPG leakage", an official said.

A senior official of the Fire & Emergency Services department told the news agency-Kashmir News Observer (KNO) that during the last two months, over 175 fire incidents have been reported in Srinagar. Most of these incidents, he said, were caused by electric short circuits, followed by LPG gas leaks.

"The ongoing year has so far recorded over 175 fire incidents resulting in the death of at least 3 persons and injuries to two. Primarily, most of them have occurred due to the electric short circuits after indiscriminate use of heating gadgets and excessive load on the department. wires," the official said.



According to the officials, despite holding frequent fire and safety awareness camps, during the year 2023, district Srinagar received around 550-600 fire calls. Many people, the official lamented, have ignored the Dos and Don'ts of fire safety guidelines issued by the



The weather will generally remain dry from April 1-4, the MeT office said.

It has also issued an advisory for travelers and tourists to plan their trip accordingly, particularly on March 30.

Farmers have been advised to suspend farm operations during March 27-31. There is a possibility of thunderstorms, lightning activity, a hailstorm, and gusty winds from

There is also the possibility of landslides, mudslides, and shooting stones during the period in view of inclement weather.

The day temperature at most of the weather stations in Kashmir Valley was recorded at 7-8 degrees Celsius above normal the previous day, while the night temperature also improved above normal during the intervening nights of Monday

Srinagar, the summer capital, had a low of 5.4 degrees Celsius, and it was 0.4 degrees Celsius above the normal of 5.0 degrees Celsius on Tuesday.

The tourist hot spot of Pahalgam in south Kashmir's Anantnag district recorded a low of 0.7 degrees Celsius, and the famous ski resort of Gulmarg in north Kashmir's Baramulla district recorded a low of 2.6 degrees Celsius during the intervening nights of Monday and Tuesday. (UNI)

#### Over 175 Fire.....

Speaking on the issue, the Fire & Emergency Services official highlighted the need for increased awareness camps, programmes and heightened caution regarding fire safety measures across Kashmir.

"Simple precautions like regular maintenance of electrical appliances, proper storage of flammable materials, and awareness of fire evacuation procedures can significantly reduce the likelihood of such incidents," he stated.

Meanwhile, residents in Srinagar are expressing concerns over the frequent frequency of fire incidents in recent months. They emphasised the importance of measures to prevent loss of life and

"We have noticed an increase in fire incidents in Srinagar, and it is worrying. It's crucial for everyone to prioritise fire safety and take necessary precautions to avoid such emergencies," said Tahir Ramzan, a resident of Srinagar outskirts.

the remote hilly region of Mughal Maidan on the banks of river Chenab in district Kishtwar, Dr Singh said, he was touched by the large number of women and members of the Gujjar community who had added jest and colour to this pro-

While the earlier Congress governments had discarded the Gujjar community and left them to fend for themselves and lead a life of homelessness, Dr Jitendra Singh said, it is Prime Minister Modi who came up with the sensitive idea of providing a pukka / concrete house to every household regardless of caste, creed or religion. As a result, many Gujjar families which earlier lived in makeshift shelters today own a house of their own.

As for the entire region of Kishtwar is concerned, Dr Jitendra Singh said, from a neglected remote area, it has emerged as North India's power hub and has undergone amazing transformation in the last 10 years which is to be seen to be believed.

Dr Singh said today that Jammu and Kashmir's Kishtwar is all set to emerge North India's major "power hub" generating around 6,000 MW of power after the

completion of the ongoing power projects. During his address and later speaking to the media, Dr Jitendra Singh said that 6 to 7 major Hydro power projects have come in the region in a short span of 9 to 10 years ever since Narendra Modi took over as

Elaborating on this, he pointed out that the largest capacity project is Pakal Dul with a capacity of 1000 MW. Its estimated cost, as of now, is Rs.8,112.12 crore and expected timeline of competition is 2025. Another major project is Kiru Hydro-

electric project with a capacity of 624 MW. The estimated cost of the project is Rs. 4,285.59 crore and the timeline in this case is also 2025, he said.

The Minister further informed that at the same time, 850 MW Ratle project has been revived as a joint venture between the centre and UT of J&K.

In addition, the existing Dulhasti power station has an installed capacity of 390 MW, while Dulhasti II Hydroelectric project will have a capacity of 260 MW, he added.

Dr Singh said these projects shall not only augment the power supply position thereby making up for the shortage of power supply in the UT of J&K, but the huge investment being made for construction of these projects is also a boost for direct as well as indirect opportunities for the local people.

For six long decades, said Dr Jitendra Singh, the successive governments at the Centre and the State had ignored Kishtwar region because of their vote bank politics. It was only after Prime Minister Modi took over that he changed the work culture and ensured that all neglected regions would be given their due attention and priority so that they may also rise to the same level.

For example, he said, for several years, people here had been agitating and demanding a Degree college for Paddar but Congress and National Conference governments deliberately ignored this demand. It was only after Prime Minister Narendra Modi took over in 2014 that a Degree college was sanctioned for Paddar under Centre's scheme RUSA (Rashtriya Uchchatar Shiksha Abhiyan).

Citing another example, Dr Singh said that before 2014, road travel to Kishtwar was cumbersome and on the slightest landside, the Doda-Kishtwar road got blocked. But today, the road travel time from Jammu to Kishtwar has reduced from over 7 hours in 2014 to less than 5 hours now. Similarly, he said, during these 9 years, Kishtwar has come up on the Aviation Map of India and has been sanctioned an airport under Centre's UDAAN Scheme, which nobody had ever imagined.

Similarly, Dr Singh said, three new national highways including Khilani-Sudhmahadev Highway, a series of Degree Colleges, mobile towers enroute Machail Yatra and other remote areas have also come up during the Modi government, he said.

As for Machail, Dr Jitendra Singh said, mobile towers have been set up, multiple toilet complexes constructed and solar plants installed for regular power supply, and all this happened only after 2014. Not only this, the motorable road to Machail is under fast track construction and the day is not far when Kisthwar to Machail travel would be just about 1 1/2 to 2 hours, he added. (UNI)

compensation being paid by the government was not as per the town criteria.

"Ushkara is within the municipal limits and even our houses that we built here need permission from the municipal committee. But now when our land is being acquired, we have been considered to be outside municipal limits thereby making us suffer," said a resident Mohammad Ashraf.

He said the land acquired for the bypass passes through the fully grown apple orchards and many residents earn their

livelihood from them. "Now that land is being acquired for the road, we need justice as for as the compen-

sation is concerned," he said. The residents had already represented the concerned authorities including Divisional Commissioner Kashmir to review the compensation amount however it has been to no avail.

'We are now contemplating to approach the courts with our plea as the authorities have not addressed our grievances", another resident said whose orchard land too is being acquired for the proposed

by-pass. He said that orchardists in other localities of the town including Khanpora, Rangwar and Kanthbagh are being compensated fairly well while the people in Ushkara are being offered the lowest rates as compensation for land acquisition, which is sheer injustice.

The residents have appealed to the UT administration to award them compensation in line with other localities.

A senior official of the Baramulla district said that compensation is awarded as per the stamp rates prevailing in the area.

"However, if anyone is aggrieved, there is a proper procedure which they should follow," the officer said, adding that all procedures for the land acquisition are being followed.

The proposed bypass road would start from Kanispora on the left side of the highway while coming from Srinagar and would emerge on the outskirts of Khanpora locality traversing a distance of around 13 kilometres.

The most of the land acquired for this project- which is the third phase of the Srinagar-Baramulla National Highway

widening and up gradation project- consists of prime Horticulture land of Baramulla, famous for its red delicious apple

The proposed by-pass road would be connected with the strategic Baramulla-Uri Stretch of the Highway which runs upto Kaman post-the last post on the Line of Control. The work is also underway for the double-laning of Baramulla Uri highway.

for the pilgrims for the pilgrimage. Official sources stated that preparations for the annual yatra have already commenced as health certificates are being arranged in ten districts of Jammu division.

"As the exact date for the start of the yatra is yet to be announced officially but as per reports, it is likely to begin from June 29," they added.

Sources said that the health certificates will be issued from March 15 onwards and will be considered as valid passenger

"The Directorate Health Jammu has submitted the details of nominated doctors to the administration," they added and said that the Kathua and Jammu districts boast the highest number of designated health centers, including associated hospitals, community health centers (CHC), and district hospitals.

As per sources, Lieutenant Governor Manoj Sinha, who is also Chairman of Shri Amarnath Shrine Board also recently chaired a meeting here at Raj Bhawan and discussed the arrangements and preparations for the yatra.

The 52-day long pilgrimage concludes on August 19 on the occasion of Rakshahandhan.

"After the conclusion of the Lok Sabha Polls, the administration will get busy with Shri Amarnath preparations, likely starting from June 29 and conclude on August 19,"

will seek the court's intervention to stay the decision to increase reservation, against unconstitutional acts. Merit must prevail for all students," the Association said in a statement.

"We have sought timing from the J&K Lieutenant Governor regarding the concerns of students. Besides, our delegation will meet concerned ministers and opposition leaders," the statement said.

They, however, made it clear that their stance was not against any community, region, religion, or faith.

"Our concern lies solely with the fairness and balance within the reservation system. While we support the principle of reservation, we believe that a 70% reservation over 30% open merit ratio is disproportionate and unjust. This disproportionality undermines the merit-based approach that is essential for fostering equal opportunities and excellence," they said.

The J&K recently announced a separate 10% reservation for Paharis and other tribes. The administration also amended the Jammu and Kashmir Reservation Rules, 2005 in the light of Jammu and Kashmir Reservation (Amendment) Act, 2023 dated 15.12.2023, Constitution (Jammu and Kashmir) Scheduled Castes Order (Amendment) Act, 2024, Constitution (Jammu and Kashmir) Scheduled Tribes Order (Amendment) Act, 2024 and recommendations of Jammu and Kashmir Socially and Educationally Backward Classes Commission.

The open merit aspirants are fuming over reducing them to mere 30 percent.

"JK admin's decision to increase ST reservation by 10% at the expense of open merit is a blatant disregard for meritocracy and fair opportunities. Slashing open merit to just 30% is a betrayal of 70% population, This isn't appeasement, it's MURDER," an aspirant Sahil Parray posted on X.

While no top politician has opposed the move, the former Mayor of Srinagar J&K Apni Party, Junaid Mattu is the only exception.

"Pahari leaders are speaking up for Paharis. Gujjar leaders are speaking up for Gujjars. But who will speak for victims belonging to the Open Merit category in J&K - the suffocated political orphans in today's circumstances? A cry for meritocracy has no political dividends?," Mattu posted on X recently. (UNI)

"My message in writing is to open up but just to yourself and express your emotions, never let them overtake your life," she said.

"Don't look yourself down at least put a step forward and see the world cheering you up, there will be hurdles but you need to feel and get through the struggles in order to taste the success," she said in her message to budding writers, while adding that, "I think if somebody has even tried to write a sentence, it depicts a situation, it depicts some episodes, and it contains a story that he/she is trying to share with the world".

"The object of bail is neither punitive nor preventive. Deprivation of liberty must be considered a punishment unless it can be required to ensure that an accused person will stand his trial when called upon," Court said.

Court observed that accused has been in custody for a period of more than three months, weighs in the mind of this court and a balance between the rights of the accused as to his liberty and larger public interest of the society has to be struck.

"Accordingly, the application for grant of bail is allowed," Court said. Earlier, while referring to various provisions of law and Supreme Court judgments, defence counsel Advocate Aamir Masoodi submitted that severity of punishment is very less and punitive

beyond seven years in the present case. "My client is not required for custodial interrogation as he is lodged

in judicial custody now," he added. On 31 December 2023, J&K Police said that it identified six individuals connected to the fraudulent activities of 'Curative Survey Private Limited, and

arrested one person from Tamil Nadu. The accused company is alleged to have duped hundreds of people across Jammu and Kashmir in lieu of providing sustained monthly income after paying registration fee and participating in online surveys.

### **PDD Warns Employees Against Demonstrations, Strike In Light** Of SC Ruling, Employees **Conduct Rules**

JAMMU, MAR 26: The Jammu and Kashmir Power Development Department has warned departmental employees against demonstrations or strikes, citing the government instructions, J&K Government Employees (Conduct) Rules and ruling of the Supreme Court.

In an instruction circular issued here today, (circular no. 03-JK PDD of 2024 dated: 26-03-2024), the department said 'it has come to notice that some employees are resorting to demonstrations and strikes in favour of certain assumed demands, which is totally illegal'.

Citing the government instructions, J&K Government Employees (Conduct) Rules and ruling of the Supreme Court for dealing with such issues, the circular said that the Rule 20 (ii) of the Jammu and Kashmir Government Employees (Conduct) Rules, 1971 clearly underlines that; no government employee shall resort to, or in any way abet any form of strike in connection with any matter pertaining to his service or the service of any other government employee".

Elaborating further, it said that Vide SRO-160 dated 14-7-1995, the Jammu and Kashmir Civil Services (Recognition of Service Association) Rules, 1995 issued by the General Administration Department prohibit Gazetted officers from making associations.

These rules further provide that recognition of the Service Associations already registered can also be with-

drawn if the government is satisfied that such association is violating the service conduct rules, or is not fulfilling the conditions laid down in the rules.

The Circular also mentioned General Administration Department's communication of 2023, warning the government employees to desist from uncalled demonstrations and strikes, which constitute an act of serious indiscipline and misconduct.

Quoting a ruling by the Supreme Court in case Appeal (Civil) No.5556/2003 titled T.K. Rangarajan vs Government of Tamil Nadu (SC 2003) the circular instructions read that the employees have no fundamental, statutory or moral right to resort to strike as there is no law regarding it, and also, according to various service and conduct rules, they are prohibited to go on a strike.

"A strike is a powerful weapon; it affects the society as a whole, and the government employees cannot go on a strike affecting society... Government employees cannot claim that they can take the society at ransom by going on strike. Even if there is injustice to some extent, as presumed by such employees, in a democratic welfare State, they have to resort to the machinery provided under different statutory provisions for redressal of their grievances. Strike as a weapon is mostly misused which results in chaos and total maladministration", it said.

The circular has warned that employees who intend to go on strike or demonstrations, or those found organising such demonstrations shall be dealt with strictly as per law.





### **Probe Agency Attaches Assets Worth More** Than ₹ 124 Crore In Money Laundering Case

#### ■ HT News Network

New Delhi: The Enforcement Directorate on Tuesday said it has attached assets worth more than 124 crore belonging to various companies as part of a money laundering investigation against Religare Finvest Limited (RFL) and others.

The properties attached, as part of a provisional order issued under the Prevention of Money Laundering Act (PMLA), are in the form of land and farm houses located in the "posh" area of Gurugram and Delhi and belong to RS Infrastructure Pvt. Ltd., Kenwood Mercantile Pvt. Ltd., M/s Goodfaith Builders Pvt. Ltd. and others, the central agency said in a statement.Kenwood Mercantile Pvt. Ltd. and Goodfaith Builders Pvt. Ltd are entities belonging to the M3M group, a Gurugram-based realtor and 430 acres of land in Gurugram and Faridabad belonging to these entities has been attached being the "proceeds



of crime flowing through a maze of companies to the M3M group", it said.

The agency alleged a partnership firm by the name of M3M India Holdings -- with its partners Roop Kumar Bansal, Basant Bansal, Abha Bansal and Pankaj Bansal-- had received "proceeds of crime in excess of 500 crore by showing sale of shares of a land owing company RS Infrastructure Pvt Ltd at a grossly inflated value of 726 crore to an entity Lowe Realty Pvt. Ltd. (currently known as Lowe Infra and Wellness Pvt. Ltd.)".

The land owned by RS Infrastructure Pvt. Ltd. was "deliberately inflated" by M3M India Holdings (former shareholder of RS Infrastructure Pvt. Ltd.) to drain out hefty funds from Lowe Realty Pvt. Ltd. which borrowed the same amount from Religare group, the agency claimed.

Mr Fadnavis said Gadchiroli district, part of which is affected by Naxalism, will be transformed into an industrialised one in the next five years with scope for multiple employment opportunities without touching the water, land and forest of tribals.

## 2.2 Million Videos In India Removed By YouTube Over Violation Of Guidelines

New Delhi: YouTube removed over 2.25 million videos in India between October and December 2023 for the violation of its community guidelines, with the country topping the list of video takedowns ahead of nations like the US and Russia.

Singapore with 1,243,871 video takedowns ranked second on that list and the United States (788,354) was placed third, according to YouTube's data on video removals by the country/region of upload.

Indonesia ranked fourth (770,157), while for Russia the number of video takedowns stood at 516,629, as per YouTube's Community Guidelines Enforcement report that provides global data on the flags YouTube receives and how the Google-owned platform enforces policies.

Globally, during the period (Q4 2023) YouTube removed over 9 million videos for falling foul of its community norms. More than 96 percent of these videos were first flagged by machines rather than humans.

The videos were removed for violat-



ing community norms on parameters like harmful or dangerous content, child safety, violent or graphic content, nudity and sexual content, misinformation and others.

The latest report showed that between October and December 2023, over 2.25 million videos (2,254,902) were removed in India for violating YouTube's community guidelines. India topped the list of 30 countries in video removals.

Globally, 20.5 million (20,592,341) channels were removed by YouTube for violating its community guidelines during the quarter ended in Decem-

The report explained that when a channel is terminated, all of its videos are removed. The number of such

videos removed during this time period due to a channel-level termination stood at 95.5 million (95,534,236).

"A YouTube channel is terminated if it accrues three community guidelines strikes in 90 days, has a single case of severe abuse (such as predatory behaviour), or is determined to be wholly dedicated to violating our guidelines (as is often the case with spam accounts)," YouTube said.

The Google-owned video streaming platform said it works hard to maintain a safe and vibrant community.

"We have Community Guidelines that set the rules of the road for what we don't allow on YouTube," it said.

For instance, it does not allow pornography, incitement to violence, harassment, or hate speech. YouTube said it relies on a combination of people and technology to flag inappropriate content and enforce these guidelines. Flags can come from automated flagging systems, from members of the Priority Flagger program, or from users in the broader YouTube

# "Heroes": All-Indian Crew's SOS Saved Lives In US Bridge Collapse, Says Governor

The container ship that rammed a bridge in US' Baltimore, causing it to collapse almost entirely and sending cars and people plunging into the river below, was manned entirely by a crew of Indians. This was confirmed by shipping company Maersk, which had chartered the Singapore-flagged container ship, named Dali.

According to a report by news agency AFP, several vehicles and nearly 20 people are believed to have fallen into the Patapsco River after the 300-metre-long vessel crashed into one of the legs of the bridge. The ship had a crew of 22 members, all of whom were Indian. Quoting the Synergy Marine Group, which manages the Dali, a report said all crew members had been



accounted for and none of them were injured.

Footage showed lights going out on the ship just before it rammed a leg of the Francis Scott Key Bridge, a portion of which collapsed on the vessel itself.

Maryland's governor said the ship, which was moving at a "rapid" eight knots (nine

miles per hour), issued a Mayday call moments before it collided with the pillar of the bridge and this helped saved lives as some road traffic could be stopped.

"These people are heroes. They saved lives last night," Governor Wes Moore was quoted as saying by news agency AFP.

The Dali struck a pylon of the bridge at approximately 1:30 am local time (11 am IST) on Tuesday. Vehicles could be seen on the road surface as the bridge warped and crashed in sections, with the third tranche cantilevering upwards before it, too, tumbled into the water.

Rescuers said they were still looking for at least seven people, having pulled two people free.

Baltimore Mayor Brandon Scott said maintenance workers were on the bridge at the time of the collision, an incident he described as an "unthinkable tragedy... like something out of an action movie."

"We have to be thinking about the families and people impacted, folks who we have to try to find," he said.

In a statement, Maersk said, "We are horrified by what has happened in Baltimore, and our thoughts are with all of those affected... We can confirm that the container vessel 'DALI', operated by charter vessel company Synergy Group, is time chartered by Maersk and is carrying Maersk customers' cargo. No Maersk crew and personnel were onboard the vessel."

"We are closely following the investigations conducted by authorities and Synergy, and we will do our utmost to keep our customers informed," it added.

# **The Wandering Dark** Shadow Of World War -3rd

Tensions on the front line in Ukraine continue to grow, bringing forward the possibility – as French President Emmanuel Macron declared last week - of a serious and grim expansion of this war further into Europe.

At the same time, other hotspots around the globe, from Asia to Africa, keep heating up. In light of all these events, one cannot help but wonder what a third world war might look like. Obviously, this goes beyond (or before) a nuclear holocaust that would reduce the planet to radioactive waste. Would the new technologies we keep hearing about mean it would be different from the first two world wars?

As we read of new defense tech developments that involve humanoids or drones coupled with artificial intelligence and quantum technology, there is an indirect dissemination of information telling the general public that any potential big war will be similar to science fiction. It will be a war where these drones and humanoids face each other, while children, women and men stay safe at home waiting for a winner. A war where everything is virtual and cyberattacks replace bombs and shells, leaving interruptions to Wi-Fi and short power cuts as the biggest risks.

We will not delve into the point that cyberattacks on key infrastructure, such as energy sites or dams, could cause catastrophic damage. But is this view that many in the general public hold actually true: that they will be safe at home while war takes place in another dimension with lasers and other tech gimmicks we cannot see? A preliminary answer refuting this view comes straight away. It lies in the  $discreet\,yet\,persistent\,focus\,of\,Western$ leaders on reestablishing a militaryindustrial capacity. It is said that history does not repeat itself but it often rhymes. In that sense, the situation in 2024 resembles the situation in 1935, whether in terms of Western military-industrial capacity or technological competition between the two opposing sides. Moreover, we also notice a similarly troubled world map, where order is no longer clear and conflicts arise in an unpredictable manner, without a clear understanding of the endgame. Conflicts where ideology, brute force and technology all come into the mix. Some even see the Spanish Civil War in many places on the map of the world.

One might even say that, today, the length of time for which total superiority lasts has shrunk. It is becoming rare for one side to maintain indefinite total superiority over the other.

The situation in Ukraine with its rules of engagement is probably the best answer to what a world war might look like. The reality is that nothing has changed and war will be a meat grinder in the worst possible sense. Once drones match drones, humanoids match humanoids, AI matches AI and quantum computing matches quantum computing, all technologies and their use will cancel each other out. Then, war will take its usual and ugly form of men killing men and trenches that look like the ones used in the First and Second World Wars, only with more powerful bullets. Thinking, as many of the public tend to believe, that robots and drones will do the fighting, just as apps allow food to be cooked and delivered for us, is complete delusion.

# Why Leaders Need Flexible Communication Skills

Whether you're the CEO of a major corporation or team leader on a small project, you'll find that you spend most of your work time talking with your subordinates. Particularly at higher levels of the organizational hierarchy, managers spend 70 percent to 80 percent of their time in discussion, mostly with those working under them. Leaders employ a variety of communication styles, but generally speaking, the goal is to get their subordinates to work toward a common goal.

According to German psychologists Niels van Quaquebeke and Fabiola Gerpott, leadership communication styles tend to fall into two types, which they call tell-and-sell and ask-and-listen. They outline the differences between these and the right situations for using each in a paper they recently published in the journal Current Opinion in Psychology.

#### Tell-and-Sell and Charismatic **Leadership Style**

Leaders may tend to use one or the other style when they engage with their subordinates, but van Quaquebeke and Gerpott maintain that truly effective leaders need to be flexible in their communication styles, using each according to the particular situation and the specific goals the leader hopes to achieve.

In the tell-and-sell approach, leaders communicate a common goal to their subordinates. This is the "tell" part. Leaders then try to convince their subordinates that this is a goal they want to work towards. This is the "sell" part.

To be effective, leaders who use the tell-and-sell approach will have to rely on their personal charisma to win over the hearts and minds of their subordinates. Autocratic leaders may tell their subordinates what to do and expect them



to obey. But without the sell part, subordinates will passively comply to the minimum extent necessary to avoid punishment, and they may even actively work to sabotage their leader's goal.

In contrast, charismatic leaders can actually get their subordinates to want to work hard and make sacrifices, because they have bought into the vision their leader has sold them. We only need to think about famous charismatic leaders such as Steve Jobs or Barack Obama to see just how effective the tell-and-sell leadership style can be in galvanizing a corporation or a country toward a common goal.

#### **Ask-and-Listen and Democratic Leadership Style**

The tell-and-sell approach works well when leaders already have a clear vision of a common goal and the pathway to reach it. But when this isn't the case, leaders can be more effective when they use the ask-and-listen communication style. In this approach, leaders present a general idea of a goal but seek input from their subordinates to clarify that goal as well as to plan the pathway to it.

In the ask-and-listen approach, the leader's role is to create a safe environment for all subordinates to express their opinions. Thus, leaders have to listen to their subordinates' responses without judgment, trusting that the discussion will work its way toward a consensus. Although leaders should refrain from expressing their own opinions at this point, they do need to ask questions and use paraphrases to clarify understanding.

When leaders use the ask-and-listen communication style, they aren't trying

to sell a common goal to their subordinates. Rather, they're trying to lead their subordinates into building a common goal of their own making. Because all members have had their voices heard, and because the group has come to a consensus, dedication to the cause is generally quite strong. This approach works well when there's flexibility in the outcome the leader hopes to achieve.

#### **Choosing the Right Communication** Style for the Situation

 $Both \, leadership \, communication \, styles \,$ can be effective, but they work in different ways. The tell-and-sell approach is about giving subordinates a sense of who they are as a group. We are the ones who will make the next major technological breakthrough. We are the ones who will overcome problems to make society better.

In this way, subordinates gain a sense of being part of something bigger than themselves.

In contrast, the ask-and-listen approach is about giving subordinates the sense that they can work together to achieve common goals. Because the leader has listened with an open mind to their ideas, the subordinates feel empowered to put the plan they devised into action, and because that plan arose from the group, they'll generally feel quite devoted to it.

If you've found yourself in a leadership position before, you probably see yourself in one of these two styles. However, as van Quaquebeke and Gerpott point out, it's not a question of which leadership communication style is better. Rather, it's about which one will be more effective in a particular situation.

To be an effective leader, you need to be flexible in your communication style. If you have a clear vision, tell-and-sell is the right approach, but you'll have to rely on your personal charisma to get your subordinates on board. In contrast, if you're looking for a creative solution to a problem, and if your subordinates have sufficient expertise, an ask-and-listen approach is the way to go. And you won't have to sell them on the idea, either, as they'll buy into it themselves.

# PM Modi To Flag Off BJP's **Uttar Pradesh Campaign From Meerut On March 30**

### Nirmala Sitharaman Counters Jairam Ramesh's Criticism Of Pension Scheme

New Delhi: Reacting to Jairam Ramesh's remark that Atal Pension Yojana is a "poorly designed scheme", Union Finance Minister Niramala Sitharaman today slammed the Congress general secretary and said that the Congress prefers that the poor should not have pensions so that they are forced to rely on government handouts, which keeps them dependent on "dynasty politicians".

The Congress today attacked the Modi government over the Atal Pension Yojana, alleging it is a "very poorly-designed scheme" and a "paper tiger" that needs officials to hoodwink and coerce people into participating in it.

Lashing out at Congress' criticism of the Atal Pension Yojana, Ms Sitharaman said, "On the Atal Pension Yojana, Jairam Ramesh known for using verbal sophistry to hide facts, is being malicious or is ignorant of the basic tenets of designing a good pension scheme."

She further said that the Atal Pension Yojana is designed based on best practice choice architecture to automatically continue the premium payment unless the subscriber opts out.

"This is a deliberate and beneficial feature which is in the best interest of the subscribers. Instead of requiring people to decide each year to continue, they have to take a decision to discontinue. This makes many of them take the right deci-

sion and save for their retirement," she posted on X."Richard Thaler (Nobel prize winner in Economics 2017) and Cass Sunstein (a Professor who worked in the Obama administration) are known for their book 'Nudge' which explains the need for proper 'choice architecture' in designing pub-

lic schemes," she said.

### "Encourage Fair, Transparent Legal Process": US On Arvind Kejriwal Arrest

New Delhi: The United States government is monitoring reports of Arvind Kejriwal's arrest and has encouraged its Indian counterpart to ensure "a fair, transparent, and timely legal process" for the jailed Delhi Chief Minister and opposition leader, a State Department spokesperson told Reuters this week.

The US' response comes days after Germany's Foreign Office stressed that the Aam Aadmi Party leader, like any other Indian citizen facing charges, is entitled to a fair and impartial trial.

'We assume and expect that standards relating to independence of judiciary and basic democratic principles will also be applied in this case," a German government spokesperson said Friday.

The Indian government reacted strongto the comment, summoning the German envoy and labelling the Foreign Office spokesperson's remark "blatant interference in internal matters".

"We see such remarks as interfering in our judicial process and undermining the independence of our judiciary," the External Affairs Ministry said, "Biased assumptions are most unwarranted."

Asked about India's protest to Germany, the State Department spokesperson told Reuters, "We refer you to the German Foreign Ministry for comment on their discussions with the Indian government."

Prime Minister Narendra Modi's government has not yet reacted to the US State Department.



The Enforcement Directorate took Mr Kejriwal into custody last week - in dramatic circumstances after a Delhi court refused protection from arrest-following a late-night raid at his residence.

He was sent to custody of the central agency for seven days; i.e., till Thursday.

### After Karnataka Man Loses Rs 1 Crore In IPL Betting, Wife Dies By Suicide

Bengaluru: Darshan Babu is an engineer who is fond of betting on cricket matches  $and \, has \, been \, placing \, major \, bets \, on \, Indian \,$ Premier League (IPL) games since 2021. He often borrows money after losing a bet, or to place one when he is short on funds. His 23-year-old wife, tired of the constant harassment by creditors, died by suicide.

Ranjitha was found hanging at her home in Karnataka's Chitradurga on March 18. According to the family, Darshan had racked up a debt of over 1 crore.

He worked as an assistant engineer in the Minor Irrigation Department at Hosadurga and had been ensnared in the realm of IPL betting from 2021 to 2023. This took a major toll on the couple's finances. Allegedly, he had borrowed over 1.5 crore to place bets after his luck ran out and he lost all his money. While he managed to return

1 crore, cops say that he still has a pending loan of 84 lakh.

Ranjitha married Darshan in 2020. She realised the truth about Darshan's involvement in betting in 2021, claims her father Venkatesh.

In his complaint, Venkatesh said that



his daughter was extremely distressed due to the constant harassment by moneylenders and this led to her suicide. He has also named 13 men who had allegedly lent the money.

He said that his son-in-law was lured into betting with a promise of quick money."He (Darshan) was not willing to get into betting, but the suspects forced him saying it was an easy way to get rich. They promised to finance his betting activities against some blank cheques as security," he said.

Cops during their investigation found a suicide note, where she detailed the harassment they faced. Darshan and Ranjitha have a two-year-old son.

### BJP To Go Solo In Punjab, Stage Set For 4-Way Fight For 13 Lok Sabha Seats

Chandigarh: The BIP will go solo in the election for 13 Lok Sabha seats in Punjab, state party chief Sunil Jakhar said in a video message today, putting an end to speculation on a possible tie-up between the BJP and its estranged ally Shiromani Akali Dal (SAD).

"The BJP will be contesting the Lok Sabha polls in Punjab alone. The party has taken this decision on the basis of feedback from the people, party workers and leaders," Mr Jakhar said, stressing that the Narendra Modi government had worked tirelessly for Punjab and the work is not hidden from anyone.While it is the BJP that has officially pulled the plug, the Akali Dal had dropped broad hints on its plan to go solo after a meeting of its core committee this Friday.

The key reason behind the two parties not joining hands appears to be a mismatch in their core ideological planks. The Akali Dal's panthic agenda to reach out to Sikhs appears to clash with the BJP's nationalist posturing. Also, unlike in 1996, when the Akali Dal joined hands



with BJP for an alliance that lasted over two decades, the Sukhbir Singh Badal-led party set conditions for another tie-up.

The party resolution said that the Centre must honour its commitment to release all Sikh prisoners who had completed their terms and fulfil all promises made to farmers.

"The party will continue to put principles above politics, and it will never deviate from its historic role as a champion of the interests of Khalsa Panth, all minorities as well as all Punjabis," the resolution said.

"As the sole representatives of the Sikhs and of all Punjabis, the party will continue its fight for more powers and genuine autonomy to the states," it added.Doubling down on its support to farmers protesting against the Centre, which had prompted Akali Dal to exit the NDA in 2020, the resolution said Akali Dal will continue to champion the cause of farmers and farm labourers. "SAD is the largest representative demo-

cratic organization of the

farmers and has always

been in the forefront of fighting for their interests," it said. It also opposed "any attempts to dilute, in letter or in spirit, the Constitu-

### **Madhya Pradesh Woman Attempts Suicide With 3 Daughters, 1 Survives: Cops**

Bhopal: In a tragic incident in Madhya Pradesh's Bhopal on Tuesday, a woman hanged herself along with her three daughters, following which the woman and her two daughters died while one girl was admitted to hospital in a serious condition, a police official said.

The incident occurred in Rondia village under the jurisdiction of Gunga police station in the state capital on Tuesday morning. Those who died were identified as Sanjeeta (28), Aradhya (5) and Shrishti (1.5) while one girl undergoing treatment has been identified as Manu (2.5 years). On getting the information, the police rushed to the spot and started an investigation into the matter.

Bhopal Superintendent of Police (SP, rural) Pramod Kumar Sinha told news agency ANI, "We received information at 7:30 in the morning that a woman had hanged herself along with her children in Rondia village under Gunga police station. Acting on it, the police reached the spot and found that a woman along with her two children were dead and a girl was sent to the hospital."

After that, the police called the FSL (Forensic Science Laboratory) team and after performing the Panchnama, all the bodies were sent for post-mortem examination, he added."In the preliminary investigation so far, we came to know that the woman was in trouble with her in-laws. Her husband was addicted to liquor and also used to beat the woman. Information about dowry harassment and torture due to having only three girls and not having a son has also come to notice. We are investigating all aspects and whatever facts are revealed, based on it action will be taken," the officer added





# Israeli operation rages around major Gaza hospitals

GAZA STRIP: Israeli forces fought fighters in besieged Gaza on Monday including around at least two major hospitals, raising fears for the patients, medics and displaced people trapped inside.

Troops and tanks have encircled Gaza City's Al-Shifa Hospital, the territory's biggest, for a week and more recently moved on the Al-Amal Hospital in the main southern city of Khan Yunis.

While Israel has labelled its operations "precise" and said it has taken care to avoid harm to civilians, aid agencies have voiced alarm about civilians caught up in the fighting.UN chief Antonio Guterres, on a crisis visit to the Middle East, has pleaded for an end to the "nonstop nightmare" for the 2.4 million people trapped in Gaza's worst-ever crisis.

As Israel's top ally the United States has also voiced rising concern. US Vice President Kamala Harris stressed on ABC TV that a Rafah invasion would be "a huge mistake" and, when asked whether she would rule out "consequences" for Israel, replied that "I am ruling out nothing": 'We are suffering' The health ministry in the



Gaza Strip put the total Palestinian death toll at 32,333, most of them women and children. Bombardment and fighting in Gaza killed another 72 people overnight, according to the ministry. More than 50 airstrikes rained down on the Gaza Strip, said the Hamas government press office. Food and water shortages have deepened the suffering, especially in northern Gaza where residents, mostly women and children, were waiting in line to fill up jerrycans and buckets in Jabalia. Palestinians living near Al Shifa report hellish conditions, including corpses in the streets "We don't even have food to give us the energy to go to collect the water — let alone the innocent children, women and the elderly," said one man, Bassam Mohammed al-Haou. Another local man, Falah Saed, said "we are suffering a lot from water shortages because all and pipes and pumps have stopped working since the beginning of the war". Hospital battles Palestinians living near Al Shifa have reported hellish conditions, including corpses in the streets, constant bombardment and the rounding up of men, who are stripped to their underwear and questioned.

The Al Shifa raid was in its eighth day and the military reported detaining some 500 people. Israel has said the operation will continue until the last militant is "in their hands", signalling an extended presence at Al Shifa, which troops also raided in November.

At Al Amal Hospital, the Palestinian Red Crescent said Israeli forces had surrounded all entrances and prohibited hospital staff from leaving.

The military said its Al Amal operation included "raids on several terrorist infrastructure sites in the area and located explosive devices, RPGs (rocket-propelled grenades) and military equipment".

## Trump wins lifeline in civil fraud case

NEW YORK: Donald Trump was thrown a huge lifeline on Monday when an appeals court slashed what could have been a crippling demand for a nearly half-billiondollar bond payment and also gave him 10 more days to pay.

The Republican presidential candidate got the unexpectedly positive news about his New York civil fraud case while he was sitting in court for another case — a hearing in his upcoming criminal trial over paying hush money to a porn star.

Trump had been facing a Monday deadline to pay the huge original bond pending an appeal against a judge's decision that he is liable for fraudulently conspiring to inflate his net worth.

Trump had made clear he was unable to find the \$454 million and he risked seeing New York state confiscate parts of his property empire in response. Now with Monday's decision, he will have 10 more days to pay just \$175 million.

### EU probes Apple, Google, Meta under new digital law

BRUSSELS: The European Union on Monday hit Apple, Google parent Alphabet and Meta with the first-ever probes under a mammoth digital law, which could lead to big fines against the US giants.

Among six firms named as market "gatekeepers" under the EU's landmark Digital Markets Act — along with Amazon, TikTok owner ByteDance and Microsoft - the companies have been obliged to comply with the new law since March 7.

"We are not convinced that the solutions by Alphabet, Apple and Meta respect their obligations for a fairer and more open digital space for European citizens and businesses," said the EU's internal market commissioner, Thierry Breton.

In a series of late-night court hearings in Moscow that ran into the early hours of Monday, four of the men – with bruises and cuts over their faces — were dragged into the court in front of dozens of reporters who had assembled at the capital's Basmanny district court.

Russia's FSB said it had detained a total of 11 people. Security service officers wheeled one in to the hearing on a medical gurney, following reports and videos on Russian social media of bloody interrogations after the men were arrested on Saturday.

One of the suspects was shown having part of his ear cut off and stuffed into his mouth.

Another was shown with his hands tied and his hair held by an interrogator, a black boot beneath his head. Another was questioned in a hospital bed.

## Security Council finally ends paralysis on Gaza

UNITED NATIONS: The UN Security Council finally passed a resolution on Monday, demanding an immediate ceasefire in Gaza during Ramazan, an unconditional release of prisoners, and urgent expansion of aid into the besieged Palestinian enclave.

Reacting promptly after the vote, UN Secretary General António Guterres emphasised that the long-awaited resolution must be implemented as the council's failure to do so "would be unforgivable".

The decision came after last-minute discussions within the council successfully avoided another potential veto.

The draft resolution was passed, because





the US did not use its veto and abstained. However, a Russian amendment failed due to insufficient votes. In the substantive vote, 14 members voted in favour of the resolution.US Ambassador Linda Thomas-Greenfield emphasised that in adopting the resolution, the Security Council demonstrated support for ongoing diplomat-

ic efforts led by Washington, Qatar and

Egypt to achieve an immediate and sustainable ceasefire, secure the release of all prisoners, and alleviate the suffering of Palestinian civilians in Gaza."The United States fully suports these critical objectives," she affirmed. "These objectives formed the basis of the resolution we proposed last week, a resolution that Russia and China vetoed."Thomas-Greenfield

### **US Bridge Collapses After** Ship Collision, Vehicles, **People Fall In Water**

Washington: A major bridge in the US city of Baltimore almost entirely collapsed Tuesday after being struck by a container ship, sending multiple vehicles and up to 20 people plunging into the harbor below. Dramatic footage showed a 300-meter vessel hitting

a footing of the Francis Scott Key Bridge, sending the steel-built structure crashing into the Patapsco River. Lights from what appear to be vehicles can be seen on the road surface as the bridge warps and crashes

in sections, with the third tranche cantilevering upwards before it, too, tumbles into the water. Several small explosions can also be seen during the rapid collapse."Unfortunately, we understand that there were up to 20 individuals who may be in the

Patapsco River right now as well as multiple vehicles,' Kevin Cartwright of the Baltimore Fire Department told CNN."So we have... a mass-casualty multi agency incident underway. "We understand that there could have potentially

been a vehicle, a tractor trailer or a vehicle as large as a tractor trailer on the bridge at the time that it collapsed."The footage appeared to show the ship going dark twice in the moments before the collision, with thick black smoke issuing from the ship's funnel, possibly indicating activity from the engine.

### **US Woman Beats Mother To** Death With Cooking Pan, Calls 911 To Admit Crime

A woman in the US beat her mother to death with a cooking pan and then called the emergency number 911 to confess the brutal killing, according to NBC News. Quoting police, the outlet further said that a domestic dispute was the cause behind the woman's extreme action. Police were called to the home at Westchester Avenue in Bronx, New York City and found a woman with a severe head injury just before 4 am. They further said that the 46-year-old woman was unresponsive with a visible wound to the back of her head.Her 26-year-old daughter, identified by the outlet as Skydajah Patterson, called 911 and told the operator, "I just killed my mom." She alleged she did this in self-defence as her mother tried to attack her.

As per Metro, the policemen found Patterson still holding the kitchen pot that was full of blood.

No other witnesses were present at the scene, as per the police. The officers who reached house took 46-year-old

Selma McLean to Lincoln Hospital, where she was pronounced dead.

Her daughter, meanwhile, was taken into custody. The police have not immediately revealed what charg-

Selma Mclean had reportedly called cops two times in the past saying she was being attacked by her daughter, as per Metro.

### **5 Chinese Nationals Killed** In Suicide Bomb Attack In **Northwest Pakistan**

Peshawar: Five Chinese nationals were killed in an explosion when their convoy was attacked by a suicide bomber in northwest Pakistan on Tuesday, a top police officer said. A suicide bomber rammed an explosivesladen vehicle into a convoy of Chinese engineers which was on its way from Islamabad to their camp in Dasu in the Khyber Pakhtunkhwa province, Mohammad Ali Gandapur, the regional police chief, told news agency Reuters."Five Chinese nationals and their Pakistani driver were killed in the attack," Mohammad Ali Gandapur said. Dasu is the site of a major dam and the area has been attacked in the past. A blast on a bus had killed 13 people, including nine Chinese nationals. in 2021. The Khyber Pakhtunkhwa police had reached the spot and started relief operations. The rest of the people in the convoy have been protected, Mohammad Ali Gandapur said.

### **Bring Ex Pakistan PM Imran** Khan, Wife To Court On April 4, Orders Court

Islamabad: A Pakistani court on Monday ordered authorities to present jailed former premier Imran Khan and his wife Bushra Bibi on April 4 during the hearing of their appeal seeking bail in different cases. District and Session Court judge Tahir Abbas Sipra heard the case on the plea filed by the couple seeking bail in the cases about the forgery of receipts for Toshakhana gifts, while Mr Khan had also filed a peti-

tion to seek bail in a May 9 violence case as well. The order was issued after the Adiala jail officials failed to mark Mr Khan's attendance through a video link for which the order was issued at the last hearing. Last week, another district and sessions court approved a request seeking to produce Khan and PTI leader Shah Mahmood Qureshi in court, directing authorities to ensure the politicians' production on April 20.

The petition, requesting their production, was heard by Judicial Magistrate Mureed Abbas about the Parliament attack case against Mr Khan and others. Mr Khan had been implicated in dozens of cases since his removal from government in April 2022.

# Tips to play safe Holi

he most awaited summer festival is upon us! Holi is here and the excitement is at an all-time high because of all the fun that comes along with it. Holi holds a special place in everyone's heart.

The sacred festival brings an opportunity to connect, rejoice and rejuvenate. Down the ages, people have been delighted to splash colours on their near and dear ones to celebrate the occasion with gaiety and fun. The use of colours during Holi is not just for fun. The traditional Holi colours were extracted from plants like turmeric, neem and Palash and therefore had several positive health benefits.

To make sure that Holi 2024 is the happiest for you, here are a few tips.

Young babies have very delicate skin and immature immune systems. It is best not to put any colours on babies younger than six months because of their delicate skin. A red sandalwood tika should be enough to symbolically celebrate the festival.

We often do not pay attention to the protection of our eyes while playing Holi.

Avoid wearing contact lenses. The harsh chemicals can cause an infection by smearing your lens. Wear sunglasses/goggles to avoid any sort of optical injuries from any misfired water balloons and to prevent colours from coming in contact with the eyes. Avoid touching your eyes while playing Holi. Do not rub your eyes! Rub-

bing can aggravate the problems further. Dress yourself and your kids in fullsleeved clothes to create one more barrier between your skin and the colours.

Moisturizing skin with a natural oilbased moisturizer before heading out to play with colours is very important for a

dryness.. This also provides protection against colours.

You'll need to protect your nails too!



creates a barrier between your skin and the colours. It also helps the colours to be taken off easily upon washing.

Remember to apply sunscreen 20 minutes before going out in the sun. Use a sunscreen of SPF 20 and above on the neck, arms, and whichever part of your body is exposed to the sun. . If your skin is prone to pigmented patches, select a higher SPF. Most sunscreens have built-in moisturizers. If your skin is very dry, first apply the sunscreen, wait for a few minutes and then apply a moisturizer. Apply moisturising lotion or cream on the arms and

Apply leave-on conditioner or hair serum on hair before playing Holi. Oil your hair or wear a bandana/ scarf/ cap to cover your hair.

. Hair Cream containing sunscreen is also available in the market. Take very little, spread on both palms and massage light into the hair, or smooth palms over the hair. Or, apply pure coconut oil/ mustard oil and massage it lightly into the hair. Oil will make sure your hair doesn't get too dry and the colour also does not go deep into your hair, causing breakage and

quality nail paint to prevent your nails from getting stained.. This helps to protect the nails from absorbing Holi colours.

The real problem is the removal of colours after playing Holi. Rinse the face with plenty of plain water and then use a cleansing cream, or lotion. Apply and massage it on the face. Then wipe off with moist cotton wool. Remember to cleanse the area around the eyes too, using a light touch. A cleansing gel helps to dissolve the colours and facilitates their removal.

To make your own cleanser, take half a cup of cold milk and add one teaspoon of any vegetable oil, like "til," olive or sunflower oil. Mix well. Dip cotton wool into this mixture and use it to cleanse the

Use ubtan, a pack made with gram flour, curd and turmeric to remove the colour from your skin gently. This pack will not only help to reduce the colour of your skin, but it will also nourish it in the process and keep the damage away.

Sesame seed (til) oil can be used to remove colours from the body, massaging it on the skin. This not only helps to remove the colours, but gives added protection to

the skin. Sesame seed (til) oil actually helps to counteract sun-damage. While bathing, scrub the body gently with a loofah or wash cloth. Immediately after your bath, apply a moisturizer on the face and body, while the skin is still damp. This helps to seal in moisture.

If there is itching, add two tablespoons vinegar to a mug of water and use it as a last rinse. This helps to reduce itching. However, if the itching continues, and there is rash and redness, there may be an allergic reaction to the colour. Consult a doctor as soon as possible.

While washing the hair, first rinse with plenty of plain water to wash away the dry colours and tiny particles of mica. Then apply a mild herbal shampoo, working it into the hair with the fingers. Massage the scalp gently and rinse thoroughly with water again.

Beer can be used as a last rinse. It will soften and condition the hair. Add the juice of a lemon to the beer. Pour over the hair after shampooing. Leave on for a few minutes and rinse off with plain water.

The day after Holi, mix two tables poons of honey with half a cup of curd. Add a pinch of turmeric. Apply this on the face, neck and arms. Leave it on for 20 minutes and wash it off with water. Helps to remove tan and soften the skin.

Within the next few days give your hair a nourishing treatment. Mix one tablespoon of pure coconut oil with one teaspoon of castor oil. Heat and apply on the hair. Then dip a towel in hot water, squeeze out the water and wrap the hot towel around the head, like a turban. Keep it on for 5 minutes. Repeat the hot towel wrap 3 or 4 times. This helps the hair and scalp absorb the oil better. Wash your hair after


## Is Loss Of Appetite An Indication Of **Early Signs Of Kidney Disease?**

Dr Manoharan highlights, "In non-dialyzed chronic kidney disease patients and those undergoing maintenance dialysis, anorexia is primarily linked to the buildup of unidentified anorexigenic compounds and inflammatory cytokines. Additionally, alterations in appetite regulation, such as amino acid imbalances, contribute to increased transport of free tryptophan across the bloodbrain barrier. This results in a hyper serotoninergic state, which is conducive to reduced appetite. Increased PTH levels in patients with CKD are also associated with poor appe-



# IPL 2024: Klaasen Set For Rare Battle Against Bumrah

KOLKATA: Over the last couple of years, Sunrisers Hyderabad's Heinrich Klaasen has developed into one of the most fearsome hitters in T20 cricket. He was their top-scorer in IPL 2023 - 448 at a strike rate of 177 - and has begun 2024 with a ferocious display at Eden Gardens, where his 63 off 29 balls nearly upstaged Andre Russell. While all of the other SRH batters got starts against Kolkata Knight Riders, Klaasen was the sole reason they stayed in the chase as long as they did.

On Wednesday, against Mumbai Indians in Hyderabad, Klaasen could face a brand-new challenge. Well almost. His head-to-head battle with Jasprit Bumrah is only one-ball old, and he scored one run off it. In ODIs, he's faced 20 deliveries from Bumrah and scored 18 runs for one dismissal. Amid the glut of international and franchise cricket, the prospect of a new match-up between two players on top of their game is a rarity.

Given Klaasen's importance to Sunrisers, Mumbai could well keep the majority of Bumrah's overs for when he's in the middle. They will certainly minimise bowling spin to Klaasen-since

the start of 2023 he averages 148.5 and has a strike rate of 193 against spin in T20 cricket. But Klaasen's no mug against pace either. He has a career strike rate of 148.45 against the quicks, and dispatched Mitchell Starc for three sixes in an over on Saturday.

Bumrah, though, is usually in a league of his own. After missing IPL 2023 with a back injury, he made his comeback to the league with a spell of 3 for 14 in Mumbai's season opener against Gujarat Titans despite two of his overs coming at the death. All of which sets up the prospect of a tantalising battle with Klaasen, as both Mumbai and Sunrisers gun for their first points of IPL 2024.

The match is especially significant for the Sunrisers, who lost seven out of eighthome games last season, and would love a winning start in Hyderabad this year.

In his first match as Mumbai Indians  $captain, Hardik\, Pandya\, travelled\, to\, the$ home of the team he first led in the IPL, and found himself booed at the Narendra Modi Stadium in Ahmedabad. He was also the subject of much vitriol on social media, especially for asking Rohit Sharma to field on the boundary. Some of Hardik's other captaincy decisions also came under scrutiny, like opening the bowling himself and bringing on Bumrah only in the fourth over of the Titans innings, and batting at No. 7 below Tim David. Will Hyderabad be kinder to Hardik Pandya?

Aiden Markram led the Sunrisers franchise in the SA20 - Eastern Cape - to back to back titles but his stock has dropped in Hyderabad and he was replaced as captain by Pat Cummins ahead of this season. Markram was picked for SRH's opening game in Kolkata and made 18 off 13 balls. After a poor IPL 2023 - 248 runs at a strike rate of 126 - he needs to find form quickly this year to stay ahead of Travis Head and Glenn Phillips in the overseas pecking order.

Legspinner Wanindu Hasaranga is yet to join the Sunrisers squad and is expected to be unavailable for at least another week as he consults doctors overseas about chronic pain in his left heel. The question for Sunrisers is whether to persist with Marco Jansen, who was expensive against KKR, as their overseas bowling option for a while longer.

### Hasaranga's Sunrisers debut to be delayed by at least a week



**NEW DELHI:** Wanindu Hasaranga is expected to be unavailable for Sunrisers Hyderabad for at least another week as he consults doctors overseas about chronic pain in his left heel.

Although Hasaranga played in Sri Lanka's limited-overs series against Bangladesh in March, ESPNcricinfo understands he did so through substantial pain. Sri Lanka Cricket's medical staff have assessed him, and suspect the pain is down to musculo-skeletal apparatus in his left heel having become

SLC's doctors have asked Hasaranga to seek further medical opinion on the exact nature of the injury, and how best to manage it. He is expected to travel out of Sri Lanka to do so next week.


In any case, he has not joined the Sunrisers squad yet, and there is no set date on when he will do so. The target, for both SLC and Hasaranga himself, is likely to be the T20 World Cup in June, where he is set to captain his national team.


If his condition requires further rest, treatment, or rehabilitation, his return to the IPL will likely be delayed further.

Hasaranga had a spectacular 2022 IPL season for Royal Challengers Bangalore for whom he took 26 wickets at an economy rate of 7.54. Sunrisers had paid INR 1.5 crore (approx USD \$181,000) for him at the most-recent

Earlier this month, Hasaranga was suspended from playing Sri Lanka's ongoing Tests against Bangladesh, after racking up eight demerit points for breaching article 2.8 of the players' code of conduct during the third ODI against Bangladesh. Had Hasaranga, who had just come out of Test retirement prior to the ban, been unavailable for the red-ball games, he would have missed the initial matches of Sri Lanka's next international assignment: the T20 World Cup in June.

SLC, however, dismissed claims that Hasaranga's return from retirement was a ploy to make sure he was available for the T20 World Cup, stating that he had informed them in an email on March 16 of his desire to be considered for Test cricket selection going forward, citing his improved fitness levels.
