



However, history proved relentless as none managed to cross the established dominance of Congress and BJP.

Notably, the Gulmarg Cable Car comprises two phases; one from Gulmarg resort to Kongdori valley and the second from Kongdori to Apharwath Peak. The first phase reaches an altitude of 8,694 feet, while the second ascends to the towering Apharwat peak at 13,058 feet. With 108 cabins and 18 towers, the Gulmarg Gondola provides a safe and exhilarating experience for all visitors.

However, last year (2022-2023), the number of tourists who had a Gondola ride was 8.5 lakh,

intense battle, with nominations set to commence on April 12 and conclude on April 19.

While the NC has declared its intention to contest three Lok Sabha seats in the Kashmir Valley, including Anantnag-Rajouri, the PDP is expected to field candidates for two of the three seats. However, formal announcements from both parties are pending, along with the BJP's candidate revelation.

The Anantnag seat has historically been a key battleground, witnessing significant electoral contests. Former MP Mehbooba Mufti's victory in 2014 and subsequent resignation in 2016 triggered prolonged vacancy, with elections delayed for security reasons. Swain told reporters at a press conference here.

The J&K Police chief stated that in the last 48 hours, searches were conducted at 10 places, and seven people were identified after their involvement in drone delivery cases was confirmed in the Rajouri and Poonch districts.

"Three persons have been arrested who were found involved in receiving and distributing the material transported from drones sent by the Pakistani handlers," said Swain.

He was flanked by ADGP CID Nitish Kumar, ADGP Law and Order Vijay Kumar, and ADGP Jammu Zone, Anand Jain.

He stated that the seven OGWs are also identified for being involved in picking up the drone-dropped materials and further distributing to disrupt peace in the region ahead of the Lok Sabha elections.

The DGP identified those arrested as Gulshan Naz, a resident of Kotranka (already arrested under the UAPA), Imtiaz Ahmed, a resident of Kotranka, and Abid Shah, a resident of Budhal, Rajouri.

Asserting that the police have sufficient evidence for their involvement in the case, he said, "The arrested persons were operating in the region on the directions of the mastermind identified as Mohammad Qasim, alias Suleman as Salman, resident of Mahore, Reasi, currently based in Pakistan-occupied-Kashmir (PoK), a commander of Lashkar-e-Taiba (LeT) outfit."

The Jammu and Kashmir government has already announced a reward of Rs 10 lakh for information leading to Qasim's arrest.

Qasim was involved in the IED blast in pilgrim's bus in Katra and the Narwal blast, he said, adding that the LeT commander has also been actively brainwashing vulnerable youth using social media platforms and attempting to lure them into joining militancy.

"Police have evidence against the arrested persons, who were in touch with their Pakistani handlers as they were circulating the items drone dropped from Pakistan to the people providing logistic support to terrorists, OGWs and the families of those already in jail."

"Many youngsters have prevented themselves from falling into the trap laid by Qasim but we want parents and teachers to make them money laundering and financial fraud across aware that if anybody falls into the trap they will ultimately be arrested." Swain also added that the surveillance is being maintained on social media handles, especially the usage of VPN and other such networks to connect with the anti-national elements. (UNI)

ing his election tour of the upper reaches of district Udhampur including the areas like Basantgarh, Lati, Gordy, Landar, etc., Dr Singh said, Udhampur because of its typical topography with a large part of the district located on difficult terrains this road construction work should have been undertaken several decades ago but as a deliberate design it was not done in spite of the fact that the PMGSY scheme for the rural road construction was also introduced by NDA-1 under PM Atal Bihari Vajpayee but not carried forward with the same spirit by the successive governments till Prime Minister Natendra Modi took over in 2014 and Udhampur was given the top priority.

the news agency-Kashmir News Observer (KNO), the garden, managed by Khan Mudasir, witnessed an unprecedented response from visitors within the first five days of its opening, with 105,861 tourists having visited since March 23.

He said this year saw a mix of both domestic and foreign tourists, with a significant increase compared to last year. While only around 1,500 foreign tourists visited last year, a total of 415 foreigners and 5,112 locals have visited the garden so far this year.

The officers informed that the number of local visitors has crossed the 100,334 mark, making the total count of visitors to the Tulip Garden this year reach 105,861. Moreover, 100,334 tourists from vari-

ous parts of the country have visited the garden within the past 11 days.

To encourage educational visits, a special 20% discount on tickets has been extended to students until April 10, as announced by the contract overseeing the garden.

Visitors have hailed the government's efforts in ensuring a smooth and enjoyable experience, expressing satisfaction with the arrangements made.

Despite challenges such as pre-booked accommodations affecting travel to Kashmir, officials anticipate that the garden will surpass last year's record of 366,000 visitors. With tourist numbers at an alltime high, a further increase in visitors is expected after Eid, they said.

History Repeats.....

six districts of Jammu and Kashmir, has remained impervious to their influence. Over the course of 14 Lok Sabha elections since 1967, the electorate has consistently favored candidates from Congress and BJP, relegating regional contenders to the sidelines.

From its inception, Udhampur constituency has steadfastly resisted representation by regional parties. In a historical reflection, the early years saw Congress asserting its stronghold, only to be later supplanted by BJP's ascendancy. While some regional parties managed to secure second or third positions, none could establish a substantial foothold.

The trajectory of the constituency's political landscape witnessed Congress's dominance for six consecutive terms until BJP emerged victorious in 1996. Since then, BJP has maintained its grip on the seat, with Dr. Jitendra Singh, also a minister in the central government, clinching succesattempts, have failed to resonate with the electorate. Shiromani Akali Dal's candidate could muster only 1.3 percent of the vote share, while Jharkhand Party's attempt yielded a meager 0.1 percent.

In the annals of Udhampur's electoral history, Congress has clinched victory eight times, closely followed by BJP's six triumphs, solidifying the duopoly of the two major players. Meanwhile, regional contenders such as National Conference, PDP, and Panthers Party have been relegated to secondary positions, unable to break the entrenched dominance of Congress and BJP. Despite the influx of small parties vying for attention, the electorate's loyalty remains steadfast, reaffirming the entrenched political dynamics of the region.

Meanwhile, the Bharatiya Janata Party (BJP) and the People's Democratic Party (PDP) are yet to unveil their candidates for the coveted seat. Speculations abound regarding the BJP's potential choice of a Muslim candidate, while the PDP, a member of the India alliance alongside the NC, remains tight-lipped about its electoral strategy.

The Anantnag-Rajouri parliamentary seat, formed post-delimitation, encompasses Rajori and Poonch and is slated for voting in the third phase on May 7. As the election fervor picks up, political parties are gearing up for an

Consequently, the court scheduled the matter for further hearing on May 15, granting the state sufficient time to furnish the necessary updates on the progress made in implementing the RTE Act.

It also directed the authorities to submit a comprehensive list of government-aided schools in Jammu & Kashmir that are presently imparting free education in accordance with the RTE Act.



PDP May Refrain From Fielding Candidates Against NC: Omar Abdullah

SRINAGAR, APR 2: Former Jammu and Kashmir Chief Minister Omar Abdullah on Tuesday said the National Conference and Peoples Democratic Party (PDP) are part of the INDIA alliance and PDP might refrain from fielding candidates against his party in Kashmir.

"We were together on the stage during the recent INDIA alliance meet (in New Delhi) and nobody has broken the alliance", NCVice President Omar Abdullah told media persons in south Kashmir's Anantnag district on Tuesday.

He said Mehbooba Mufti hasn't shown any inclination to contest against the NC.

Omar pointed to a recent rally in Delhi where PDP leader Mehbooba Mufti reaffirmed PDP's allegiance to the INDIA alliance.

Asked if PDP announces its candidate in the three seats of Kashmir and that would divide the votes which will benefit BJP Omar said that media would like to see such a situation.

"Why are you trying to have our fight with PDP? Does PDP anywhere say that they are going to contest the elections", he questioned.

The cracks between the two INDIA alliance partners are visible after NC on Monday fielded veteran Gujjar leader Main Altaf for the all-important South Kashmir seat. The announcement in all likelihood has ended chances of a patch up for seat sharing with INDIA partner PDP.

When asked if the NC was contesting all three seats in Kashmir due to pressure from the Enforcement Directorate (ED) raids, Omar said that the decision was taken based on having won the previous elections.

'No decision of seat sharing has been changed. For DDC polls, we took the 2014 Assembly election results, and wherever PDP had won, they contested the DDC polls and wherever NC had won, we got the opportunity. PC (Peoples Conference) was also with us then and they chose their candidate where they had won. We used the same formula here as well. Where does the ED come in this?" he asked.

Omar asked the media persons why they didn't expose the emerging new alliances in Kashmir like "A team, B team and C team" of the BJP instead.

Regarding announcing the candidature of Mian Altaf from the Anantnag-Rajouri parliamentary constituency who was an "outsider", Omar said Mian Altaf belongs to Kashmir.

"He belongs to Rajouri-Poonch as he belongs to other parts of the Kashmir valley. If the Prime Minister belonging to Gujarat is contesting elections from Uttar Pradesh, why does the media channels not have any objection with that", he questioned and added "even candidates from south India being given tickets from north India to Rajya Sabha".

'MAJORITY OF KASHMIRIS UNAWARE OF NEURODEVELOPMENTAL CONDITIONS'

SRINAGAR, APR 02: The each case. For some, their condimajority of the population in Kashmir remains unaware of neurodevelopmental conditions, with those with autism often encountering discrimination, stigma and a lack of support, according to psychologists.

Autism Spectrum Disorder (ASD) is a developmental disorder characterised by neurological differences.

Speaking with the news agency-KashmirNewsObserver(KNO), Zoya Shafat Mir, a clinical psychologist and founder of Psychlite, a psychology clinic, explained that ASD impacts various aspects of a person's life, with manifestations varying indegree and presentation across individuals.

She said common signs of autism include deficits in language and social communication, sensory sensitivities, restricted and repetitive behaviours, as well as intense interests.

"However, not all these symptoms are necessarily present in tion may be very apparent, while for others, there may be no noticeable signs that set them apart from the neurotypical majority," she said, adding, "Each child with autism is unique, with different sensory needs, interests, preferences, and communication patterns. Some are completely nonverbal, while others cannot stop talking. Some refuse to eat food items that are not crunchy, while others cannot tolerate the sound of a lawnmower. Some will ask vou questions about tigers all day, while others can name every distinct part of a car." To ensure correct diagnosis and individualised help, rather than a one-size-fitsall approach towards treatment, it is crucial to understand autism as a spectrum, Zoya said.

She said there has been a shift in the perception of autism over the years. "It has evolved from a focus solely on deficits and challenges towards a more holistic understanding. Recognition of



the strengths and talents possessed by individuals with autism is growing," she said, citing examples of exceptional qualities such as photographic memory, excellent pattern recognition, and strong logical thinking.

Zoya added, "As awareness and research have progressed, so has our understanding of autism. We are starting to recognize the strengths and talents of individuals with autism. Recognising and nurturing these strengths has empowered individuals with autism to thrive in environments

where their unique abilities are valued and celebrated. However, this shift in perspective is yet to occur in Kashmir, where a significant portion of the population remains unaware of neurodevelopmental conditions."

"Our society's narrow perspective fails to acknowledge the diverse range of experiences and capabilities within the autism spectrum, hindering the full integration and acceptance of individuals with autism in all aspects of society," she observed. Professor (Dr) Yasir H Rather,

a renowned psychiatrist, talked about the transformative power of autism acceptance in the lives of patients. "Autism acceptance is more than just understanding; it's about embracing the uniqueness of each person, celebrating their strengths, and supporting their challenges," he said.

Syeda Zehra, a Behavior Therapist at Psychlite, highlighted the importance of patience, understanding and creating a structured and supportive environment for children with autism to thrive.

"Creating a structured and supportive environment helps them feel secure and ready to learn," she said, adding, "Witnessing their growth and development is incredibly rewarding, fueling my passion for making a difference."

Overall, the experts stressed the need to challenge stereotypes, foster understanding and provide support to ensure that those with autism have the opportunity to thrive and contribute meaningfully to society.

Lok Sabha Elections 2024 Over 16.23 lakh voters to decide fate of 12 candidates in Udhampur **Parliamentary Constituency**

KATHUA, APRIL 02: The fate of 12 candidates will be decided by over 16.23 lakh voters of Udhampur Lok Sabha seat in the first phase of General Elections to be held on April 19.

The Udhampur parliamentary constituency is spread over five districts including Kishtwar, Doda, Ramban, Udhampur and Kathua.

According to the figures provided by the office of the Returning Officer 4-Udhampur Parliamentary Constituency, there are 16,23,195 registered voters in Udhampur Lok Sabha seat including 8,45,283 male, 7,77,899 female and 13 transgender electors.

The Election Commission of India (ECI) has set up 2637 polling stations across the constituency, of which 2,457 are situated in rural areas and 180 in urban areas, ensuring accessibility and convenience for voters from all corners of the constituency.

Of notable mention is the inclusion of 23,637 Persons with Disabilities (PWDs) within the electoral roll, encompassing 14,362 males and 9,275 females.

The young voters, aged 18-19 years, stands at 45,825 male voters, 38,641 female voters and 2 transgender, totaling 84,468 potential first-time voters.

The constituency boasts a considerable elderly population, with 12,020 male voters and 13,612 female voters aged 80 above, totaling 25,632 seasoned voters contributing to the electoral discourse.

rampant urbanization and mismanagement. The lush valleys and serene lakes of Kashmir have long been symbols of natural beauty and tranquility. However, beneath this pictures que facade lies a stark reality: unchecked urbanization is devouring these invaluable resources at an alarming rate. Rivers, lakes, and wetlands are being encroached upon, drained, or filled in to make way for infrastructure and development projects.

More than 9,119 hectares of open water surface and wetland have disappeared between 1911 and 2014, while only 6,873 hectares were preserved.

The consequences of this environmental degradation are far-reaching. The loss of water bodies not only disrupts the delicate ecological balance but also threatens the livelihoods of those dependent on them. Fishermen, farmers, and communities that rely on these water sources for irrigation and drinking water face an uncertain future.

Moreover, the disappearance of water bodies exacerbates existing challenges such as flooding and water scarcity. Wetlands act as natural sponges, absorbing excess rainfall and reducing the risk of floods. Their destruction leaves communities vulnerable to the ravages of climate change, with implications for public health, agriculture, and infrastructure.

Government authorities must enforce strict regulations to prevent further encroachment on water bodies and prioritize their preservation in development initiatives. Recognizing Women's Crucial Role in Development, Peace and Stability



The recent surge in suicides among NEET aspirants has undoubtedly ignited a nationwide alarm, shedding light on the profound and longstanding issues embedded within our education system. Despite the remarkable strides made since India's independence, particularly in sectors like education with the establishment of esteemed institutions like the IITs and IIMs, we find ourselves grappling with formidable challenges, especially in the realm of medical education. The harsh reality remains that out of the approximately 20,00,000 students who appeared for NEET UG in 2023, only a meager 90,000 seats are available for MBBS across India, spanning private, semi-government, and government colleges. 

Kota, a city renowned for its coaching institutes, experienced an alarming 60% surge in suicidal cases post-pandemic, serving as a stark reminder of the gravity of the situation. The underlying causes of this epidemic of stress and despair among NEET aspirants are complex and multifaceted. Firstly, the lack of personalized interaction in coaching institutes leaves students feeling isolated and unable to address their personal struggles or seek emotional support. Moreover, the weight

of parental expectations, coupled with financial burdens, exacerbates the psychological toll on students. The relentless cycle of mock tests and academic pressures only serves to compound their stress, often driving some towards unhealthy coping mechanisms like drug addiction.

The Education system was a couple of books and little home work. Students were a good time to play and cheer happily. There was no competition at all and students were careless both about careers and their course. Still they moved and we got the great personalities like Albert Einstein, Isaac Newton, Stephen Hawking, Some socio-political giants like Ali Mohammed Jinnah, Mahatma Gandhi, Dr Sir Mohammad Iqbal(R.A.) and others.

A roll of 250 to 300 student classroom is marking with daily 7 to 8 students. Despite counseling of experts and mentors, the curse on our little student generation is their heavy school bags with much of overweight books that is a definite cruelty causing them severe heath problems day by day. Weight of school bags is increasing and not decreasing at any rate, our school children have turned slaves of educational system where commission of booksellers and teachers making their bags heavier and heavier.

There is no

scope of creativity, imagination, ingenuity, inspiration and critical analysis. These children got no time to think except rote learning and homework. The systememboldens and promotes them with memorization and rote learning concept. The

little children didn't get any time to ponder freely or think openly. This is an open oppression on them. We have kept them on method of cramming and memorizing selection of books is totally a hallucination and horror. Many companies are producing stuff in name of books and their is no to ask them the level against the children, Schools and teachers get their commissions to choose the book publishing companies. It is a large misconception we are doing for our younger generation. In fact it has became a disastrous disease among people that much difficult books mean informative and higher standard of learning. Alas!!

It is a delusion that burdensome and difficult books are prescribed. Children's of today are more sensitive than those a few decades before (unconscious children). The extra burden and deprivation of liberty builds pressure on them. Then the children feel their life in despondency, desolation, loneliness, failure and deprivation. Then what we can get are suicidal cases and drug addicts cum

India Will Get Permanent UN Security Council Seat, But: S Jaishankar

Rajkot, Gujarat: External Affairs Minister S Jaishankar today said India will definitely get permanent membership of the United Nations Security Council as there is a feeling in the world that it should get the position, but the country will have to work harder this time for it.He was speaking during an interaction with intellectuals in Gujarat's Rajkot city and was asked by the audience on India's chances of becoming the permanent member of the world body.

The United Nations was formed around 80 years ago, five nations - China, France, Russian Federation, the United Kingdom, and the United States - decided among themselves to become permanent members of its security council, Mr Jaishankar said.

At that time, there were a total of around 50 independent countries in the world, which has over time increased to around 193, he said."But these five nations have kept their control, and it is strange that you have to ask them to give us their consent for a change. A few agree, a few others put forward their position with honesty, while



others do something from behind," he said. This has been going on for several years, the minister said.

"But now, there is a feeling across the world that this should change, and India should get a permanent seat. I see this feeling increasing every year," he said.

"We will definitely get it. But nothing big is ever achieved without hard work," Mr Jaishankar said.

"We will have to work hard, and this time we will have to work even harder," he added.

The Union minister said India, Japan, Germany and Egypt have put forward a proposal together before the UN and he believes this will take the matter a bit forward.

The world believes that India as the fastest growing large economy can become the engine of global growth," he said. The world understands that India has technological talent, he added.

World agencies such as the UN understand India's achievements in social sectors like access to water, electricity, roads, health, schooling, etc, the external affairs minister further said.

'We should understand that being the fifth largest economy, on the way to becoming the third largest and with the biggest population, the world believes us to be talented people and expects us to contribute to resolve challenges," he added.

Probe Agency's Liquor Policy Kickback Charge In Court, "Lies", Says AAP

New Delhi: The Aam Aadmi Party has spent 45 crore on the election in Goa and there is enough evidence that party chief and Delhi Chief Minister Arvind Kejriwal was involved in money laundering, the Enforcement Directorate told the Delhi High Court today, hours after the Supreme Court remarked on its failure to produce evidence of a money trail and gave bail to senior party leader Sanjay Singh. AAP rubbed in the top court's comments, calling the agency's allegation a "lie"."The ED just lies. The Supreme Court said no money trail was found, and no money was found. The ED could not provide a shred of evidence in the Supreme Court. It is working at the behest of BJP, which wants to topple Delhi government at any cost," read a rough translation of AAP's statement in Hindi.

This is the first time the Central investigation agency made its allegations on Goa official, including it in its response to Mr Kejriwal's challenge to his arrest.

Along with challenging his arrest in the case, Mr Kejriwal has also demanded release as interim relief. The matter would be heard by the court tomorrow.

Calling AAP the "major beneficiary of the proceeds of crime generated in the Delhi Liquor Scam", the ED claimed, "Part of the proceeds of crime to the tune of cash of 45 crore approx. has been utilised in the election campaign of AAP in Goa



Assembly elections 2022".

The agency also questioned Mr Kejriwal's objections, arguing that he has waived his right to question his detention today, and cannot now be allowed to argue that it is illegal. Moreover, proper procedures under Section 16 of PMLA and Article 22 of the Constitution were strictly followed during his arrest, the agency has claimed.

The section empowers the ED to arrest anyone on basis of material in their possession that indicate s/he has committed an offence punishable under law. The agency is allowed to record its reasons for such belief in writing, with the grounds of arrest to be communicated to the accused "as soon as may be".

In his plea, Mr Kejriwal has said that he was arrested by ED despite the fact that they do not have any material in possession that may lead to a belief of his guilt. The provisions of PMLA are being used to persecute and destroy the fabric of the democratic and federal structures, he said.

Chennai: Union Finance Minister Nirmala Sitharaman on Tuesday accused the ruling DMK in Tamil Nadu of spreading a false campaign on the Katchatheevu islet ceded to Sri Lanka by India in 1974, and for making "irresponsible" statements on the issue.

Late M Karunanidhi, who was DMK president and Tamil Nadu chief minister at the time, was aware of the then ruling Congress's move but did not object, she said.The Congress, which failed to come to power in Tamil Nadu after 1967, owes an explanation to the nation for the loss of the territory which former prime minister Indira Gandhi described as a 'tiny mass of rock', she said.

Mrs Sitharaman claimed that former Prime Minister Jawaharlal Nehru had described Katchatheevu as a "nuisance".

"Let them set right the lies they have been saying for half a century," Sitharaman said, while speaking to reporters after an interaction at the Viksit Bharat Ambassador campus dialogue programme here.

Ahead of polling in Tamil Nadu on April 19 for the Lok Sabha elections, the Katchatheevu issue has put on centre stage in the state, after Prime Minister Narendra Modi recently attacked the Congress and the DMK over the ceding of the tiny island 50 years ago.

Both the Congress and its ally DMK have hit back at the BJP for raking up the five-decade-old bilateral agreement between India and Sri Lanka ahead of polls.Accusing the DMK of supporting the UPA government's "anti-people initiatives", the minister said the DMK "merely" wrote 21 letters to Prime Min-



ister Narendra Modi seeking the retrieval of Katchatheevu, while all along the Dravidian party has refrained from uttering anything against the Congress government, which was also responsible for banning 'Jallikattu'.

The then chief minister Karunanidhi did not object at all even though the then foreign secretary explained it in detail in 1974. "But the DMK is spreading a false campaign that the islet had been ceded without their knowledge. We have documentary evidence to prove them wrong," she claimed.

On the opposition charge as to why the BJP-led government at the Centre had not acted on the matter during a decade of its rule, she responded saying the government prevented a fisherman from getting hanged in Sri Lanka and brought him home safely. In addition, steps have been taken to secure the release of fishermen from time to time, she added.

Denying that the BJP was making Katchatheevu an election issue, Sitharaman said, "There's no auspicious time to talk about it. This is an issue concerning the nation's security and sovereignty. It is our right." The issue also concerns the lives of Indian fishermen and cannot be seen in isolation, she added.

"Indira Gandhi, AB Vajpayee Lost Polls, So Can Nitin Gadkari," Says His Congress Rival **In Nagpur**

Nagpur, Maharashtra: Pitted against Union minister Nitin Gadkari, former Nagpur mayor and Congress candidate Vikas Thakre is banking on his strong local connect with the voters and on the past precedents of political heavyweights biting the dust in polls. The 57-year-old leader, who began his political innings as a corporator from the region that is home to the RSS headquarters, is brimming with confidence as opposition parties have closed ranks against the BJP, and suggests that his rival Nitin Gadkari has only catered to development projects benefiting the well-off sections of the society."Only time will tell whether I have put my hand in the lion's den or whether the lion will strike," Mr Thakre, who represents Nagpur(West) seat in the state assembly, told Press Trust of India in an interview. 5 Killed In Strikes By Israel's F-35 Jets On Iran Consulate In Syria

Tehran: Israeli strikes on the Iranian consulate in the Syrian capital on Monday killed at least five people including a senior commander of the Islamic Revolutionary Guard Corps, Iranian state media reported."At least five people were killed in the attack which was carried out by F-35 fighter jets," Hossein Akbari, Iran's ambassador to Damascus, said in front of the levelled building in an interview broadcast on state TV. He did not give the source of his information about the aircraft. A part of Iran's consulate in the Syrian capital was flattened on Monday by what was described as an Israeli air strike, a startling apparent escalation of conflict in the Middle East that would pit Israel against Iran and its allies.

The Israeli air strikes destroyed the Iranian embassy's consular annex, killing and wounding everyone inside, Damascus said as Iranian state TV reported a Revo-



lutionary Guards commander among the dead.Monday's attack was the first time the vast embassy compound itself had been hit, and comes amid soaring tensions over Tel Aviv's war in Gaza and intensifying violence between Israel and Iran's allies.UK-based war monitoring group the Syrian Observatory for Human Rights said eight people, including several Guards members, were killed when "Israeli missiles... destroyed the building of an annex to the Iranian embassy".Revolutionary Guard commander among eight killed in strike; Tehran says it reserves the right to respondIran's ambassador to Syria, Hossein Akbari, giving a lower death toll, told Iranian state TV that "at least five people were killed in the attack which was carried out by F-35 fighter jets". AFP reporters saw the annex building had caved in, and emergency services were rushing to search for victims under the rubble as sirens wailed in the upscale Damascus district of Mazzeh.Reuters reporters at the scene saw smoke rising from rubble of a building that had been flattened, and emergency vehicles parked outside.

An Iranian flag hung from a pole in front of the debris. The Syrian interior and foreign ministers were both spotted at the scene. Security forces shielded the site where earth-moving equipment was brought in to clear the debris and remove charred vehicles from the road outside, watched by a crowd of onlookers.

Syria's defence ministry said "the attack destroyed the entire building, killing and injuring everyone inside, and work is underway to recover the bodies and rescue the wounded from under the rubble".

12-year-old opens fire in Finnish school, injuring three: police

A 12-year-old opened fire on Tuesday at a school outside the Finnish capital Helsinki injuring three other children, police said, adding that the attacker was in custody.

The school in Vantaa has around 800 pupils and 90 staff. Children in grades one to nine, or aged seven to 15, attend the school. "There are people injured in the shooting incident", police said shortly after 10am (7am GMT). Police were alerted to the scene at 9:08am and later specified that the suspect and the injured were all 12 years old.

The city of Vantaa's crisis group was activated following the shooting, local media reported. Images from the scene showed a large number of police at the school.Police officers talk to family members of pupils at the Viertola comprehensive school in Vantaa, Finland on April 2. — Reuters

In an update around 11:30am, police said the suspect, who was carrying a gun at the time, had been arrested in an area of Helsinki in a "calm manner". Parents of pupils attending the school told the media that the shooting had occurred in a classroom.

Police urged the public to stay away from the area and remain indoors. "Do not open the door to strangers," they said in a statement.

Finnish Interior Minister Mari Rantanen said in a post on X that the day had started in a "shocking way". "I can only imagine the pain and worry that many families are experiencing at the moment," she said.

Israel leaves Gaza's largest hospital in ruins

GAZASTRIP: Charred buildings and a rubble strewn expanse littered with bodies were all that was left of the Al-Shifa hospital complex on Monday, after Israeli forces ended a two-week offensive at what used to be Gaza's largest medical facility.

The health ministry in Gaza said that after heavy Israeli air strikes and tank fire, "the scale of the destruction inside the complex and the buildings around it is very large". "Dozens of bodies, some of them decomposed, have been recovered from, in and around the Al-Shifa medical complex," it said, adding that the hospital was now "completely out of service".

Hundreds of people, including some who had been sheltering in the hospital prior to the Israeli incursion, rushed back to check damage and hunt for belongings.

Several doctors and civilians at the damaged complex told AFP that at least 20 bodies had been found, some of which appeared to have been driven over by military vehicles. Several were found close to the west entrance to the complex, which the Israeli army used during its departure from the hospital grounds on Monday."The tanks went over them. Destruction. Children. Innocents. Unarmed civilians. They (soldiers) went over them," one witness said, asking not to be named. A correspondent saw one badly decomposed body bearing tyre marks. Following the Israeli withdrawal, the scene inside Al-Shifa hospital was one of devastation, with windows blown out, concrete walls blackened and volunteers carrying away shrouded corpses across the sandy wasteland. The Gaza mdia office said Israeli forces killed 400 Palestinians around Al-Shifa, including a woman doctor and her son, also a doctor, and put the medical facility out of function. There was no immediate Israeli response. "The occupation destroyed and burnt all buildings inside Al-Shifa Medical Complex. They bulldozed the courtyards, burying dozens of bodies of martyrs in the rubble, turning the place into a mass graveyard," said Ismail Al-Thawabta, director of the media office. A spokesperson for Gaza's Civil Emergency Service said Israeli forces had executed two people whose bodies were found at the complex in handcuffs, and used bulldozers to dig up the grounds of the complex and exhume corpses.

Taiwan leader embarks on 'peace journey' to China

TAIPEI: Taiwan's former president Ma Ying-jeou headed to China on Monday for what he called a "journey of peace" aimed at cooling cross-strait tensions.

Speaking to reporters at the airport before his departure, Ma described his trip to China as 'a journey of peace and a journey of friendship'.

China claims democratic Taiwan as part of its territory and has never renounced the use of force to bring the self-ruled island under its control.

Ma of the Beijing-friendly Kuomintang party oversaw an improvement in crossstrait ties during his 2008-16 stint in office, culminating in a summit between him and Chinese President Xi Jinping in Singapore in 2015.

But Tsai Ing-wen, who succeeded him in 2016, rejected Beijing's claim to the island. Tensions have further risen since January this year when Tsai's deputy Lai Ching-te — whom Beijing regards as a "dangerous separatist" — was elected to succeed her.

At the airport, Ma told reporter he hoped



"when the situation across the Taiwan Strait is tense, we can convey the sentiments of the Taiwanese people that they love peace, hope for cross-strait exchanges and hope to avoid war."

Ma added that he aimed to promote youth exchanges and to "reduce hostility and accumulate goodwill".

Last year, Ma made the first visit to China by a current or former Taiwanese leader in more than seven decades in a bid to improve the "cross-strait atmosphere".

On Monday, he said that trip "proved that this method is feasible and we can resolve cross-strait confrontation through building friendship between young people on both sides".

Iran president says Israel's Syria attack 'will not go unanswered'

Iran's President Ebrahim Raisi on Tuesday condemned a deadly air strike blamed on Israel against his country's consular annex in Damascus, saying the "cowardly crime will not go unanswered".

"After repeated defeats and failures against the faith and will of the Resistance Front fighters, the Zionist regime has put blind assassinations on its agenda in the struggle to save itself," Raisi said on his office's website.

"Day by day, we have witnessed the strengthening of the Resistance Front and the disgust and hatred of free nations towards the illegitimate nature of (Israel). This cowardly crime will not go unanswered."

he air strike on the Iranian embassy's five-storey annex killed seven members of the Islamic Revolution Guards Corps, which runs Iran's overseas military operations.

Among the dead, were Brigadier Generals Mohammad Reza Zahedi and Mohammad Hadi Haji Rahimi, both senior commanders in the Quds Force, Guards' foreign operations arm.

Zahedi, 63, had held a succession of act.

The UN Security Council was to discuss the deadly strike later on Tuesday at a meeting requested by Syrian ally Russia.

"Iran reserves its legitimate and inherent right under international law and the United Nations Charter to take a decisive response to such reprehensible acts," Iran's mission to the world body said.

It warned the strike could "potentially ignite more conflict involving other nations" and called on the Security Council "to condemn this unjustified criminal act."

Israel Approves Bill To Allow Al Jazeera Broadcast Ban Amid Hamas War

Jerusalem: The Israeli parliament passed a bill Monday giving top ministers the authority to bar from Israel the broadcasts of news channel Al Jazeera -- a step Premier Benjamin Netanyahu is poised to take.This law, which passed by 70 votes to 10, carries the authority to ban the broadcast of content from foreign channels but also allows the closing of their offices in Israel.

Netanyahu has vowed to take "immediate action" to shut down Al Jazeera in Israel once the law passes. Israel had claimed in January that an Al Jazeera staff journalist and a freelancer killed in an airstrike in Gaza were "terror operatives". The following monthit said another journalist for the channel, wounded in a separate strike, was a "deputy company commander" with

Hamas.Israeli troops have



been fighting against Hamas in Gaza since October. Al Jazeera has fiercely denied the accusations and accused Israel of systematically targeting Al Jazeera employees in the Gaza Strip. The bill permitting officials to stop foreign media deemed to harm national security had already passed its first par-

liamentary hurdle last month.Netanyahu's Likud party said he asked "to make sure that the law to close Al Jazeera will be approved this evening" in Israel's parliament, the Knesset.Al Jazeera's bureau chief in the Palestinian territory, Wael al-Dahdouh, was also wounded, in an Israeli strike in December that killed the network's cameraman.The war between Israel and Hamas began with the militant group's October 7 attack that resulted in about 1,160 deaths in Israel, mostly civilians, according to an AFP tally of Israeli official figures.

'Havana Syndrome' linked to Russian intelligence unit: report

WASHINGTON: The mysterious so-called Havana Syndrome symptoms experienced by US diplomats in recent years have been linked to a Russian intelligence unit, according to a joint media investigation released on Monday.Havana Syndrome was first reported in 2016 when US diplomats in Cuba's capital reported falling ill and hearing piercing sounds at night, sparking speculation of an attack by a foreign entity using an unspecified sonar weapon.Other symptoms including bloody noses, headaches and vision problems were later reported by embassy staff in China, Europe and the US capital Washington.

The diplomats may have been targeted by Russian sonic weaponry, according to the joint report by The Insider, a Russia-focused investigative media group based in Riga, Latvia, Germany's Der Spiegel and CBS's 60 Minutes.

The year-long investigation "uncovered evidence suggesting that unexplained anomalous health incidents, also known as Havana Syndrome, may have their origin in the use of directed energy weapons wielded by members of (the Russian GRU) Unit 29155," the report said.

Over 800 scammers arrested in China-Myanmar joint operation

YANGON: More than 800 people suspected of being cross-border scammers were arrested in a joint police operation by Myanmar and China, Beijing's embassy in Yangon said on Monday.

Scam compounds have flourished in Myanmar, staffed by citizens from China and other countries who are often forced to work swindling their compatriots in an industry analysts say is worth billions.

Beijing – a major ally and arms supplier of Myanmar's isolated junta – has repeatedly asked the military to crack down on such operations.

Chinese law enforcement provided input to their Myanmar counterparts, who launched raids around Muse city, a major trade hub in northern Shan state, the embassy said on its WeChat channel.

Myanmar police arrested 807 people "who committed cross-border crimes" and seized computers, mobile phones and "fraud scripts", it said in a statement.

Among those arrested were 352 Chinese citizens, who were transferred to China on Sunday, the statement said. The remainder were Myanmar nationals, it added.

The junta has not commented on the raids.

Last year, the United Nations human rights office said at least 120,000 people were being held in scam compounds in Myanmar.

Many were housed in the town of Laukkai in northeastern Shan state, which has since been captured by an alliance of ethnic minority armed groups. The alliance said it would wipe out the scam compounds.

"Senseless": India Rejects China's "Invented Names" For Arunachal Pradesh

New Delhi: The Ministry of External Affairs today firmly rejected attempts by China to rename places in Arunachal Pradesh and asserted that assigning "invented names" will not alter the reality that the state "is, has been, and will always be" an integral and inalienable part of India.

The statement was issued by the MEA in response to media queries in the wake of China releasing a fourth list of 30 new names of various places in Arunachal Pradesh amid Beijing's stepped-up assertions in recent weeks to re-emphasise its claim over the Indian state.


"China has persisted with its senseless attempts to rename places in the Indian state of Arunachal Pradesh. We firmly reject such attempts. Assigning invented names will not alter the reality that Arunachal Pradesh is, has been, and will always be an integral and inalienable part of India," MEA Spokesperson Randhir Jaiswal was quoted as saying in the statement. On March 28,



India said that Beijing may "repeat its baseless claims" as many times as it wants but that is not going to change New Delhi's position that Arunachal Pradesh "was, is and will always remain" an integral and inalienable part of the country. Mr Jaiswal had said this during his weekly press briefing, in response to a query on China continuing to harp on its claim over Arunachal Pradesh. His comments at the briefing had come days after Chinese Foreign Ministry spokesman Lin Jian had reiterated China's claim.

The school is accused of demanding an admission fee of Rs 85,000, a practice prohibited by law, as highlighted in a video featuring allegations made by a lady named Sana.

Justice Sunil Hali has emphasized that charging admission fees without FFRC approval is strictly prohibited, with violators facing legal consequences. The FFRC's investigation has revealed that the school failed to submit the necessary fee regulation documentation for the academic session 2024-25 by the deadline of December 31, 2023.

To address these allegations and regulatory violations, the Chairman/Principal of Kashmir Haward School has been summoned to appear before the FFRC office in Hyderpora on April 3, 2024. They have been directed to provide all pertinent information for a thorough examination of the matter.

Justice Sunil Hali cautioned the school that non-compliance with this directive could lead to further actions, including an investigative inquiry, fee collection suspension, and potential recommendations for the school's recognition suspension by the government.

The Chairperson has reaffirmed the FFRC's commitment to upholding regulatory standards and ensuring compliance in Private educational institutions to protect the interests of students and families.

healthy but are usually nutritionally deprived. **1. Flavoured yogurt**

Yogurt is a probiotic that contains protein, calcium and other essential nutrients. Now, the market is flooded with flavoured yogurts that are high in sugar, unwanted calories and preservatives. Therefore, it is wise to stick to plain or fresh yogurt. You can add chopped fresh fruits to plain yogurt for the sweetness.

Weight watchers often stick to diet soda with no sugar and fewer calories. However, drinking diet soda is also linked with many health issues. Those who drink diet soda are at a higher risk of metabolic syndrome than those who don't. Studies have also shown that consumption of artificial sweeteners present in most diet sodas is linked to a higher risk of developing cancer.

Comparing binge drinking to moderate drinking

For this study, Dr. Rana and his team analyzed alcohol use data from more than 430,000 people who received care at Kaiser Permanente Northern California.

Study participants ranged in age from 18 to 65 and had no prior heart disease at the start of the study.

Participants were placed in three alcohol intake levels - low (one to two drinks per week for both men and women), moderate (three to 14 drinks per week for men and three to seven drinks for women), and high (15 or more drinks per week for men and eight or more drinks per week for women).

Additionally, researchers categorized study participants by whether they engaged in binge drinking or not.

Those who participated in binge drinking had five or more drinks per day in the past three months for men and four or more drinks per day in the past three months for women.

Scientists compared the relationship between alcohol intake levels reported by participants to coronary heart disease diagnoses received during the four years after.

Binge drinking significantly raises heart disease risk

Upon analysis, the researchers found that women who did not binge drink but reported high alcohol intake had a 45% increased chance of developing heart disease compared to female participants who reported moderate alcohol intake.

Scientists also discovered that women who fit the binge drinking category increased their heart disease risk by 68%

"These findings suggest that we need to be educating women about potential heart risks associated with binge drinking," Dr. Rana said.

"Our findings also underscore how important it is for healthcare providers to ask women not only how often they drink but if they binge drink." The study also found that male participants with high alcohol intake had a 15% higher risk of heart disease compared to those reporting moderate alcohol intake.

Males with a high alcohol intake who also met the criteria for binge drinking had a 33% increased risk of heart disease

The study also found that male participants with high alcohol intake and met the binge drinking category heightened their heart disease risk by 33% compared to those reporting moderate alcohol intake.

Can heart damage from alcohol be reversed?

After reviewing this research, Dr. Jennifer Wong, a board certified cardiologist and medical director of Non-Invasive Cardiology at MemorialCare Heart and Vascular Institute at Orange Coast Medical Center in Fountain Valley, CA, told MNT she felt it was useful information about how alcohol might adversely affect the heart.

"It gives doctors additional evidence to present to patients when encouraging them to decrease their alcohol intake," Dr. Wong explained.

"(For future research) it might be useful to see what the effects of cutting back would be in terms of cardiovascular outcomes, such as heart attack or myocardial infarction and deaths from cardiovascular causes."

MNT also spoke with Monique Richard, a registered dietitian nutritionist and owner of Nutrition-In-Sight, who was not surprised by the study's findings because while a little bit of a good thing can be beneficial, a lot of anything can be harmful.

Should diabetics have an evening snack?

nacks can bump up our energy in the middle of a busy day and prevent us from overeating at the next regular meal. Typically, about 25 per cent of daily calories come from snacks. Choosing snacks wisely is, therefore, a must for good health as well as diabetes control and weight management.

An avocado a day may improve diet quality, researchers suggest

por diet quality has been associated with a higher risk of cardiometabolic disease

A recent study suggests daily avocado consumption may improve overall diet quality, but the effects on cardiometabolic health were unclear.

Experts say a varied and balanced diet is the best way to support longterm health and longevity.

In the United States, many adults have poor diet quality and do not meet key dietary recommendations provided by the Dietary Guidelines for AmericansTrusted Source.

With poor diet quality being the leading risk factor for cardiometabolic diseases, this increases the risk for chronic health conditions that are among the leading causesTrusted Source of death.

Finding ways to improve diet quality in the general population is crucial for promoting better health outcomes.

Now, a recent study from Penn State University analyzed the impact of a food-based intervention - daily avocado intake – on diet quality and cardiometabolic risk.

The findings, published in Current Developments in Nutrition, revealed that consuming one avocado daily



for 26 weeks improved adherence to the Dietary Guidelines for Americans among adults with abdominal obesity. However, the changes in diet quality did not directly influence cardiometabolic disease risk factors. The study received funding from

the Avocado Nutrition Center. In this 26-week, multi-center, randomized controlled trial, researchers studied 1,008 participants aged 25 and older with abdominal obesity and typically low avocado intake.

Participants were divided into two groups. One group was provided with a daily supply of one avocado (approximately 168 grams) and received guidance on how to include it in their daily diet. The other (control) group, was asked to maintain their usual dietary habits, limiting their avocado consumption to two or fewer per month, and received no dietary counseling.

Diet quality was evaluated through unannounced 24-hour recalls at various intervals during the study, and scored with the Healthy Eating Index-2015 (HEI-2015)Trusted Source to measure adherence to dietary guidelines.

As per the USDA's classification, this clinical trial considered avocado servings - one-half cup chopped or approximately 75 grams - as part of the total vegetable component in the HEI-2015 scores.

The participants' cardiometabolic disease risk factors, including visceral fat volume, liver fat fraction, C-reactive protein, metabolic syndrome criteria, body weight, body mass index (BMI), insulin, VLDL cholesterol, and the total cholesterol to HDL cholesterol ratio, were also monitored to understand the effects of daily avocado consumption on these factors.

During the study, researchers found that individuals who consumed avocados daily showed a "potentially clinically relevant" increase of 4.74 points in their HEI-2015 scores compared to the control group that consumed their regular diet.

Watermelons may improve diet quality and cardiometabolic health

wo studies investigated the effects of watermelon on diet quality and cardiometabolic function.

They found that watermelon consumption is linked to higher nutrient intake and better heart health.

Further research is needed to understand how watermelon affects cardiometabolic health.

Watermelons contain many nutrients, such as potassium, vitamin C, and magnesium. The fruit also has a high bioavailability of antioxidants, including lycopene and l-citrulline.

Studies have shown that watermelon supplements and extracts decrease blood pressure and cholesterol levels.

Comparably fewer studies investigate raw watermelon, however, and those that do tend to involve large quantities of over 2 lbs per day.

Nevertheless, these studies also report that consumption of the fruit is linked to lower cholesterol and body weight, as well as a lower risk of prostateTrusted Source, lung, and breast cancerTrusted Source.

Further study of raw watermelon's health effects could improve dietary guidelines and prevention strategies for cardiometabolic health.

Recently, two studies that investigated the health effects of watermelon consumption.

The first study, published in Nutrients, found that children and adults



who consumed watermelon had a higher intake of various nutrients, including dietary fiber, magnesium, and potassium, than non-consumers. They also had a lower intake of added sugars and saturated fatty acids.

The second study, also published in Nutrients, found that drinking watermelon juice for two weeks protects vascular function.

Dr. John A. Galat, cardiac surgeon at Novant Health, Charlotte, North Carolina, who was not involved in the studies, told Medical News Today:

"As the hot summer months approach these two studies, incidentally both funded by the National Watermelon Promotion Board, suggest that the regular enjoyment of watermelon might be good for you! In fact, over indulging likely would not have any adverse effects unlike so many other things that we enjoy." He noted, however, that based on

these two studies alone, he would not necessarily promote watermelon consumption to those who don't already enjoy the fruit.

Watermelon consumers may have a healthier diet

For the first study, researchers analyzed data from 56,133 individuals from the National Health and Nutrition Examination Survey (NHANES) study.

They collated the data between 2003 and 2018, and included two 24-hour dietary recalls from individuals ages 2-18 years alongside adults.

The average watermelon consumption among adults and children was 125 and 162 grams per day. Around 98% of participants consumed raw watermelon, whereas 2% consumed watermelon juice.

By analyzing the dietary information, the researchers were able to estimate overall nutrient intake among watermelon consumers and non-consumers.

To ensure accuracy in their results, they controlled for factors including physical activity, poverty income ratio (PIR), smoking status and alcohol intake. They also controlled for the consumption of other foods, including total vegetables, nonwatermelon fruits, and dairy intake.

In the end, they found that children and adults watermelon consumers had over 5% higher intake of.

Frequent Flyer Jordan Cox Ready To Seize His Chance With Essex

SYDNEY: What does it take to build a career in professional cricket's modern, itinerant era? In this fragmenting landscape, the days of biding one's time and awaiting that international call are receding, and in their place a new generation of go-getter cricketer is emerging, with a restless curiosity and an increasingly clear understanding of how to cash in on their athletic prime.

Players such as Jordan Cox, for instance, a 23-yearold whose seemingly inevitable England debut remains, for now, just beyond his reach, but who isn't about to let that circumstantial setback restrict his career progression.

Midway through last summer, Cox secured a highprofile and not-uncontroversial move from Kent to Essex, a club he describes as being "best suited for what I want at this moment in time", which hardly smacks of the fulfilment of a lifelong dream.

And little wonder, given the winter he's just had. With apologies to his new county, and with no sense whatsoever that he'll be stinting on his efforts as Essex's season begins, next week's County Championship opener against Nottinghamshire at Trent Bridge will be Cox's fifth professional debut of the past five months.

His string of new beginnings began back in November, when Cox stepped out for Bangla Tigers in the Abu Dhabi T10, where his six matches produced 265 runs, two half-centuries and a strike-rate of 232, including a ferocious 90 not out from 36 balls against the eventual finalists, Deccan Gladiators.

By the time that final took place, however, Cox had already swapped continents for what became a fourmatch stint with Melbourne Renegades in Australia's Big Bash League, which then gave way to a return to the UAE in January to play for Gulf Giants in the ILT20.

And, having previously sampled the SA20 and the Lanka Premier League in the 2022-23 winter, Cox then capped this year's travels by making his first appearances in the Pakistan Super League, with six matches for Islamabad United in February and March prior to his link-up with his newest new squad for Essex's preseason in Abu Dhabi.

"I left on November 10, and I was back 10 days ago, so I've been aware a fair chunk," Cox says during Essex's pre-season media day in Chelmsford. "I love it. I went to private school, I was a boarder. So my parents were like, 'have fun at school, see you at Easter holidays, see you at Christmas'. So I'd only go home like three times a year, so I'm pretty used to being away from home." That sense of adventure is palpable as Cox lifts the curtain on the touring lifestyle to reveal a glimpse of what this new world is really like. The SA20, he says, is "carnage ... the flights are full on ... fly, rest day, game, everywhere." The ILT20, by contrast, was just 40-minute bus rides between Dubai, Sharjah and Abu Dhabi."It was the first time I've ever unpacked in a franchise environment."

Ben Stokes Opts Out Of England's T20 World Cup Defence

Hero Of 2022 Final Concentrates On Return To Full Test Fitness In Wake Of Knee Surgery

LONDON: Ben Stokes has ruled himself out of the T20 World Cup in June, telling England's management that he does not want to be considered for selection for their title defence in the Caribbean.

Stokes hit the winning run in the 2022 final, grinding out his maiden T20I half-century as England beat Pakistan by five wickets at the MCG. But he has only played two T20 matches since, both at last year's IPL, and said missing the World Cup was "a sacrifice that allows me to be the allrounder I want to be for the foreseeable future".

Having previously retired from ODI cricket in the summer of 2022, Stokes reversed his decision in order to play in the 50-overWorldCuplatelastyear. However, that availability required him to delay knee surgery, and he was only able to bowl five overs across England's recent 4-1 Test series defeat to India. He is expecting to play for Durham in the County Championship at some stage in the next few months, after opting out of IPL 2024.

"I'm working hard and focusing on building my bowling fitness back up to fulfil a full role as an allrounder in all formats of cricket," Stokes said in a statement released by the ECB on Tuesday. "Opting out of the IPL and the World Cup will hopefully be a sacrifice that allows me to be the allrounder I want to be for the foreseeable future.

"The recent Test tour of India highlighted how far behind I was from a bowling point of view after my knee surgery and nine months without bowling. I'm looking forward to playing for Durham in the County Championship before the start of our Test summer. I wish Jos [Buttler], Motty [Matthew Mott] and all

the team the best of luck in

defending our title."

Stokes was reluctant to commit to the T20 World Cup before his surgery but said last month that he expected to be available for the tournament. Mott, England's white-ball coach, confirmed in December that his return would be "a given" if fit, saying: "[Stokes] gives us that ability to have a seam bowler in your top six that gives you so many options with your team balance.'

In Stokes' absence, England will consider using Liam Livingstone in the No. 4 spot that he filled during their 3-2 defeat to West Indies in December -

though Livingstone limped off with an apparent muscle strain while fielding for Punjab Kings on Sunday, and is waiting on scan results to determine its severity. Jamie Overton, the Surrey allrounder, will also come into contention.

Stokes has only played three T20Is for England outside of World Cups in the last three years and his decision may well have ended a 43-match T20I career which has only rarely seen him at his best. But he could yet come into contention for the 2026 T20 World Cup in India and Sri Lanka, when he will still only be 34 years old.
