

#### Light Rains.....

till today afternoon, but the weather conditions took a shift thereafter as several areas of Kashmir including Srinagar, the summer capital of Jammu & Kashmir, thus simultaneously brought down the mercury across the valley.

According to the news agency—Kashmir News Observer (KNO), the reports of hailstorm were received from many areas of Shopian district including Sugoo, Tharina, Molu, Dangerpora and others while the crops have also suffered huge damage in these areas as well.

Dr Mukhtar Ahmad, Director Meteorological department (MeT) said the weather is expected to remain generally dry from tomorrow till April 25, but added that the possibility of afternoon thundershower activity at isolated places can't be ruled out.

Furthermore, according to the forecast, the weather would remain generally cloudy while light rain with thunder is expected at many places from April 26-27.

Moreover, the MeT department in its advisory had asked the farmers to resume farm operations after April 21st.

The Srinagar-Jammu national highway was restored for vehicular movement after remaining closed for hours due to mudslide at Mehad, Ramban and shooting stones at Kishtwari Pathar, Banihal yesterday.

As soon as the road was cleared, the traffic was allowed to ply in the late after-

"India will become a developed nation in 2047 or even earlier, but in that, several people have to play a role," Minister Puri

"The Prime Minister sets the coordinates as the prime agent of change, but he has to be supported by others who believe in that vision."

Highlighting the current economic status, Minister Puri noted, "Right now, we are at USD 4 trillion. By 2040, our economy will be USD 40 trillion."

He envisioned that when India achieves a USD 40 trillion economy, it will not just be a 'Sone ki Chidiya' (golden bird) but the 'envy of the world'.

During his address, Minister Puri referenced India's historical economic significance, citing historian Angus Maddison of Cambridge University, who documented that India's contribution to the global economy in the year 1700.

Puri emphasisied, "During the year 1700, India that is 'Bharat' was referred to as 'Sone ki Chidiya'. According to historian Angus Maddison of Cambridge University, who has extensively documented economic history, it is conclusively shown that India's contribution to the global economy in the year 1700, until the Battle of Plassey, was roughly 25 percent or more of the global GDP."

"In 2014, people used to say that India is one of the fragile five economies. Since 2014, we have reached the 5th position," Minister

Puri remarked. Minister Puri said, "Within the next 5 years, India will be amongst the top 3 economies in the world."

The Viksit Bharat Ambassador meetup served as a platform for discussing India's economic progress and the integral role of Kashmir in contributing to the nation's

development agenda. The event witnessed a gathering of influential figures, including startup leaders, women influencers, and distinguished personalities from Kashmir. (Agencies)

"We were desirous of fighting the elections from all the three Lok Sabha seats in Kashmir on our own strength. "We will work in accordance with the roadmap with full force and the candidates having support of the BJP will definitely win the elections as our party has a strong

support base and organisational structure and network in every nook and corner of Iammu and Kashmir," he said.

Raina said Union Home Minister Amit Shah, addressing an election rally in Jammu on April 16, had asked the people in Kashmir to reject the Congress, National Conference and PDP, who have "ruined" the region and prefer other parties contesting the elections from the three seats.

"The home minister made it clear that we have to fight together to defeat the dynastic parties who have pushed J&K into a fire. They have ruled J&K for many decades in the past and brought death and destruction in the valley. They (Congress, NC and PDP) are the enemies of Kashmiris because they have been indulging in politics of hatred and they are doing everything to push J&K back to the old days of violence," he said.

Chugh said the fight is between Prime Minister Narendra Modi, who "freed Jammu and Kashmir from the clutches of Article 370", and the three dynastic parties – the Congress, National Conference and PDP who "exploited" people over the decades under the constitutional provision.

Meanwhile, Union Minister Hardeep Singh Puri said that the issue of BJP not yet declaring candidates on the three Lok Sabha seats in the Kashmir valley is being dis-

Modi ji gave Rs 20 thousand crore to 87 lakh farmers in Rajasthan as Kisan Samman Nidhi. Made 3 lakh lakhpati didi. Tap water was supplied to the homes of 51 lakh poor people. 2 crore people were given the benefit of Ayushman Bharat scheme. Work was done to build toilets in the houses of 86 lakh poor people. Congress is an anti-development party," Amit Shah said further.

The remaining 13 seats in Rajasthan will be contested in the second phase on April 26.

The remaining phases will be held on May 7, May 13, May 20, May 25 and June 1 accordingly. The last general elections in 2019 were also held in seven phases.

In 2019, BJP registered a sweeping victory winning 24 out of 25 seats, while the remaining one seat was won by Rashtriya Loktrantrik Party Candidate Hanuman Beniwal. (Agencies)

favour of NDA and 'Viksit Bharat'. Targeting the INDIA bloc, he said the opposition alliance doesn't have a leader at present, and has no vision for future, and "their history was of scams."

Karnataka is going to the polls in two phases. While 14 Lok Sabha segments in the southern parts of the state will vote on April 26, the remaining 14 constituencies in the northern parts will vote in the second phase on May 7.

Meanwhile, Prime Minister Narendra Modi today took a swipe at Rahul Gandhi, saying that in the ongoing Lok Sabha elections, "Congress's sahabzade" will also lose from Wayanad constituency in Kerala and he will have to look for a safer seat after that.

Addressing a rally at Nanded in Maharashtra to campaign for BJP candidates from Nanded and Hingoli seats, PM Modi said the information available for the first phase of Lok Sabha polls indicates that there has been a one-sided voting in favour of the National Democratic Alliance (NDA).

Referring to Rahul Gandhi, PM Modi said, "After losing Amethi, the Congress" sahabzade will lose Wayanad as well. So he will have to look for a safe seat after April 26." In an apparent reference to Sonia Gandhi, he said some INDIA bloc leaders left the Lok Sabha and moved to the Rajya Sabha as they have no courage to contest elections.

"For the first time, the family will not vote for a Congress candidate in the constituency where they live as there is no party candidate there." he said.

PM Modi said he has spent 10 years fixing the bad governance of the Congress regimes. "A lot of work needs to be done," he added.

The Congress has been a barrier in the development of farmers and poor people, he alleged.

"The agriculture crisis did not happen now. It happened because of the flawed policies of Congress," PM Modi said.

They may claim anything, but the reality is that Congress leaders have accepted defeat even before the announcement of polls," he

He termed the opposition alliance a grouping of selfish people who have come together to protect their corrupt practices.

He appealed to voters to come out in large numbers to exercise their voting right in the Lok Sabha elections.

"You are not doing any favour by voting. you are securing the country's future. I want to boost the morale of the party workers from the opposition. You (opposition leaders) are sure to lose the polls, but you will get a chance some day. But you must appeal to voters to vote," he said.

PM Modi said the INDIA bloc constituents were contesting the elections against each other in 25 per cent seats.

After (the election results on) June 4, they will be fighting more with each other," he

He said that without the Citizenship (Amendment) Act, what fate would have befallen Sikhs who came from Afghanistan.

The NDA under PM Modi is seeking a stronger majority for a third consecutive term, while the constituents of the opposition INDIA bloc are hoping for a rebound after facing reverses in the 2014 and 2019 elections. (Agencies)

continued for the fifth day without any breakthrough, officials said.

Despite ongoing efforts, including by the State Disaster Response Force (SDRF), National Disaster Response Force (NDRF), Indian Army's MARCOS and other teams, there have been no traces of the missing persons, Showkat Ahmad and his son Hazik Showkat, and another Farhan Parray.

The tragic incident occurred on April 16 when a boat capsized in the Jhelum River in the Gandbal area of Batwara, resulting in the deaths of six individuals and leaving three locals missing. The search operation has yielded only a few school bags so far, with no sign of the missing individuals.

ASI SDRF, Abdul Rashid told KNO that the rescue teams have been on job for the last five days but there has been no success in finding the missing trio.

"We have been on our toes, searching for the missing trio, but unfortunately, nothing has been found yet," the ASI said, adding, "We have also been searching near Chattabal Veer as there are chances the bodies might float there, but till now, nothing has been

During the initial stages of the rescue operation, four school bags were recovered near Chattabal Veer, with two additional bags retrieved later in the day by SDRF personnel. However, the missing bodies are yet to be traced.

Meanwhile, people, including religious clerics, have been visiting the bereaved families to offer condolences and pray for the safe recovery of the missing persons.

with purported leopard sightings, a significant majority-90%-are found to be baseless upon scrutiny.

"It may not be correct to say that there is a spike in the presence of leopards in urban areas," Ahmad stated. "Of the reports we receive, 90% turn out to be fake, and we take up the matter with the police against those involved in spreading false rumors about the presence of leopards.'

Speaking over the possible reasons for leopards venturing into urban areas, Ahmad noted that of the minor percentage where leopard presence is confirmed, the primary driving force is the search for food, as these animals move out of their natural habitat for suste-

According to Ahmad, a complex interplay of elements such as leftover foods and open garbage disposal systems are attracting stray dogs, which in turn become prey for these majestic

Addressing the proliferation of misinformation on social media regarding leopard sightings, Ahmad stressed that actions would be taken against those spreading rumors, urging the public to refrain from sharing unverified reports to prevent unnecessary panic and fear.

"In the central division, since I took over about 10% of reported cases are confirmed to be authentic," Ahmad stated while underlining the importance of responsible reporting.

Elaborating on the reasons behind leopards venturing into urban areas, Ahmad highlighted the search for food as a primary driving force. He pointed out that dogs, being soft prey, are attracted to areas with poor waste management practices, inadvertently drawing leopards closer to human settlements.

Ahmad underscored the importance of maintaining clean surroundings, advocating for the closure of unattended structures and the cleaning of bushes in empty lands to deter leopards from seeking shelter in urban environments.

He advised that communities residing near forested regions, national parks and protected areas take proactive measures to mitigate potential conflicts, such as securing garbage bins, refraining from feeding stray animals, and implementing community-driven conservation initiatives.

Meanwhile, some observers have attributed the surge in leopard sightings to rapid urbanization and habitat loss, forcing these elusive predators to adapt to changing landscapes.

The presence of abundant garbage and leftover food inadvertently creates a secondary food source in the form of stray dogs, further enticing leopards into urban vicinities.

### **BJP contesting Kashmir** elections through proxies, alleges Omar Abdullah

PULWAMA, APR 20: Former Chief Minister and National Conference Vice President, Omar Abdullah on Saturday said the Bharatiya Janata Party is contesting elections in Kashmir under the symbols of bat and apple, rather than their own party symbol.

According to the news agency-Kashmir News Observer (KNO), Omar while addressing reporters after a gathering of party workers at Deeri Murran Pulwama, said the BIP is reluctant to announce its own candidates for the Anantnag-Rajouri Parliament seat, and possibly for other seats as well. They are using proxies to contest the elections, he alleged.

Abdullah questioned the BJP's strategy, asking why they are not directly participating in the elections and instead supporting "B and C teams". He criticised the Saffron party for making grand claims without fielding their own candidates, especially considering the uncertain outcome of polling, particularly in the Udhampur seat.

"If they have been making big claims then why did they leave the field empty and support their teams," he said, adding, "When the polling is yet to be conducted on the Jammu seat, then on what basis



can the BJP celebrate its victory."

"I want to remind Ravinder Raina that the polling has not even happened for the Jammu seat. We don't know how many votes would be cast. BJP should declare its victory after the voting. For now, their Udhampur seat seems to be in danger," he added.

Regarding the contest in the Anantnag-Rajouri Parliament seat, the former chief minister said there is no direct competition between a "BJP-supported party" and the NC. "Unfortunately, we have a fight now with our own friend who was with us and left us for this seat," he said.

Omar added, "The Home Minister recently indicated support to B and C teams by saying that they are not in a hurry for Lotus to bloom in Kashmir,"

When asked about the BJP's claim of securing 400 seats, the NC leader said, "Let's wait till June 05 to see the actual results. Ladakh seat is going out of their hands and yesterday's (Friday's) voting indicates they won't be able to win Udhampur seat."

"National Conference is poised to win all three seats in Kashmir based on the response from the people," he added.

## Sajad Lone Seeks Apni Party Support To Consolidate Anti-National Conference Votes In Baramulla

## In 5 years, Srinagar Distt records over 450 kidnapping, rape cases

'Witnesses at least 170 cases of attempt to suicide, 63 cases of murder'

**SRINAGAR, APR 19:** In the past more than five years, Srinagar district have witnessed at least 455 kidnapping and rape cases and 63 murder cases.

According to the official figures available with the news agency-Kashmir News Observer (KNO), police authorities in district Srinagar from have registered at least 455 kidnapping and rape cases from 2019 to January 31-2024.

The official also said that during this period, the police authorities in the region has recorded at least 63 cases under crime head murder and 170 suicidal cases under crime head attempt to suicide.

This information was revealed by the Public Information Officer (PIO) of district police Srinagar in a reply to Right to Information (RTI) application filed by the activist M M Shuja.

According to the official figures, police in 2019 have registered at least 15 suicidal cases under crime head attempt to suicide in Srinagar followed by 26 cases in 2020.

In the year 2021, it also recorded at least 51 such cases, 41 cases in 2022 and 34 suicidal cases in 2023.

The official figures further reveal that in 2024 till the month end of January, a total of three suicidal cases were registered in Srinagar district. a total of eight kidnapping and rape



About the cases of kidnapping and rape, the PIO has informed that the district police Srinagar in year 2019 has registered at least 98 such cases followed by 21 cases in the year 2020.

It also said that the Srinagar district in 2021 has registered at least 100 cases of kidnapping and rape under crime head and has also witnessed 128 such cases in 2022 and hundred cases in 2023 respectively.

The official figures states that that in 2024 till the month end of January,

cases were registered in Srinagar district.

Likewise, the PIO has mentioned that in the year 2019, police in Srinagardistrict have registered at least six murder cases followed by 13 cases in 2020, at least 24 murder cases in 2021, thirteen cases in 2022 and six cases in 2023.

The PIO has further revealed that in January-2024, police authorities in the district have registered only one such case under crime head murder.

### **122 Glaciers Shrinking in** Pir Panjal, Heightened Risk of Glacial Lake Outburst **Floods: Report**

SRINAGAR, APR 20: A study on the damage caused by climate change has revealed shocking information. According to the report, 122 glaciers are shrinking in the Pir Panjal, raising concerns about potential glacial lake outburst floods.

Researchers have identified 122 glaciers in the Pir Panjal range, whose size has drastically decreased since 1980. Glaciers covering an area of approximately 25.7 square kilometers have diminished to just 15.9 square kilometers.

This revelation comes from a study conducted by researchers from the National Institute of Technology, Srinagar, led by Mohammad Ashraf Ganai and Syed Qaiser Bukhari. The findings have been published in the International Journal of Hydrology



Science and Technology.

The researchers analyzed data spanning four decades, from 1980 to 2020, focusing on the glaciers within the Pir Panjal range of the Kashmir Basin in

Glaciers facing south have experienced more significant melting compared to those facing north. Additionally, glaciers situated at an average altitude of 3,800-4,000 meters above sea level have exhibited more pronounced melting than those at lower elevations.

The decline in glaciers poses a threat of water scarcity, impacting agricultural production and everyday life. The rapid and substantial melting of glaciers also increases the risk of glacial lake outburst floods, which could disrupt the ecosystem and pose significant hazards.

## Authorities in Baramulla to impose Rs 5000 fine for unauthorised roadside parking

Warns of strict action against violators for encroaching roads

BARAMULLA, APR 20: Authorities in Baramulla have urged people to refrain from encroaching roads and parking their vehicles on roadsides, saying violators will have to pay a hefty fine of Rs 5000. Street vendors, encroachment

of roads by shopkeepers by put-

ting merchandise, signboards and wrong parking of vehicles were the main reasons for obstructing public movement besides leading to frequent traffic jams, an official told news agency—Kashmir News

Observer (KNO). He said they have decided to relocate street vendors of civil lines Baramulla to Tashkan Adda (Kokar Bazar) and General Bus Stand Baramulla.

"Any vendor found with his cart outside these designated areas will be dealt strictly in accordance with law and a fine

of Rs 2000 will be imposed on the spot," the official added. Meanwhile, an administrative

order notifying all the shopkeepers to remove their illegal encroachments of their own besides asked them not to park their vehicles along roadsides as

well as bridges to ensure hassle free movement of pedestrians/ commuters and to avoid undue traffic jams.

"Any person found violating the orders will be dealt strictly in accordance with the law, which shall include the fine of Rs. 5000," it said.



## **Implement Forest Rights Act on ground**

This would have meant that the people living near the forests would get the rights associated with the Act but that was not to be.

The people living near the forests also known as forest dwellers yearn for the total implementation of the Forest Rights Act in Jammu & Kashmir. The forest dwellers have been complaining that despite many representations the Act has not been implemented and as such they are being denied the benefits that would accrue out of the same. This needs to be looked into by the people at helm so that no section of society is left out on the path of development.

**Even though Gram Sabhas across the length and** breadth of the union territory have declared forests as community forests no further action has been taken. As a result of this the implementation of Forest Rights Act has not taken off in Jammu & Kashmir. The forest dwellers have carried out protests in support of their demands but still then no relief has been meted out to them.

On their part the forests dwellers should also fulfil their obligations under the Forest Rights Act. They should ensure that only the decayed trees or fallen trees are used while as the green ones are not touched. It is also their responsibility to keep track of the activities being carried out in the forests and nearby. They should catch hold of the forest smugglers and this would ensure that no harm or damage is caused to the green cover of the union territory.

Since the Government of India believes in all round development of the country and development of different sections of society it is imperative that forest dwellers are not left out of the race. This would mean that the forest dwellers become real stakeholders in the development of country and they will feel associated with the economic progress of the country. As such one can think of real development of the country in the real sense.

Over the years the depletion of forest cover has taken place and time has come when the lost glory has to be retained. Same is possible only when forest dwellers are involved in the process of minimizing further damage to the green gold. The concerned department should take pro-active measures so that Forest Rights Act is implemented in Jammu & Kashmir.

What do items such as chia seeds, flaxseeds, apple cider vinegar, massage, sauna, dark chocolate and various varieties of green tea have in common? They are all believed by many to be miracle weight-reducing agents. What they also have in common is the fact that, whatever other benefits they may have- and they have many- none of them remotely answers to the description of miracle weight reducer. The perception lives on regardless; and advertisers and salesmen- who are hardly the most conscientious of beings you could ever meet-are not complaining in the least. In a perfect world one would expect this breed to be a little more upright than usual when it comes to matters of medicine and health; but it is not a perfect world, as you probably have guessed already.

While one cannot rule out the efficacy in this regard of chia seeds and the like in some parallel universe; in the universe that we happen to inhabit, weight management is about calorie balance and calorie balance alone. An intake-expenditure surplus makes you gain weight; a deficit makes you lose weight; while an equilibrium means constant weight. Weight loss is then as much about not doing (not consuming certain things at all, and not eating anything in excess) as it is about doing (working out). In fact, much more so; for such is the calorie-intensity of some of the foods (and drinks) on offer that three hours of workout can easily be offset by indulgence of ten minutes or less. While one's diet and exercise regimen help, complement and reinforce one another immensely, the two are all there is to it when it comes to weight management.

This obvious and simple fact (despite its simplicity, or probably because of it) cannot be stressed enough. ## Extension lecture on short stories!

In the last ten years, I have participated in more than 25 literary seminars. But it was the first time I was invited for an extension lecturer on the topic of "How to write a short story" organized with pomp and shown by the Government Degree college-Tandur, Vikarabad District, Telengana State.

My ticket was booked early morning of March 04, 2024, from Gulbarga to Tandur. At the station, I was welcomed by the student, Mohammed Sameer Qureshi, of the same college. The distance from the station to the college is approximately 5 km, where more than 5 dozen students, including the head of Urdu and Hindi departments, were waiting for me.

The duration of the lecture was 90 minutes. Students of the Urdu and Hindi departments were listening to me carefully. Indeed, I was prepared for the lecture and took notes from the book based on the fundamental rules of short stories, but I never imagined that I would speak for the first time on the topic for 90 minutes. It was only the outcome of the student's seriousness and the college staff's love for

The principal of the college is very humble and down to earth. Here, it would be better to mention that there I was only one speaker for the function. After the function, I was in the chamber of principal on a dining table fixed in a corner, so he managed a single packet of lunch for me. I was waiting at the table for my hosts and heads of departments, but they didn't come because the principal hadn't invited them. After lunch, I discussed the matter with Dr Asrar-ul-Haque Department of Urdu, and he told me about the principles of principal sahab. At the table, I was thinking that the principal would share my lunch box, but he didn't. He opened his homemade lunch box. It means we shared the table but he didn't share any items from the lunch. It was his principles and styles of management.

In the 90-minute lecture, I was a speaker sometimes, sometimes a lecturer, the narrator of my literary journey, sometime student, and sometime a question raiser. In all

ways, I have completed my lecture. On a large scale, my lecture was divided into three parts. The first

part was based on the fundamental



principles/speeches of short story writing, like plot, character, point of view, conversion, starting and ending, style of narration, power of feeling, ability to differentiate, ability of imagination, reactions, psychology, and language power.

I have explained all these literary terms as a class teacher. After explaining and analyzing all the terms, I said that all terms are related to starting the writing. That

means there are many rules & regulations and principles for learning and starting to write. Otherwise, there are not any writing rules, because every writer knows what the best style for short story writing is. It is mandatory to learn all the rules when starting. Slowly Slowly most writers fix their rules.

The second part of the lecture was related to my short literary journey. I narrated that I was in

Nadwatul Ulema Lucknow. I have started to write letters to the Editor. I used to write a letter every week and would send it to Rashtarya Sahara Lucknow's resident Editor, Mr. Qutbullab. He used to publish my letters on different topics after appropriate editing. The next step was column writing. Generally, columns are being written on current issues. Nadwa campus was wide and wary. There were available all the basic needs on the campus, so Nadwa administration used to close all the gates to maintain the educational atmosphere. We, students, were free to go to the market or out of Nadwa gates only on Friday in a week. Due to this system, or waiting for Friday, sometimes my columns used to be wasted because they used to be on current issues. In this difficult situation, I have planned to write short stories. I, casually, used to write columns and short stories. I started to send my long essay to Weekly Aalami Sahara, Noida, where the Late Abdul Qaduir Shams was a senior Sub Editor, who started to publish my columns and short stories. My first story was published in Aalami Sahara, Noida. This was my fiction writing journey. Students from different

departments of Government, Degree College, Tandor were listening to my fiction journey. They were excited and were planning to hold the pen.

In the third part of my lecture, I presented some philosophical paragraphs from Manto and my shorts, and quotations from Manto's articles. Here, only one Manto's quotation: When Saadat Hasan Manto was asked how he writes, he said that he takes paper, pencil, pen, or typewriter and starts writing. He is not a writer who thinks how to write a story." As I said above, there is no rule for writing a story.

Finally, it was a very memorable and fantastic literary trip, because there were many aspects to make the trip memorable. First, my 90-minute lecture made me confident that I could deliver long speeches. Second, the silence and intent of students during my first extension lecture. Third, the simplicity of Dr. Syed Asrar-Ul-Haque, the Principles and administrative styles of M. Ravinder, the Principal, and the remarks on my lecture by Dr.Vivek Kumar Dubey Department of Hindi crept into my heart.

# Bose and Bose

It was 12 June 1942. At a press conference in Berlin, Germany, Netaji Subhas Chandra Bose said, "I regard myself as a servant of the Indian nation and my present task is to lead the fight for India's independence. But as soon as India is free, it will be the duty of the Indian people to decide what form of Government they desire and who should guide the future Indian state... I am convinced that during the course of this war India will be free. The freedom of India will mean the expulsion of AngloAmerican imperialism from Asia, and it will afford a powerful stimulus to freedom movements all over the world."

These powerful words of Netaji were broadcast by Azad Hind Radio and heard by thousands across Europe and India. His speeches called for struggles against both British and US imperialism which had shackled the colonies.


Having escaped from British India in January 1941, Bose in Germany proposed to the Germans that the "Free Indian Government" be established in Berlin. He was disappointed by the lack of immediate support from Adolf Hitler whom he had met a fortnight earlier.

Though Bose greeted Hitler as 'an old revolutionary', the Führer made clear his unwillingness to make any moves or issue any proclamations. Hitler told Bose that he would facilitate his trip to East Asia; not by an air route but that a submarine would be placed 'at his disposal'.

"My own experience has now convinced me that by the logic of history, the Tripartite Powers have become our natural friends and allies. Every blow struck at the British Empire is a help to India in her fight for freedom," he said during the press conference. (Germany, Italy and Japan were the Tripartite Powers he referred to.) When asked about his plans, he replied, "the plans of a revolutionary must always be adapted to the circumstances of the moment and to the needs of the situation in which he is interested."

Historians have commented on Bose's self-image now as a 'revolutionary', linking himself to a tradition of violent resistance stretching back to the earliest days of British conquest, especially in the regions of Bengal.

In Netaji's life, as he moved through war-torn Europe, there was another revolutionary, another Bose who came to play a historic, dramatic part in India's freedom movement. This was Rash Behari Bose, a global revolutionary who had escaped from Calcutta and settled in Japan way back in 1915. The two Boses, unrelated to each other, were bonded by their patriotism and sense of adventure and fearlessness.



Rash Behari, since the early party of the century had worked with revolutionaries in Punjab; he was instrumental in recruiting the uncles of Bhagat Singh for revolutionary activities.

During the Delhi Durbar of 1911, he was with the Anusilan Samiti which planned to bomb the procession of Viceroy Lord Hardinge. In 1913, after the Lahore bombing conspiracy, Rash Behari went into hiding in Calcutta, then Varanasi.

In 1914-15, Rash Behari Bose was spurred into action against atrocities which Ghadr Party members had faced. He planned a great uprising within the British Indian Army. 21 February 1915 was the D-Day, but a traitor in Lahore put paid to all the

Several revolutionary workers, including Ghadr leaders were killed in clashes with police and military; this came to be known as the first Lahore Conspiracy Case. Rash Behari escaped to Varanasi, and then onwards to Japan.

Under a false identity of PN Tagore, and posing as a relative of Rabindranath Tagore, he boarded a steamship from Calcutta on 12 March 1915, reaching Japan on 5 June. Rash Behari was now a revolutionary on foreign soil, just as Subash Chandra would be decades later.

When in 1924, he founded the India Independence League in Tokyo, little did he know a long struggle awaited him. His slogan ~ 'Asia for Asians' ~ struck a chord. With Rash Behari's efforts East Asians now began to look upon India's emacipation as a stepping-stone to Greater Asian liberation from colonial bondage.

Both Rash Behari and Rabindranath Tagore had looked eastwards: one promoted Indo-Japanese cooperation and goodwill at a political level, while Gurudev built on the cultural front. In Rash Behari's perspective, enemies of Britain were friends of India, no matter what their ideology was. He was a hard-headed realist. Rash Behari had his differences with Tagore, who had written to him, "Japan has not taken long to betray the rising hope and repudiate all that seemed significant in her wonderful and symbolic awakening and has now become itself a worse menace to the defenseless people of the East."

 $Rash\,Behari\,countered\,this\,anti-Japanese$ propaganda by Indians by organising meetings, and advocating Indo-Japanese collaboration under the League. In November 1938, he even issued a manifesto boldly calling for revision of India's foreign policy. Subhas Chandra, at this time, was Congress President ready for challenges that would

make him part ways with the party.

With the bombing of Pearl Harbour on 7 December 1941, a new chapter began. Both the Boses, in different continents, were now striving to utilise the war to strengthen the cause of Indian Indepen-

Between December 1941 and March to June 1942, Rash Behari established contact with military and civil high commands in Japan to impress upon them the necessity to help India in her struggle for freedom, in line with Japan's objectives.

His campaign bore fruit and General Tojo, Japan's Prime Minister, declared in the Imperial Diet that his government was prepared to help Indians achieve freedom.

Rash Behari was not alone in this campaign. Swami Satyananda Puri or Praffula Sen of Anusilan Samiti and Sirdar Pritam Singh were team-mates from Bangkok.

Together they reorganized the League and shifted its base to Singapore. Rash Behari was president of Council of Action who ensured the newly formed Indian National Army was accorded powers and status of a free National Army of an Independent India, in equality with armies of Japan and other friendly powers.

Rash Behari threw himself heart and

soul into organising the IIL and INA. He took tough decisions when INA was faced with a leadership crisis, dismissing General Officer Command General Mohon

On 9 December 1942, Rash Behari said: "I once again pledge to serve the cause of India's Independence without fear and without favour, loyalty and conscien $tiously to the \,utmost \, \overline{ofmy} \, ability... it \,would$ have broken my heart, if at this moment, I had let this movement die...'

By April 1943, Rash Behari had set the INA house in order, though his health was deteriorating. A military training centre was operational in Kuala Lumpur with 1,000 civilians undergoing modern warfare

He now was eagerly awaiting the arrival of Subhas Chandra Bose in the East. He organized an official invitation for Subhas in Germany, requesting his participation at the Bangkok Conference. Meanwhile a safe passage for Subhas Chandra Bose was arranged, between Germany and Japan, to reach Tokyo. The stage was set a dramatic chapter of our freedom struggle: one Bose was ready to hand over the baton to the other younger Bose.

## What happens in Davos stays in Davos

The optics is about making the world a better place. The opportunity is about networking amidst moolah and minds with messianic zeal.

It is that time of the year when ideas, intellectuals and a large caravan of global net worth travel to the mountains, to the annual jamboree of the World Economic Forum at the ski resort town of Davos in Switzerland. This week, the much-celebrated confluence of public purpose and private profit, will brainstorm or in WEF lingo "engage in constructive, forwardlooking dialogues and help find solutions through public-private cooperation". Doubtless it will occupy prime time media and mind space. The optics is about making the world a better place. The opportunity is about networking amidst moolah and minds with messianic zeal.

It is said talk is cheap. Not when it is Davos, if it means breathing rarefied air with billionaires, heads of state and the momentarily conscientious tinsel star. As any realtor would tell you location does matter. The fancy digs - a chalet or a penthouse apartment - could cost upwards of the annual per capita income of G7 nations. For those willing to rough it out, just to attend sessions on moolah mantra garnished with celeb spice, the cost for a bed under a decent roof would be roughly \$1200 or the annual per capita income of more than 30

countries. The attendees will stimulate the economy of Davos in the hope of stimulating their minds with ideas and intellectuals.

Of course being at GPS 46.802128 9.833477 is not mandatory but presence is enabled by a seductive illusion, of hope and the promise of migrating in status -- from wannabe to would be. Over the next four days more than 1500 leaders - the list of attendees is 79 pages long - including over 50 heads of state, 600 CEOs will mark their presence at WEF. The Indian delegation besides the billionaire's brigade includes four union ministers and three chief ministers. The US delegation has six members of the Biden Administration including climate envoy John Kerry and a dozen elected members from both houses.

The genius of the idea propagated by Klaus Schwab is essentially the scent of relevance it conveys, the currency of being somebody, that fleeting moment of immediacy and rare intimacy in thoughts. The idea which has persistently persuaded the rich and the famous, heads of state and global corporations is that being visible at WEF every January

The banner this year is 'Cooperation in a Fragmented World'. The title may sound familiar to regulars. The 2018 banner read "Creating a Shared Future in a Fractured



World". That year the WEF invited Donald Trump, then US President. The New York Times headline read 'Fox in the Globalist Henhouse?' The Davos men witnessed, up close and personal, the man whose campaign raged against the "party of Davos", the globalizers, as ideological enemies. Trump declared "I am here today to represent the interests of the American People" and spoke about America First.

The call to action in 2015 similarly was about altered geopolitics. The title was 'The New Global Context'. It was inspired by an anniver-

sary -- in 1815 the world gathered at the Vienna Congress in search of peace and a new world order. On January 16, 2015, in what could be an enduring comment, the German Foreign Minister Frank-Walter Steinmeier defined 2015 as "a world in search of a new order." In 2023 déjà vu must be experiencing déjà vu. Not very different you could say but yet differentiated.

Consider the art of making a distinction without differing. In 1973 the WEF issued what it called the Davos Manifesto. The crux read: "The purpose of professional management is to serve clients, shareholders, workers and employees, as well as societies, and to harmonize the different interests of the stakeholders." In 2020 Schwab updated the manifesto. It now reads: "The purpose of a company is to engage all its stakeholders in shared and sustained value creation. In creating such value, a company serves not only its shareholders, but all its stakeholders employees, customers, suppliers, local communities and society at large." The new manifesto, in its full explanatory version, is 139

The essence of WEF is its ability to discern popular pulse. There is no dearth of issues confronting the world and as always the 2023 agenda is riveted by concerns. For instance 'Addressing the Current Energy and Food Crises in the context of a New System for Energy, Climate and Nature'; 'Addressing the Current Geopolitical Risks in the context of a New System for Dialogue and Cooperation in a Multipolar World' and if you so choose, 'Addressing the Current High Inflation, Low Growth, High Debt Economy in the context of a New System for Investment, Trade and Infra-

Does Davos make a difference? While it may seem that the WEF meetings create quantum change in how the world engages with issues, in reality it is at best a venue which brings issues and people face to face. Sure, there have been offshoots which have got propagated and nurtured. The reality is that public-private cooperation is governed by the statute of limitations in a world of nation states informed and influenced by domestic politics.

Catalysis of collective consciousness does not necessarily alter collective conscience. What happens in Davos verily stays in Davos.

## Tihar's Arvind Kejriwal Report On Insulin Reaches Lt Governor, Atishi Claims Threat To Him

New Delhi: Delhi Chief Minister Arvind Kejriwal had stopped taking insulin months before his arrest and is on a basic anti-diabetes oral medicine, officials said on Saturday, citing a report by the Tihar jail administration to Lieutenant Governor VK Saxena. "The entire narrative being built and fear-mongering by the Aam Aadmi Party regarding Kejriwal's sugar levels, is only based on a purported treatment of Kejriwal being carried out by a Telangana based private clinic. Interestingly, Kejriwal, as advised by the Telangana doctor, was on an insulin - reversal programme and the doctor had stopped insulin dosage much before the arrest of Kejriwal," the Tihar jail report said.

In response, Aam Aadmi Party (AAP) leader Atishi said the report has "exposed" the BJP's "conspiracy". "At the behest of the BJP, a conspiracy is underway to kill Kejriwal in jail. The chief minister has been taking insulin for 12 anti-diabetes oral tablet called Metformin, the years, what is the problem for the Tihar administration to give insulin to him?," she asked.



The Delhi minister also claimed that Mr Kejriwal used to take 50 units of insulin daily before he was sent to jail.

Mr Kejriwal -- who is under the care of a Telangana-based private doctor for diabetes -- stopped taking insulin a few months ago and, at the time of his arrest, he was on a basic officials said, citing the Tihar report.

During his medical check-ups in Tihar jail,

Mr Kejriwal told doctors that he was taking insulin "since the last few years and stopped taking it a few months back", the report said.

'Kejriwal's alleged treatment at a private clinic in Telangana is a curious case where Delhi's Chief Minister, who boasts of a worldclass health infrastructure in Delhi is surreptitiously getting treated at a south India clinic of which he even fails to provide medical documents," the report said.

"Notably, the entry of this Telangana clinic in the whole episode surrounding Kejriwal's arrest in the excise scam comes close on the heels of the south Indian liquor cartel that played a key role in framing and execution of the now-scrapped excise policy of the AAP Government," the report said.

Mr Kejriwal was arrested on March 21 by the Enforcement Directorate in connection with a money-laundering case linked to the Delhi government's now-scrapped excise policy. He has been lodged in Tihar jail since

## **DK Shivakumar Faces** Police Case For "Undue" **Influence At Elections"**

New Delhi: A police case has been registered against Karnataka Deputy Chief Minister DK Shivakumar for violating the model code during campaigning for the Lok Sabha elections. The case pertains to a video of the Congress leader where he allegedly told Bengaluru voters that he would provide them a supply of water from river Cauvery if they voted for his brother DK Suresh. DK Suresh is contesting from Bangalore Rural.

The state Election Commissioner said that his speech violates the model code and a police case has been registered for "bribery and undue influence at elections".

In a video clip that surfaced on social media, DK Shivakumar was purportedly heard saying to the



residents of a housing society in his brother's constituency that he had come for a "business deal" and if they voted for his brother he would ensure the supply of Cauvery river water to them."I am here for a business meeting. You want Cauvery water and the CA site. All other issues are small. If I get these done, what will you do to me? I spoke to the commissioner about this issue. I asked what can be done. I believe in sharing and caring," Mr Shivakumar says while

addressing a rally."You have

to share your confidence with me so I can care for you. You have voted by booth, not by candidate. I am DCM, Minister for BDA, Bengaluru, and water everything I am here. Everything is in your pockets. I have come to your house, make use of me, vote for me. Within two/three months, I'll get these done," he adds.Residents of Bengaluru have been dealing with a severe water crisis for the last two months. Bengaluru primarily gets its water supply from two sources - the Cauvery river and groundwater. For most non-drinking uses, recycled water processed by sewage treatment plants is used. With no rain for a while now, the primary sources have been stretched to their limits.Bengaluru needs 2,600-2,800 million litres of water daily, and the current supply is half of what's required.

## Congress Under Fire As Leader Alleges 'Love Jihad' After Daughter's Murder

Bengaluru: The gruesome murder of a Karnataka corporator's daughter has become the latest flashpoint between the Congress and the BIP. The Congress leader's daughter was stabbed seven times by a former student of the college she was attending in Hubbali. Cops suspect that he murdered her because she rejected his advances.

Neha Hiremath, 23, was a first-year student of Master of Computer Applications and Fayaz Khondunaik was earlier her classmate. According to a senior police officer, Fayaz, who stabbed her multiple times, claimed during interrogation the two had been in a relationship but she had been avoiding him of late.

The issue has snowballed into a political slugfest between the ruling Congress and the opposition BJP. While the ruling party has tried to project it as an incident from a personal angle, the BJP has said it shows the deterioration of law and order in the state. Union Minister and Dharwad Lok Sabha BJP candidate Pralhad Joshi suspected that there was a love jihad angle behind the incident. There is a complete deterioration of law and order under the Congress regime, he alleged, urging Chief Minister Siddaramaiah to stop minority appeasement politics and special treatment to a "particular community." However, Home Minister G Parameshwara said there was no "love jihad" angle as of now.

What has exacerbated the state government's troubles is the girl's father also calling the crime a 'Love Jihad' case. Niranjan Hiremath, a Congress corporator, claimed that the accused had planned to "trap his daughter". "The gang had



conspired for a long time. They had planned either to trap her or to execute her. They have been threatening her in that backdrop. However, the girl had not heeded to their threats," Mr Hiremath told the media."The whole state and country witnessed what happened to my daughter. If they say that it is personal, what is personal in this? Are they my relatives?" he added.

Union Minister Meenakshi Lekhi also launched a scathing attacking attack on the Congress government in the state saying that the C in the party's name stands for "corruption, criminality, and ommunal violence.""For any government, it is a salient duty to ensure that our children acquire the proper moral and ethical lessons in schools. Even the people should have requisite awareness in this regard," the BIP MP told news agency ANI."People should have the belief that the law and machinery of a state will ensure that those who do wrong are brought to book. However, the Congress has failed abjectly in this regard (in Karnataka)," she added. The Congress retorted by saying that the state has the best law and order and the BJP was trying to impose the Governor's rule in Karnataka.

#### **Odisha Boat Capsize Death Count Rises To 8, Search Operation Ends**

Bhubaneswar: The death count in the Mahanadi river boat capsize in Odisha's Jharsuguda district rose to eight with the recovery of six more bodies on Saturday, an official said on Saturday. "This conduct is deplorable and totally contrary to the values and good practices that we are trying to inculcate in our society. We have filed police reports and will take appropriate legal action," he said.

The police said late Friday night that the letters, which were sent by post to the victims' workplaces, contained pictures of the victims' faces superimposed onto obscene photographs of a man and a woman purportedly in an "intimate and compromising position".

There have been over 70 police reports since March about such extortion letters, according to a Channel News Asia report on Saturday.

The letters warned of "threatening consequences" unless they contacted the email address provided.

Balakrishnan said: "In this age of deep fakes and scams, we must take a strong collective stand against such conduct.' Amirabdollahian warned that if Israel retaliated and acted against the interests of Iran, Tehran's next response would be immediate and at maximum level.

"If Israel wants to do another adventurism and acts against the interests of Iran, our next response will be immediate and will be at the maximum level," Amirabdollahian said. The attack appeared to target an Iranian Air Force base near the city of Isfahan, deep inside the country, but without striking any strategic sites or causing major damage.

Israel has said nothing about the incident. U.S. Secretary of State Antony Blinken said the United States had not been involved in any offensive operations.

Biden said he had called for the US Trade Representative to triple the tariff rates for Chinese steel and aluminium if Beijing was confirmed to be using anti-competitive practices."They're xenophobic," he added. "They've got real problems. I'm not looking for a fight with China, I'm looking for competition -- but fair competition."Beijing and Washington have clashed in recent years on flashpoint issues from technology and trade to human rights as well as over the self-ruled island of Taiwan and the disputed South China Sea. Relations have stabilised somewhat since Presidents Joe Biden and Xi Jinping met in San Francisco in November for talks that both sides described as a qualified success. The two held a follow-up telephone call this month in which they clashed over US trade restrictions on technology and on Taiwan, which Beijing claims. But they also agreed that two high-level US officials would soon travel to China -- Treasury Secretary Janet Yellen visited last week, with top diplomat Antony Blinken due in Beijing soon.

The United States also this week announced a probe into China's trade practices in the shipbuilding, maritime and logistics sectors. China's commerce ministry hit back, saying the probe was "full of false accusations, misinterpreting normal trade and investment activities as harming US national security and corporate interests, and blaming China for its own industrial problems".

#### **Dubai carriers resume** flight operations following record-breaking storm

Dubai's flagship carrier Emirates and sister airline flydubai have restored normal operations after a record-breaking storm caused severe flooding across the United Arab Emirates earlier this week, the airlines said on Saturday.

Emirates cancelled nearly 400 flights and delayed many more as a result of a record storm that hit the desert city of Dubai on Tuesday, according to a statement released by the airline's president, Tim Clark.

"As of this morning ... our regular flight schedules have been restored. Passengers previously stranded in the airport transit area ... are en route to their

"It will take us some more days to clear the backlog of rebooked passengers and bags, and we ask for our customers' patience and understanding," Clark added. He also said that Emirates provided 12,000 hotel rooms and 250,000 meal vouchers to affected customers.

Flydubai also returned to its full flight schedule from the airport's Terminal 2 and Terminal 3 today following the weather-related disruption, a spokesperson for the airline said in a statement.

According to the Civil Aviation Authority's (CAA) website, various carriers' flights from Pakistan are travelling to and from Dubai.

Due to the impact of the storm, the airline suspended check-in for passengers departing from Dubai and halted its transit operations through Dubai International Airport, a major global travel hub, leaving thousands of travellers stranded.

The airport has struggled to return to normal operations after the storm flooded taxiways, forcing flight diversions, delays and cancellations.

The UAE has suffered the impact of the flooding for days, with roads between the city and Abu Dhabi still partially underwater as of Saturday. In Abu Dhabi, some supermarkets and restaurants faced product shortages, unable to receive deliveries from Dubai.

#### Pakistan denounces 'political use of export controls' after US sanctions alleged missile suppliers

Pakistan rejected what it said was the "political use of export controls" after the United States imposed sanctions on four entities for their alleged involvement in supplying "missile-applicable items" to Pakistan's ballistic missile programme, the Foreign Office (FO) said on Saturday.The US State Department claimed on Friday evening that the entities — three Chinese and one from Belarus — were particularly assisting Pakistan's long-range missile endeavors. The statement specified that "the ultimate goal of sanctions is not to punish, but to bring about a positive change in behavior."The entities facing sanctions include the Belarus-based Minsk Wheel Tractor Plant, the People's Republic of China-based Xi'an Longde Technology Development Company Limited, Tianjin Creative Source International Trade Co Ltd and Granpect Company

The president of Bosnia and Herzegovina has sent a letter to President Asif Ali Zardari seeking Pakistan's support for a United Nations draft resolution to declare the Srebrenica massacre a genocide and July 11 the International Day of Remembrance for the victims, it emerged on Saturday.

According to the letter, seen by Dawn.com, a draft UN resolution has been proposed by Germany and Rwanda and co-sponsored by the United States, Bosnia and Herzegovina and other countries.

Bosnian President Denis Becirovic is seeking a vote from Pakistan in the resolution's favour which calls to declare the 1995 Srebrenica massacre a genocide, as well as condemn the atrocities committed against unarmed Bosnian civilians.

The resolution commemorates the 29th anniversary of the massacre, where Bosnian Serb forces killed more than 8,000 Bosniak men and boys after occupying Srebrenica, which was a designated UN safe zone in July 1995.

## Poor diet increases cancer risk: Scientists uncover missing link

oor diet can increase the risk of obesity, heart disease, type 2 diabetes, and some cancers.

Experts have not yet found any firm causative links between individual dietary components and cancer.

A new study has discovered that methylglyoxal – which is produced when glucose is broken down in cells — may help explain the link between poor diet and cancer.

They suggest that a long-term poor diet leads to an increase in the production of methylglyoxal, which switches off cancerpreventing genes, increasing cancer risk.

Poor nutritionTrusted Source is associated with many health conditions, among them obesity, heart disease, type 2 diabetes, and cancers, including those of the breast, uterus, and large intestine. High intakes of sodium, saturated fats, and sugars can increase the risk of chronic conditions like heart disease and type 2 diabetes, but what links diet and cancer is less clear.

Although many foods are said to be associated with increased or decreased cancer risk, according to the National Cancer InstituteTrusted Source, no studies have yet shown that any dietary component directly causes or protects against

molecule that can disrupt cell function, so is broken down by enzymes into less harmful substances. However, if too much methylglyoxal is produced, the study suggests, the excess can then damage **DNATrusted Source.** 

The researchers first investigated the effect of methylglyoxal in cells from people who had inherited a copy of a mutated gene – BRCA2 – that increases the risk of breast and ovarian cancers.

They discovered that methylglyoxal temporarily disabled tumor suppression by BRCA2, which could increase the likelihood of cancer developing.

Prof. Ashok Venkitaraman, corresponding author, NUS Centre for Cancer Research, National University of Singapore, told Medical News Today:

"[M]ethylglyoxal triggers the destruction of BRCA2 protein, reducing its levels

in cells. (It doesn't prevent expression of the BRCA2 gene.) This effect is temporary, but can last long enough to inhibit the tumor-preventing function of BRCA2."

Methylglyoxal damaged DNA in cells that had the mutated form of the BRCA2 gene. Repeated exposure to methylglyoxal increased the level of damage to the

"It is well documented that some individuals are at a high risk of developing breast, ovarian, pancreatic or other cancers because they inherit a faulty copy of the cancer-preventing gene - BRCA2 from their parents," Venkitaraman said.

"Our recent findings show that cells from such individuals are particularly sensitive to the effects of methylglyoxal, which is a chemical produced when our cells break down glucose to create energy. We find that methylglyoxal inhibits the tumor-preventing function of BRCA2, eventually causing faults in our DNA that are early warning signs of cancer development," he added.

Similar effects seen without gene

"The study revealed that even individuals without a genetic predisposition might still face an increased cancer risk if they present with elevated methylglyoxal levels. This scenario is commonly observed in those with diabetes or prediabetes, conditions often linked with obesity or suboptimal dietary and lifestyle

## **Heart Failure, Not Stroke, Is Most Common Complication of AFib, Study Finds**

he risk of atrial fibrillation, the most common type of heart arrhythmia, has increased with one in three people expected to develop the disease in their lifetime. Now a new study finds that the most frequent complication of this disease is heart failure rather than stroke.

With these increasing numbers more strategies are needed to prevent either heart failure or stroke in people with atrial fibrillation, according to the study authors. The study was published in The BMJ, on April 17 and examined 3.5 million people in Denmark from 2000 to 2022 who had no history of atrial fibrillation at age 45 or older.

Researchers found 362,721 people with a new diagnosis of atrial fibrillation, almost evenly split between men (54%) and women (46%), and followed them until heart attack, heart failure, or stroke.

From 2000 to 2010, the lifetime risk of atrial fibrillation was 24%; from 2011 to 2022, that risk increased to 31%, with men and people who had a history of stroke, heart attack, heart failure, diabetes, or chronic kidney disease seeing a larger increase.

And among people found to have atrial fibrillation, the lifetime risk of heart failure was 41% — twice the lifetime risk of stroke (21%) and four times that of heart attack.

"Heart failure was the major complication after atrial fibrillation in our study, but the international guidelines for the management of atrial fibrillation mainly focus on stroke prevention. The high lifetime risk of heart failure encourages greater attention to prevent heart failure after atrial fibrillation," Vinter said. What causes AFib?

There are four chambers in the heart – two atria and two ventricles and atrial fibrillation occurs when those chambers don't function properly due to abnormal electrical activity, which causes the atria and ventricles to contract at different speeds.

Advanced age, high blood pressure, hyperthyroidism, diabetes, binge drinking, and a history of underlying heart disease are all factors that can contribute to the development of atrial fibrillation, Paul Drury, MD, board certified cardiologist and associate medical director of electrophysiology at Memorial Care Saddleback Medical Center in Laguna Hills, CA. who was not involved in the study, told Healthline.

## **Lungs Of Young Adults More Susceptible To** Covid-19 Causing SARS-CoV-2 Virus, Claims Study

hile older age has been associated with an increased risk of SARS-CoV-2, the virus responsible for Covid-19, a new study has revealed that the lungs of young adults are more susceptible to the virus. The study, which was posted on a preprint website and has not yet undergone peer review, showed that the lungs of older individuals are less susceptible to SARS-CoV-2 and flu virus replication compared to the young. "In contrast to SARS-CoV-2, flu viruses replicate more efficiently in human alveolar cells, leading to stronger innate immune responses," Dr Vipin M. Vashishtha, a member of WHO's Vaccine Safety Net, said in a post on X.

"These findings indicate that the elderly are not more susceptible to respiratory virus infection than young people as a rational of elevated risk for severe disease by local viral replication only, but points towards other mechanisms such as immune-mediated pathogenesis, he explained.

In the study, researchers from the University of Bern in Switzerland evaluated the influence of lung ageing on the efficiency of replication of influenza Avirus (IAV) and SARS-CoV-2, as well as determined the pro-inflammatory and antiviral responses of the distal lung tissue. Using precision-cut lung slices (PCLS)



technology, used for respiratory research, from donors of different ages, and found that influenza viruses H1N1 and H5N1 replicated in the lung parenchyma with high efficacy. Conversely, SARS-CoV-2 wild-type and delta variants replicated less efficiently.

While SARS-CoV-2 infection was not causing detectable cell death, influenza virus infection "caused significant cytotoxicity and induced significant early interferon responses," the researchers said. "These findings suggest that aged lung tissue might not favour viral dissemination, pointing to a determinant role of dysregulated immune mechanisms in the development of severe disease," they said. ## David, Pollard fined for providing **DRS** assistance from dugout

**NEW DELHI:** Mumbai Indians batter Tim David and batting coach Kieron Pollard have been fined 20% of their match fee for breaching the IPL's code of conduct during their match against Punjab Kings in Mullanpur on Thursday.

While the IPL did not reveal the details of the breach, ESPNcricinfo has learned that both Pollard and David were penalised for signalling from the dugout to the on-field batters to seek a review for a wide delivery.

The incident took place on the last ball of the 15th over when Arshdeep Singh bowled a full and angled delivery outside off stump that Suryakumar Yadav failed to connect. Suryakumar did not review it initially, but asked for one belatedly. Punjab Kings' stand-in captain Sam Curran walked up to the on-field umpire and it is mitted to query an umpire understood he was querying whether 15 seconds had elapsed.

It is understood that the onfield umpires were clear about the Mumbai batters not looking in the direction of the dugout before asking for the review.

Later, the IPL sought the footage from the broadcaster to check for the sequence of events leading to the review. After confirming the Mumbai dugout had clearly prodded the on-field batters, the match officials informed the franchise about the breach.

The said clause applied in this case was 3.2.3 in the IPL playing conditions which states: "The two batters may consult with each other prior to deciding whether to request a Player Review. Under no circumstances is any player perabout any aspect of a decision before deciding on whether or not to request a Player Review.

"If the on-field umpires believe that the captain or either batter has received direct or indirectinputemanatingother than from the players on the field, then they may at their discretion, decline the request for a Player Review. In particular, signals from the dressing room must not be given. Breach of this provision will be liable for reporting under COC."

As per a media release by the IPL, David and Pollard committed a Level 1 offence under Article 2.20, which covers all types of conduct that are contrary to the spirit of the game. However, it did not specify the

Article 2.20 states: "When assessing the seriousness of the offence, the context of the particular situation, and whether it was deliberate, reckless, negligent, avoidable and/or accidental, shall be considered. Further, the person lodging the Report shall determine where on the range of severity the conduct lays, with the range of severity starting at conduct of a minor nature (and hence a Level 1 offence) up to conduct of an extremely serious nature (and hence a Level 4 offence)."

Both David and Pollard admitted to the offence and accepted the match referee Sanjay Verma's sanction.

Mumbai, who went on to win the match by nine runs, are currently seventh on the points table with three wins and four losses from seven games. Their next match is on Monday, against Rajasthan Royals in




