JAIPUR, APR 23: Prime Minister Narendra Modi on Tuesday sharpened his attack on the Congress, saying it is difficult to follow one's faith under the party and again accused it of hatching a deep conspiracy to snatch people's wealth and distribute it among "select" people.

Reffering to the 'redistribution of wealth' remarks made by him at a rally in Rajasthan's Banswara on Sunday, the prime minister said it has angered the Congress and INDI Alliance so much that they have started "abusing" Modi everywhere

"I have put forth the truth before the country that Congress is hatching a deep conspiracy to



snatchyour wealth and distribute it among the 'select' people," he said at a rally in Tonk.

"Two-three days ago, I exposed this vote bank politics of Congress as appeasement politics; this has angered Congress and its INDI Alliance so much that they have started abusing Modi everywhere," he said while asking "why the Congress is scared of the truth and hiding its policies". "It is written in their manifesto that they will survey the wealth. 

are discreetly shuffled between multiple accounts to evade detection. Perpetrators, operating from outside the UT of Jammu and Kashmir, lured potential victims through emails, chatrooms or social media, offering inducements in exchange for renting out their bank accounts. Once trapped, victims unknowingly help in illegal transactions through mule bank accounts, sending the money to the criminal's main accounts.

Acting upon the matter, Cyber Police Station Kashmir Zone, Srinagar, has filed a case vide FIR No. 10/2024 under relevant legal provisions and initiated a comprehensive investigation.

Subsequent inquiries have revealed numerous mule accounts operating in various Districts of Kashmir Zone, with transactions totalling crores of rupees. Four individuals from Srinagar city have been identified in orchestrating and managing these mule bank accounts, as well as enticing unsuspecting individuals to participate in these illegal activities. Consequently, these four accused persons identified as Sajad Ahmad Rah son of Mohammad Maqbool Rah residing at Chinar Colony Mehjoor Nagar, Srinagar, Tawqair Ahmad Bhat son of Tariq Ahmad Bhat residing at Banpora Nowgam, Srinagar, Ubaid Ahmad Rah son of Mohammad Ayoub Rah residing at Hamdaniya Colony Bemina, Srinagar and Amir Rah son of Mohammad Maqbool Rah

Police teams have also recovered one .30-bore automatic Chinese pistol along with a magazine and four live cartridges from his possession, it said.

The statement quoting DGP Yadav said that acting swiftly on intelligence inputs, Punjab police teams from Counter Intelligence, Jalandhar laid a special 'naka' (check barrier) in the area of Rama Mandi, Jalandhar, and arrested the accused after recovering the sophisticated automatic pistol from his possession.

Sharing more details, Senior Superintendent of Police, Counter Intelligence, Jalandhar, Navjot Singh Mahal said that the accused has received money in his bank account via Dubai and procured the pistol along with ammunition from Samba in J&K.

A case was registered on Monday under relevant sections of the IPC and under the Arms Act at State Special Operations Cell police station in Amritsar, he said, adding further investigations are going on.

The government's steadfast commitment to improving road infrastructure has markedly elevated the region's overall quality of life by enhancing connectivity and accessibility," said the officials.

According to KNO, the funeral prayers were held at 2.30 pm in Kunda village in which hundreds of the people participated. After the prayers, Razaq's body was laid to rest in the native graveyard where his father was buried.

His father Muhammad Akber was also a victim of terrorism as his throat was slit by the terrorists in the year 2003. Razaq was appointed in the social welfare department on compassionate grounds after his father's killing and was working as a junior assistant in the department. Razaq's eldest son is just 15 years old.

Earlier, once the bullet-ridden body of Razaq reached his home, the pall of gloom descended in the area as everybody was heading towards his house to pay their respect to the departed soul. According to the locals, he was a kind hearted and helpful person who was always ahead of others in reaching out to the people whenever they were in need.

Locals told KNO that terrorists had reached his home by enquiring from locals without ascertaining their identity. They were hiding in his house and once Razaq entered after completing prayers, he was fired upon by the terrorists and injured him critically. He was shifted to the nearby hospital where he was declared dead on arrival.

They believed that terrorists were probably after Razaq's brother Tahir

Khursheed, who is working in the Territorial Army, but there was no confirmation from police and administration.

AIIMS Jammu.....

District Samba, AIIMS Jammu is set to become a hub for medical care in the region. Anticipating a daily influx of 2000 to 3000 patients across various specialty units, meticulous arrangements are being made to ensure a seamless transition.

In the first phase, 183 faculty positions have been created, with 85 staff already appointed and the recruitment process for the remaining underway. highway has reduced travel time to reach destinations, the rainy season poses significant dangers for travelers on the Jammu-Srinagar Highway," one local cab driver, who frequently travels from Srinagar to Jammu, emphasized the perilous conditions caused by shooting stones and landslides along many stretches of the route.

Essential supplies, including grains, pulses, vegetables, mutton, poultry, petroleum products, and medicines, are transported through this route to the landlocked Valley. Before the construction of the tunnel

between Qazigund and Banihal, commuters relied on the Jawahar Tunnel, which often faced closures due to heavy snowfall in its vicinity.

However, since the inauguration of the new tunnel, this issue has been resolved. Nonetheless, challenges persist during rainy weather, especially along the Banihal to Ramban stretch where ongoing construction work hampers smooth travel, said a traveler.

Rain often triggers landslides, in several areas rendering the road impassable, while sunny days bring the peril of shooting stones, endangering the lives of travelers.

News agency KNS reported that the most treacherous section is from Ramsoo to Banihal, where travelers face a barrage of challenges including landslides, shooting stones, slippery conditions, and gushing seasonal streams, making every inch of the journey perilous.

The Srinagar-Jammu National Highway, designated NH-44, has historical significance as the primary conduit for transportation of goods, people, and military supplies to and from the Kashmir Valley.

Over the years, various infrastructure projects have been initiated to improve its reliability and accessibility.

Projects like road widening, tunnel construction, and snow and avalanche protection measures have been undertaken to make the highway an all-weather lifeline.

Despite these endeavors, the highway continues to face persistent challenges, especially during the rainy season, necessitating frequent maintenance and repair work to keep it operational.

In recent years, significant progress has been made in the development of Jammu and Kashmir's infrastructure. The ongoing

Elaborating further, Dr Jitendra Singh recalled that way back in 1960 the Indus Water Treaty was finalised between India and Pakistan by the then Prime Minister Jawaharlal Nehru and Pakistan President Ayub Khan, as a result of which, the three major river waters that India was to share happened to be Ravi, Satluj and Beas. By constructing Shahpur-Kandi Dam, he said, India was to utilize the her share of water from river Ravi for irrigating 3500 to 4000 hectares of land in Samba and Kathua border districts of Jammu & Kashmir as well as Gurdaspur and Pathankot districts of Punjab.

While the Punjab government was forthcoming in cooperating to set up this project, the successive governments in Jammu & Kashmir avoided it on one pretext or the other till Prime Minister Narenda Modi took over in 2014 and the project was revived, he added.

Similarly, Dr. Jitendra Singh said, Congress and its allies had denied 4% of reservation to the youth living along the International Border of Samba while allowing the same to the youth along the LoC, simply because of vote bank politics. This anomaly, he said, was also undone after Prime Minister Modi took over.

Dr. Jitendra Singh said, with the new industry coming up in Samba and the surrounding regions, the entire belt from Kathua to Samba holds the potential to emerge as a major recruitment and training centre of North India particularly because of its connection with three territories mainly Punjab, Himachal Pradesh and Jammu & Kashmir.

Dr Jitendra Singh said that this entire belt has been traditionally known to be inhabited by marshal race and the youth of this area were always known for their valour and bravery in Armed Forces, both before independence and afterwards. 

Moreover, the official documents and latest figures accessed by the news agency–Kashmir News Observer (KNO) states that more than 18 percent of government schools at elementary level here have an adverse Pupil Teacher Ratio (PTR).

The officials from Jammu and Kashmir in 2023 had said that the count of overall public schools had reduced by nearly 19 percent owing to the 'zero or low enrolment of students in government schools'.

However, the Ministry of Education (MoE) in the latest figures regarding the school size and single teacher schools in Jammu and Kashmir has said that, "Out of the total 23,173 schools in the UT, there are 848 schools with zero enrolment."

It also said, "16,179 schools are with less than 50 enrolments. Further, there are 2413 single teacher schools in the UT.'

"In addition, the number of schools with adverse PTR at the elementary level is 18.43 percent," it reads.

Pertinently, KNO in 2023 reported that the count of overall public schools in Jammu and Kashmir have reduced by nearly 19 percent owing to the 'zero or low enrolment of students in government schools'.

The officials of the department had said that it had some government schools wherein the student enrolment was very low or even some with less than five. "We had merged them with the nearby government schools.'

It also said that such schools were being reflected on UDISE as separate schools. "Earlier we used to have 23,117 government schools as per UDISE but in the updated database, we have only 18,820 schools," an official had informed KNO.

The concerned official at that time had also said, "We had nearly 4300 government schools wherein the student enrolment was less than five or zero. As of now there was no such government school with zero enrolment."

The School Education Department in the year 2022 had said that it had identified more than 1200 such government schools that were having low enrolment of students.

It had said that such schools would likely be merged in accordance to the catchment and feasibility of the students.

In April-2022, School Education Department had said that it was all set to merge hundreds of government-run-schools of Jammu and Kashmir having an inadequate student enrolment.



Lessons from Gandhi's life

In a voice choked with sadness and emotion, two hours after the assassination of Mahatma Gandhi on 30 January 1948, Pt. Jawaharlal Nehru, first Prime Minister of India, while announcing the dastardly act to the nation through All India Radio, inter alia said: "...The light that has illumined this country for these many years will illumine this country for many more years, and a thousand years later, that light will be seen in this country and the world will see it and it will give solace to innumerable hearts..." A little more than seventy-six years ago, Mahatma Gandhi's life was abruptly terminated.

Surely, he would have never thought that his end would be so unexpected, less than six months after he and the whole band of freedom fighters, many of whom had suffered greatly and sacrificed their lives, had secured India's freedom from the colonial yoke. Those who sacrifice their life and endure persecution for the benefit of humankind have a very high station in the sight of God. From the very beginning when the Báb, MartyrProphet of the Bahá'i Faith, declared his mission, thousands

of followers had to bear the brunt of persecution, several hundred willingly sacrificed their lives. While none of us can fully fathom the mysteries of martyrdom and why so much innocent blood is shed, the history of humankind is replete with soul-stirring episodes of supreme sacrifice, such as that of Jesus Christ and his apostles; Imam Husayn and his entire family, massacred on the plain of Karbala; Guru Tegh Bahadur, who at the urging of his minor son, later Guru Gobind Singh, willingly offered his life, refusing to yield to the diktat of a tyrant, and the assassination of Gandhiji, Father of the Nation.

Today let's reflect on the life of Gandhiji. What was the message of his death? What does he have to teach the world? With so much violence everywhere today, what is so significant about Bapu's killing? We can answer these questions with the word "yagna". Yagna was the spirit of his life and the message of his death. Every breath of his life, including the last, was an oblation to his country, his principles and his faith in God. The theme of his life was truly sacrifice.

He could have been a wealthy attorney. He could have had a life of relative ease and prosperity. However, he was man devoted to his country and to its freedom. Through his tireless efforts and his simple piety he showed the world how through principles of satyagraha, ahimsa and sarvodaya his fellow-country men and women could be inspired and motivated to achieve greatness. However, in spite of national and international acclaim, he never lost his humility, his dedication or his spirit of sacrifice.

Rather, the flames of his true yagna to Bharat mata seemed to only grow until he, himself, was the poornahuti, or final offering. Gandhiji's spirit of non-violence and sacrifice did not only pertain to overt actions. It was a quality of the spirit – a quality of humble love for all human beings. There is a story of a man travelling by train to Porbandar in the same coach as Gandhiji. However, the man did not know that the skinny old man in his coach was Mahatma Gandhi. So, all night long this man lav down on the seat, occupied the entire berth and pushed Gandhiji and put his feet on him and left Gandhiji with barely enough room to sit upright. However, Gandhiji did not fight, nor complain.

How easy it would have been



to shout and say, "I am Mahatma Gandhi; give me room in the coach." But Gandhiji's ahimsa was an ahimsa of the tongue and an ahimsa of the heart. So, he simply let the man use as much of the seat as he desired. As the train pulled into Porbandar, the man mentioned that he was going to see the famous Mahatma Gandhi. Gandhiji still remained silent. He had no need to stray from humility and disclose his identity. As Gandhiji descended from the train to a welcoming crowd of thousands, the man fell at his feet, begging for forgiveness.

Gandhiji, of course, blessed and forgave him, telling him only that he should be more respectful of

others, regardless of who they are. He taught the man the true lesson of sarvodaya, that everyone must be treated with dignity and respect, even those who are less fortunate. Fully aware of his shortcomings, Gandhiji tenaciously clung to truth and virtue all his life. The BhagavadGita was his closest companion and source of guidance. How unfortunate it is that today so many people claim that their lives and their work are "God's". Yet, they use this as an excuse to lie, to cheat and even to kill.

And, at the end it is clear that they merely used God's name in the service of themselves. Gandhiji remained pure and his death is the clearest example. Due to his commitment to ahimsa and complete surrender in God he refused to have bodyguards. Hence, on that fateful day as he climbed the four sandstone steps where people had gathered for the evening prayer meeting, a 'stout young man in khaki dress' made obeisance to him and the very next moment fired three shots from his pistol that was hidden in his pocket.

Gandhiji collapsed on the ground and gasping for breath uttered "hey Ram," "hey Ram." Gandhiji would not have wanted to be only remembered in history books. He would not want to be remembered only as the freedom fighter who led India to independence. He would want his message to live on; he would want his yagna to continue burning, to continue bringing light and warmth to all the world.

He was steadfast in his commitment to the law of nonviolence which he believed was the law of love and fervently wanted to make it the law of our species. Bahá'is believe that it is within the power of everyone, just as Gandhiji showed through his life, to bring about positive change. When enough of us prioritize the well-being of future generations above our own instant gratification, the country will progress rapidly and every citizen will benefit greatly from positive and sustainable development.

To this end, the words of Martin Luther King Jr., also a martyr, are so pertinent: "If humanity is to progress, Gandhi is inescapable...We may ignore him at our own risk."

The Land-Locked Kashmir

Historically, Kashmir has always been known as a land-locked country in the high Himalayan Mountains. In the earliest Chinese records Kashmir is described as, "a country enveloped on all sides like a precious jewel by the snowy mountains, with a valley in the south which leads up to it and serves as a gate of the Kingdom". Famous Chinese traveller, Hiuen Tsang describes Kashmir which he calls Kia-shi-mi-lo as a country surrounded on all sides by very high mountains which have very narrow and contracted passes for entry. According to him these natural bulwarks have protected the country from its neighbours who have never succeeded in subduing it. The Greek chronicles also mention Kashmir as Kaspeira, a country surrounded by high mountains whose inhabitants are great footwalkers! In fact, this isolation of Kashmir in the high mountains allowed it to remain unmolested for a long time. In ancient Kashmir there used to be an official called the "Dawara Pati", the guardian of the passes whose job was to keep an eye on all passes which were guarded by garrisons of soldiers.

The conquest of Kashmir by Mughals, even though through treachery, ended Kashmir's isolation. However, even with the passing of the country from Mughals to Afghans, to Sikhs and finally to Dogras, the physical isolation continued. The only access was through the Jhelum Valley road along the River Jhelum. After, the events of 1947, even though Kashmir got disconnected from its Central Asian neighbours in the North, yet access became easier towards South. Finally, with the advent of civil aviation, Kashmir is no longer a land locked and isolated "country"! The valley of Kashmir has become a global tourist destination and millions of



almost for six months or so. These include Gurez and Tilel Valleys; Karnah; Wadwan Valley of Kishtwar. The other areas in the State which remain land-locked in winter are Ladakh where totally land-locked is the remote valley of Zanskar. In this modern age it is unthinkable of people getting totally isolated for months on end. They have no access either by road or by air. The people in these areas face not only a physical trauma but also a psychological one. Unfortunately, most of the rulers in recent times have totally neglected this aspect of winter inaccessibility of these remote areas.

After a wait of decades, the government has finally started work on the Zoji La tunnel to ensure year round access to Ladakh by road. This is a welcome step and one hopes the work would be completed on a fast track. It would have been ideal if notice of inaccessibility of other areas had also been taken. The long term accessibility of these areas would also require construction of tunnels below the passes which get closed in winter due to heavy snowfall. These include the Sadhna Pass, the Razdani Pass, the Simthan Pass, the Margan Pass and so on. These passes would need much shorter tunnels which may be cheaper and easier to construct. Let us hope the government keeps the requirements of these people living in remote areas in view and formulates a plan to

make these accessible in winter also.

Pending construction of tunnels, the government could explore connecting these remote areas by short haul turbo-prop aircraft. These aircraft do not need long and concrete runways and can land on small strips and in some cases even in plain fields. Air Asia and the Indigo Airlines do have these small turbo-prop aircraft and are operating services to some areas. The government needs to explore the possibility of inviting these airlines to survey the areas and start such short haul air services. Even these services could be subsidised to allow reasonable pricing of these flights. At the moment, some of these areas in the state are serviced by MI-17 helicopters of IAF for which the government makes payments to the Ministry of Defence. Similar, treatment needs to be given to the Zanskar area also which too remains totally cut off during winter. Here again sometime IAF courier services are operated. The worst part is the assistance to sick people during winter. Sometimes the concerned Deputy Commissioners do requisition helicopters from the Air Force. However, providing of a regular short haul air service can ameliorate the suffering of these people till these are made accessible on a round the year basis.



"They Want To Break Country": PM On Goa **Congress Leader's Constitution Remarks**

Seizing on the remarks by the party's South Goa candidate, Prime Minister Narendra Modi has hit out at the party and Rahul Gandhi, accusing them of insulting BR Ambedkar's Constitution and attempting to break the country. Addressing a public meeting on Monday, Congress's South Goa candidate Viriato Fernandes had said the Indian Constitution was "forced" on Goa after its liberation from Portuguese rule and that he had said as much to senior party leader Rahul Gandhi ahead of the 2019 Lok Sabha elections.

Referring to the remarks, PM Modi said at a rally in Chhattisgarh's Mahasamund on Tuesday, "The Congress's Goa candidate is saying that the Constitution of India does not apply on the state. He has clearly said the Constitution was forced upon Goa and that he had said this to Congress' 'shahzada' (prince) in the past."

The 'shahzada' jibe, a reference to the Congress' "dynastic politics", has been regularly used by the PM to refer to Wayanad MP Rahul Gandhi.

"Is this not an insult to Babasaheb Ambedkar and the Constitution?



Is this not meddling with the Constitution? This is all part of a wellthought-out conspiracy to break the country. Today, they are negating the Constitution in Goa, tomorrow they will try to negate BR Ambedkar's Constitution all over India," Prime Minister Modiadded. The PM's remarks are significant because the Congress has been accusing the BJP of wanting to change the Constitution if it is elected for a third term. This was also stated by BJP's six-time MP

from the Uttara Kannada constituency, Anant Hegde, who had said the party had set a target of 400 Lok Sabha seats for the NDA so that the Constitution could be amended. After the comment, Mr Hegde waskeptoutofthelistofcandidates for the Lok Sabha polls.

Countering the Congress' charge, PM Modi said, "Leave aside the BIP, even Babasaheb Ambedkar himself cannot abolish the Constitution." 'Someone Else Decided Destiny' Mr Fernandes, who had met Mr

Gandhi as part of an NGO, 'Goencho Away', which was pressing for dual citizenship for Goans who have opted for Portuguese passports, had said, "We (during a meeting with Mr Gandhi in a hotel near Panaji) raised 12 demands before Mr Gandhi, and one of them was about (granting) dual citizenship. Mr Gandhi asked me whether the demand was constitutional. We said no."

He said the senior Congress leader had told the delegation that the demand would not be considered if it was not constitutional.

"I explained to him that the Indian Constitution came into force on January 26, 1950. When Goa was liberated from the Portuguese rule in 1961, you (referring to the then Central government) forced the Constitution on us. We were not included in it," Mr Fernandes said. The Congress candidate said he recalled a speech by Jawaharlal Nehru, Mr Gandhi's grandfather, in which he said that post-liberation Goa will decide its own destiny. "But our destiny was decided by someone else," he claimed. The PM also used the remarks made by the Congress' South Goa candidate to attack Rahul Gandhi.

Heatwave In 4 States Going To **Polls On Friday, Experts Fear Drop In Turnout**

New Delhi: As the BJP eyes a third consecutive term and the INDIA bloc tries its best to stop it from doing so, parties and voters are not only having to contend with rising political temperatures but also a heatwave sweeping many states, which is seen to have impacted the turnout in the first phase of polls. The voter turnout for the first and biggest phase of the general elections settled at 65.5%, a drop of 4.4 percentage points from the 69.9% seen in the same constituencies in 2019.As many as 13 states and Union Territories are going to the polls in the second phase of Friday and what has got experts as well as the Election Commission worried is that there is a heatwave warning for parts of at least four such states - West Bengal, Bihar, Uttar Pradesh and Karnataka - on that day. Data from Bihar's Nawada and Gaya Lok Sabha constituencies backs the hypothesis that higher temperatures, especially over 40 degrees Celsius, have an impact on voter turnout. On April 11, 2019, the maximum temperature was 35 degrees C in Nawada and the turnout was 52.5%; this dropped to just 41.5% on April 19, when the maximum temperature was 42 degrees Celsius.

In Gaya, the turnout was 56% on April 11, 2019, when the maximum temperature



was 35 degrees C, dropping to 52% last Friday, when the maximum temperature was 42.The India Meteorological Department has forecast a hot summer, with an increase in the number of heatwave days. With six phases of polling still left, Chief Election Commissioner Rajiv Kumar and the Election Commissioners held a highlevel meeting, which was attended by the IMD chief, to take stock of the situation. A meeting is also planned with Chief Electoral Officers of the states to take stock of necessary facilities like awnings, drinking water and fans at all polling stations. Scientist at the India Meteorological Department, told NDTV, "We have issued a red alert for heat in West Bengal for the next three days. Temperatures in Bihar will exceed 40 degrees Celsius. A heatwave is expected in eastern Uttar Pradesh after 24 hours and in western Uttar Pradesh after two days.

Arvind Kejriwal, K Kavitha To Stay In Jail, Custody Extended By 14 Days

Mayawati Promises To Work For A New **State Comprising West UP Districts**

Meerut, Uttar Pradesh: BSP chief Mayawati today promised to work for a separate state comprising districts of western Uttar Pradesh and fulfil the "longstanding demand" of setting up a bench of the Allahabad High Court in Meerut, if voted to power at the Centre.

Addressing an election rally in support of her party nominee from the Meerut Lok Sabha seat, the BSP chief attacked the Congress and BJP and also targeted the Samajwadi Party (SP) on the issue of reservation, alleging the SP does not want the people belonging to SC/ST communities to get quota benefits.

She also said that her party, if voted to power, will work to fulfil the demands and address problems of the region. "We will take positive steps with regards to your longstanding demand of a Allahabad High Court bench here in Meerut like that in Lucknow," she said. The central government has not been paying attention to it but when we come to power at the Centre, we will take positive steps in this regard," Mayawati said.

Referring to how her government in Uttar Pradesh had passed a resolution for a separate state, which was sent to the Centre, she said, "Since the beginning, our party has been of the view that the western region should be made a separate state for better development of the region.

"We had got a resolution passed by the state assembly and sent to the central government but they did not act on it. When our party comes to power at the Centre, your western UP will be made a separate state," she said.

The former Uttar Pradesh chief min-



ister alleged that the quota facility meant for the Dalits, adivasis (STs) and OBCs in government jobs has not been filled up in the country for years and the quota in promotions for the SCs/STs has also been made ineffective.

"I want to remind the members of the SCs/STs that when the SP was in power in Uttar Pradesh, it had ended reservation in promotions. Will the members of these sections give even a single vote to them and waste it on a party which is bent upon finishing their reservation. The SP does not want SC/ST people to get full benefits of reservation," she said. She also alleged that when an amendment bill for reservation in promotions was presented in the Rajya Sabha, the SP MPs had torn it. "Will such Samajwadi Party do good for the Dalits and shoshits (exploited class). Not only this, the districts, parks, universities that we (BSP government) had made in the name of great men belonging to these sections of society were mostly changed by the subsequent Samajwadi Party government."

Kolkata: The Congress and Trinamool Congress leader Mamata Banerjee do not have the guts to touch the Citizenship Amendment Act, Union Home Minister Amit Shah said today, assuring that all Hindu refugees will get citizenship under the new law.

Mr Shah was addressing a rally at Karandighi in Bengal's Uttar Dinajpur district to bolster support for BJP candidate from Raiganj Kartik Paul. The Raiganj seat was won by the BJP in 2019. Trinamool has fielded Krishna Kalyani, an MLA, from the north Bengal seat. Raiganj votes in the second phase on Friday.

Mr Shah said the Bengal Chief Minister cannot stop infiltration into the border state. "Can Mamata Banerjee stop infiltration? She cannot. Only (Prime Minister Narendra) Modiji can stop infiltration."

'You gave us 18 seats last time. Modiji gave Ram Mandir. Give us 35 seats this time, we will stop infiltration," he said.

The Home Minister also referred to the Sandeshkhalirow, which has emerged as a big talking point in Bengal this election season. "In Sandeshkhali, Mamata Banerjee allowed women to be tortured so that her votebank is not affected. The High Court intervened and today the accused are in jail," Mr Shah said. The island in Bengal's North 24 Parganas had made national headlines after local Trinamool leaders were accused of land grab, extortion and sexual harassment.

Mr Shah also brought up the Calcutta High Court's order scrapping about 25,000 appointments of government school staff over alleged irregularities. "Rs 10 lakh to 15 lakh were paid for each job. 51 crore rupees were recovered from (former Bengal minister) Partha Chatterjee's home."

"Mamata Banerjee came to power on the slogan of Maa, Maati, Manush. In Sandeshkhali, Maa was tortured, Maati was given to Bangladeshi infiltrators and Manush have been suffering due to corruption," Mr Shah said. "Vote for BJP and Mamata Banerjee's goondas will be hung upside down and straightened," he said.

Asia hit hardest by climate, weather disasters in 2023: UN

Global temperatures hit record highs last year, and the UN's weather and climate agency said Asia was warming at a particularly rapid pace.

The World Meteorological Organisation said the impact of heatwaves in Asia was becoming more severe, with melting glaciers threatening the region's future water security.

The WMO said Asia was warming faster than the global average, with temperatures last year nearly two degrees Celsius above the 1961 to 1990 average.

'The report's conclusions are sobering," WMO chief Celeste Saulo said in a statement.

"Many countries in the region experienced their hottest year on record in 2023, along with a barrage of extreme conditions, from droughts and heatwaves to floods and storms.

"Climate change exacerbated the frequency and severity of such events, profoundly impacting societies, economies, and, most importantly, human lives and the environment that we live in.'

The State of the Climate in Asia 2023 report high-



lighted the accelerating rate of key climate change indicators such as surface temperature, glacier retreat and sea level rise, saying they would have serious repercussions for societies, economies and ecosystems in the region."Asia remained the world's most disaster-hit region from weather, climate and water-related hazards in 2023," the WMO said.

The annual mean near-surface temperature over Asia in 2023 was the second highest on record, at 0.91°C above

the 1991-2020 average, and 1.87°C above the 1961-1990 average.Particularly high average temperatures were recorded from western Siberia to central Asia, and from eastern China to Japan, the report said, with Japan having its hottest summer on record.

As for precipitation, it was below normal in the Himalayas and in the Hindu Kush mountain range in Pakistan and Afghanistan.

Meanwhile, southwest China suffered from a drought, with below-normal precipitation levels in nearly every month of the year. The High-Mountain Asia region, centred on the Tibetan Plateau, contains the largest volume of ice outside of the polar regions. Over the last several decades, most of these glaciers have been retreating, and at an accelerating rate, the WMO said, with 20 out of 22 monitored glaciers in the region showing continued mass loss last year.

The report said 2023 sea-surface temperatures in the northwest Pacific Ocean were the highest on record.

Last year, 79 disasters associated with water-related weather hazards were reported in Asia. Of those, more than 80 per cent were floods and storms, with more than 2,000 deaths and nine million people directly affected.

Tensions flare at US universities over Gaza protests

Tensions flared between pro-Palestinian student protesters and school administrators at several US universities on Monday, as in-person classes were cancelled and demonstrators arrested.

The protests, which began last week at Columbia University with a large group of demonstrators establishing a "Gaza Solidarity Encampment" on school grounds, have spread to other campuses, including Yale, MIT and others.

Some Jewish students at Columbia have reported intimidation and anti-Semitism amid the days-long protest, which is calling for the prestigious New York institution to divest from companies with ties to Israel.

Classes were moved online on Monday, with university president Nemat Shafik calling for a "reset" in an open letter to the school community.

"Over the past days, there have been too many examples of intimidating and harassing behavior on our campus," she said.

"Anti-Semitic language, like any other language that is used to hurt and frighten people, is unacceptable and appropriate action will be taken.

"To de-escalate the rancor and give us all a chance to consider next steps, I am announcing that all classes will be held virtually on Monday," she added.

Last week, more than 100 protesters were arrested after university authorities called the police onto the private campus Thursday, a move that seemingly escalated tensions and sparked a greater turnout over the weekend.

Mimi Elias, a social work student who was arrested, told AFP on Monday: "We are going to stay until they talk to us and listen to our demands.

"We don't want anti-Semitism or Islamophobia. We are here for the liberation of all," Elias said.

Joseph Howley, an associate professor of classics at Columbia, said the university had reached for the "wrong tool" by involving police, which had attracted "more radical elements that are not part of our student protests".

"You can't discipline and punish your way out of prejudice and community disagreement," Howley told AFP.

Disciplinary action

As the holiday of Passover began on Monday night, social media images appeared to show pro-Palestinian Jewish students holding traditional seder meals inside the protest areas on multiple campuses, including at Columbia.

Further downtown, police began detaining protesters who had set up their own encampment at New York University at around 8:30pm, the New York Times reported, after the school called the students' behavior "disorderly, disruptive, and antagonising".

There were also demonstrations at MIT, the University of Michigan and Yale, where at least 47 people had been arrested on Monday after refusing requests to disperse.

Iraq, Turkiye agree to cooperate against Kurdish militants

BAGHDAD: Turkish President Tayyip Erdogan said relations with Iraq were entering a new phase after the neighbours agreed to cooperate against Kurdish militants, boost economic ties via a new trade corridor and consider Iraq's needs for access to scarce water.

Erdogan was in Iraq on a long-awaited visit, the first by a Turkish leader since 2011, following years of strained relations as Ankara ramped up cross-border operations against PKK militants based in mountainous, mainly Kurdish northern Iraq.

"I shared my belief that the PKK's presence in Iraq will end. We discussed the joint steps we can take against the terrorist organisation PKK and its extensions targeting Turkiye," Erdogan said at a joint news conference with Iraqi Prime Minister Mohammed Shia al-Sudani in Baghdad.

The two countries agreed to a strategic framework agreement overseeing security, trade and energy as well as a 10-year deal on the management of water resources that would take Iraq's needs into account, Sudani said.

Sudani said the two countries would



cooperate to bolster border security and act against non-state armed groups that could be working with terrorist organisations. He did not mention the PKK specifically.

An Iraqi government spokesperson said PKK members were welcome in Iraq so long as they did not engage in political activism or carry weapons. He did not elaborate

The PKK took up arms against the Turkish state in 1984 and is designated a terrorist organisation by Ankara and its Western allies. Turkiye has conducted a series of cross-border operations against the group in northern Iraq since 2019.

Trump Paid Porn Star To "Protect Family, Reputation," His Lawyer Says

Prosecutors launched the hush-money trial of Donald Trump by revealing new details Monday about how they seek to prove the former president corrupted the 2016 election to bury a sex scandal, while a defence lawyer countered the payment was meant only to protect his reputation.

The trial in lower Manhattan, the first of a former president, involves 34 felony counts alleging Trump falsified business records to cover up a \$130,000 payment to porn star Stormy Daniels to stifle her claims of a sexual liaison. Prosecutors say he falsified records by claiming the reimbursements to his former attorney, Michael Cohen, who paid Daniels, were for legal fees.

Prosecutor Matthew Colangelo used his opening statement Monday to sketch out a criminal conspiracy involving Trump, Cohen and David Pecker, who ran the company that owned the National Enquirer and agreed to buy and bury negative news about the former president. The plot, he said, began in a May 2015 meeting in Trump Tower. "The evidence will show this was not spin or strategy but a plan to influence the election to help Donald



to return to the White House in a rematch with President Joe Biden. It's one of four prosecutions hanging over the presumptive Republican nominee, who calls the case election interference and a witch hunt by Democrats.

Trump attorney Todd Blanche had a

Germany, Britain act against 'Chinese spies'

BERLIN: Germany and Britain on Monday both swooped on suspected spies accused of passing on secret information to China, as concern deepens in the West over aggressive Chinese espionage.

In Germany, investigators arrested three German nationals in the west of the country suspected of sharing information on maritime technology, prosecutors said in a statement.

The trio, named as Herwig F., Ina F. and Thomas R., are accused of taking part in an informationgathering project funded by Chinese state agencies, as well as illegally export-

ing a laser to China. Powered By Streamlyn In Britain, two men were charged with handing over "articles, notes, documents or information" to China between 2021 and last year. Police named the men as Christopher Berry, 32, and Christoper Cash, 29, who previously worked at the UK parliament as a

researcher.



Beijing rejects espionage accusationsThe German arrests and British charges come amid repeated Western warnings of Chinese intelligence services targeting advanced technologies. German Interior Minister Nancy Faeser warned of the "considerable danger posed by Chinese espionage in business, industry and science".

"The area affected in the current case - innovative technologies from Germany that can be used for military purposes – is particularly sensitive," Faeser said.

Defaming China China firmly rejects accusations that it carried out spying activities in Germany, its embassy in Berlin said on Monday, after three Germans were arrested on suspicion of working with the Chinese secret service.

"We call on Germany to desist from exploiting the espionage accusation to politically manipulate the image of China and defame China," a spokesperson for the embassy said in an emailed statement.

After Iran's "Harsher **Response'' Vow, Hezbollah** Launches Rockets At Israel

New Delhi: Hezbollah last night launched a barrage of rockets at an Israeli army headquarters in northern Israel amid tensions between Israel and Iran. Hezbollah is an armed group based in Lebanon that is funded financially and militarily by Iran.A statement from Hezbollah confirmed the rocket attack on the headquarters of the 3rd Infantry Brigade of the 91st Division at Ein Zeitim Base, claiming to have launched "dozens" of Katyusha rockets - 82 mm and 132 mm rockets that are frequently used by the armed group. The attack was allegedly in response to Israeli incursions into southern Lebanese villages, including recent strikes on Srifa, Odaisseh, and Rab Tlatin, as reported by Lebanon's official National News Agency (NNA).

The Israeli military, in its response, identified approximately 35 rocket launches originating from Lebanon into the Ein Zeitim area but reported no casualties. Israeli forces retaliated by targeting the sources of the rocket fire. Since the onset of hostilities, casualties have mounted

on both sides. In Lebanon, at least 376 people, predominantly Hezbollah fighters, have been killed.

LONDON: Veteran news anchor Huw Edwards resigned from the BBC on Monday on "medical advice", the broadcaster said, nine months after he become embroiled in a scandal over sexually explicit images involving a teenager.

Edwards, 62, had been the BBC's lead presenter in key events, such as the death and funeral of Queen Elizabeth II, but was suspended in July 2023 when allegations first emerged.

"Huw Edwards has today resigned and left the BBC," the broadcaster said in a statement. "After 40 years of service, Huw has explained that his decision was made on the basis of medical advice from his doctors.

"The BBC has accepted his resignation which it believes will allow all parties to move forward. We don't believe it appropriate to comment further."

Earlier this year the BBC apologised to the family of the man who the broadcaster said Edwards had paid for sexually explicit pictures when he was a teenager

As the accusations became front-page news last July, Edwards' wife Vicky Flind said the father-of-five was "suffering from serious mental health issues" and had been admitted to hospital.

The man's family had complained to the BBC about Edwards in May 2023.

Floods swamp China

Since Thursday, Guangdong has been battered by unusually heavy, sustained and widespread rainfall, with powerful storms ushering in an earlier-than-normal start to the province's annual flooding season in May and June.

200 bodies exhumed at Gaza hospital

JERUSALEM: The head of Israeli military intelligence has resigned after accepting responsibility for the failures that allowed the devastating Hamas-led attack on Israel on Oct 7, the military said on Monday.

Major General Aharon Haliva, a 38-year veteran of the military, was one of a number of senior Israeli commanders who said they had failed to foresee and prevent the deadliest attack in Israel's history.

"The intelligence division under my command did not live up to the task we were entrusted with. I have carried that black day with me ever since," he said in a resignation letter released by the military.

He will remain in post until a successor is named. Israeli media and commentators expect further resignations once the main military campaign in Gaza wraps


Palestinian groups like Hamas.In the early hours of the morning, following an intense rocket barrage, thousands of fighters from Hamas and other groups broke through security barriers around Gaza, surprising Israeli forces and rampaging through communities in southern Israel.

Some 1,200 Israelis and foreigners were killed in the attack, most of them civilians, and around 250 were taken into captivity in Gaza, where 133 remain as hostages, according to Israeli tallies.

The head of the armed forces, Lieutenant-General Herzi Halevi, and the head of the domestic intelligence agency Shin Bet, Ronen Bar, both accepted responsibility in the aftermath of the attack but have stayed on while the war in Gaza has continued.By contrast, Prime Minister Benjamin Netanyahu has so far not accepted responsibility for the Oct 7 attack, although surveys indicate that most Israelis blame him for failing to do enough to prevent or defend against it.

Plain gold jewellery exports grew 61 pc in FY24

Chennai: Exports of plain gold jewellery, which had been low during the Covid years, surged 61 per cent in FY24.For FY24, exports of plain gold jewellery surged by an impressive 61.72 per cent to \$ 6792.24 million as compared to \$ 4199.96 million in FY23. "Total Gold jewellery (plain and studded jewellery), which saw a 10.47 per cent decline between April 2023 to September 2023, rebounded strongly in the latter half of the year, achieving a growth of 46.91 per cent," as per the data of the Gems and Jewellery Export Promotion Council. Gross export of total gold jewellery (both plain and studded) for the FY 2023-24 grew 16.75 per cent to \$11230.18 million over the comparative figure of \$9618.80 million for the previous year. The UAE is the largest market of Indian plain gold jewellery and in FY24 also emerged as a significant market registering a growth of 107.2 per cent to reach \$4,528.66 million compared to \$2,185.67 million in the previous year. Markets of UAE and Bahrain accounted for over 85% of India's plain gold jewellery exports. During the Covid years, the market had seen a lull. However, after the India-UAE CEPA came into effect, exports have seen a remarkable spurt. "The increase in plain gold jewellery exports may be attributed to the pragmatic foreign trade agreements by the Govt. The implementation of India-UAE CEPA couldn't have come at a better time, especially when the industry faced various challenges with economic downturns in major export markets and escalating geopolitical concerns, all of which led to the decline in demand," Vipul Shah, Chairman, GJEPC, said. Australia also witnessed a growth of 37 per cent in plain gold jewellery exports attributing its growth to the India-Australia ECTA. However, the overall gross exports of gems and jewellery in FY24 declined 14.45 per cent to \$ 32285.85 million compared to \$37737.05 million in the preceding period. Cut and polished diamond exports in FY24 decreased by 27.58 per cent to \$15967.02 million compared to \$22047.72 million in the previous year. Gross export of coloured gemstones grew 14 per cent and platinum gold jewellery exports by over 400 per cent. the society and keep talking about Hindu-Muslim," the Congress president said.Referring to the Congress' promises for the youth and women, Mr Kharge continued, "Yuva Nyay is for all. Naari Shakti is for all. It is not only for Muslims, not only for Scheduled Castes, Scheduled Tribes, those below the poverty line. It is for all. During the UPA era, we have given some rights without the people asking for them. For example, the Mahatma Gandhi National Rural Employment Guarantee was given by Sonia Gandhi and the BJP had opposed it."

"They said that by bringing in MGN-REGA, Congress was bringing poverty to the country. We made MGN-REGA a right, education a right, food security a right. These things can't be taken away even if PM Modi and (Union Home Minister) Amit Shah wish to do so. These are permanent rights brought by the UPA government," he added.

What to Know About Stage 4 Breast **Cancer Remission and Recurrence**

hen cancer is in remission, it's not visible on imaging or other tests. There's a chance it's still in the body but too small to detect. Recurrence means the cancer has returned, either in the original site or in nearby lymph nodes. There's no current cure for stage 4 breast cancer, but it can be treated and managed.

Most people with stage 4 breast cancer have alternating periods of disease stability and disease progression.

It isn't clear why stage 4 cancer doesn't progress further in some people, yet others who have the disease don't survive. In most cases, stage 4 cancer is likely to return, even if a person enters remission.

This article looks at remission and recurrence for people living with stage 4 breast cancer.

What is stage 4 breast cancer?

Stage 4, or metastatic, breast cancer means the cancer has spread - or metastasized - beyond its point of origin to other organs and tissues. For people who received a diagnosis between 2013 and 2019, the 5-year relative survival rate for stage 4 breast cancer is 31%Trusted Source.Although remission is an important milestone during cancer treatment, it doesn't mean the body is free of cancer. When cancer is in remission, healthcare professionals can't see the disease on imaging or other tests. There's a chance the disease is still in the body but at a level that's too small to detect.

When treatment destroys all cancer cells that could be measured or seen on a test, it's called a pCR. This stands for pathological complete response or pathological complete remission.

A partial response or partial remission means the cancer partly responded to the treatment, but the treatment didn't destroy it.



A 2017 review reports that advanced therapies are extending the amount of time before cancer becomes detectable again. There's an indication that further improvements, especially in areas such as immunotherapy and targeted therapyTrusted Source, will increase the number of people living with stage 4 cancer.

Breast cancer recurrence means the disease has returned after it was undetectable for some time.

The cancer may return in the same breast where doctors first diagnosed it. This is called local recurrence. Or the cancer may come back in the lymph nodes near the spot where the tumor first developed. This is called regional recurrence.

Treatment for stage 4 breast cancer may include targeted therapies, hormonal therapies, or immunotherapy. A comprehensive and exhaustive treatment plan may rid your breast tissue and surrounding lymph nodes of cancer.

However, cancer may spread to another organ, such as the liver, brain, or lung. If tests identify the cancer cells in other organs outside the breast as breast cancer cells, it means the cancer has metastasized. Even though cancer is growing in one of those organs, it is still stage 4 breast cancer.

If the cancer cells in one of those organs differ from the breast cancer cells, it indicates two types of cancer. A biopsy can help determine this.

If you have a breast cancer recurrence and feel overwhelmed and distressed, consider joining a breast cancer support group. Some people find talking with others about their fears and frustrations helpful.

A relative survival rate gives an idea of how long someone with a specific condition may live after their diagnosis compared with someone without the condition. For example, a 5-year relative survival rate of 31% means that someone with that condition is 31% as likely to live for 5 years as someone without the condition.

While there is no cure for metastatic breast cancer, it's possible to manage the disease with treatment for a number of years. It's also possible for the cancer to go into remission. It can go into complete remission (when there are no cancer signs or symptoms) or partial remission (when the cancer is still present but has become smaller).

While there's no data on how long remission can last, new treatments can help to control the cancer, relieve symptoms, and allow people to live longer.

What are the odds of surviving stage 4 breast cancer?

Although there's no cure for stage 4 breast cancer, treatments are available, and survival rates continue to improve. The 5-year relative survival rate for people who have been diagnosed with stage 4 breast cancer is 31%. This means that, on average, people who have stage 4 breast cancer are about 31% as likely as people who don't have that cancer to live for at least 5 years after receiving a diagnosis.



The Rajasthan Royals legspinner achieved the landmark against Mumbai Indians on Monday

NEW DELHI: 200 Wickets for Yuzvendra Chahal in the IPL, the first bowler to reach the milestone. Dwayne Bravo is second on the list of leading wicket-takers in the IPL with 183 scalps. 2 Players with 200plus wickets in a T20 competition before Chahal in the IPL. Danny Briggs (219) and Samit Patel (208) have 200-plus wickets in England's T20 Blast.

158 Chahal's wickets in the 125 IPL matches he played in India. Only Bhuvneshwar Kumar (160) has more wickets

than him in IPL matches in wickets for two franchises in India. Chahal has 42 wickets in the UAE, which is the joint highest along with Jasprit Bumrah.

7 Hauls of four wickets or more for Chahal in the IPL, the second most most in the league along with Lasith Malinga. Sunil Narine leads the list with eight hauls of four or more wickets. 20Instances of Chahal taking

three or more wickets in an IPL match. Only Jasprit Bumrah (22 times)hastakenmorethree-plus wickets than Chahal in the IPL. 4 Bowlers with 50-plus the IPL, including Chahal. Piyush Chawla (KKR and Punjab), Axar Patel (Punjab and DC) and Rashid Khan (SRH and GT) are the other bowlers on the list.

Chahal is the only player with 100-plus wickets for RCB in the IPL. He has 61 wickets for Rajasthan Royals and is their joint second highest wicket-taker in the IPL behind Siddharth Trivedi (65).

52 Wickets for Chahal at the Chinnaswamy Stadium in Bengaluru in 42 IPL matches. Only

three other bowlers have bagged 50-plus wickets at a venue in the IPL.

152 Wickets for Chahal in the middleovers(7thto16thover)-the most for any bowler in this phase. AmitMishra(139) is next on the list. Chahal's strike rate (17.30) in the middle overs is only behind Kagiso Rabada(15.88) and Bumrah(17.28) amongthe42bowlerswith30-plus wickets in this phase.

Jaiswal bats himself back to form, for Royals and for India

LONDON: Yashasvi Jaiswal is back. He will say he never went away, and his strike rate will agree. But for a run machine, IPL2024 was lukewarm. Before Monday night.

Coming into his eighth game of the season, Jaiswal had scored 129 runs striking at 145.78, but only averaging 17.28. He was getting starts but was usually guilty of going too hard at the ball, losing his shape and his wicket in the process. He had failed to make it out of the powerplay six times out of seven, falling to pace on every occasion. Not having a fifty was also concerning, especially with everything being looked from a T20 World Cup point of view.

On Monday, against one of his favourite IPL opponents, over 88 minutes and 60 balls, Jaiswal answered at least some of the questions: there was no form slump, and no need to change his approach. In Jaipur, Jaiswal hit his second century against Mumbai Indians in three innings, finishing with an unbeaten 104 at a strike rate of 173.33. And while the finishing was top-notch, the pacing of his innings was what set it apart.

Jaiswal had a strike rate of 110 in the first ten balls of his innings.

That went up to 180 after 20 balls. By 30 balls, he had got to his maiden half-century of the season. What had changed was how Jaiswal was allowing the ball to come on to his bat rather than go after it. He struck five fours and a six in the powerplay, all with the flourish and timing we are accustomed to.

"It's more the Yashasvi Jaiswal we know. I think he took his time early on, played some conventional shots and then we all know what he could do," Wasim Jaffer said on ESPNcricinfo's TimeOut. "He has everything in his armoury, but he just needed a little bit of time to bat out of that powerplay, which he did. Those failures helped him to realise that this is how he needs to approach a T20 innings."

Jaiswal scored his first boundary, a straight six over Gerald Coetzee's head, on the first ball of the fourth over. Coetzee didn't take to being treated like that kindly. What followed were four searing back-of-a-length balls bowled at around the 150kph mark. Jaiswal was rushed into a pull on the fifth ball of the over, with the top edge just clearing the wicketkeeper.

But it was the final delivery of that Coetzee over that would have pleased Jaiswal no end. A 151.1kph bolt was delivered around the length area on off stump. Jaiswal just stood tall and punched the ball through covers. #Jazball was on.

"I really enjoyed [batting] from the start, and I was just trying to make sure that I was watching the ball properly and playing my cricketing shots, which I think I did today," Jaiswal said after on the official broadcast the game. "I really enjoyed it, I really loved it. I am trying to keep doing what I do. Some days are tough, and some days are good. I was just playing - that is all. I didn't have anything in my mind."

He had a slice of luck when on 50, as Nehal Wadhera shelled a simple catch at long-off, and Jaiswal knew it was his night. No Mumbai bowler was spared - not even Jasprit Bumrah - as Jaiswal heaved him away for six over deep square leg followed by a four to fine leg. He was lethal against spinners, collecting 47 off 25 balls at a strike rate of 188, while he struck at 162.85 against the quicks.

It took Jaiswal 59 balls to reach his second IPL century, and as he removed his helmet and thumped the air, there was relief written all over his face. Three balls later, Royals had registered their seventh win of the season.

"He is the most exciting young player in world cricket at the moment. There are a couple out there, and he is right at the top of that conversation,"Tom Moody said."[An] all-format player, how he has grown so quickly, from his Under-19 journey to international cricket to IPL stardom is quite remarkable. It is a privilege to watch. Some of those cover drives today were right out of the top drawer."

"I don't think he needs anyone. He is always filled with a lot of confidence," Royals captain Sanju Samson said. "We knew that it is just a matter of one game. I think the way he batted in the powerplay, he was calm, composed and he knew that things are under control. We knew in the dugout that he is playing some [nice] cricketing shots today and he will be fine today. Really happy for him."
