NEW DELHI, APR 24: Prime Minister Narendra Modi on Wednesday alleged that the Congress plans to tax inheritance passed down from parents to their childre

Addressing a poll rally at Chhattisgarh's Surguja, PM Modi said the Congress's dangerous intentions are coming out in the open.

Referring to senior Congress leader Sam Pitroda, he said, "The advisor of the Congress family had earlier said that the middle class should be taxed more. Now they say that they will impose an Inheritance Tax and tax the inheritance received by people from their parents."

PM Modi said the wealth you accumulate with your hard work won't pass down to your children. "Congress will snatch it as their mantra is loot during your lifetime and even loot after your death."

He said, "As long as you live, Congress' high taxation will make you suffer. When you are dead, they will put the burden of inheritance tax."

Meanwhile, Prime Minister Narendra Modi on Wednesday hit out at the Congress, saying the "vote bank hungry" party

wanted to implement reservation on the basis of religion.

Addressing a poll rally in Ambikapur, the headquarters of Surguja district in Chhattisgarh, PM Modi also said the Congress wanted to impose inheritance tax in the country and snatch the rights of people's children.

Some forces want a "weak" government of the Congress and "INDI" alliance in the country as they thought that if India becomes 'atmanirbhar' (selfreliant), their shops will be shut, he said.

Over 17.80 Lakh Voters To Decide Fate Of 22 Candidates In Jammu PC On April 26

JAMMU, APR 24: Over 17.80 lakh voters will decide the fate of 22 candidates contesting from 5-Jammu Parliamentary Constituency in the second phase of Lok Sabha polls to be held on April 26.

The Jammu parliamentary constituency is spread over 18 Assembly segments in four districts including Reasi, Samba, Jammu and Rajouri.

According to the figures provided by the office of Returning Officer 5-Jammu Parliamentary Constituency, there are 17,80,835 registered voters in Jammu PC including 9,21,095 male, 8,59,712 female and 28 transgender electors.



Among these 37,822 (37,025 male and 797 female) are service voters.

The Election Commission of India (ECI) has set up 2416 polling stations across the constituency including 18 Green Polling Stations, 46 Pink Polling Stations and 18 PwD manned polling stations.

In its 2009 manifesto, Congress's intention was the same and in the 2014 manifesto, it clearly said it will not leave this issue, the prime minister said.

The Congress wanted to change the Constitution and hand over rights of the SCs, STs and OBCs to its vote bank, he said.

The intention of the Congress is not good, it is not according to the Constitution, social justice and secularism. If anyone can protect your reservation, it is the BJP, Modi said.

"The Congress's eyes are not only on your reservation, but also on your earnings, your houses, shops and farms. The 'shehzada' of Congress (apparently referring to Rahul Gandhi) says they will conduct an X-ray of the property of every house and every family in the country. The Congress will snatch all these from you and they say that they will equally distribute them," he said.

Do you know to whom they will distribute it after "looting" it from you? Modi asked, to which the people replied in affirmative.

"I need not to tell you to whom they will distribute," he added.

Modi further said the "dangerous intentions" of Congress are coming to forth one by one and now it says it will impose inheritance

The investigation into the matter revealed that Bhat's actions tarnished the image and reputation of the institution. Following a thorough inquiry, the charges against Bhat were substantiated, leading to his dismissal from service with immediate effect.

The dismissal, in accordance with Clause (viii) of Rule 30 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, also renders him ineligible for future employment.

Health Secretary Reviews Arrangements For Shri Amarnathji Yatra

JAMMU, APR 24: Secretary, Health and Medical Education, Dr. Syed Abid Rasheed Shah, today chaired a meeting to review healthcare arrangements being put in place for the upcoming Shri Amarnathji Yatra, 2024.

During the meeting, the Administrative Secretary directed the officials to collaborate closely with Shri Amarnath Shrine Board, Health Department and security forces to ensure coordinated healthcare services for the Yatris.

The Secretary instructed the officials to finalize all necessary arrangements before the Yatra begins. He highlighted the importance of having both portable and fixed oxygen supplies

at all health centers established along the Yatra route. Further, he instructed Director Health Services, Kashmir, to expedite establishment of a 100-bedded hospital by ONGC and arrange the required human resources for the hospital. He also stressed the need to make sure that all essential medicines and medical equipment are readily available for the pilgrims.

The Secretary emphasized the importance of facilitating a seamless and hassle-free Yatra experience for the pilgrims. He directed for ensuring that requisite healthcare staff should be readily available at all healthcare institutions, especially on highways and critical points along the Yatra route. He called



for implementation of a quick and reliable emergency response system at all levels and instructed the officials to ensure deployment of ambulances along the Yatra route. He asked for keeping the 102 and 108 Ambulance systems on alert during the Yatra.

The Director Health Ser-

vices Kashmir provided an overview of the planned healthcare arrangements for the Yatra. He informed that a total of 55 medical centers will be set up, including 06 base hospitals with 100 bedded hospital each at Baltal & Chandanwari, 11 medical aid centers, 12 emergency aid centers, 26 oxygen booths,

and 15 on-route facilities. He further stated that 17 on-route facilities will be kept on standby to address any emergencies. The Director also shared that they have planned to deploy a total of 1415 healthcare staff for the Yatra, including 173 specialists, 244 medical officers, and 998 paramedics. Out of these, lances shall be utilized during

754 will be sourced from J&K, and 661 will be requested from the Ministry of Health & Family Welfare, Government of

The Deputy Director Health Services, Jammu (Nodal Officer for AmarnathYatra Jammu Division) provided the details of medical arrangement on Yatra routes from Lakhanpur to Banihal. He informed that 15 emergency rooms will be made operational to tackle any emergency during the Yatra, 53 health centres will be ready for providing medical care facilities to Yatries from Lakhanpur to Lamber ground Banihal. More than 60 ambulances including 20 ALS ambuYatra. Apart from this, the services of 15 Doctors and 60 Paramedics of Jammu Division will be placed at the disposal of Director Health Services, Kashmir for Amarnath Yatra-2024. The medical teams will also be deployed at Yatri Niwas Bhagwati Nagar Jammu and Yayri Niwas Chanderkote, Ramban to provide 24x7 medical care facilities to Amarnath

Amidst persistent thundershowers, J&K braces up for 3-day heavy rainfall from Apr 27

SRINAGAR, APR 24: As the parts of Kashmir continued to witness thundershowers in the afternoon hours for the last couple of days, the weatherman here has predicted moderate to heavy rainfall in Srinagar and elsewhere from April 27.

Talking to the news agency—Kashmir News Observer(KNO), Director Meteorological department (MeT), Dr Mukhtar Ahmad said that the afternoon thunder-



showers are expected to continue for tomorrow as well, but a three-day wet spell is expected in Jammu & Kashmir from April 27.

"As per the forecast, moderate to heavy rainfall is expected in J&K areas especially in Srinagar, South Kashmir areas, Ramban and Doda from April 27 to April 29," he said, adding that the major activity is expected on April 29.

About the fall in the maximum temperature, he said that the maximum temperature will continue to witness a fall in the next few days and is expected to improve from May 01, 2024. Moreover, as per the data, Jammu & Kashmir has recorded normal precipitation from March 01, 2024 to April 24, 2024.

Samba is the only station where the deficient rainfall of 22 per cent has been recorded during the period. As per the data, against the normal precipitation of 187.5 mm, Srinagar has recorded 275.5 mm rainfall during the period.

So far since March 01 till April 24, Anantnag, Budgam, Bandipora, Baramulla, Ganderbal, Kulgam, Kupwara, Pulwama and Shopian stations have recorded normal precipitation.

However, Shopian district in South Kashmir despite witnessing hailstorm and moderate rainfall from the last couple of days, has recorded large deficient rainfall, where against the normal precipitation of 194.4 mm, only 70.8 mm rainfall was recorded during the period.

Buyers vanish as gold prices soar in Kashmir

Gold dealers cite ongoing Israel-Iran conflict for high gold prices

SRINAGAR, APR 24: Gold dealers in Jammu and Kashmir are struggling to get buyers as the rates of the yellow metal have been increasing since the escalation of tension between Iran and

As per news agency—Kashmir News Observer (KNO), the latest spike in gold prices came after geopolitical tensions between Iran and Israel, with both nations engaging in aggressive rhetoric and military posturing.

Such geopolitical uncertainty

often triggers a flight to safety among investors, driving up the demand for assets like gold, traditionally considered a hedge against political instability and economic turmoil.

In response to the soaring prices, gold traders have witnessed a noticeable shift in consumer behaviour. Instead of flocking to purchase gold jewellery during the ongoing wedding season, gold dealers rarely get any customers nowadays.

As per the gold dealers, the

rate for 22 karat has increased to Rs 6,660 per gram. For 24 karat (999 gold) pure gold, the price stands at Rs 7,216 per gram.

Mohammad Yusuf Zargar, a gold dealer said they have been struggling to get customers for more than a month now after tension escalated between Iran and Israel.

"The gold rate skyrocketed. We have been only getting the sellers while there is very less turn to buy the gold. Last week, the gold pound touched Rs 65000.

Though the rates have been now coming down still it is unaffordable for the middle class. As such dealers have ceased to sell the pound as of now," he said.

The gold dealers said many investors are opting to liquidate their gold holdings to capitalize on the booming real estate mar-

"We've seen a decline in foot traffic and sales of gold jewellery. People are selling their gold to invest in property, believing it offers better returns and stabil-

ity in uncertain times. Almost 9-percent of the sellers said they are selling gold to invest in real estate," said Abdul Rouf, another gold dealer.

As the wedding season in Kashmir approaches, gold dealers and jewellers claim that the soaring prices are deterring prospective buyers. "Since April, marriage and other wedding related functions start in the valley. People struggle to buy the jewellery as its cost has increased for the last one month," Rouf said.





LET YOU INTROSPECT!

With the electioneering at its feverish pitch the regional mainstream parties of Jammu & Kashmir are busy in witch hunt and are blaming each other. These parties have been accusing each other of supporting Bharatiya Janta Party (BJP) in one way or other. However, these parties are forgetting an important point in this regard and that is that they have been a part of the BJP governments at one time or other.

National Conference's Vice President Omar Abdullah was a junior minister in the National Democratic Alliance (NDA) government at the centre headed by veteran BJP leader late Atal Bihari Vajpayee. As such he cannot blame the Peoples Democratic Party (PDP) of betraying the people of Jammu & Kashmir by entering into alliance with the BJP and forming the government in the erstwhile state of Jammu & Kashmir in 2015.

The PDP President Mehbooba Mufti cannot blame the National Conference for the bloodshed in Jammu & Kashmir since it was she who in the aftermath of 2016 street violence had said that youth have not gone to military camps to fetch candies and that the security forces carrying out firing on them is justified. Mehbooba also cannot justify her alliance with BJP since her party had before the 2014 elections said that only PDP can stop BJP's entry into Jammu & Kashmir.

Apni Party President Syed Mohammad Altaf Bukhari has been quite critical of PDP and its President Mehbooba Mufti. Facial recognition: Coming soon to an airport near you

Biometric technology is expanding at airports across the United States — and the world — and transforming the way we move through them, from checking a bag to boarding the plane.

On a recent Thursday morning in Queens, travelers streamed through the exterior doors of La Guardia Airport's Terminal C. Some were bleary-eyed — most hefted briefcases - as they checked bags and made their way to the security screening lines.

It was business as usual, until some approached a line that was almost empty. One by one, they walked to a kiosk with an iPad affixed to it and had their photos taken, as a security officer stood by. Within seconds, each passenger's image was matched to a photo from a government database, and the traveler was ushered past security into the deeper maze of the airport. No physical ID or boarding pass required.

Some travelers, despite previously opting into the program, still proffered identification, only for the officer to wave it away.

This passenger screening using facial recognition software and made available to select travelers at La Guardia by Delta Air Lines and the Transportation Security Administration, is just one example of how biometric technology, which uses an individual's unique physical identifiers, like their face or their fingerprints, promises to transform the way we fly.

This year could be the "tipping point" for widespread biometrics use in air travel, said Henry Harteveldt, a travel industry analyst for Atmosphere Research. Time-consuming airport rituals like security screening, leaving your luggage at bag drop and even boarding a plane may soon only require your face, "helping to reduce waiting times and stress for travelers," Harteveldt said.

In the United States, major airlines have increasingly invested in facial recognition technology as have government agencies in charge of aviation security. Overseas, a growing number of international airports are installing biometrics-enabled electronic gates and self-service kiosks at immigration and customs.

The technology's adoption could mean enhanced security and faster processing for passengers, experts say. But it also raises concerns over privacy and ethics.

Dr. Morgan Klaus Scheuerman, a postdoctoral researcher at the University of Colorado who studies the ethics of artificial intelligence and digital identity, said many questions have emerged about the use of biometrics at airports: How are the systems being trained and evaluated? Would opting out be considered a red flag? What if your documents don't match your current

"I'm sure many people feel powerless to stop the trajectory," Scheuerman said.

In the U.S., Bullish About the Technology The TSA, with more than 50,000 officers at nearly 430 airports in the United States, is the main federal agency ensuring the safety of the hundreds of millions of passengers whofly each year. Travelers who are determined to be "low-risk" can apply for TSA's PreCheck program, which offers expedited security

screening at more than 200 domestic air ports.PreCheck, which requires an in-person appointment to show documents and give fingerprints, and biometric verification by Clear, a private screening company, have helped to reduce the wait time for screening, but air travelers still must occasionally stand in long queues to get to their gates.

The TSA has experimented with facial recognition technology since 2019. Screening

verification currently offered at Denver and Los Angeles International Airports and some 30 other airports starts when a photo is taken of the traveler. Then facial recognition software is used to match the image to a physical scan of a license or passport. The photo is deleted shortly afterward, according to the agency. This process, which passengers can opt out of, will be available at some 400 more airports in the coming years, the agency said.

Melissa Conley, a TSA executive director overseeing checkpoint technologies, said biometric technology is better than human agents at matching faces rapidly and accurately.

"People are not good at matching faces. It's just known," Conley said. "Machines don't get tired."

The process still requires passengers to show their IDs. But the program being tried by Delta, called Delta Digital ID, changes that.

With Delta Digital ID, PreCheck travelers can use their faces in lieu of boarding passes and ID at both bag drop and security at La Guardia and four other airports, including John F. Kennedy International Airport, also in New York City's Queens borough, and Hartsfield-Jackson Atlanta International

Facial recognition shaves more than a minute off bag drop, to roughly 30 seconds, and reduces the security interaction from 25 seconds to about 10 seconds, said Greg Forbes, Delta's managing director of airport experience. While a "simple change," the time savings add up, making the line noticeably faster, Forbes added.

"Anywhere that there's PreCheck, I think, could benefit from Digital ID," Forbes said.

Other airlines have begun similar experiments for PreCheck travelers: Those flying on American Airlines can use their faces to get through PreCheck screening at Ronald Reagan Washington National Airport and also to enter the airline's lounge at Dallas-Fort Worth International Airport. United Airlines allows PreCheck travelers to use their faces at bag drop counters at Chicago O'Hare International Airport; the airline is $scheduled \,to\,bring\,th is\,program\,to\,Los\,Angeles$ International Airport in March.

And Alaska Airlines plans to spend \$2.5 billion over the next three years in upgrades, including new bag drop machines, in Seattle, Portland, Oregon, San Francisco, Los Angeles and Anchorage, Alaska. A machine will scan the traveler's ID, match it to a photo, and then scan the printed bag tags. The new system, designed to move guests through the bag tagging and dropping process in less than five minutes (compared to around eight minutes now), will be in Portland in May.

Charu Jain, the airline's senior vice president of innovation and merchandising, said that it felt like the right moment for Alaska because of improved technology and increasing passenger familiarity with facial recognition.

The fastest growing use of facial recognition software at U.S. airports so far has been in security measures for entering and exiting the United States.

The growth stems from a 2001 congressional mandate, in the wake of 9/11, requiring the implementation of a system that would allow all travelers arriving and departing the United States to be identified using biometric technology.

Overseen by the Customs and Border Protection agency, the biometric system for those entering the United States is in place, and scanned 113 million entries at airports last year. For those leaving the country, the system is available at 49 airports, with the CBP aiming to cover all airports with international departures by 2026.

Biometric entry is mandatory for foreign nationals. But biometric exit is currently optional for these travelers, while CBP is making the system fully operational. At any border, the biometric process is optional for U.S. citizens, who can instead request a manual

Diane Sabatino, acting executive assistant commissioner for field operations at CBP, said that the system aims to improve security, but she acknowledged rising privacy concerns. Images of U.S. citizens taken during the process are deleted within 12 hours, she said, but photos of foreign nationals are stored for up to 75 years.

"We are not scanning the crowd looking for people," she said. "It's certainly a privacy issue. We are never going to ask them to sacrifice privacy for convenience."

Miami International Airport, the second busiest airport in the U.S. for international passengers last year, has one of the "largest deployments" of biometrics in the country, airport executives say. In a partnership with SITA, a global information technology provider for the air transport industry, the air port has installed the technology for departing passengers at 74 out of 134 gates and plans to cover the remaining gates by the end of this year, said Maurice Jenkins, chiefinnovation officer at Miami-Dade Aviation Department.

The contract with SITA costs \$9 million, but Jenkins said the new technology was increasing efficiency in the rest of the airport's operations, such as fewer gate agents checking documents.

Document-Free Travel Overseas

Experts believe the future of air travel is one where facial recognition will be used throughout the entire airport journey: bag drop, boarding, even entering lounges and purchasing items at retail stores within the airport. It may be so streamlined that security checkpoints could be eliminated, replaced instead by security "tunnels" that passengers walkthrough and have their identity confirmed

"This is the future," said Dr. Sheldon Jacobson, a computer science professor at University of Illinois at Urbana-Champaign who researches aviation security.

According to a recent report by SITA, in which 292 airlines and 382 airports around the world were surveyed, 70% of global airlines are expected to use some sort of biometric identification by 2026 and 90% of airports are currently investing in the technology.

More comprehensive experimentation has already landed at some airports abroad. Later this year, Singapore's Changi Airport intends to go passport-free for departures; all passengers, regardless of nationality, will be able use this system. At Frankfurt Airport in Germany, passengers can now use their faces from the time they check-in to boarding. The airport is installing biometric technology throughout its two terminals and making it available to all airlines.

InChina, 74 airports – 86% of the country's international airports — have biometric technology in place, according to a report released last month by the global market research company Euromonitor and the U.S.

Travel Association. At Beijing Capital International Airport, the country's busiest airport, travelers can use facial recognition throughout their entire journey, even to pay for items at duty-free shops.

But in the United States, according to the report, only about 36% of international airports have some biometric capabilities.

There are several reasons for the country's lagging adoption, said Kevin McAleenan, the former acting secretary for the U.S. Department of Homeland Security and currently CEO of Pangiam, a travel technology company. Simply, the United States has many airports and the immigration exit process here is different from other places.

At many airports overseas, the government controls immigration for departing travelers, allowing these airports to have a governmentestablished biometric system.

In the United States, airlines, using CBP passenger data, confirm the identities of travelers leaving the country.

Concerns Over Government Surveillance

Biometrics use has already seeped into daily life. People unlock their phones with their faces. Shoppers can pay for groceries with their palms at Whole Foods.

But critics believe that the technology's convenience fails to outweigh a high potential for abuse – from unfettered surveillance to unintended effects like perpetuating racial and gender discrimination.

Cody Venzke, senior policy counsel on privacy and technology at the American Civil Liberties Union, said the government had not yet shown a demonstrated need for facial $recognition \, technology\, at airports\, and\, worried$ about a "nuclear scenario.'

"Facial recognition technology," he said, could be "the foundation for a really robust and widespread government surveillance and tracking network."

"That technology might be able to be used to track you automatically and surreptitiously, from place to place, as you go about your day, and create a really detailed mosaic about everything about your life,"

The ACLU supports a congressional bill, introduced last November, called the Traveler Privacy Protection Act. Listing concerns over security and racial discrimination, the bill would halt the TSA's ongoing facial recognition program, and require congressional authorization for the agency to resume it.

Conley, of the TSA, said a stop in the agency's biometrics efforts would "take us back years."

For some travelers, facial recognition has already become a reliable tool. At JFK on a recent afternoon, Brad Mossholder, 45, used Delta's Digital ID line to breeze through the security screening at Terminal 4 and bypass a dozen travelers in the adjacent PreCheck

He was flying from his home in New York to San Diego for his job in corporate retail, and as a frequent business traveler, has used facial recognition several times. The process is faster and easier overall, Mossholder said, and he wasn't worried about privacy.

"Honestly, my photo is on LinkedIn, it's on a million social media sites," he said. "If you really wanted to see a picture of me, you could."

Congress Planned Religious Census In Armed Forces: Minister's Big Charge

Defence Minister Rajnath Singh on Wednesday said previous Congress governments at the Centre tried to create a division in the country's armed forces by recommending a 'religious census'. This comes amid the furore around wealth redistribution, an idea Rahul Gandhi allegedly said would be followed up on and implemented if his party was voted to power.

Addressing an election campaign at Vishakhapatnam on Wednesday, the Union Defence Minister said, "The Sachar Committee, which was formed by the Congress government, recommended a religionbased census in the armed forces in 2006. The Congress, in its manifesto (for the ongoing Lok Sabha elections), has also hinted at a reservation for religious minorities if they are elected. If they introduce reservations for religious minorities and extend the idea to the armed forces, it wouldn't bode well for the country's unity and integrity of the country."

"What worries me more is that whatever the Congress has put in its manifesto in the name of minority welfare has echoes of the ideas and recommendations in the



Sachar Committee report," the Union Defence Minister said. In a scathing attack on the Congress over its 'appeasement' politics, he said the grand old party was trying to introduce a 'religion-based reservation' through the back door, adding that appeasement shows

the 'real face' of the Congress. "The Congress, through its manifesto, was subtly trying to bring back the idea of reservation on grounds of religion into the political and electoral discourse. However, PM Modi exposed their face because of which he is facing such brickbats from the Congress," Rajnath Singh added.

"The promises that the Congress has made in its manifesto stand to divide our society. Sections 3 and 6, under the Minorities Chapter in their manifesto, bare their real intentions. This is a party that divided the country on religious lines and has appeasement in its DNA," the Union Defence Minister stated further.

The 'Rangnath Mishra Commission' and 'Sacchar Commission' were put together under the previous Congress-led UPA at the Centre,

with the sole purpose of according a special treatment to a particular community in the name of minority welfare, the Union Minister said. "I remember when (former) Prime Minister Manmohan Singh said minorities, especially Muslims, have the first right to the country's resources. And when Modi-ji reminded the Congress of the statement by the former PM, they got furious," Rajnath Singh added. The previous Congress government

in undivided Andhra Pradesh set up a 'communal laboratory' by giving reservations to Muslims in government jobs, Rajnath Singh alleged, adding that it amounted to a blatant disregard of the ideas enshrined in the Constitution.

"From 2004 to 2014, the Congress government made five attempts to introduce Muslim reservation but the Supreme Court and the laws of land prevented them from advancing their agenda," he added. On the chief of Congress' overseas chapter, Sam Pitroda calling for discussions on the introduction of an 'inheritance tax' in the country on the lines of the US, the Union Defence Minister said the grand old party should clarify whether it wants to impose such a levy.

Kalaburagi, Karnataka: Seeking to strike an emotional chord with the people of his home district of Kalaburagi, Congress President M Mallikarjun Kharge today appealed to them to at least attend his funeral if they thought he worked for them even though they do not wish to vote for the party candidate here in the coming Lok Sabha elec-

Speaking at a poll rally at Afzalpur in this district, the 81-year-old also said that if they (people) did not vote for the Congress candidate, he would think that he did not have "any place" in Kalaburagi anymore.

The Congress has fielded Kharge's son-in-law Radhakrishna Doddamani from Kalaburagi, against BJP's sitting MPUmesh Jadhav.

"If you miss your vote this time (if you don't vote for the Congress candidate), I will think that I don't have any place here for me and I could not win your heart,"

said Mr Kharge, who won the Lok Sabha elections here in 2009 and 2014, but lost in 2019.

"Whether you vote for us

(Congress) or not, but at least come to my funeral if you think that I have done for Kalaburagi," the Congress chief said. He also said that he would

continue in politics till his last breath to "defeat" the BIP and RSS ideology.

"I am born for politics. Whether or not I will contest the election, I will strive till my last breath to save the Constitution and democracy of this country. I will not retire from politics," Mr Kharge asserted. Explaining further, he said retirement happens from a position but one should not retire from his/her principles. "I am born to defeat the ideology of the BJP and RSS and not to surrender before them."

He also advised Karnataka Chief Minister Siddaramaiah, who shared the dais with him, to follow his principles. "I tell Siddaramaiah repeatedly that you may retire as CM or MLA, but you cannot retire from politics till you defeat the ideology of the BJP and

Sunetra Pawar, Wife Of Ajit Pawar, Gets Clean Chit In Rs 25,000-Crore 'Scam'

Mumbai: In a reprieve for Sunetra Pawar, wife of Maharashtra Deputy Chief Minister Ajit Pawar and NDA candidate for the Baramati Lok Sabha seat, the Mumbai Police has given her a clean chit in an alleged 25,000-crore cooperative bank scam. In a closure report filed in January details of which have now emerged - the Economic Offences Wing (EOW) of the Mumbai Police, which is investigating the Maharashtra State Cooperative Bank (MSCB) case, has said that no criminal offence is made out in the transactions allegedly linked to Ms Pawar and her husband. Ms Pawar will be contesting from the Baramati seat, a bastion of Sharad Pawar, against his daughter Supriya Sule, who is also her sister-in-law.

The filing of the report has given more ammunition to the opposition, which has consistently accused the BJP of using central agencies and police forces against leaders opposed to it and either going slow on the investigation or giving them a clean chit as soon as they align with the saffron party. The opposition parties call this the BJP's "washing machine".

Ajit Pawar had joined the ruling alliance of the BJP and the Shiv Sena (Eknath Shinde



faction) and taken oath as a Maharashtra deputy chief minister after breaking the NCP, formed by his uncle Sharad Pawar,

The EOW's closure report states that the bank did not suffer any loss in the process of sanctioning loans to, or the sale of, the Jarandeshwar Sugar Mill, which is linked to Ajit Pawar.

It said that Sunetra Pawar had resigned from the post of director of Jai Agrotech in 2008 and, two years later, the company gave 20.25 crore to Jarandeshwar Sugar Mill. The mill was then bought by a firm called Guru Commodity in an auction for 65.75 crore but given on lease again to a company in which relatives of Ajit Pawar, including Rajendra Ghadge, were

Samajwadi Party Chief Akhilesh Yadav To Contest Lok Sabha Polls From UP's Kannauj

Lucknow: Samajwadi Party chief Akhilesh Yadav will contest the 2024 Lok Sabha election from Uttar Pradesh's Kannauj - the seat that sent him to Parliament thrice and also voted for his wife, Dimple Yadav, and Mulayam Singh Yadav, the late SP patriarch - his party said Wednesday in a post on X.

Mr Yadav, a former UP Chief Minister, will file his papers at noon tomorrow, the SP said. He also won the Azamgarh seat in 2019, but quit after he was elected to the UP Assembly from Karhal in 2022.

Speculation the SP leader will return to the Lok Sabha battlefield had been doing the rounds. Earlier today SP leader Ram Gopal Yadav was quoted as saying the decision had been taken.

Mr Yadav's proverbial homecoming will mean SP leader Tej Pratap Singh Yadav, who was named as the candidate earlier this week



Yadav's nephew; he is the grandson of Mulayam Yadav's brother Ranveer, and won the Mainpuri seat in the 2014 election.

Sources said the switch was the result of discontent among SP workers on the ground, who were keen that the party boss contest the family seat. Mr Yadav had originally opted against contesting this election since he wanted time to plan the overall strategy.

Kannauj was a Samaj wadi Party stronghold till the BJP's Subrat Pathak won it - by fewer - will not contest. Tej Pratap Yadav is Akhilesh than 14,000 votes - in 2019. The seat was won

by Akhilesh Yadav's wife in a bypoll in 2012. She retained it in the 2014 election, but lost it to Mr Pathak five years later. Mrs Yadav was later fielded from Mainpuri in the 2022 bypoll due to the death of Mulayam Singh Yadav. She won by nearly three lakh votes.

She has been re-nominated from the Mainpuri seat. Akhilesh Yadav won the seat in the 2000 bypoll and retained it in the 2004 and 2009 general elections, winning by more than three lakh and 2.5 lakh votes respectively. The SP is allied with the Congress-led INDIA bloc in this election. It is contesting the lion's share - 63 - of UP's 80 Lok Sabha seats. The other 17 have been allotted to the Congress.

nations were filed for 88 parliamentary constituencies across 12 States and UTs going for polls in phase 2 for the Lok Sabha Elections.The last date for filing nominations for phase 2 for all 12 States and UTs was April 4.After the scrutiny of 2633 nominations filed, 1428 nominations were found to be valid. The last date for withdrawal of candidature for all 12 States and UTs was April 8.

In phase 2, Kerala has a maximum of 500 nominations from 20 parliamentary constituencies, followed by 491 nominations from 14 PCs in Karnataka. A minimum of 14 nominations were received from the parliamentary constituency in Tripura. 16-Nanded Parliamentary Constituency in Maharashtra received a maximum of 92 nominations.

The first phase of the polling covered 102 constituencies of 21 states and union territories (UTs). Ten states and UTs were fully covered, while 11 states and UTs were partially covered. As the high-decibel

campaigns for the Lok Sabha polls kick off, promises and guarantees by various political parties took place. Prime Minister Narendra Modi has launched the "Modi Ki Guarantee" as the central theme of his campaign.

"We Can't Control Polls": Supreme Court To Prashant Bhushan In VVPAT Case

New Delhi: The Supreme Court today said it is not the controlling authority for elections and cannot dictate the functioning of Election Commission, a constitutional authority. The remarks came during the hearing on petitions seeking thorough cross-verification of votes cast on Electronic Voting Machines (EVM) with paper slips generated through the VVPAT system. The court has reserved the judgment for now.

The bench of Justice Sanjiv Khanna and Justice Dipankar Datta questioned if it can act on mere suspicion.

Responding to concerns raised by Advocate Prashant Bhushan, appearing for petitioner Association for Democratic Reforms, the court said, "If you are predisposed about a thought-process, then we cannot help you... we are not

here to change your thought process." Amid the Opposition's apprehensions regarding the EVM voting system, the petitions seek a direction to cross-verify every vote cast on EVMs with the paper slips generated by the VVPAT system. Currently, this cross-verification is done for five randomly selected EVMs in every

Assembly constituency. In the earlier hearings, the petitioners raised the issue of public trust and drew comparisons with European countries that have gone back to the ballot voting system. The court shot down such comparisons, observing that the challenges here are different. The Election Commission, on its part, stressed that the current system is foolproof.

An EVM has a control unit and a balloting unit. These are connected by a cable. These are also connected with a



VVPAT--Voter Verified Paper Audit Trail -- machine. This machine enables a voter to see if the vote was cast properly and went to the candidate he/she supports. As proceedings began this morning, the court sought some clarifications from the poll body about microcontrollers in the system and if they can be re-programmed. The Election Commission responded that all three units have their own microcontrollers and these can be programmed only once. Mr Bhushan contended that these microcontrollers have a flash memory that is re-programmable. "To say that it is not re-programmable is incorrect," he said. The court said it has to trust the poll body's technical report. "They are saying quantum of flash memory is very low. They can store 1024 symbols, not software. They say that as far as microcontrollers in the CU (control unit) is concerned, it is agnostic. It does not recognise the party or symbol, it knows the buttons," Justice Khanna said.

When Mr Bhushan wondered if it is possible to load a malicious program in the flash memory, the court remarked, "Can we issue a mandamus on the basis of a suspicion? We are not the controlling authority of another constitutional authority, we cannot control the elec-

Nitin Gadkari Faints During Rally In Maharashtra: "Due To **Heat, Fine Now"**

Mumbai: Union Minister Nitin Gadkari fainted while speaking at an election rally in Maharashtra's Yavatmal on Tuesday afternoon. Fortunately, the senior Bharatiya Janata Party leader received prompt treatment and was able, after a brief pause, to get back up on stage and continue his speech.

Shortly after completing his speech, Mr Gadkari posted on X (formerly Twitter).

"I felt discomfort due to the heat at the rally in Pusad, Maharashtra. But now I am completely healthy, and am leaving for Varud to attend the next meeting. Thank you for your love and good wishes." A disturbing video of the incident - which was unfortunately streamed live on X (formerly Twitter), including by his own account - showed Nitin Gadkari being carried away by those on stage, many of whom rushed to form a shield around the BJP leader to give him, and those treating him, some privacy. Mr Gadkari - who fought the first phase of the Lok Sabha election as the candidate from Nagpur, a seat he won in 2014 and 2019 - was campaigning for Rajashree Patil, who is from Chief Minister Eknath Shinde's faction of the Shiv Sena and is the ruling Mahayuti alliance's pick for Yavatmal-Washim.

There was speculation about the political future of Mr Gadkari earlier this year, after the BJP delayed naming him as its Nagpur Lok Sabha candidate. That delay even led to a cheeky invitation from former Chief Minister Uddhav Thackeray; he extended a 'join us' message to Mr Gadkari.

"I had told Gadkari this two days ago, and I am repeating it again. If you are being insulted, leave the BJP and join the Maha Vikas Aghadi (MVA, which is an alliance of Congress and the formerly undivided Shiv Sena and Nationalist Congress Party, led by Mr Thackeray and Sharad Pawar).'

"We will ensure your victory. We will make you a minister when our government comes to power, and it will be a post with powers," Uddhav Thackeray declared. The BJP, it seems, heard and responded. Days later Mr Gadkari was named in the party's list.

Blinken due in China to exert pressure but also seek stability

US Secretary of State Antony Blinken was due in China on Wednesday, as the United States ramps up pressure on its rival over its support for Russia while also seeking to manage tensions with Beijing.

The US diplomat will meet China's top brass on Friday in Beijing, where he is also expected to plead for restraint as Taiwan inaugurates a new leader, and to raise US concerns on Chinese trade practices — a vital issue for President Joe Biden in an election year.

But Blinken is also seeking to stabilise ties, with tensions between the world's two largest economies palpably easing since his last visit in June.

At the time, he was the highest-ranking US official to visit China in five years, and the trip was followed by a meeting between the countries' presidents in November.At that summit in California, Chinese President Xi Jinping agreed to a US wish list including restoring contact between militaries and cracking down on precursor chemicals to fentanyl, the powerful painkiller behind an addiction epidemic in the United States. Blinken will start his visit on Wednesday in Shanghai.



While in the city, he will meet students and business leaders in what an aide called a bid to highlight warm ties between the American and Chinese peoples.The friendly side trip — the first visit by a US secretary of state to the bustling metropolis since Hillary Clinton in 2010 – would have been unthinkable until recently, with hawks on both sides previously speaking of a new Cold War between the two powers. Treasury Secretary Ianet Yellen similarly toured the manufacturing hub of Guangzhou before visiting Beijing earlier this month.A senior US official previewing Blinken's trip said that the United States and China were at a "different place than we were a year ago, when the bilateral relationship was at an historic low point"."We also believe, and we have also clearly demonstrated, that responsibly managing competition does not mean we will pull back from measures to protect US national interests," he said. The Biden administration's eagerness to engage China stands in stark contrast to its efforts to isolate Russia since its invasion of Ukraine in February 2022. After initially being pleased that Beijing has not directly supplied weapons to Russia, the United States in recent weeks has accused China of lavishing industrial material and technology on Moscow. Washington has encouraged European leaders, including German Chancellor Olaf Scholz, who recently visited Beijing, to stand firm on China not backing Russia, believing that it wants stable ties with the West as it focuses on addressing economic headwinds at home. "If China purports on the one hand to want good relations with Europe and other countries, it can't on the other hand be fuelling what is the biggest threat to European security since the end of the Cold War," Blinken said Friday after Group of Seven talks in Capri,

Iran, Pakistan agree to 'expeditiously finalise' free trade agreement: joint statement

Tehran and Islamabad agreed to "expeditiously finalise" a Free Trade Agreement (FTA), a joint statement said on Wednesday as Iranian President Ebrahim Raisi concluded his three-day official visit to Pakistan. According to a joint statement issued by Iran and Pakistan, "both sides agreed to expeditiously finalise the FTA and hold the next sessions of annual Bilateral Political Consultations (BPC) and Joint Business $Trade\,Committee\,(JBTC)\,as\,well\,as\,the\,22nd$ round of the negotiations of the Joint Economic Commission (JEC) in the near future".

Last month, Iranian Ambassador Dr Reza Amiri Moghadam had said the FTA would increase mutual trade, highlighting the need to have strong air, maritime and sea links. The joint statement recalled the exchanges and meetings during Raisi's visit to Pakistan, saying that both sides "reviewed the entire spectrum of Pakistan-Iran bilateral relations". Both neighbours also agreed to "enhance mutual interaction through regular exchange of high-level



visits", it added.Pakistan and Iran also agreed to facilitate a regular exchange of economic and technical experts, as well as delegations from Chambers of Commerce from both countries to intensify economic cooperation. The declaration of the Reemdan border point as an international border crossing point under the TIR Convention and the opening of the remaining two border sustenance markets was also agreed upon, the statement said.It added that both countries "affirmed their commitment to transform their common border from 'border of peace' to a 'border of prosperity' through joint developmentoriented economic projects, including setting up of joint border markets, economic free zones.

Boat disasters in Africa, Europe leave 43 dead

NAIROBI/WIMEREUX: Twenty-one migrants died on Tuesday in boat disasters off the coast of the Horn of Africa and trying to cross the English Channel from France to Britain. Bodies of 22 people were found off the coast of the Tunisian port city of Sfax in recent days.

According to the UN's migration agency, at least 16 people are dead and 28 missing in a new migrant boat disaster off the coast of the Horn of Africa nation of Djibouti.

It was the second fatal maritime accident on the perilous so-called Eastern Migration Route from Africa to the Middle East in as many weeks.

Another vessel carrying mainly Ethiopian migrants sank in the same area off the Djibouti coast on April 8, claiming the lives of several dozen people.

Boat capsizes off Djibouti leaving 16 dead, bodies of 22 found along Tunisian coast and five drown while trying to reach **English shores**

"Tragedy as boat capsizes off Djibouti coast with 77 migrants on board including children," the International Organisation for Migration (IOM) said in a post on X,



formerly Twitter. "At least 28 missing. 16 dead," it said, adding that the local IOM branch was "supporting local authorities with search and rescue effort".

Yvonne Ndege, a spokeswoman for the agency, said in Nairobi that the 16 fatalities included children and a baby, without offering further details.

Tunisian coast tragedy

The bodies of 22 people presumed to be sub-Saharan migrants were found off the coast of the Tunisian port city of Sfax in recent days, a court spokesperson said on Tuesday.

"Twenty-two bodies were discovered in the Sidi Youssef port (off the coast of Sfax) since Saturday," Hichem Ben Ayed, spokesman for the Sfax court, said.

to secure his release. Gershkovich, who was accredited by the Russian Foreign Ministry to work in Russia as a journalist, was

arrested during a trip to the Urals city of Yekaterinburg. He has been held for over a year at Moscow's highsecurity Lefortovo prison. The US has accused Russia of using him for the purpose of "hostage diplomacy".

"We will continue to denounce and impose costs for Russia's appalling attempts to use Americans as bargaining chips," President Joe Biden said last month on the anniversary of Gershkovich's arrest.

10 killed as two Malaysian military choppers collide

KUALA LUMPUR: Two Malaysian military helicopters collided and crashed during a training session on Tuesday, killing all 10 crew onboard, the country's rescue agency said.

Footage shared online showed several helicopters flying low in formation over the Lumut naval base, located about 160km from Kuala Lumpur, while participating in a fly-past rehearsal ahead of Naval Day celebrations in May.

One chopper was seen clipping the rear rotor of another, causing both to go into a tailspin and crash.

"The two helicopters collided during flight training," said Suhaimy Mohamad Suhail, senior operations commander from the fire and rescue department, adding that all 10 crew members on board were confirmed dead by medical officers.

The two aircraft involved were a Eurocopter AS555SN Fennec and an AgustaWestland AW139, the rescue agency said.

Israel Says Forces Carrying Out "Offensive **Action" Across Southern Lebanon**

Jerusalem: Israeli forces are carrying out "offensive action" across southern Lebanon, Defence Minister Yoav Gallant said Wednesday without specifying whether ground troops had crossed the border.

"Many forces are deployed on the border and IDF (army) forces are carrying out offensive action currently throughout southern Lebanon," Gallant said in a statement, also claiming that "half of Hezbollah's commanders in southern Lebanon have been eliminated" in months of

"The other half are in hiding and abandoning the field to IDF operations," he added without giving a specific number.

In a separate statement, the army



said it had struck 40 Hezbollah targets in southern Lebanon.

"A short while ago, IDF (army) fighter jets and artillery struck approximately 40 Hezbollah terror targets" around Aita al-Shaab in southern Lebanon, including storage facilities and weaponry, it said. The army said Hezbollah "has established dozens of terror means and infrastructures in the area" to attack Israel.Lebanon's state-run National News Agency said Israel had carried out more than 13 strikes near Aita al-Shaab and surrounding villages. "Israeli warlanes carried out ...

more than 13 air strikes targeting the outskirts of the towns of Aita al-Shaab, Ramya, Jabal Balat and Khallet Warda," it said. The strikes came after Hezbollah said it fired a fresh barrage of rockets across the border on Wednesday after a strike blamed on Israel killed two civilians.

The group had already fired rockets at northern Israel late on Tuesday "in response" to the civilian deaths. Cross-border exchanges of fire have flared between the Israeli army and Iran-backed Hezbollah since Hamas's October 7 attack on Israel triggered war in Gaza

Since October 7, at least 380 people have been killed in Lebanon, mostly Hezbollah fighters but also 72 civilians, according to an AFP tally.

Bill to ban TikTok in US clears Congress

The United States Senate on Tuesday approved legislation requiring the popular social media app TikTok to divest from its Chinese parent company ByteDance or be shut out of the US market. The measure was part of a \$95 billion foreign aid package, including military assistance to Ukraine, Israel and Taiwan, which has now cleared Congress and heads to President Joe Biden's desk.

US and other Western officials have voiced alarm over the popularity of TikTok with young people, alleging it allows Beijing to collect data and spy on users. It has 170 million users in the United States alone.

These critics also say TikTok is subservient to Beijing and a conduit to spread propaganda. China and the company strongly deny these claims.

The bill, which could trigger the rare step of barring a company from operating in the US market, passed the Senate by a 79-18 vote three days after it cleared the House of Representatives with strong bipartisan support.

Biden has stated he will sign the legislation. He reiterated his concerns about TikTok in a rare telephone conversation with Chinese President Xi Jinping early this

Fears grow for Rafah as Gaza crisis rages 200 days on

GAZA STRIP: The Israeli aggression entered its 200th day on Tuesday as aid groups warned that Israeli plans to invade the southern city of Rafah where most Gazans

have taken refuge would create an "apocalyptic situation". Fears have been rising that Israeli Prime Minister Benjamin Netanyahu will soon follow through on repeated threats to send troops into Rafah, where 1.5 million people have sought shelter, many in makeshift encamp-

ments. "Everybody seems to be on a countdown to war across the largest displacement camp on Earth, which is Rafah," Norwegian Refugee Council chief Jan Egeland said.

Egeland warned that a ground assault on Rafah would be an "apocalyptic situation" and that humanitarian groups "are completely in the dark on how to mitigate this countdown to a catastrophe".

Also on Tuesday, the United Nations rights office said it was "horrified" at reports of mass graves found at the Gaza Strip's two biggest hospitals after Israeli sieges and

Israel has repeatedly targeted Gazan medical facilities during the war, accusing Hamas of using them as command centres and to hold hostages abducted on October 7. Hamas denies the accusation.

Gaza's Civil Defence agency said nearly 340 bodies were uncovered in the past three days of people killed and buried by Israeli forces at the Nasser Hospital in the southern city of Khan Yunis.

Israel's army responded by saying that claims it had buried Palestinian bodies were "baseless and unfounded", without directly addressing allegations that Israeli troops were behind the killings.

The army said that "corpses buried by Palestinians" had been examined by Israeli troops searching for hos-

tages and then "returned to their place". UN rights chief Volker Turk called for an "independent" probe into the deaths at Nasser and Gaza City's Al-Shifa hospitals, noting the "special protection" awarded to medical facilities under international law.

New Urine Test for Prostate Cancer May Help Reduce Unnecessary Biopsies

that utilizes 17 genetic markers has demonstrated a high degree of accuracy in screening for serious cancer

The test also significantly reduced unnecessary biopsies for individuals with indolent, low-grade prostate cancer.

The results are exciting, but questions remain as to whether the test would perform in a more racially diverse popu-

Researchers have identified 17 unique genetic markers that are overexpressed by high-grade prostate cancers, which can be screened for accurately using a urine test. Experts say the test can help doctors identify serious cancers while also reducing unnecessary biopsies.

Prostate cancers are graded according to a Gleason score. Trusted SourceThe higher the grade the more likely the cancer will spread quickly and grow.

This new test could potentially help with diagnosing and treating cancer earlier and with fewer invasive measures.

The health benefits of screening for prostate cancer with a standard prostatespecific antigen (PSA) blood test have historically come with the tradeoff: the potential for unnecessary, invasive procedures, such as prostate biopsies.

However, innovations in the realm of prostate cancer biomarker tests are helping to improve diagnostic accuracy alongside PSA testing.

The results of one such biomarker test, known as the MyProstateScore 2.0 (MPS2), which were published this month in JAMA OncologyTrusted Source, indicate that the test is highly accurate for detecting highgrade cancers.

Researchers found that the test had a 95% sensitivity for prostate cancer of grade group 2 or greater, and 99% for grade group

"It does look impressive and exciting. I definitely think this is moving the field in the right direction, which will be help-



ful for patients in the long term," Geoffrey Sonn, MD, an Associate Professor of Urology at Stanford Medicine who wasn't affiliated with the research, told Health-

However, questions remain about whether the test could be accurately applied to a racially diverse population, a limitation that the authors acknowledge in the research.

Adam Murphy, MD, MBA, an Associate Professor of Urology at the Northwestern University Feinberg School of Medicine, called the research, "a good addition to the literature," but noted that there were clear limitations regarding race. Murphy wasn't affiliated with the research.

"It's hard to know how it performs in other ethnic minority groups," said Mur-

To develop the test, researchers sequenced nearly 60,000 genes, eventually identifying 54 markers of prostate cancer. They found 17 of these markers were further stratified to indicate highgrade cancer.

Research and guidelines on prostate cancer screening have increasingly focused on identifying these high-grade cancers to help with early detection and

"Prostate cancer differs from many other cancers in that there's a subset of low-grade prostate cancers that really do not behave like cancer. They don't spread or metastasize, and thus they pose minimal risk of harm," Jeffrey Tosoian, MD, MPH, an Assistant Professor of Urology and Director of Translational Cancer Research at Vanderbilt University Medical Center, and lead author of the paper, told Healthline.

"We set out to improve upon existing tests through two mechanisms. One is that we identified markers that are specific for higher-grade cancers," Tosoian said. "The other was the breadth of markers. We were able to use newer technology that allows us to capture seventeen, plus a referene gene, so eighteen genes with a single test.'

The study included 743 men with an average age of 62, and a PSA score of 5.6. The test had a 95% sensitivity among men who had a grade group 2 or greater cancer; this sensitivity improved to 99% in men

with a grade group 3 or greater cancer. In practical terms, that means the test accurately identified 95 out of 100 and 99 out of 100 incidences of cancer, depending on the grade of the cancer.

"Most cancers won't express all of these different markers. Most will only express a subset of them. And so by having more markers in a single test, it's likely to pick up more of the higher grade cancers that exist in the population," said Tosoian.

Reducing false positives for prostate

Another major finding of the study was the expected number of unnecessary biopsies that utilizing the test avoided.

PSA testing is known to result in false positivesTrusted Source, which can lead to anxiety and stress, so doctors have sought out other tests, such as biomarker tests, to improve accuracy. PSA is naturally secreted in the body, whether or not cancer is present, so an elevated PSA does not indicate cancer by itself. However, due to an elevated PSA level, a doctor might be inclined to order additional testing, including a biopsy.

"For a long time, someone would get a PSA blood test and if it was abnormal, they would just go straight to having a biopsy done of their prostate, which leads to lots and lots of procedures that are uncomfortable at best," said Sonn.

In the case of the MPS2 test, however, researchers found that utilization of the test could have reduced the rate of unnecessary biopsies by an estimated 35-42%. That is a significant improvement over other biomarker tests, which have been found to avoid between 15-30% of unnecessary biopsies.

"The aim would be that MPS2 can preserve the proven benefits of PSA screening in terms of early detection of high grade cancers that can be effectively treated, while significantly reducing the potential harms of false positive testing," said Tosoian.



Rashid: 'Things change quickly... we have the mindset of champions'

England legspinner says 50-over failure in India is irrelevant to June's T20 World Cup

SYDNEY: Adil Rashid believes that England have "the mindset of champions" heading into June's T20 World Cup, and has said they have drawn a line under their failure to defend their 50-over crown in India late last year.

Rashid was ever-present at last year's World Cup in which England won only three of their nine group-stage games, two of which came after their elimination had been confirmed. The tournament marked the end of a cycle for their 50-over team but Rashid insisted that they should not read too deeply into those struggles ahead of their 20-over title defence.

"The 50 overs was a completely different format," Rashid ever. It is what it is. We didn't have the best tournament. We didn't play well: bat, ball, as a team, as a unit - everything. But I think this is a completely different format where currently we're world champions at that.

"We're confident. We've got the team, we've got the mindset, we've got the players, we've got the experience. If we go out there having the same belief, I think we'll - hopefully - go all the way. We don't look at it as 'we had a bad World Cup' because that's a completely different format. It's 50-over, that's not T20. We try not to mix both together.

"You have the mindset of champions... we are not think-

said."Wehadapoorrunorwhat- ing of what's gone on in the past; not thinking about a poor World Cup or people not [being] in form because things change very quickly when you go into a tournament or the first game comes. Prior to that, we may not be playing well but as soon as the tournament comes, people can turn up, teams can turn up and just switch on and

win the World Cup." Rashid's comments were echoed by Matthew Mott, England's white-ball coach, in a recent interview with the Times newspaper."We are confident," Mott said. "I think we've got a good squad. It is going to come down to the team that reads the conditions best. I don't think there is any hangover from the last World Cup. It's a different format and we are going out there to try to win it."

Mott also suggested that Jos

Buttler will base his captaincy more on "gut feel" at the T20 World Cup than in previous years, with less reliance on planning and data. "We'll do our match-up beforehand, and he [Buttler] is armed with that," Mott said. "He takes that quite seriously, but he wants to be more spontaneous out on the field." Rashid believes that approach will enable England to play with more freedom. "Fifty overs is a lot longer game [than T20] with a lot more thinking, a lot more strategic things, a lot more planning involved," he said.

MUMBAI: Pat Cummins used to be a nice guy. There are many recorded instances of this. He is protective of the environment. And of his mates. He has written probably the coldest press release ever, which doesn't really add anything to this, except that he did it to shut down a bunch of larger-than-lifetotally-above-reproach Aussie legends from going after the people in his care.

Ben Stokes, another saviour of our sweet, sometimes jingoistic game once lost himself in the face of crowd abuse and returned fire by picking on them for wearing glasses. Cummins stars in ads endorsing them. For large sums of money, obviously, but he could have used that movie star mug of his for any number of nefarious purposes. He could have brought the dab back. Instead, he stayed true to his hero arc that dates all the way back to 2011 when an 18-yearold him was too quick for Jacques Kallis.

A 19-, 20-, 21- and 22-year-old Cummins suffered through endless injuries, $somehow\,getting\,stronger\,with\,each\,one$ until he returned a fully-formed, stresstested, fast-bowling artiste. The lines he drew to connect the red ball in his hand to the tops of various off stumps that stood22 yards away, supposedly under the protection of generationally gifted batters, could rival da Vinci himself.

It was all going so smoothly. No. 1-ranked bowler. Fur baby lover. World Cup winner. The only thing he had to do was stay the course. But no. He went and became captain of a T20 team for the first time ever, and that team just happens to be Sunrisers Hyderabad (SRH), who have been waylaying every single bowler they have come across for the past two months. Does he not hear the cries? Does he not see the pain he is causing members of his own tribe?

"Remove this Impact Player rule, sir," Mohammed Siraj said, "Everyone is coming and hitting us."

Now, on the surface, this has nothing to do with Cummins or his SRH brethren. But remember there was no pushback about this rule when it was introduced last year. So what's different now? What has the Impact Player done this year that is so horrible? Well, he keeps shoring up batting line-ups, encouraging them to






You see? He's egging them on and he's not even being polite about it. "I'll keep saying," Cummins mispronounced gloating there in a video that SRH put out on social media, "you'll hear from us every time. That's how we want to play. It's not going to work every game but I can tell you everyone's terrified when they come up against us and we're going to blow some teams out of the water."

Where did it all go wrong? How has he strayed so far? The pragmatist who kept fielders out on the boundary in the very first over of an Ashes series was now painting that same strategy as weakness just because he's the one with a batting line-up putting the fear of god into the opposition.
